Brief facts of the instant appeal are as under:

- That the appellant is educated upto M.A. Islamiyat and was appointed on 25.06.1987 as a Junior Clerk by the Deputy Registrar Cooperative Department at Swat and he served on the said post in the above mentioned department till 2011. The appellant was sent to surplus poll from Cooperative Department and was adjusted in the Agriculture Department in the year 2002, the appellant was promoted to the rank of Senior Clerk on 30.05.2016, he served his duties to entire satisfaction of his superiors with spotless carrier.
- 2) That as compare to the appellant, respondent No. 4 is qualified upto Matric and was appointed as Black Smith on 01.12.1988, he has got no experience as required by the law and rules for the post of Clerk, but even then being a political influential and blue eyes of politicians, his cadre was changed from Black Smith to Junior Clerk in the span of short period, he was promoted as Senior Clerk. It is further submitted before this hon'ble court

that respondent No. 4 cannot write a single word on the computer / type writer but even then he was appointed as Junior Clerk thus his appointment as Junior Clerk and his subsequent promotion as to the Senior Clerk is without lawful authority and illegal and the same be declared as such.

- That the order of the respondent dated 04.12.2018, 07.12.2018, 16.01.2019, 18.02.2019 and 28.02.2019 are sufficient to established the influentially of the respondent No. 4.
- 4) That now it is settled by the superior courts that the public servant shall not be made a rolling stone and as such the transfer, adjustment, replacement in a couple of days is highly objectionable and illegal.
- 5) That appellant submitted an appeal against the orders of respondent No. 2 dated 16.01.2019 to respondent No. 1 which is still pending.
- 6) That feeling aggrieved from the illegal acts of the respondents, the appellant has no other alternate, efficacious, speedy remedy, hence to approach this hon'ble tribunal, inter alia, on the following grounds.

GROUNDS

a) That the impugned order is illegal and void-ab-initio, hence not maintainable in the eyes of law.

- b) That mandatory provision of law and rules have badly been violated by the respondents and the appellant has not been treated according to law.
- c) That the appellant did nothing that would amount to misconduct.
- d) That the impugned order is not speaking and thus untenable in the eyes of law.
- e) That the appellant has been punished without any commission or omission on his part.
- f) That the appellant's representation may be considered as integral part of this appeal.
- g) That any other ground will be taken at the time of arguments.

It is, therefore, most humbly prayed that appeal of the appellant may kindly be accepted as prayed for in the heading of appeal.
