already completed the required qualifying service for retirement under the rules instead of medical grounds hence the appellant may be directed to apply a fresh for premature retirement on the basis of fulfilling qualifying service for premature retirement. Thereafter the appellant time and again approached the respondents for retirement on medical ground alongwith an appeal for review of the direction given vide letter dated 22.01.2019 which was rejected vide order dated 17.04.2019 hence the appellant having no other alternate remedy filed the instant service appeal U/S 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 with the prayer that the impugned order of dated 22.01.2019 and order dated 17.04.2019 may be set aside by declaring it illegal, vide unlawful, without authority, based on malafide and direct the respondents to entitled the appellant for retirement on medical grounds and also entitled for payment of all outstanding dues from the date when her salary has been stopped with all benefits of pay and service.

3. The learned counsel for the appellant argued that the respondent No.2 referred the appellant for standing medical board vide letter dated 03.08.2018. The appellant was called for the medical board by the DG health vide letter dated 10.08.2018 to be appearing before standing medical board on 12.09.2018. The appellant appeared before the board on 15.09.2018 and vide letter dated 27.09.2018 report of standing medical board to the office of respondent No.2 on 10.08.2018 by the DG health office. Again the respondent No.2 directed the respondent No.4 vide letter dated 27.09.2018 for processing the case of the appellant for premature retirement on medical ground by furnishing all the requisite documents. Further contended that the office of respondent No.2 changed his previous stance contrary to the case in process the respondent No.4 was directed vide the impugned order of 22.01.2019 to resubmit the

retirement case of the appellant on the basis of the completion of qualifying service for ordinary premature retirement on the basis of medical ground. The appeal of the appellant dated 11.02.2019 was not considered and vide letter dated 17.04.2019 the respondent No.4 was informed that the application of the appellant along with others has been rejected and they should apply for premature/superannuation retirement whichever is applicable in their individual cases. Further contended that the impugned action and inaction on the part of respondents are against the law and justice. The respondent No.2 took the shelter behind the general instructions by the government issued vide letter dated 11.12.2018 wherein it was directed that the civil servants who has completed/eligible for premature retirement. There cases and appeal for retirement on medical ground may not be sent to competent authority. Further contended that the case of the appellant was processed quite earlier then the direction issued on 22.01.2019 and was at final stage and as a general rule of law. The case of the appellant is not covered on the impugned instruction of dated 22.01.2019. Further contended that the appellant has been arbitrary treated and being qualified for retirement on medical grounds and as such accrued rights are being denied by the respondent without any just cause contrary to the clear cut provisions of law and the fundamental rules. Moreover that from the date of her medical report she has been relieved from duty and her salary has been stopped and her pensionary benefits has not been paid. In this connection the learned counsel for the appellant relied upon the judgment of the Peshawar High Court reported as 2019 PLC (CS) notes 24. He further pleaded that the appeal may be accepted and the impugned orders of dated 22.01.2019 and 17.04.2019 be set aside and all the benefits as per prayers may be granted by the respondents.



- The learned Assistant Advocate General contested the facts, grounds of the appeal and arguments of the learned counsel for the appellant and argued that her request/appeal for premature retirement on medical ground has been rejected in the view of the order dated 11.12.2018. As she has completed her qualifying service for premature retirement. He further stated that the appellant has been dealt in accordance with the law and rules. No fundamental rights has been violated of the appellant while directing her to apply for fresh ground on premature retirement on the basis of qualifying service instead of medical grounds, hence the appeal may be dismissed with costs.
- 5. Arguments heard. File perused.
- 6. The Tribunal examined the arguments and counter arguments, the memo of appeal and the Para-wise comments of the respondents and relevant record attached to the case file and observes that the request of the appellant was initiated with her application of dated 07.07.2018 wherein she requested for retirement on medical ground with effect from 31.07.2018 her request for medical examination by the standing medical board was formally taken up with Director General Health Service by respondent No.2 vide letter dated 03.08.2018. The standing medical board recommended her for premature retirement on medical ground being incapacitated and not fit to continue in government service. Respondent No.2 forwarded the medical board recommendation to respondent No.4 and directed to process the case of the appellant for retirement on medical ground for the approval of the competent authority. After the instructions issued by the respondent No.2 vide letter dated 22.01.2019 the case of the appellant for retirement on medical ground was reversed at a final stage and converted it to the premature retirement on the basis of qualifying service without any statutory provision. It



appears that the impugned inaction on the part of respondent No.2 to submit the case to the approving authority is not covered under the law as the appellant has been denied her right for opting retirement on medical ground as provided in FR 10-A. Moreover, the denial of invalid pension and service benefits as required under SR 4 AA is not covered under the law and the instructions issued by the finance department under circular letter dated 1<sup>st</sup> December 1998.

7. In view of the above discussion we are of the considered opinion that the instant appeal carries merit and is approved with setting aside the orders adverse to the interest of the appellant and the respondents are directed to process the case of the appellant for retirement on medical ground and grant her invalid pension with effect from the date she has been relived from the duty. Parties are left to bear their own costs. File be consigned to the record room.

### **PRAYER**

On accepting this service appeal, the impugned order dated 22/01/2019 ( Wrongly mention as 22/01/2018) and order dated 17/04/2019 may graciously be set aside by declaring it illegal, void, unlawful, without authority, based on mala fide, void abinitio and thus not sustainable and the appellant is entitled for retirement on medical ground and also entitled for payment of all outstanding dues from the date when her salary has been stopped with all back benefits of pay and service



### Respectfully Sheweth:

- 1. That petitioner was serving as Head Mistress in the Government High School Tarkha Koi, Tehsil and District Karak and serving the department from 31/01/1990.
- 2. That petitioner is suffering from severe Cardiac problem with high blood pressure and diabetes disease from the past 2/3 years and is unable to perfume her duties, therefore, she filed an application for retirement on medical grounds on 07/07/2018. (Copy of application is attached as Annexure "A")
- 3. That respondent No. 5 vide letter dated 23/07/2018 forwarded application of the petitioner to worthy respondent 2. (Copy of Letter is attached as Annexure "B")
- 4. That respondent No. 2 vide letter dated 03/08/2018 referred all the relevant document to Director General, Health Services, Khyber Pakhtunkhwa, Peshawar for arranging Medical Board for Examination of petitioner. (Copy of the letter is attached as Annexure "C")
- 5. That Worthy Director General Health vide letter dated 10/08/2018 directed the petitioner to appear before the Medical Board on 12/09/2018 and accordingly petitioner appeared before the Standing Medical Board and has been examined on 15/09/2018. (Copy of the letter is attached as Annexure "D")
- 6. That the Chairman Standing Medical Board vide letter dated 27/09/2018 submitted the report of Standing Medical Board, wherein it is clearly mentioned that petitioner is unfit for government Job, therefore, she may be boarded out on medical grounds as she is permanently incapacitated. Respondent No. 2 vide letter dated 27/09/2018 requisitioned complete documents required for premature retirement on medical ground for obtaining approval of the respondent No. 1. (Coy of the Standing Medical Board and letters are attached as Annexure "E" to "E-II")
- 7. That after complying all the codal formalities respondent instead of sending the case before the competent authority issue directions vide letter dated 22/01/2019 (Wrongly written as 22/01/2018)

that as petitioner has completed minimum service for retirement therefore, no needs for medical ground, with further directions that petitioner may apply for premature retirement on fresh ground. ( Copy of the letter is attached as Annexure "F")

8. That petitioner time and again approach respondent for her retirement on medical ground and also filed an appeal for review of the direction given vide letter dated 22/01/2019 which has been rejected vide order dated 17/04/2019 (Copies attached as Annexure "G" and "H"), thus the petitioner having no other alternate remedy approaches this Hon'ble Court, inter alia, on the following grounds:

### GROUNDS:

- A) That the impugned actions and inactions violate the mandate provided under Article 4 of the Constitution of Pakistan.
- B) That respondent are legally bound to treat the petitioner in accordance to law and he is entitled for pre-mature retirement on medical grounds.
- C) That earlier vide letter dated 03/08/2018 respondent No. 2 by himself referred petitioner case before Standing Medical Board and accordingly petitioner appeared before the Standing Medical Board and valid constituted Medical Board declare petitioner unfit for government service, but now after the whole process respondent directed petitioner to apply fresh on the basis of minimum qualifying service, which is totally illegal and against the rule and regulation.
- D) That respondent vide letter dated 27/09/2018 directed respondent No. 4 to submit complete documents required for pre mature retirement on medical ground and after production of all the required documents issuance of the impugned letter dated 22/01/2019 is totally illegal, against the law and thus liable to be stuck down.
- E) That government vide letter dated 11/12/2018 has issued general instruction to the attached department that civil servant who has completed / eligible for pre-mature retirement there case and

appeal for retirement on medical ground may not be sent to competent authority and shall be discouraged, which is totally illegal, against the law and vest rights of the civil servant has been taken away, but any how the same instruction are not applicable on petitioner case as the process of medical board was already completed on 15/09/2018 and retrospective effect can be given to such like notification.

- F) That no proper opportunity of hearing has been provided by the respondent to the appellant, hence he has been condemned unheard and the case has been decided in a mechanical manner with out application of judicious mind.
- G) That nor the fundamental rules nor the CSR has been taken into consideration while deciding the case of appellant.
- H) That respondent has not adopted proper procedure in deciding the departmental appeal/ representation nor the same has been refer to proper competent authority. Similarly no opportunity of hearing has been provided to appellant to explain her stance and law on subject.
- I) That respondent No. 3 has also conducted last three (03) years audit and issued NDC for the purpose of retirement on 15/09/2018 and pay of the petitioner has been stopped from the said date, which clearly suggest that respondent has allowed for all practical purposes on pre-mature retirement on medical grounds but at the very belated stage issued the impugned directions to left the petitioner in hanging position, which is totally illegal and against the law.
- J) That because the impugned actions and inactions are against the principles ordained under Article 25 of the Constitution of Islamic Republic of Pakistan.
- K) That because the impugned actions and inactions are blatantly against all norms of justice and principles of reasonability based on victimizations and discrimination.
- L) That the petitioner by her own sweet will is not willing to proceed on retirement but her poor health problem not allowed her to



continue her job, therefore, the directions issued vide impugned letter is totally illegal and violation of the basic fundamental rights of petitioner.

- M) That petitioner has been arbitrary treated and he being qualified for the retirement on medical ground but has accrued rights are denying by the respondents without any just cause contrary to the clear cut provision of law.
- That from the date of her medical report she has been relieved from duty and her salary has been stopped and till date she has not been give the pensionery benefit which is totally against the rules and regulation and petitioner due to this act of respondent sustaining mental stress and financial constrained. It is very difficult for her to meet her day to day financial affair and her treatment.
- O) That the petitioner is fully entitled for the pre-mature retirement on medical grounds and denial of the same by the respondent is totally illegal, void against the rules and regulation thus indulgence of this Hon'ble Tribunal is required.
- P) That appellant also seeks permission of this Hon'ble Forum to raise additional points at the time of arguments.

It is, therefore, respectfully prayed that on accepting this Service Appeal;

- A) The impugned order dated 22/01/2019 (Wrongly mention as 22/01/2018) and order dated 17/04/2019 may graciously be set aside by declaring it illegal, void, unlawful, without authority, based on mala fide, void abinitio and thus not sustainable and the appellant is entitled for retirement on medical ground and also entitled for payment of all outstanding dues from the date when her salary has been stopped with all back benefits of pay and service
- B) The respondent may please be direct to act in accordance with law and the action and inaction of the respondents in not finalizing petitioner retirement case on the basis medical grounds is unconstitutional, unlawful, illegal without lawful

authority and direction may please be issued to respondent to finalized the pre-mature retirement case on medical ground of the petitioner and to grant the pensionary benefits to the petitioner without any further delay.

- C) Declare the letter dated 22/01/2019 and 17/04/2019 illegal, void, unlawful and without authority thus ineffective upon the rights of the petitioner thus liable to be struck down and the petitioner is fully entitled for pre-mature retirement on medial ground with all back benefits of outstanding dues from the date her salary has been stopped.
- P) Any administrative orders which are against the rules and regulation may please be declare ultra varies to the constitution of the Islamic Republic of Pakistan and thus liable to be struck down, furthermore the administrative order can not be applied retrospectively.

If such a civil servant applies for retirement on medical grounds, he may be discouraged and advised to apply for premature retirement.

# PART II, CHAPTER III

#### GENERAL CONDITIONS OF SERVICE.

F. R. 10. Except as provided by this rule, no person may be appointed in Pakistan to a post in Government service without a medical certificate of health, which must be affixed to his first pay bill. A local Government may make rules prescribing the form in which medical certificates should be prepared, and the particular medical or other officers by whom they should be signed. It may, in individual cases, dispense with the production of a certificate, and may by general orders exempt any specified class of Government servants from the operation of this rule.

(For rules made by the Governor-General under Fundamental Rule 10, see Supplementary Rules 3, 4 and 4-A).

[For Administrative Instructions issued by the Governor-General in connection with Fundamental Rule 10 regarding Conditions of age on Appointment to Government Service, See Part I of Appendix No. 3 in Volume II of this Compilation.]

Government order.- Once a person is asked to produce a medical certificate of fitness for entry into Government Service whether in a permanent or temporary capacity and has actually been examined and declared unfit, it is not open to the authorities exercising the powers of a local Government to use their discretion to ignore the certificate that has been produced.

- a) The authority competent to fill the post held by a Government servant may require him to appear before a medical authority for medical examination if, in the opinion of the competent authority, the Government servant is suffering from a disease which renders him unfit for the proper and efficient discharge of his duties or from a disease which is communicable and is likely to endanger the health of other Government servants.
- b) If the medical authority concerned, after examining the Government servant, certifies that the Government servant requires a period of absence from duty for the purpose of rest and treatment and that there is reasonable prospect of his recovery, the competent authority may grant him leave, including extraordinary leave, for such period as the medical

authority recommends, provided that it is due and admissible to the Government servant, and the competent authority may do so as if the Government servant had himself applied for the leave.

c)

- i. If the medical authority after examining the Government servant, certifies that the Government servant is permanently incapacitated for service, the findings of the medical authority shall be communicated to the Government servant immediately. The Government servant may, within seven days of the receipt by him of the official intimation of the findings of the medical authority, apply to the- Director General, Health, for a review of his case by a second medical board. Such an application shall be accompanied by fee the amount of which shall be fixed by the Director General, Health. The Director General, Health, shall then arrange for the convening of reviewing medical board consisting of persons who were not members of the first medical board. If the reviewing medical board also certifies that the Government servant is permanently incapacitated for further service, the competent authority may require him to retire from service and may grant him such invalid pension and/or gratuity as may be admissible to him under the rules, and the competent authority may do so as if the Government servant had himself applied for an invalid pension.
- ii. In case the reviewing medical board holds that the Government servant is fit for Government service, he shall be reinstated forthwith and the period of his absence will be treated as duty. If, however, the board certifies that the Government servant is not fit but there is a reasonable prospect of his recovery, the case will be regulated under the provisions of clause (b) above.
- iii. In case the Government servant concerned docs not apply for a review of his case within seven days of the receipt by him of the official intimation of the findings of the first medical board, the competent authority may require him to retire from service and may grant him invalid pension and/or gratuity as provided for in sub-clause (i) above.
  - **d)** The Central Government may make rules prescribing the form in which the medical certificate should be prepared and the medical officers by whom it should be signed.

F. R. 11. Unless in any case it be otherwise distinctly provided the whole time of a Government servant is at the disposal of the Government which pays him, and he may be employed in any manner required by proper authority, without claim for additional remuneration, whether the services required of him are such as would ordinarily be remunerated from general revenues, from local fund or from the revenues of a State that has acceded to Pakistan.

SUBJECT: MEDICAL EXAMINATION FOR THE PURPOSE OF COMMUTATION OF PENSION ON INVALIDATION.

Sir,

I am directed to refer to the subject noted above and to say that under the provision of fundamental Rule 10A the authority competent to fill the post held by a Government may require the Government Servant to appear before a medical authority for medical examination if, in the opinion of the competent authority, the Government servant is suffering from a disease which renders him/her unfit for the proper and efficient discharge of his duties or from a disease which is communicable and is likely to endanger the health of other Government servants. The Forms of medical certificate are set out under Supplementary Rule 4AA. If the medical Board finds that the Government Servant concerned is suffering from disease which renders him permanently unfit for Government service and recommends that he/she may be invalidated from Government service, then the competent authority may require the Government Servant to retire from service and may grant him such invalid pension and or gratuity as may be admissible to him/her under the Rules.

- Under the existing rules a Civil Servant at his option is entitled to commute upto 50% of his Gross Pension. Rule 8(7) of the Civil Services Pension Rules inter alia provides that commutation shall become absolute, that is, the title to receive the commuted portion of the pension shall cease and the title to receive the commuted value shall accrue, on the date on which the Medical Board signs the medical certificate. The requirement of medical examination under the rules contained in Chapter-VIII of the Civil Services Pension Rules, is a separate and distinct requirement from the requirement of medical examination required for invalidation of government servants. This requirement of medical examination was valid in case of retirement on superannuation, on invalidation or on retirement on retiring pension. This requirement was however waived off if commutation was asked for within one year of the date of retirement. But in cases of premature retirement on medical grounds, the requirement of medical examination for the purpose of commutation of pension was NOT waived off as stated in Finance Department letter No.SO(SR.III)FD-4-36/76, dated 28.12.1978.
- 3. The above requirement of second medical examination in case of invalidated pensioners was eliminated vide para 8 (c) of the Finance Department's O.M. No.FD(PRC)1-1/94, dated 30.6.1994. A question has arisen as to when the commutation now becomes 'absolute' in terms of rule 8(7) of the Civil Services Pension Rules. The matter has been re-examined. The exact intent of para 8(c) of Finance Department's O.M. dated 30.6.1994 referred to above is that the medical board which is convened for invalidation of a Government Servant may also assess expected age in terms Chapter-VIII of the Civil Services Pension Rules, and the government Servant retired on invalid pension may be saved the trouble of second Medical Examination for the purpose of commutation. In other words the requirement of medical examination for the purposes of Chapter-VIII of the Civil Services Pension Rules, as per se was not waived off. It has, therefore, been decided that when a medical board is convened for invalidation of a Government Servant, that medical board may also be specifically requested to report its recommendation in FORM 8 (PEN) appended to the Civil Services Pension Rules alongwith medical certificate under SR 4AA.
- 4. These instructions shall take immediate effect and will also be applicable to cases of invalidation already referred to medical board but medical certificate not recorded on the date of issue of this letter.
