

1. That petitioner is belong to District Bannu having certificate of Shahadat Ul almaia ama , khassa along with Metric and appointed on the post of TT on dated 07/10/1989 and most senior Theology Teacher employees of the respondents department .(copy of the ACR is enclosed as

2. That according to KPK Civil Servant Act 1973 and KPK INITIAL APPOINTMENT AND TRANSFER RULE 1989 provide promotion form TT to STT where in 2021 working paper are prepared where petitioner was at serial No. 2 of the seniority list and 5 post are lying vacant for promotion from TT to STT . **(Copy of working paper is enclosed as annexure B'')**.
3. That on dated 29-10-2021 Promotion order of Respondents No.5 to 7 are issued and appellant is defer without any reason then after on 23/07/2023 once again working paper are prepared where Respondents No. 10 to 12 are given promotion who are junior to the appellant but once again appellant is denied and thus on 04-09-2023 promotion order of Respondents are issued . **(Copy of the promotion order , working paper and second promotion order are enclosed as annexure C, D & E'')**.
4. That after appellant preferred service appeal and on dated 30/11/2023 appeal of the appellant is rejected by the Respondent No. 2 and convey the rejection order on dated 02/01/2024 through head master GMS Bazida Yousaf Khan and received rejection order . **(copy of service appeal and rejection order are enclosed as annexure F & G'')**.
5. That having no other officious remedy for relief the petitioner invokes the jurisdiction of this Hon'ble Service Tribunal for redressed of his grievance which is relates to his terms and condition of his service inter alia on the following grounds .

GROUND:-

- A. That, appellant is eligible for promotion from dated 29-10-2021 where junior from the appellant are promoted to STT hence appellant is entitled

- B. That promotion of the respondents 5 to 12 are against norms of administration of good governance where senior is denied while junior are given the promotion which is against the policy of merit promotion policy.
- C. That appellant has vested right for promotion as per criteria as led down by the respondents department . Appellant is appointed 1989 while Respondents No. 5 to 12 are appointed in 2010 so appellant is most senior to the Respondents No. 5 to 12.
- D. That respondent made discrimination between the TT employees of the respondents department were appellant has qualification for initial requirement as led down by the Promotion policy , so appellant is entitled for promotion from dated 29-10-2021.
- E. That promotion order of Respondents 5 to 12 is clear cut violation of article 4,5,25 of the constitution hence fundamental rights of the petitioner is infringed so this tribunal has jurisdiction to see the violation of fundamental of the petitioner as well as other employees of the respondents department.
