

- II) AGAINST ISSUING THE SENIORITY LIST UNDER THE NEW RULES OF 2023 FOR DEPARTMENTAL PROMOTION.
- III) AGAINST THE NON-RESPONDING/ INACTION OF THE RESPONDENTS OF REJECTION OF THE DEPARTMENTAL APPEAL DATED 26.09.2023 OF THE APPELLANT AND SUBSEQUENT ISSUANCE OF IMPUGNED FRESH TENTATIVE SENIORITY LIST DATED 19.10.2023 ON THE BASIS OF IMPUGNED NEW PROMOTION RULES DATED 14.09.2023.

**Prayer-in-Appeal:**

On acceptance of the instant service appeal, the newly issued rules 2023 for promotion of Naib Qasids dated 14.09.2023 may kindly be set aside and the process of promotion i.e. D.P.C. in the light of the newly issued rules of 14.09.2023 may kindly be stopped and the respondents may kindly be directed to promote the appellant on the basis of Promotion Rules 2018-2019 where- under their other colleagues have been granted promotion on the basis of S.S.C. 2<sup>nd</sup> division instead of S.S.C. 3<sup>rd</sup> division.

---

**Respectfully Sheweth:**

1. That the Appellants are a law abiding and peaceful citizens of the country. (Copy of CNICs is Annexure "A")
2. That the appellants were appointed as Naib Qasid in the respondent department and since his appointment he is performing his duties regularly and honestly.
3. That in the year 2018 Promotion Rules for Naib Qasids to the post of Junior Village Secretaries were framed wherein criteria for promotion was set as SSC 2<sup>nd</sup> division and six months Diploma in C.I.T. (Copy of rules is Annexure "B").

4. That in the year 2019 the same rules for promotion were amended with prescribed qualification as CIT + 2<sup>nd</sup> division in SSC. (Copy of rules 2019 is Annexure "C")
5. That in the meanwhile promotions were made by the respondents according to the prescribed rules/ qualification in District Charsadda as well as other districts. (Copy of list is Annexure "D").
6. That the appellants approached to the Director General LG&RDD i.e. respondent No.2 for promotion on the basis of said rules/ criteria whereby the respondent No.2 wrote a letter to respondent No.4 to promote the appellant accordingly. (Copy of application and letter are Annexure "E and F").
7. That no heed whatsoever was paid by the respondent No.3 to the request of appellants as well as direction of respondent No.2.
8. That after some time on 03.03.2021 the appellants again also made an application to respondent No.2 as reminder to promote the appellant according to the existing rules. (Copy of application/ reminder is Annexure "G").
9. That during the pendency of the said application, promotions were made in District Malakand on 07.10.2022 in the light of promotion rules, 2018. (Copies is Annexure "H").
10. That it is pertinent to mention here that in the light of said rules Tehsil-wise tentative seniority list for promotion was prepared by the respondents on 21.10.2022 in which the list for promotion in District Peshawar was also included. (Copy of tentative seniority list is Annexure "I").

11. That the respondents were required to issue final seniority list and to make promotions on the basis of same, but the promotion was delayed on one pretext or the other and was not made in time for reasons best known to them.
12. That in the meanwhile when valuable vested rights were accrued to the appellant on the basis of tentative seniority list, the respondents convened the S.S.R.C. meeting in order to adjust their blue-eyed persons with lesser qualification than the appellant i.e. 3<sup>rd</sup> division instead of 2<sup>nd</sup> division, for which rules were changed vide notification dated 14.09.2023 with qualification from S.S.C. 2<sup>nd</sup> division to simple S.S.C. i.e. 3<sup>rd</sup> division on Tehsil-Wise seniority list just to deprive the appellant from promotion despite having higher qualification i.e. 2<sup>nd</sup> division which is a sheer discrimination and highhandedness on the part of respondents on one hand and bringing weak/ ineligible people to higher posts on other hand which is not permissible under the law. (Copy of notification is Annexure "J").
13. That the appellant approached to the respondents through a written representation vide diary No.5570 dated 26.09.2023, but the same was not considered and a fresh tentative seniority list dated 20.10.2023 was issued on the basis of new rule i.e. SSC 3<sup>rd</sup> division. (Copy of departmental appeal is Annexure "K").
14. That in the meanwhile the respondents orally warned the petitioners/ appellants not to approach any legal forum/ court otherwise the seats for promote will be filled by initial recruitment.

15. That having no other efficacious remedy available, the appellant now approaches this Hon'ble Tribunal against the said notification/ new rules on the following grounds, inter alia;

**GROUND:**


- a) That the said act of respondents by changing the rules to the disadvantage of the appellant is against law, facts and material available on record.
- b) That the said act of the respondents is illegal, unlawful, and unconstitutional, hence liable to be struck down.
- c) That the appellant have every legal right to be promoted to the post of junior village secretary on the basis of existing rules of 2018-2019 as other such like candidates have already been promoted on the basis of promotion rules, 2018-2019.
- d) That the appellant has not been dealt in accordance with law as against the Articles 4 and 25 of the Constitution.
- e) That the appellant has been discriminated as against Article 25 of the Constitution.
- f) That any other grounds will be raised at the time of hearing with the permission of this hon'ble Tribunal.

It is therefore, humbly requested that on acceptance of the instant service appeal, the newly issued rules for promotion may kindly be set aside and the process of promotion i.e. D.P.C./ promotion process in the light of the newly issued rules may kindly be stopped and the respondents may kindly be



directed to promote the appellant on the basis of promotion rules 2018-2019 where-under their other colleagues have been granted promotion on the basis of prescribed qualification as S.S.C. 2<sup>nd</sup> division instead of simple S.S.C. 3<sup>rd</sup> Division.


- 5) That balance of convenience also lies in favour of petitioners/ appellants.

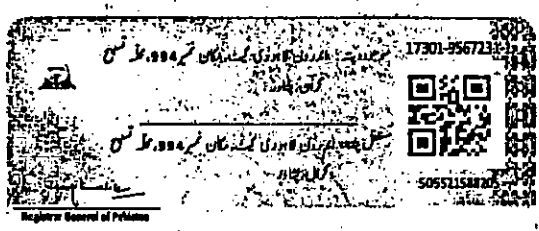
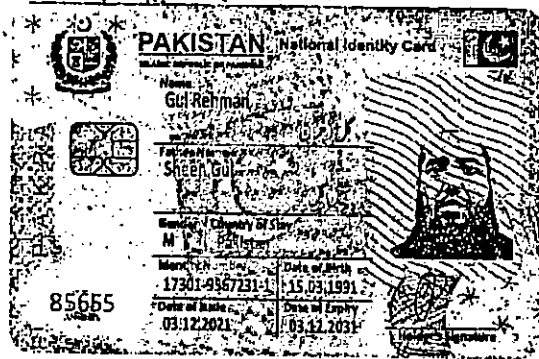

**AMENDMENTS**

In the Appendix,-

- a) Against Serial No. 2, in column No. 6, for the existing entries, the following shall be substituted, namely:
- i) "Fifty per cent by initial recruitment through Khyber Pakhtunkhwa Public Services Commission on the pattern of syllabus prescribed for the Officers in Provincial Management Service.";
  - ii) Forty per cent by promotion, on the basis of seniority-cum-fitness, from amongst the Progress Officers with at least three years service as such; and
  - iii) Ten per cent by promotion, on the basis of seniority-cum-fitness, from amongst the Senior Scale Stenographers and Assistants with at least three years service as such.";
- Note:** For purpose of promotion to the post of Assistant Director against ten per cent quota, there shall be maintained a joint seniority list of Senior Scale Stenographers and Assistants.";
- b) against Serial No. 3, in column No.6, for the existing entries, the following shall be substituted, namely:
- i) "Fifty (50) per cent by promotion, on the basis of seniority-cum-fitness, from amongst the Superintendents with at least three years service as such; and
  - ii) Fifty (50) per cent by initial recruitment.";
- c) against Serial No.5, in column No. 6, for the existing entries, the following shall be substituted, namely:
- i) "Twenty per cent by promotion, on the basis of seniority-cum-fitness, from amongst diploma holder Sub-Engineers with at least ten years service as such and have passed the prescribed Departmental Examination;
  - ii) Ten per cent by promotion, on the basis of seniority-cum-fitness, from amongst Sub-Engineers with at least five years service as such and who possess Bachelor's Degree in Engineering or its equivalent qualification from a recognized University; and
  - iii) Seventy per cent by initial recruitment.";

- d) against Serial No. 6, in column No.6, for the words, colon and slash "Assistants/Accountants/Senior Scale Stenographer", the word "Accountants" shall be substituted;
- e) against Serial No. 15A, in column No.6, for the word, figure and brackets "ten (10)", the word, figure and brackets "five (05)" shall be substituted; and
- f) against Serial No. 16, in column No.6 for the existing entry, the following shall be substituted, namely:
  - i) Twenty (20) per cent by promotion, on the basis of seniority-cum-fitness, from amongst the Naib Qasids and Chowkidars in the Village Council / Neighborhood Council with seniority at Tehsil level, having Secondary School Certificate in Second Division from a recognized Board or institute and six months Diploma in IT from recognized Board / Institute with three (03) years service as such; and
