U/S 4 **OF** THE KHYBER APPEAL PAKHTUNKHWA SERVICE TRIBUNAS ACT 1974, AGAINST THE FINAL SENI)RITY LIST OF ASSISTANT/ SUB DIVISIONAL OFFICERS (BPS-17) OF PUBLIC HEALTH ENGINEERING DEPARTMENT, KELYBER PAKHTUNKHWA, STOOD ON 11/01/2023, WHEREAS, NOTIFIED/ ISSUED THROUGH S.O. (ESTT)/ PHE/ B-77/2021, DATED NOT AGAINST 24/07/2023 AND DEPARTMENTAL CONSIDERING REPRESENTATION OF THE APPELLANT DATED 22/08/2023

Respectfully Sheweth:

- That appellant was initially inducted in the department in year 2013 as Sub-Engineer (BPS-12). (Appointment letter is attached as annexure "A").
- 2. That after completion of his B.Sc, Civil Engineering Degree, appellant's name was included in his seniority list of in service graduate Sub Engineers List, while, according to prevailing rules of P.H.E

Department, the due time of promotion of applicant was July 2020 there were also seats available under 5% quota of in service graduate Sub Ergeneers but inspite of availability of reserved post and various request of appellant, the department remained reluctant and delayed the matter of appellant's promotion to one years.

3. That above mentioned delay in the just and legal promotion of appellant without specification of cogent and just cause, was tantamount to omission of the part of department for which the appellant should not be suffered.

That after delay of one year, the department arranged D.P.C meeting on 26/05/2021 thus, the appellant was promoted as Assistant Engineer/ Sub Divisional Officer (B.P.S-17) vide notification No. S.O. (Estt:) PHED/ 4-53-B/2021, dated 13/07/2021. (Copies of promotion order is and DPC are attached as annexure "B" & "C").

5. That, thereafter the department grepared a Combined Seniority List of Assistant Engineer/

Sub-Divisional Officer on 04/10/2021, followed by subsequent tentative seniority list dated 24/12/2021 wherein applicant's name was placed at correct and most appropriate position. (Both Sonority Lists dated 04/10/2021 and 22/12/2021 are attached as annexure "D" & "E" respectively).

That astonishingly, later on, again impugned б. Tentative Seniority List vide S.O. (Estt)/ PHED/ 13-77/ 2022/ Vol-X dated 11/01/2023 was issued, which was totally unjust and in contradiction of previously maintained seniority lists by the department, because the sequence of names as followed in previous seniority list was totally changed and disturbed and falsely appointees of the same year were being kept senior to promotee's of department of the same year, who were serving form several years most efficiently, department hence appellant filed an objection/ appeal on 23/01/2023 against the same but in vain/ not responded/ considered till date. (Copies are annexed as annexure "F" & "G").

That on 24/07/2023 the department issued final seniority list in which again direct recruits of the department were kept senior to appellant who was a regular promote of the department as per recommendation of D.P.C in year 2021 but was illegal un justifiely placed at Serial No. 13, which is against the law and rules, feeling aggrieved of the same appellant preferred to file a department appeal on 22/08/2023 which is also not responded within the statutory period of three months. (Copies are annexed as "H" & "I").

Hence, this appeal, inter-alia, on the following grounds:

GROUNDS:

7.

A. That direct recruitees has no right to be kept senior to appellant who is serving departmental from several years prior to them, hence keeping them senior to appellant is not only unjust but is also against the law, and provisions of ESTA CODE. (Edition 2021).

- B. That appellant has every right to be placed at appropriate position at seniority list i.e. above to direct recruitees of the same year.
- C. That the respondents department and its officials are illegally bound to draw sonority list according to law and rules on the subject.
- D. That by drawing wrong seniority hat of the incumbents of the department the respondents trying to deprive the appellant from further promotion which is right of the appellant according to law and rules.
- E. That initially appointed recruitees of the same year has no right to e kept senior to promotes of the same year.
- F. That Superior Courts have held in its verdicts that promotes of the department shall be deemed senior in comparison with an direct recruitees of the same

year.

That other grounds will be raised with permission of this Hon'ble Tribunal during the arguments.

It is, therefore, humbly prayed that on acceptance of the instant Service Appeal, the impugned Seniority List dated 24/07/2023 may kindly be rectified by placing the appellant as senior to direct recruitees and thereafter the appellant may also be promoted from the date when he become eligible for promotion with all back benefits, as per law and policy.

Any other relief as deemed app priate in circumstances of the case, not specifically asked for, may also be granted to the appellant.





After long one year delay, PHED arranged the Departmental Promotion Committee (DPC) meeting which was held on **26-05-2021**, wherein the undersigned was considered: for promotion to Assistant Engineer/Sub Divisional Officer and was subsequently appointed as Assistant Engineer/Sub Divisional Officer (BPS-17) vide notification No. SO(Estt:)/PHED/4-53-B/2021, Dated **13-07-2021**.

2. Furthermore, after latest DPC, the department prepared a combined seniority list of Assistant Engineer/Sub Divisional Officer on **04-10-20**21 and being junior most on that time, my name was placed at bottom at Serial No. 32 (An nexure-I) which was the correct and most appropriate position. To

It is most humbly submitted as under: -

- 1. That applicant has been rendering his services in your prestigious Department since 2013, with full devotion and hard work. Whereas, this entire era of his services remained spotless.
- That recently, while performing his duties efficiently as Assistant Engineer/Sub-Divisional Officer/Planning Officer II, the PHE Department has been issued above mentioned impugned seniority list which is unjust in nature and not maintained in a legally prescribed manner.
- 3 That prior to the above-mentioned seniority list, a tentative list has also been issued by this Department, against which a departmental appeal has also been filed by the applicant (Copy annexed), a reply of which is still awaited.
- 4. That instead of addressing the applicant's grievance above mentioned impugned seniority list has been finalized and issued with the same illegality, which has badly affected the precious rights of the applicant for the following reasons: -
- A. That in July 2020, the applicant was eligible for his promotion as an in-service graduate sub-engineer under the 5% quota and the posts were also available but despite various written requests of the applicant for said promotion, the department unnecessarily delayed the matter for one year without any just cause and cogent reason. Thus, this omission on the part of the department caused physical stress and pecuniary loss to the applicant for which the applicant should not be held responsible.
- B. That later on, the applicant was promoted to the post of Assistant Engineer/ Sub Divisional Officer (BPS-17) on 13/07/2021, in the meanwhile, from time to time seniority lists were being maintained and issued by departments that were correctly bearing the applicant's name in the appropriate position and serial number.
- C. That applicant was astonished to find a misplacement of his position and name in the tentative seniority list dated:11/01/2023 followed by above mentioned impugned final seniority list and the initially recruited cadre was given seniority instead of the promoted cadre, who were serving the department from several years.
- D. That depriving the applicant of his deserving appropriate position in the list mentioned above is not only unjust but also unlawful and Lantamount to exploitation, unwarranted by law as well as in derogation with Article 4 of the

constitution of Islamic Republic of Pakistan 1973, which clearly provides that a state shall ensure elimination of all kinds of exploitation.

- E. That as per the settled Principle of law, the promoted cadre of the department shall be deemed senior in comparison with an initially recruited cadre of the same year. Similarly, the impugned seniority list is also hit by the principles laid down in the various verdicts of the Apex Court of the country in which such seniority lists having legal errors are declared to be 'unlawful and unconstitutional. Thus, the applicant is not treated in accordance with the law and constitution as ensured in Article 4 of the prevailing constitution.
- F. That applicant has performed all his duties to the entire satisfaction of his superiors without any complaint from any quarter till date and has cogent reasons and eligibility to be placed at the appropriate position in the seniority list of the department as per law, on the contrary, applicant reserves his right to approach competent forum of law for redressal of his grievance.

It is therefore very humbly requested that by keeping ir view above mentioned circumstances and facts the impugned seniority list dated: 24/.)7/2023, may kindly be rectified and the applicant may kindly be placed at the appropriate position in the same list i.e., at serial No:02 as per law and policy, please.


