PRAYER IN APPEAL:

ON ACCEPTANCE OF THIS SERVICE APPEAL THE IMPUGNED ORDER NO. 10007/Dtd 14-**10-2023 MAY KINDLY BE DECLARED TO THE EXTENT OF RESPONDENT NO.4 (SAIIAD** ALI, SST GHS AHAD KHAN SWABI) BEING AN UNLAWFUL ORDER , PASSED WITHOUT LAWFUL AUTHORITY IN VIOLATION OF TRANSFER/ POSTING POLICY, TENURE POLICY AND BASED ON PERSONAL LIKES/ **DISLIKES, HENCE LIABLE TO STRUCK DOWN** AND CONSEQUENTLY RESPONDENTS MAY KINDLY BE DIRECTED TO ACCEPT THE TRANSFER APPLICATION OF APPELLANT AND ISSUE TRANSFER ORDER OF APPELLANT FROM GHS DOLARI GADOON DISTRICT SWABI TO GHS AHAD KHAN DISTRICT SWABIT IMMEDIATELY.

ANY OTHER RELIEF WHICH THIS HON'BLE TRIBUNAL DEEMS PROPER IN THE CIRCUMSTANCES OF THE APPEAL, MAY ALSO BE GRANTED IN FAVOR OF APPELLANT.

DEPARTMENTAL APPEAL AGAINST IMPUGNED ORDER IS PENDING SINCE 18-10-2023 AND YET NOT BEEN DECIDED.

HENCE THIS APPEAL AFTER THE LAPSE OF 90 DAYS STATUTORY PERIOD.

Respectfully Sheweth.

Brief facts of the case leading to this service appeal are as under:-

- That appellant was appointed in Respondents department as a SST (Maths/ Physics) on adhoc basis on contract through Order No. 1531-36/File No-5/A-14/SST/Adhoc/Apptt: (BPS-16) dated Peshawar 13-5-2020 and was posted at GHS Dalori Gadoon District Swabi through Order No. 6455-58/File No-5/A-14/Adhoc Apptt: (BPS-16) dated 24/6/2020 and charge was handed over to appellant on 26/6/2020 and since then he is performing his duties in aforementioned school. (Copies of Appointment Order, Posting Order and Charge Certificate are Annexure "A, B & C").
- 2. That in consequences of KP Teachers (Appointment & Regularization of Services) Act 2022 (KP Act No. XLI of 2022) Services of Appellant was regularized along with other SST Teachers through Notification No. 4172-76/ File No/S-3/SST(M) Regularization/2018-22 date Peshawar 1/12/2022. (Copy of Regularization Notification annexed as Annexure "D")
- 3. That in GHS Ahad Khan SST Post was going to be vacant on 14/11/2023 hence appellant applied for his transfer to GHS Ahad Khan from his present place of posting i.e. GHS Dolari Gadoon Swabi because appellant was posted

there immediately after his appointment on 24/6/2020 and has completed already his tenure as per policy but Respondents still not decided appellant's application.

- 4. That instead of deciding appellant's application for transfer, Respondents transferred Respondent No.4 to GHS Ahad Khan District Swabi through impugned Order dated 14/10/2023 without completing his tenure on his place of posting i.e., GHS Batakara where he was transferred / posted on 6/12/2022 after his promotion from CT to SST (M/P). (Copies of Promotion and Transfer Order & Impugned Order are annexure "E, F & G")
- 5. That feeling aggrieved from impugned Order dated 4.10.2023, appellant filed departmental appeal before respondent No.2 on 18/10/2023 followed by reminder, which is still pending before respondents although a statutory period of 90 days has lapsed. (Copy of Departmental Appeal is annexure "H")
- 6. That now after lapse of statutory period of 90 days, appellant have no other remedy except to file this Service Appeal on the following grounds amongst others:-

<u>Grounds:</u>

A. That throughout his career appellant have no complaint so far against himself by any one and is performing his duties with full zeal and always followed the directions of his high-ups.

- B. That impugned order is politically motivated, passed in violation of posting/ transfer policy and without any excegencies services.
- C. That it is evident in transfer/ posting policy that the tenure must be respected but in the instant case, Respondents have violated the tenure policy which shows malafide on part of Respondents.
- D. That in the impugned order there is no such extra ordinary circumstances which could provide room for justification of violating the tenure policy.
- E. That impugned order, to the extent of Respondent No.4, is politically motivated one, hence liable to be set aside.
- F. That impugned transfer order, to the extent of Respondent No.4, is against the spirit of and TORs set in Notification No- 88014-18 dated 18/9/2023, which clearly shows that impugned order is not based on merit rather on personal like & dislike. (Copy of Notification is Annexure "H".
- G. That appellant is not treated according to the law, fairness and equity and for personal like dislike, his transfer application is kept pending which shows that Respondents are not following merit and policy rather performing their duties for political consideration and personal like & dislike.
- H. That appellant seeks permission of this Hon'ble Tribunal to advance other grounds & proof in support of his stance at the time of arguments.

It is, therefore, most humbly prayed that on acceptance of this service appeal the impugned order

No. 10007/dtd 14-10-2023 may kindly be declared to the extent of respondent no.4 (SAJJAD ALI, SST GHS AHAD KHAN SWABI) being an unlawful order passed without lawful authority in violation of transfer/ posting policy, tenure policy and based on personal likes/ dislikes, hence liable to struck down and consequently respondents may kindly be directed to accept the transfer application of appellant and issue transfer order of appellant from GHS Dolari Gadoon District Swabit to GHS Ahad Khan Swabi immediately.

Any other relief which this Hon'ble Tribunal deems proper in the circumstances of the appeal, may also be granted in favor of appellant

- 4. They should not be handed over charge if they exceed 35 years or below 19 years of age. Age relaxation case may be submitted to competent authority.

If any meritorious candidate is deprived of appointment by this order, and the competent authority accepts his appeal; the appointment order of the low merit candidate will be withdrawn, and the adjustment order will be reviewed according to the merit.

- 6. Appointment is subject to the condition that the certificates/documents must be verified from the concerned authorities by the DEO (concerned), anyone found producing bogus certificate will be reported to the law enforcing agencies for further action.
- 7. Their services are liable to termination on one month's notice from either side. In case of resignation without notice their one month pay/allowances shall be forfeited to the Government.


