

8. Para No 8 is **Incorrect, & Not admitted**, as the Departmental Promotion Committee was held on 29/01/2018, the Chairperson had given direction to the members of committee to check the promotion's files thoroughly and recommended for promotion as SPSTs BPS-14 OR deferred on the ground as mentioned detailed against their names. The appellant did not submit her promotion file which is consisting of these documents (1). The appellant places at serial no 31 in the **Deferred List**, and the appellant did not submit appeal within time like other PSTs, hence denied.
