JUDGMENT:



SALAH-UD-DIN, MEMBER:- Through this single judgment,
we intend to dispose of the instant service appeal as well as connected

2. Precise facts of the appeal in hand as well as connected Appeals bearing No. 635/2019, 636/2019, 637/2019, 638/2019 and 640/2019 are that the appellants were appointed as Primary School Teachers on adhoc basis on contract, vide appointment order dated 31.05.2014 issued by District Education Officer (Male) Karak. The appellants joined their duty on 31.05.2014 and were granted annual increment for the year 2014. The services of the appellants were regularized from the date of initial appointment, vide Notification dated 15.03.2018. An entry dated Nil was, however made by Account Officer, Pay Fixation Party Peshawar in the Service Book of the appellants to the effect that a recovery of Rs. 30500/- be made from the appellants as they were not entitled to annual increment granted to them for the year 2014.

Similarly, the appellants were not granted the salary for initial three months of service. The matter was challenged through filing of departmental appeal, however the same was not responded, hence the instant service appeal.

3. Similarly, the appellants in Service Appeals bearing No. 632/2019, 633/2019, 634/2019, 639/2019 and 641/2019 have alleged almost the same facts as alleged by the appellants in the above mentioned appeals, however with the only difference in the prayer that they are seeking payment of salary for the months of June, July and August 2014 as well as grant of annual increment for the year 2014, which was not at all paid to them while in the above mentioned appeals, the annual increment was earlier paid to the appellants but later on recovery of the same was ordered.

 4. Learned counsel for the appellants has argued that the appellants were appointed vide appointment order dated 31.05.2014 and they submitted their arrival report on the same day, therefore, they were legally entitled for payment of the salary from the date of their joining duty, however the respondents did not pay salary for three months; that the services of the appellants were regularized from the date of their initial appointment and they were entitled to annual increment for the year 2014, therefore, the respondents are wrong in holding that the appellants were not entitled to the said increment; that the departmental as well as service appeal of the appellants are within time and even otherwise too, the issue being financial in nature, is not hit by limitation. Reliance was placed on an unreported judgment of august Supreme Court of Pakistan in Civil Appeal No. 117-P of 2009 titled "Syed Sabir Hussain Shah Versus The Secretary Schools and Literacy NWFP (now KPK) Peshawar and others" decided on 16.03.2011.

5. On the other hand, learned Additional Advocate General for the respondents has argued that as per the terms and conditions of service, the appellants were entitled to draw their pay with effect from 01.09.2014, therefore, they cannot claim any salary for the period from 31.05.2014 to 31.08.2014; that while counting the period from 01.09.2014 till 31.12.2014, six months service period as required for earning of the increment was not completed, therefore, the appellants

were not entitled for annual increment for the year 2014; that the appeal of the appellant is also time barred and is liable to be dismissed on this score alone. Reliance was placed on 2013 SCMR 911.

6. We have heard the arguments of learned counsel for the appellants as well as learned Additional Advocate General for the respondents and have perused the record.

7. A perusal of the record would show that the appellants were appointed as Primary School Teachers, vide appointment order dated 31.05.2014 and it is an admitted fact that they submitted their arrival report on the same day. They were regularized from the date of their appointment, vide Notification dated 15.03.2018. According to the terms and conditions as mentioned in the appointment order of the appellants, they could draw their pay with effect from 01.09.2014, however in view of section-17 of Civil Servants Act, 1973 and F.R-17, the appellants were entitled for the payment of their salaries with effect from 31.05.2014, the date on which they submitted their arrival report. The appellants are thus entitled to receive salary for the months of June, July and August 2014. Moreover, while counting from 31.05.2014, the six months service period as required for grant of annual increment stood completed and the appellants were thus legally entitled to payment of annual increment for the year 2014. So far as the question of limitation is concerned, suffice it is to state that being a financial matter, the appellants are having a continual cause of action, therefore, limitation will not have any adverse implication on the claim of the appellants.

8. APPEAL U/S 4 OF THE KPK SERVICE TRIBUNAL ACT 1974 AGAINST THE RECOVERY ENTRY DATED NIL OF RS. 30500/- WHEREBY THE APPELLANT WAS DEPRIVED OF HIS ANNUAL INCREMENT FOR THE YEAR 2014 AND THE PAYMENT OF SALARY OF THREE MONTHS, I.E OF JUNE, JULY AND AUGUST, TO THE APPELLANT, FOR WHICH DEPARTMENTAL APPEAL OF THE APPLANT DATED 16-05-2018 HAS NOT BEEN RESPONDED SO FAR DEPSITE THE LAPSE OF MORE THAN THE STATUTORY PERIOD OF NINETY DAYS.

PRAYER:-

On acceptance of this appeal, the impugned entry of Recovery of Rs. 30500/- may kindly be set aside and respondents may kindly be directed to grant the appellant annual increment for the year 2014 and also pay him salary of three months i.e June, July and August 2014.

Respectfully Submitted:-

1. That the appellant along with others was appointed as Primary School Teacher herein after referred to as PST on adhoc basis on contract vide Appointment Order dated 31-05-2014 and the appellant accordingly joined his duties the same day, i.e. on 31-05-2014 and since then he performed his duties with honesty and full devotion with spotless service career and was granted increment for the year 2014 accordingly. **(Copy of Appointment Order and Charge Report are enclosed as Annexure A & B).**

2. That in the year 2017 Khyber Pakhtunkhwa Employees of Elementary and Secondary Education Department (Appointment and Regularization of Service) Act 2017 was passed and under Section, 3 of the Act ibid the Services of the Appellant along with others were regularized from the date of initial appointment vide Notification date 15-03-2018. **(Copy of Notification dated 15-03-2018 is enclosed as Annexure C).**
3. That the Pay Fixation Party vide its entry dated Nil made entry for recovery of Rs. 30500/- on the allegations that the appellant was illegally granted increment for the year 2014, however no recovery has been started yet. **(Copy of Service Book is enclosed as Annexure D).**
4. That respondents were reluctant to receive departmental appeal of the appellant where after the appellant approached respondent No 2 vide departmental appeal through registered post, on 16-05-2018 for the grant of Annual Increment for the year 2014 and three months' salary, on approaching each time the appellant was assured that his appeal will soon be decided but without any response till date. **(Copy of Postal receipt & departmental appeal is enclosed as Annexure E & E/1).**
5. That this action of the respondents of making recovery entry in the Service Book and depriving the appellant of increment for the year 2014 and not paying three months' salary to the appellant is against the law, facts and principles of justice on grounds inter alia as follows:-

GROUND S:-

- A. That the omissions and commissions of the respondents are illegal and void ab-initio.
- B. That mandatory provisions of law have been violated by the respondents and the appellant has not been treated according to law and rules being his fundamental right.
- C. That the appellant was appointed on 31-05-2014 and he reported his arrival the same day thus is entitled to the award of Annual Increment and salary since his arrival for duty and he was also granted increment for the year 2014.


- 3-
- D. That even the services of the appellant were regularized from the date of his initial appointment and as such too are entitled to the grant of Annual Increment and salaries from the date of appointment and regularization.
 - E. That there is no omission and commission on part of the and even attended the School even during the same days, the appellant, thus never refused to perform his duties and had reported for duty on 31-05-2014.
 - F. That valuable rights had been accrued as the annual increment was granted to the appellant since long which could not be snatched without due process of law.
 - G. That the appellant could not be punished for the fault of others as there are no allegations of any sort against him.
 - H. That the appellant has been discriminated as the colleagues of the appellant appointed on 26-05-2016 were awarded Annual Increment and salaries from the date of initial appointment while the appellant is treated with a different yardstick. **(Copy of Notification dated 26-05-2016 is enclosed as Annexure F).**
 - I. That the period is more than six months and as such as per law is entitled to the award of Annual Increment and salaries since the date of his appointment.
 - J. That the appellant has about 5 years of service with unblemished service record.
 - K. That the appellant seeks the permission of this honorable tribunal for further/additional grounds at the time of arguments.

It is therefore prayed that appeal of the appellant may kindly be accepted as prayed for in the heading of the appeal.

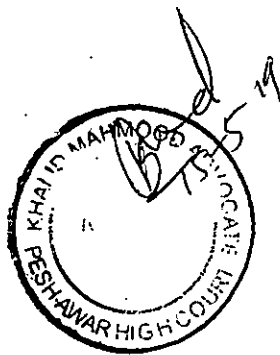

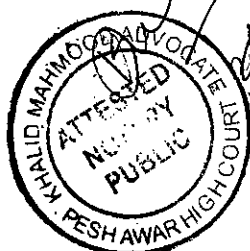



1. That the accompanying appeal is being filed today in which no date of hearing has been fixed so far.
2. That the respondents are going to make illegal recovery from the salary of the appellant without any justification.
3. That the applicant has got a good prima facie case and is sanguine of its success.
4. That the balance of convenience lies in his favor and if the respondents are not restrained from recovering the impugned amount, the applicant would suffer an irreparable loss.

It is therefore prayed that on acceptance of this application, the respondents may kindly be restrained from recovering the amount of Rs. 30,500/- from the applicant till the final disposal of titled appeal.

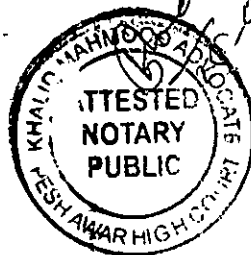



- a. Their services shall be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973, the Khyber Pakhtunkhwa (Appointment, Deputation, Posting & Transfer of Teacher, Lecturers, Instructors & Doctors) Regulatory Act, 2011, and such rules & regulations as may be issued from time to time by the government.

They shall rank junior to all other employees belonging to the same cadre who are in service on regular basis on the commencement of this act and shall also rank junior to such other persons if any, who, in pursuance of the recommendation of the Khyber Pakhtunkhwa Public Service Commission made before the commencement of this act are to be appointed to the cadre, irrespective of their actual date of appointment.
 - i. Their seniority shall be determined on the basis of their continuous service in cadre, provided that if the date of continuous service in case of two or more employees in the same, the employee older in age shall range senior to the younger one.
 - j. The regularization will not be in favour of those, who have not taken over charge or has remained absent from duty or resigned from service and not for those who are under disciplinary proceedings.

Para :- 5 As mentioned in para "3" above to the extent that for the purpose of monthly salary , Respondent No.1 , 2 & 3 are in better position to show the status of the case.

GROUNDS:-

- A. That Respondent No.4 as well as Pay Fixation Party are bound to follow the rules and instructions issued by the Provincial Government of Khyber Pakhtunkhwa from time to time.
- B. As mentioned in para "A" above Respondent No.4, has not violated any rules or law.
- C. As mentioned in para "3" above.
- D. As mentioned in para "4" above.
- E. That Administrative Department of the appellant is in a better position to satisfy the grievances of the appellant.
- F. As mentioned in Para "A" above.
- G. No comments.
- H. Relates to Respondent No.1, 2 & 3, hence no comments.



Preliminary Objections.

1. That appellant has got no cause of action to file the instant service appeal.
2. That the above titled service appeal is wrong, incorrect and against the law & facts.
3. That the appellant is estopped to file the instant service appeal by his own conduct . . .
4. That the instant service appeal is not maintainable & enter-tainable in its present form.
5. That the appellant has not come to this honourable court with clean hands and concealed the facts.
6. That the instant service appeal is liable to be dismissed due to mis-joinder & non-joinder of the party.
7. That the instant service appeal is liable to be dismissed in limine.

Factual Objections

1. Para No. 1 of the service appeal is partially correct. As per terms and conditions of appointment of order No. 15 their pay will be drawn with effect from 01/09/2014, therefore, the appellant is not entitled to be given monthly salary w.e.f 31-05-2014. The appellant is entitled to be given salary w.e.f 01/09/2014 instead of 31/05/2014. Apart from the above the appellant is not entitled of annual increment because he has not completed six months service.

2. Para No. 2 of the instant service appeal is partially correct, however, the appellant is not entitled salary w.e.f 31/05/2014.
3. Para No. 3 of the instant service appeal is correct and recovery will be started as per law.
4. Para No. 4 of the instant appeal is incorrect and wrong hence denied. The appellant is not entitled both 03 months' salary as well as annual increment.
5. Reply of para No. 5 is that the as per rules, recovery will be made from the appellant and in this regard entry in his service book has rightly been made and the appellant is not entitled for 03 months' salary as well as annual increment because as per terms & condition of appointment order that the pay of appellant will be drawn w.e.f 01/09/2014 .

Objection on Grounds.

- a. Ground "A" is incorrect and wrong hence denied.
- b. Ground "B" is incorrect and wrong hence denied. Mandatory provisions of law have not been violated by the official respondents.
- c. Ground "C" is incorrect and wrong hence denied. Detail reply is given in the above mentioned paras.

- f. Reply of Ground "F" is that the inadvertently annual increment has been granted to the appellant but after getting the knowledge recovery has rightly made from the appellant.
- g. Ground "G" is wrong and incorrect hence denied.
- h. Ground "H" of the service is incorrect and wrong. The appellant has not been discriminated but the appellant has agreed to accept the terms and condition of his

appointment order as PST, therefore, the appellant has not been discriminated.

- i. Ground "I" is incorrect and wrong hence denied. As per terms and conditions of appointment order No. 15, the pay will be drawn w.e.f 01/09/2014 the period is less than six month and as such the appellant is not entitled annual increment.
- j. Ground "J" pertain to record.
- k. Ground "K" needs no comments.





REPLY TO PRELIMINARY OBJECTIONS.

All the objections raised by the respondents are incorrect and as such denied. The appellant has got a valid cause of action and locus standi to bring the present appeal, which is liable to be decided on merit which appeal is according to law and rules on the subject besides being maintainable. The appellant has come to this honorable tribunal with clean hands who has concealed nothing from this honorable tribunal, the appellant is not estopped by his conduct to file instant appeal in which all necessary parties have been impleaded and instant appeal is well within time.

REPLY TO FACTS/GROUNDS:

Comments of the respondents are full of contradictions, rather amounts to admissions and are based on malafide. Respondents have failed to show that the version of the appellant is incorrect. Even respondents have failed to show and substantiate their version referring to any law and rules. In the circumstances the appellant has been deprived of his rights without any omission or commission on his part and he has been deprived of his rights guaranteed by the Constitution and law of the land. The appointment order of the appellant depicts that the same is effective w.e.f. 31st May 2014 and on the same very day the appellant has also taken charge of his post and the same report is signed by the Head teacher of the School with copies to all concerned. Thus their period is not less than six months and as such the appellant is entitled to the pay and increment of the subject period. Further respondents have also admitted in their reply that the services of the appellant has been regularized from the date of his initial date of appointment, as such too the appellant is entitled to all service benefits of the said period. The entry made in the service book of the appellant regarding grant of annual increment also supports the case of the appellant. Even those appointed via Order dated 26-06-1997 were granted annual increments by the department, thus the appellant could not be treated differently. **(Copy of Order dated 26-06-1997 and Service Book are enclosed as Annexure A & B).**

Respondents have tried to twist the facts as the appellant could not be made to suffer for the fault of others as no one could be punished for the fault of others. In the circumstances the appellant has not been treated according to law and rules being his fundamental right.

It is therefore prayed that appeal of the appellant may kindly be accepted as prayed for.
