**APPLICATION FOR CHANGE OF DATE OF HEARING.**



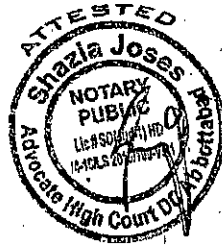
