APPEAL UNDER SECTION 4 OF KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 AGAINST THE IMPUGNED FINAL ORDER DATED 06.04.2016 WHEREBY FOLLOWING PENALTIES HEREIN BELOW MENTIONED, WERE IMPOSED UPON THE APPELLANT BY RESPONDENT NO.3:-

Sully suit

1. Recovery of 10% of the total loss of Rs. 11,40,100/- sustained To the Government Rs. 1,14,010/-

- 2. Reduced to lower stage in time scale for two stages.
- 3. Censure.
- 4. The intervening period from 16.02.2016 to 06.04.2016 is treated as leave without pay.

Respectfully Sheweth:

FACTS OF THE CASE.

- 1. That a Show Cause Notice dated 10.11.2015 was served upon the appellant wherein certain charges of inefficiency, Misconduct and Corruption were leveled against the appellant/submitted his reply to show cause notice and vindicated his plea and position and submitted a graphic account of entire facts of the case, but his submissions went unheeded. (Annex: A&B).
- 2. That on 16.02.2016 the respondent no.4 issued the impugned order whereby he imposed the major penalty of compulsory retirement upon the appellant. The appellant feeling aggrieved filed his departmental appeal against the impugned order before respondent No.3 (Conservator of \forests) and vehemently denied the alleged charges, submitted the true picture of the case. (Annex: C&D).
- 3. That on Departmental Appeal of the appellant, respondent No.3 called comments from respondent No.4. The respondent No.4 submitted his comments and thereafter respondent No.3 passed the order dated 06.04.2016, whereby the penalty of compulsory retirement was set aside, however, the following penalties mentioned herein below were imposed upon the appellant:-

- (1) Recovery of 10% of the total loss of Rs. 11,40,100/- sustained to the Government Rs. 1,14,010/-.
- (2) Reduced to lower stage in time scale for two stages.
- (3) Censure.
- (4) The intervening period from 16.02.2016 to 06.04.2016 is treated as leave without pay.

Hence the present appeal is being inter alia on the following grounds:-

GROUNDS:

- a. That the Inquiry Committee in its report found the appellant guilty of "Inefficiency" but contrary to the findings of the inquiry committee respondent No.4 passed the impugned order of compulsory retirement on the charges of Misconduct, Inefficiency and Corruption. The respondent No.4 went beyond the jurisdiction allotted to him and his action is totally illegal, unwarranted by law and based on malice.
- b. That as per findings of Inquiry Committee the charges of Misconduct and Corruption were not established against the appellant and recommended the charge of Inefficiency only but the competent authority has included the charges of Misconduct and corruption also, which is self imported view of competent authority, thus the entire proceedings and impugned orders are against the low and based on malafide consideration. The copy of Inquiry report was deliberately not provided to the appellant as the charges of Misconduct and corruption were not provided/recommended in the same, and inference was drawn relating to

Misconduct and Corruption subsequently by the competent authority, which is obviously a Misuse of power and amounts to dishonest proceeding.

That in the impugned Final Order dated 06.04.2016 the respondent No.3 observed that "The body language of the appellant also suggests him to be innocent and reveals that checking committee (especially Mr. Muhammad Maqbool Forester) had dug a pit for him and thus has done injustice to him"

That despite of this observation the Appellate Authority awarded four different penalties including Major and Minor penalties, which is against the spirit of law and rules, hence the order dated 06.04.2016 is illegal, void and not sustainable under the law.

- d. That it is mandatory obligation of the competent to supply/ forward a copy of the inquiry report to the appellant whereof the action is proposed to be taken, but the competent authority deliberately avoided the said requirement and not provided the copy of the inquiry report to the appellant which is violation of the rules, thus the impugned order is ultra vires and liable to be struck down.
- e. That during inquiry no opportunity of cross-examination of the prosecution witnesses was afforded to the appellant and this fact was admitted by the respondents, in the impugned final order dated 06.04.2016. In this state of affairs the impugned

Final Order is arbitrary, illegal and against the recognized norms of justice.

f. That it is very much/from the impugned final order dated 06.04.2016 that the inquiry proceedings were not con-ducted in accordance with the rules as it is provided in the order:-

"During the inquiry proceedings, facts on the ground have not been properly valued, gravitated and only available record has been thrashed out and that too without reply of the appellant".

- g. That the impugned final order dated 06.04.2016 is harsh and not proportionate to the guilt of the appellant as provided in the verdicts of Honourable Supreme Court of Pakistan, therefore, liable to be declared illegal and void.
- h. That in the impugned final order dated 06.04.2016 while imposing the major penalty of Reduction to Lower Stage in Time Scale for two Stages, the authority failed to specify the period for how long it will be effective, which is a violation of mandatory requirement of FR-29.
- i. That the appellant seeks permission of this Honourable Tribunal to raise more legal grounds at the time of arguments.

In view of the aforesaid facts and circumstances of the case it is humbly prayed that the impugned Final Order dated 06.04.2016 passed by respondent No.3 may graciously be set aside, being illegal and void, directing the respondents to restore the appellant to his original stage in time

scale with all back benefits. The respondents further be directed not to effect any recovery from the appellant and the intervening period from 16.02.2016 to 06.04.2016 may kindly be treated as Leave with Full Pay.

Any other relief though not specifically asked for to which the appellant is found entitled in the circumstances of the case may also be granted to the appellant.





SHOW CAUSE NOTICE

Respected Sir,

My I like to draw your kind attention to your good office letter No. 2207/GE dated 10.11.2015 through which the undersigned has been conveyed that as a result of enquiry report with regard to illicit damage in Kala Pahar RF the competent authority has tentatively decided to impose Major Penalty on account of Inefficiency, Misconduct and Corruption.

In this connection it is stated that:

The undersigned was assigned the duty of SDFO Agror and according to the job description as envisaged in West Pakistan Forest Manual Volume-II, the Range Forest Ranger or SDFO has to perform his mandatory protective and supervisory role for keeping the performance of juniors/subordinates in right direction by taking timely corrective measures for protection of forests.

Consequent upon the allotment of massive developmental targets under "Billion Trees Tsunami Afforestation Project" particularly establishment of Broad leave and Tube Nurseries, the undersigned on particulars directives of his superiors remained eventful in tracing of suitable sites having required basic facilities for raising both kind of nurseries, its documentations like collection of revenue record, drafting and signing of agreements with the land owners and collection of required quantity with good quality seed of different species besides constitution of VDCs and signing of agreements after proper documentations with regard to areas closed as well as signing of agreements for raising of youth nurseries against hefty targets due to which he could not visited the subjected forest area rather relied on the dependence of incharge Forest Guard and Block Officer. It was the exclusive responsibility of incharge Forest Guard to frequently visit the entire forest area falls in the territorial jurisdiction of his Beat as well as of Block Officer who was responsible to conduct regular surprise visits and checking of all forests beats fallen under his administrative control. Regrettably, neither the incharge Forest Guard nor Block Officer has informed the undersigned about such distressing incidence even to seek help if the forest protection was out of their control.

Norted CX

The then DFO Agror Tanawal visited the subjected forest compartment on 26.11.2614 with accompany of undersigned as well as incharge protective staff but no such alarming situation was observed elsewhere.

The compassion of Agror Forest Sub-Division has accordingly and rightly been highlighted enquiry report that mass scale forest damage is possible in short duration without notice of SDFO particularly when lower staff does not apprise SDFO. The instant sentence of the Enquiry Committee is sufficient and solid point for the defense for undersigned as SDFO Agror particularly in the prevailing circumvents when the undersigned was over occupied in other emergent nature as explained in para-2 above.

The prosecution during <u>personal hearing did not allege the SDFO for involvement in forest damage or attempting to conceal the facts</u> as contained in item-3 of findings of the Enquiry Report which also a solid fortification for the undersigned.

The Enquiry Committee in his report found the undersigned guilty of "Inefficiency" due to the reason he failed to develop his own information network for ensuring feedback about performance of staff and monitoring the status of forest conservancy. In this respect the factual position has been explain in para-2 above. But contrary to the recommendations of the Enquiry Committee, the undersigned has been found guilty of the charges of (a) Inefficiency, (b) Misconduct and (c) Corruption while the Enquiry Committee in item-4 of the report has specifically stated that the charges of Misconduct and Corruption could not be established. Hence the instant Show Cause notice is indistinct in the eye of law.



In compliance the committee checked the Forests in question and submitted detail damage list of 80 Kail trees = 11401-Cft (S.V).

PROCEEDINGS:

To probe in to the allegation, the DFO Agror Tanawai Forest Division served charge sheet. No. 3243-47/GE dated 2-3-2015. & memo of allegation bearing No. 3248-52/GE dated 2-3-2015 upon. Masood-Ur-Rehman Forester Incharge Agror Forest Sub-Division and appointed M/S Azhar Ali Khan DFO Galies (Chairman). Malik Sagheer Ahmed Principal Khyber Pakhtunkhwa Forest School Thai. (Member) as Enquiry Committee.

The record reveals that the accused official failed to furnish reply to the charge sheet to the enquiry committee and after conducting enquiry with out reply to the charge sheet. submitted the enquiry report vide his letter. No. 1256/E dated 29-9-2015. Wherein charge of In-efficiency was proved against the accused official. The Enquiry Committee has not mentioned about clear cut recommendation in the enquiry report, therefore Enquiry Report alongwith Enquiry file returned to the Chairman Enquiry Committee with the request to induce clear cut recommendation vide letter No. 1638/GE dated 13-10-2015. In response the DFO Galies (Chairman Enquiry Committee) returned the case stating that Enquiry has been conducted in the light of instructions contained in Notification. No. SOR-V (E&AD) /Instruction/2014 dated 28-3-2014 and requested for deciding the case accordingly. Therefore Show Cause Notice bearing No. 2207/GE dated 10-11-2015 was served upon the Forester the then Agror Forest. Sub-Division which was received by him on 10-11-2015, but in spite of issuance of reminders vide letter. No. 2837/GE dated 18-12-2015 & No. 3236/GE dated 11-1-2016 he had failed to do so and furnish reply during the course of personal hearing on 8-2-2016. Reply was critically examined and during cross examination the accused official could not prove himself innocent.

APPEAL AGAINST DFO AGROR TANAWAL FOREST DIVISION OFFICE ORDER NO 217 DATED 16.2.2016

With due respect it stated that the DFO Agror Tanawal Forest Division vide office order No. 217 dated 16.2.2016 by imposing major penalty has ordered for compulsory retirement from service of appellant. The major penalty so imposed is against the facts on record, ground realities as well as natural justice on following grounds amongst others:

- 1. That the undersigned remained incharge of Agror Forest Sub-Division during the period from 6.4.2014 to 14.12.2014;
- 2. That during the instant period, the appellant performed his duty more dedicatedly with full devotion according to job description and has taken proper remedial punitive action against the forest offenders. Accordingly has realized an amount of Rs. 1751470/- as compensation and value of forest produce with support of paraphofessional staff of the Sub-Division;
- 3. That no such alarming situation elsewhere in the Sub-Division was observed. All the protective staff discharges their duties satisfactorily. During the month of December 2014, hefty target of developmental activities under "Billion Trees Tsunami Afforestation Project" particularly selection of closure areas, establishment of Central Model Nurseries as well as raising of youth nurseries was allotted to SDFO Agror due to which and keeping in view the directives of high up the undersigned fully concentrated towards the special assigned task and could not conduct regular and frequent visits to each and every forest area. However, in the meanwhile on receipt of a complaint the Conservator of Forests, Upper Hazara Circle constituted a inquiry committee comprised of M/S Taimur Ilyas DFO Unhar Watershed Division, Muhammad Maqbool & Sher Bahadar Foresters vide office order No. 20 dated 17.12.2014;
- 4. That the Inquiry Committee carried out checking of Kala Pahar compartment No. 4 on 25th and 26th of December 2014 and enlisted 80 Kail stumps= 11401-cft standing volume. On spot the undersigned diverted the concentration of incharge checking committee that maximum illicit cut stump is old and prior to his taking over the charge of Sub-Division. Most of the illicit damage has taken place in malkiati area/Guzara forests due to ownership dispute of M/S Jehanzeb Khan and Alamgir Khan of Shahtoot but the request was not acceded to:
- 5. That on 14.12.2014 on receipt of a complaint regarding illicit cutting of 4 trees from Kala Pahar compartment No. 4, the undersigned with the support of incharge staff apprehended concerned forest offenders and realized compensation and value of forest produce worth Rs. 80000/-. These efforts of undersigned have not been given any weight which indicates that the checking committee was premeditated:

- 6. That the then DFO Agror Tanawal Forest Division conducted checking of Kala Pahar C-4 and observed no such alarming situation which also indicates that enlisted illicit damage was taken place much earlier for which the incharge staff had taken proper and legal action against the forest offenders. Contrary to that the checking party recorded the age of illicit cut stumps in harsh just blemish the undersigned and the then DFO Agror Tanawal:
- 7. Sir, it is astonishing to state that the Enquiry Committee in the findings of his enquiry report has categorically mentioned that "Prosecution during personal hearing did not allege the Sub-Divisional Forest Officer for involvement in forest damage or attempting to conceal the fact" hence the charges of Misconduct & Corruption could not be established. However, the accused failed to develop his own information network for ensuring feedback about performance of staff and monitoring the status of forests conservancy, therefore he is found guilty of "Inefficiency" which could not be tantamount to major penalty i.e Removal/Compulsorily retirement from service rather said act on the part of authority comes under the parameters of mis-use of powers and status. The undersigned performed my duties as SDFO Agror according to job descriptions contained in West Pakistan Forest Manual Volume-II and there is no such provision. However, as mentioned above the undersigned remained over occupied in connection with the hefty targets allotted under Billion Trees Tsunami Afforestation Project due to which remained unable to visit the forest in question besides on enquiry from the incharge staff fed back the OK reports;
 - 8. That according to the rules, the Enquiry Officer was required to recommend specific penalty duly covering the guilt clause of inefficiency to be imposed upon the undersigned, but in the instant case no penalty has been proposed. The imposition of major penalty to the appellant i.e compulsory retirement from service irrespective of the facts that the competent authority has asked the Enquiry Committee vide letter No. 1638/GE dated 13.10.2015 in this regard, is therefore illegal, unlawful and against the spirit of natural justice;

It is therefore requested to kindly accept the appeal of undersigned, set-a-side the order of competent authority with retrospective effect. The undersigned may also be allowed to be heard in person.

To probe in to the allegation , the DFO Agror Tanawal Forest Division served charge sheet No. 3243-47/GE dated 2-3-2015 & memo of allegation bearing No. 3248-52/GE dated 2-3-2015 upon Masood-Ur-Rehman Forester Incharge Agror Forest Sub-Division and appointed M/S Azhar Ali Khan DFO Galies (Chairman) Malik Sagheer Ahmed Principal Khyber Pakhtunkhwa Forest School Thai (Member) as Enquiry Committee.

DISCUSSION

The record reveals that the accused official failed to furnish reply to the charge sheet to the enquiry committee and the enquiry committee conducted enquiry with out reply to the charge sheet. The Enquiry Committee submitted the enquiry report vide his letter No. 1256/E dated 29-9-2015, wherein charge of In-efficiency was proved against the accused official. The DFO Agror Tanawal Forest Division returned the Enquiry Report alongwith Enquiry file to the Chairman Enquiry Committee with the request to induce clear cut recommendation vide his letter No. 1638/GE dated 13-10-2015. In response the

DFO Galies (Chairman Enquiry Committee) returned the case stating that Enquiry has been conducted in the light of instructions contained in Notification No. SOR-V (E&AD) /Instruction/2014 dated 28-3-2014 and requested for deciding the case accordingly. Therefore the Divisional Forest Officer Agror Tanawal Forest Division served a Show Cause Notice to the accused official vide No. 2207/GE dated 10-11-2015 and the accused furnished reply to the Show Cause Notice on 8-2-2016. After receipt of the reply of the accused official, the DFO Agror Tanawal Forest Division conducted personal hearing of the accused on 8-2-2016 and the Divisional Forest Officer Agror Tanawal Forest Division Oghi awarded Major penality of Compulsorily retirement from service of Masood-Ur-Rehman Deputy Ranger vide his office order No. 217 dated 16-2-2016.

Against the said order the accused preferred an appeal before the Conservator of Forests Upper Hazara Forest Circle Mansehra, which was sent to Divisional Forest Officer Agror Tanawal Forest Division Oghi for comments vide Conservator of Forests Upper Hazara Forest Circle Mansehra letter No. 5822/GE dated 10-3-2016. The DFO A.T vide letter No. No. 4410/GE dated 22-3-2016 has submitted his comments with relevant file which was perused and observed as under.

- 1. The accused has not replied the charge sheet, but in spite of that the Enquiry Committee has conducted the enquiry and recommended the charge of In-efficiency only.
- The record regarding cross examination of the prosecution by the accused is not available on the record.
- 3. The committee has fixed the charges of In-efficiency. But the competent authority has included the charges of Mis-conduct and Corruption also. Which seems to be the violation of section 14 (4) read with section 5 (b) of E&D Rules 2011.
 - 4. The appeal of the accused was sent to Divisional Forest Officer Agror Tanawal Forest Division Oghi for his comments, who offered his comments and submitted the following analysis/concluding remarks which is re-produce as under:
 - i) The appellant had not even submitted his defence reply which makes the whole proceedings doubtful and utterly infringes the provisions of E&D Rules, 2011.
 - ii) The enquiry committee is in the best position to induce recommendation absolutely at par with the gravity of charge(s). In the instant case, the enquiry committee has not induced recommendation despite the fact that the case had been referred back to it which is contrary to the universal practice being in vogue in the department since ages.
 - During the enquiry proceedings, facts on the ground have not been properly valued, gravitated and only available record has been thrashed out and that too without reply of the appellant.



The body language of the appellant also suggests him to be innocent and reveals that checking committee (especially Mr. Muhammad Maqbool Foreste had dug a pit for him and thus has done injustice to him.

By virtue of the above the appellant being in the climax stage of his career, judiciously deserves a chance.

ORDER

Keeping in view the finding of the enquiry committee, the appeal of the accused, the Show Cause Notice issued to the accused, the personal hearing of the accused and the office order No. 217 dated 16-2-2016, issued by the competent authority, the undersigned in the capacity of appellate authority in the case, under the powers confirmed on him vide E&D Rules 2011 section- 17 (1), (2) (c) hereby modified the office order No. 217 dated 16-2-2016, issued by the competent authority as under:-

- (a) The words, "Compulsorily retired from Service" are over ruled.
- (b) Imposed the following penalties upon the accused official i.e Masood-ur-Rehman Deputy Ranger as provided under E&D Rules 2011 vide section 4 sub section a (iii), b (i), a (i) respectively.
- Imposed recovery of 10% of the total loss of Rs. 1140100/- sustained to the Government (1).= Rs. 114010/-.
- Reduced to lower stage in time scale for Two (2) stages. (2)
- (3)
- The intervening period from 16-2-2016 to 06-4-2016 is treated as leave without pay. · (4) As such the case is disposed off:





I, Qazi Shabir Ahmad Divisional Forest Officer, Agror Tanawal Forest Division Oghi, as competent authority, am of the opinion that Mr. Masood-ur-Rehman Forester while holding the charge of Agror Forest Sub-Division has rendered himself liable to be proceeded against as he committed the following acts/omissions, with in the meaning of rule 3 of the Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules 2011.

STATEMENT OF ALLEGATIONS

That on receipt of serious nature complaints regarding illicit cutting of trees from Shahtoot Beat of Dilbori Block Agror Forest Sub-Division, Mr. Nasim Hijazi Conservator of Forests, Upper Hazara Circle vide office order No. 20 dated 17.12.2014 has constituted a committee comprising of M/S Taimur llyas DFO Unhar Watershed Division Mansehra, Muhammad Maqbool and Sher Bahadar Forester with the directives to inspect Shahtoot beat and expedite report.

That on 25 & 26.12.2014 the committee checked Kala Pahar Resume Land ij. Forests Compartment No. 4 alongwith concerned officials and ruthless indiscriminate reported/reported illicit damage to the tune of 80 Kail trees= 11401-Cft standing volume was detected and was accordingly recorded. The illicitly cut stumps were accordingly numbered, engraved and filled with red paint to avoid future complexity. The detail list is enclosed while extract is as under:

That the above illicit damage has taken place very peacefully with your active connivance within a short span/period for ulterior motives rather poor control over the subordinate staff as well as non conducting regular tour to the forests areas.

That neither alarming situation was reported by you to high-ups nor have you taken sufficient actions regarding protection of forests wealth and thus heavy loss sustained to Government exchequer.

That you have failed to apprehend the forest offenders, seize the timber obtained from the above illicitly cut trees or even realize compensation which proves your involvement with the forest offenders.

That the position of illicit damage speaks that free hand was given to the ۷İ. forest offenders for illicit cutting of precious species Kail trees and taking away the case property with your active connivance as you deliberately failed to pay any legal action within time to save the Government wealth.

- vii. That mere issuance of damage reports against few trees illicitly cut by the forest offenders do not serve any purpose as neither case property has been seized nor value of forest produce has been realized even the alarming situation has not been brought in to the notice of your superiors for seeking help.
- viii. That you have not approached the local Police for registering FIRs against the notorious forest offenders.
- 2. For the purpose of inquiry against the said accused with reference to the above allegations, an Enquiry Officer/Committee consisting of the following is constituted under rules 10 (1) (a) of the ibid rules:

The Enquiry Officer/Committee shall, in accordance with the provisions of the ibid rules, provide reasonable opportunity of hearing to the accused, record its findings and make, within thirty days of the receipt of this order, recommendations as to punishment or other appropriate action against the accused.



ENQUIRY REPORT IN DISCIPLINARY CASE OF MR. MASOOD-UR-REHMAN (FORESTER) THE THEN INCHARGE AGROR FOREST SUB DIVISION OF AGROR TANAWAL FOREST DIVISION OGHI

Read with;

1. List of illicit damage detected in Kala Pahar Forest C-4.

2. Charge sheet along with statement allegations, bearing No.3243-47 /GE, dated 2.3.2015

3. DFO Agror Tanawal Forest Division Oghi letter No.3248-52 /GE, dated 2.3.2015 wherein the enquiry committee to probe into the facts is constituted.

Brief History of case.

On receipt of serious nature of complaints regarding illicit damage in Shahtoot Beat of Dilbori Block of Agror Forest Sub Division the Conservator of Forests Upper Hazara Forest Circle Mansehra vide his office order No. 20 dated 17.12.2014 constituted a committee comprising of M/S Taimur Ilyas Divisional Forest Officer Unhar Watershed Division Mansehra. Mr. Muhammad Maqbool and Sher Bahadar Forester to check the Forest and submit the detail report. In response the committee checked the forest in question and submitted detail damage list of 80 Kail trees with commutative measuring 11401-Cft standing volume.

Out of such huge forest damage, only damage pertaining to 18 trees measuring 3302Cft was covered with different damage reports, though veracity thereof was not ascertained. The remaining Forest damage of 62 trees commutative measuring 8099Cft was detected as unreported at the time of checking.

To evaluate the conduct of the Mr. Masood-ur-Rehman (Forester) the then incharge of Agror Forest Sub Division (accused) an enquiry committee comprising following Forest officer was constituted by Divisional Forest Officer Agror Tanawal Forest Division vide letter No. 3258-62/GE, dated 2:3.2015.

Proceeding and discussion:

The accused did not furnish reply to charge sheet however appeared for personal hearing on 12.6.2015.

Ignoring the repetitions of statement of allegations, the contentions of accused vis-à-vis

The accused did not deny physical checking of the forest in question wherein following forest damage noticed:

2. During personal hearing the accused rebutted the allegations on following grounds;

1. That almost all the noticed unreported Forest damage occurred in a very short duration as mentioned in original report of the forest checking committee. During the period the accused was busy in other official matters including compilation of accounts, court attendance attending meetings with District Administration and Divisional Forest Officer

- Agror Tanawal Forest Division and supervising other developmental activities. None amongst the protective staff informed him about severity of situation.
- 2. The accused further contended that he received information of forest damage in question, when the forest checking committee checked the forest and through Damage Reports No. 61/1 to 63/1 which were submitted in bulk. The accused further explained that he did not entertain the damage reports and called explanation of concerned staff which is also mentioned in charge sheet of Forest Guard.
- 3. During discussion the prosecution did not raise any objection one above mentioned contentions of accused.

Findings.

From the analyses of the explanation made by the accused during personal hearing, the following inferences are drawn:

- 1. Report of forest checking committee and chalking of damage reports against damage of 64 trees dated 16.12.2014 to 24.12.2014, loudly speak that though chalking of damage reports was an afterthought, but duration of damage was very short.
- 2. Since Agror Forest Sub Division is a problematic place of duty, therefore every likelihood of mass scale forest damage is possible in short duration without notice of Sub Divisional Forest Officer particularly when lower staff does not apprise SDFO.
 - 3. The Prosecution during personal hearing did not allege the Sub Divisional Forest Officer for involvement in forest damage or attempting to conceal the facts.
 - 4. Hence, the charges of Mis-conduct and corruption could not be established.
 - 5. However, since the accused failed to develop his own information network for ensuring feedback about performance of staff and monitoring the status of forest conservancy, therefore he is found guilty of "In-efficiency".
