AMENDED SERVICE APPEAL U/S 4 OF THE PAKHTUNKHWA SERVICES KHYBER TRIBUNAL ACT, 1974, AGAINSTATHE NON-CONSIDERATION OF THE APPELLANT'S CASE FOR THE PROMOTION FROM DM (F) BPS-15 TO Sr.DM (F) BPS-16 IN ITS MEETING HELD ON 10.05.2018 WHEREBY THE NAME OF THE APPELLANT WAS DROPPED TO BE PROMOTED TO Sr. DM (F) BPS-16 AND THE IMPUGNED ORDER OF RESPONDENT NO. 1 DATED NIL WHEREBY HE DID NOT DECIDE THE DEPARTMENTAL APPEAL OF

# APPELLANT WITHIN A STIPULATED PERIOD OF NINETY DAYS.

#### Prayer

### By accepting this appeal,

- a) The impugned non-consideration of the appellant case for her promotion from DM (F) BPS-15 to Sr. DM (F) BPS-16 in its meeting held on 10.05.2018 whereby the name of the appellant was dropped for promotion to Sr. DM (F) BPS-16 and
- b) The impugned order of the respondent No.1 dated nil whereby he did not decide the departmental Appeal of the appellant may please be set aside and
- c) Consuequetly the appellant may be promoted from DM (F) BPS-15 to Sr. DM (F) BPS-16 with all back benefits.

### Respectfully Sheweth:

 That respondent No.2 advertized various posts including Drawing Master posts and the appellant being eligible applied for the same.

- 2. That after fulfilling all codal formalities the appellant was issued appointment order vide dated 04.06.2009 as untrained teacher because the appellant had passed Metric with Arts subjects. (Copies of the Education Testimonials and Appointment Order are attached as "A" & "B").
- 3. That the appellant was medically found fit and as such assumed the charge of her duty on 04.06.2009.
- 4. That the appellant has performed her duty with full commitment, devotion and punctuality at various stations of Bajour Agency.
- 5. That the appellant, despite performing her duty as a teacher kept continue her education privately side by side and acquired diploma of Drawing, Master certificate of B.Ed and Degree of Master in Islamiat etc.. (Copies of Education testimonials are attached as annexure "C").
- 6. That the appellant was entered as trained teacher on 09.08.2010 and on 02.12.2013, she was promoted from BPS-9 to BPS-15. (Copy of the Service Book is attached as annexure "D").

- 7. That in April 2018, according to the direction of Directorate of education of newly emerged Tribal Districts, the seniority list of the Female Drawing Masters (DMs) for promotion was prepared from District Bajour and was sent to Directorate of education of newly emerged Tribal Districts. It is necessary to mention here that three posts of Sr. DM (F) BPS-16 were vacant for promotion, therefore, the appellant alongwith two other being top of the seniority list of female Drawing Master, so, the necessary documents of appellant alongwith two other were asked from the appellant and from the concerned school and the same were submitted accordingly. (Copy of the seniority list is attached as annexure "E").
- 8. That the meeting of Departmental promotion Committee (DPC) was held on 10.05.2018 to recommend the appellant alongwith two other for promotion to Sr. DM (F) BPS-16 but unfortunately the appellant was not considered for promotion on the reason that the appellant had obtained diploma in Drawing Master from Skill Development Council
- 9. That for the redressal of her grievances the appellant submitted appeal/representation on

11.05.2018 but the same has not been decided within a stipulated period of 90 days. (Copy of the appeal/representation is attached as annexure "F").

- 10. That later on, notification regarding promotion of one female Drawing master among them from DM (F) BPS-15 to the post of Sr. DM (F) BPS-16 was issued vide notification dated 29.06.2018. (Copy of the Notification is attached as annexure "G").
- 11. That the appellant filed a service appeal before this Hon'ble Tribunal wherein the appellant was accorded permission during the peridency of appeal to amend the same. (Copy of the order dated 21.02.2019 is attached as annexure "H").
- 12. That the appellant now prefers this amended service appeal for the following amongst other grounds:

#### GROUNDS:-

A. That non-consideration of the appellant's case for promotion from DM (F) BPS-15 to Sr. DM (F) BPS-16 is prima facie illegal, unlawful and thus ineffective upon the rights of the appellant.

- B. That as per promotion rules, the appellant was eligible to be promoted to Sr. DM (F) BPS-16 but she was deprived from the same with malafide intention to make space for their blue eyed person. (Copy of the promotion rules is attached as annexure "I").
- C. That other teaching cadres such as AT & TT etc, where who did not possess professional diploma were given the benefit of Master Degree and were promoted on the basis of master degree but the appellant was discriminated as the appellant had also a Master Degree as well. (Copy of the Notification is attached as annexure "J").
- D. That respondent department should have have promoted the appellant from DM(F)/BPS-15 to the post of Sr.DM (F)/BPS-16 because if the appellant possessed professional Diploma from skill Development Council, however, on the other side the appellant also possessed Master Degree but the respondent Department deprived the appellant from this benefits malafidely.
- E. That the appellant was given the benefit of additional subjects at the time of appointment

because the appellant had passed metric with additional subjects.

- F. That in view of the above facts and circumstance the appellant was illegally dropped from the recommendation of DPC for promotion and was discriminated as well.
- G. That any other ground, not specifically mentioned, may be raised at the time of arguments, with the prior permission of this Hon'ble Tribunal.

It is, therefore most humbly prayed that by accepting this amended appeal,

- a) The impugned non-consideration of the appellant case for her promotion from DM (F) BPS-15 to Sr. DM (F) BPS-16 in its meeting held on 10.05.2018 whereby the name of the appellant was dropped for promotion to Sr. DM (F) BPS-16 and
- b) The impugned order of the respondent No.1 dated nil whereby he did not decide the departmental Appeal of the appellant may please be set aside and
- c) Consumently the appellant may be promoted from DM (F) BPS-15 to Sr. DM (F) BPS-16 with all back benefits.

d) Any other relief deems fit and appropriate in the circumstances of the instant case may please be passed.







- a) The impugned order of respondent No.2 dated 29.06.2018 whereby the appellant was ignored to be promoted from DM (F) BPS-15 to the post of Sr. DM (F) BPS-16 and
- b) the impugned order of respondent No.1 dated nil whereby he did not decide the Service Appeal of the appellant may please be set aside.
- c) And consequently the appellant may please be promoted from DM/F/ BPS-15 to the post of Sr. DM/F/ BPS-16 with all back benefits.

#### Respectfully Sheweth:

- That respondent No.2 advertized various posts including Drawing Master posts and the appellant being eligible applied for the same.
- 2. That after adopting all codal formalities the appellant was issued appointment order vide dated 04.06.2009 as untrained teacher because the appellant had passed Metric with Arts subjects. (Copies of the Education Testimonials

and Appointment Order are attached as "A" & "B").

- 3. That the appellant was medically found fit and as such assumed the charge of her duty on 04.06.2009.
- 4. That the appellant has performed her duty with full commitment, devotion and punctuality at various stations of Bajour Agency.
- 5. That the appellant, despite performing her duty as a teacher kept continue her education privately side by side and acquired diploma of Drawing Master certificate of B.Ed and Degree of Master in Islamiat etc.. (Copies of Education testimonials are attached as annexure "C").
- 6. That the appellant was entered as trained teacher on 09.08.2010 and on **1**2.12.2013, she was promoted from BPS-9 to BPS-15. (Copy of the Service Book is attached as annexure "D").
  - 7. That in April 2018, according to the direction of Directorate of education of newly emerged Tribal Districts, the seniority list of the Female Drawing Masters (DMs) for promotion was prepared from District Bajour and was sent to Directorate of

education of newly emerged Districts. It is necessary to mention here that the appellant was on the third position of the seniority list of female Drawing Master for promotion, therefore, the necessary documents of appellant were asked from the appellant and from the concerned school and the same were submitted accordingly. (Copy of the seniority list is attached as annexure "E").

- 8. That on 28.04.2018, the appellant got information from Directorate of Education of newly emerged Tribal Districts, and the clerk of respondent No.2/EDO also orally informed the appellant that the appellant could not be promoted from DM (F) BPS-15 to Sr. DM (F) BPS-16 because the appellant has obtained diploma in Drawing Master from skill Development Council. It is pertinent to mention here that the appellant was not issued any thing in writing that she was refused to be promoted from DM (F) BPS-15 to Sr. DM (F) BPS-16.
- 9. That for the redressal of her grievances the appellant submitted appeal/representation on 11.05.2018 but the same has not been decided within a stipulated period of 90 days. (Copy of the

appeal/representation is attached as annexure "F").

- 10. That the notification regarding promotion from DM (F)BPS-15 to the post of Sr. DM (F) BPS-16 was issued vide notification dated 29.06.2018 wherein the appellant's name was ignored. (Copy of the notification is attached as annexure "G").
- 11. That the appellant now prefers this service appeal for the following amongst other grounds:

#### GROUNDS:-

- A. That the refusal/denial of respondent No.2 to promote the appellant from DM(F) BPS-15 to the post of Sr. DM (F) BPS-16 is prima facie illegal, unlawful and against the seniority list.
- B. That other teaching cadres such as AT & TT etc, where who did not possess professional diploma were given the benefit of Master Degree and were promoted on the basis of master degree but the appellant was discriminated as the appellant was also possess Master Degree.
- C. That respondent department should have have promoted the appellant from DM(F)/BPS-15 to the post of Sr.DM (F)/BPS-16 because if the appellant
