Learned counsel for the appellant referred to the available record and contended that within a span of about 15 days the appellant was transferred four times under the pretext of public interest. He referred to notification dated 20.02.2019 whereby the appellant was promoted and posted at GGMS Simlian Nagar, corrigendum dated 22.02.2019 through which she was adjusted at GGHS Kokotri, another corrigendum dated 23.02.2019 whereby ~~which~~ the appellant was adjusted at GGCMPS Kangra Colony and corrigendum dated 08.03.2019 vide which the appellant was adjusted at GGMS Chapri Haripur. In the said manner the appellant was made a rolling stone, it was added. The act of respondent No. 3 is in clear disregard of transfer/posting policy of Provincial Government and also amounts to official highhandedness in misuse of the authority, it was contended.

In view of the arguments of learned counsel and available record instant appeal is admitted for regular hearing. In the peculiar circumstance of the case the respondent No. 3/District Education Officer (Female) Haripur shall appear in person on next date of hearing and explain her conduct in issuing successive orders/corrigenda in the garb of public interest. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents. To come up for written reply/comments on 01.08.2019 before S.B.





**SERVICE APPEAL U/S 4 OF KPK SERVICE
TRIBUNAL ACT, 1974 AGAINST THE
IMPUGNED ORDERS DATED 22-02-2019, 23-
02-2019 & 08-03-2019, WHEREBY, WITHIN THE
SPAN OF 15 DAYS, THE APPELLANT WAS
TRANSFERRED FROM ONE SCHOOL TO
OTHER AGAINST THE TRANSFER POLICY, ON
ACCOUNT OF POLITICAL INTERFERENCE, AT
THE BEHEST OF THE RESPONSENT NO. 4.**

P R A Y E R: On acceptance of instant Service Appeal the impugned transfer orders dated 22-02-2019, 23-02-2019 & 08-03-2019 may graciously be set aside and the appellant be allowed to perform her duties as SST (General) in GGMS Simlan Nigear, Tehsil & District Haripur as per the promotion and posting order dated 20-02-2019.

Respectfully Sheweth:-

Facts giving rise to filing of instant Service Appeal are as under:-

- (1) That the Appellant was initially appointed as CT Teacher and after having served the Education Department for 21 long years, on the basis of unblemished service and academic record, was promoted and posted in GGMS Simlan Negear, District Haripur as SST (G) vide order dated 20-02-2019. (Copy of the Order dated 20-02-2019 is appended as "A").
- (2) That in compliance with the above said Order the Appellant had taken over the charge as SST (G)/Headmistress GGMS Simlan Negear on 21-02-2019. (Copies of the handing taking over as well as the Certificate of transfer of charge are filed as "B").

- (3) That on 22-02-2019, the Respondent No. 3 under the pretext of a Corrigendum transferred the Appellant, just after one day of taking over the charge of her earlier place of posting i.e. GGMS Simlan Negear, to GGHS Kakotri and through the same order transferred the Respondent No. 3 from GGHS Kakotari to GGMS Simlan Negear. No need to mention that usually an adjustment, is always made against the vacant post, or with the mutual consent of the transferees. (Copy of the Order dated 22-02-2019 is marked as "C").
- (4) That the Appellant again vide Order dated 23-02-2019 under the pretext of another Corrigendum, ordered to be posted from GGHS Kokotri to GGCMPs Kangra Colony. (Copy of the Order is filed as "D").
- (5) That again vide Order dated 08-03-2019, the Appellant has been ordered to be posted in GGMS Chapri Haripur. It is pertinent to be noted that this post, has already been notified to NTS, for appointment against the said post, meaning thereby that after one month, the appellant would have been transferred, to some far flung area, wherever the post will be found vacant at that time; all this was done with the malafide intention at the behest and whims of

political interference, which is not only the against the transfer and posting policy but the natural justice as well.

- (6) That as vide Order dated 20-02-2019, the Appellant was posted in GGMS Simlan Negear and had taken over the charge of the said post, started to regularly perform her duties, in the said School as Headmistress, the appellant is still performing her duties regularly since the date of her posting in the said School till today. (Copies of the attendance register and the other documents pertaining to the performance of duties by the appellant in the School of GGMS Simlan Negear are attached as "E"). It is pertinent to be noted that the second Order of transfer was issued on 22-02-2019, whereby the appellant was ordered to be posted from GGMS Simlan Negear to GGHS Kakotri even not taken effect, in the meanwhile on the very next day i.e. 23-02-2019, the appellant was ordered to be posted from GGHS Kakotri to GGCMPs Kangra Colony, all these Corrigendum(s) were made just in papers and no actual transfer/posting or for that matter handing/taking over of the charge took place.
- (7) That the appellant from 21-02-2019 till today performing her duties in GGMS Simlan Negear,

the Respondent No. 2 in the Attendance Register of the School got marked the attendance of the Respondent No. 4 w.e.f. 23-02-2019 and malafidely and illegally under her signature has attested the said Register, the mere perusal of the attendance entries which were made and entered on one and same day, reveals that the arrival time of the Respondent No. 4 in the attendance Register is entered as 8.20 am whereas the School timing starts from 8.15 am as evident from the entries contained in the said Attendance Register in respect of the other teachers of the said School. It may also be noted and will be sufficient to prove that the entries with regard to the attendance of the Respondent No. 4 in GGMS Simlan Negear are factious and bogus, got marked and entered on one and same day because even the departure time for Friday is marked as 2.20 pm instead of 12.00 noon. (Copies of the relevant pages of the Attendance Register are filed as "F").

- (8) That on 08-03-2019 the Respondent No. 3 again issued a transfer posting order of the appellant from GGHS Kangra Colony/Kakotri to GGMS Chapri Haripur. (Copy of the order is appended as "G").

- (9) That the appellant has been made a rolling stone that too as per the whims and wishes of the Respondent No. 4, apparently being regulated and acted on the dictated terms of the local MPAs and the Political figures.
- (10) That all the orders, having been issued after the first order dated 20-02-2019, to the extent of the appellant are politically motivated, based on malafide, all the norms of justice, fair play and equity, appears to be passed, in colourful exercise of power.
- (11) That as the transfer orders were void abinitio and at the relevant time, no Department remedy or for that matter remedy of service appeal was available to the appellant, therefore, to do the wrong undo, the appellant approached to the Honourable Peshawar High Court Abbottabad Bench, by filing a Writ Petition, wherein the Honourable Peshawar High Court Abbottabad Bench, initially called upon the Respondent No. 2 in person, to explain the circumstances, led to issuance of the impugned transfer orders within span of 15 days however, the Writ Petition was dismissed being not maintainable for want of jurisdiction. (Copy of the order of Honourable Peshawar High Court is filed as "H").

- (12) That being aggrieved, the appellant has submitted her Departmental Appeal, dated 02-03-2019 through proper channel but till today no response has been received to the appellant hence, this appeal inter-alia on the following;

GROUND S:

- (a) That all the three impugned orders have been issued, within a span of just 15 days, which fact alone is sufficient to discard the same being against the transfer and posting policy, which at very outset in its Clause (i) provides as under:-

"All the posting/transfers shall be strictly in Public interest and shall not be abused/misused to victimize the Govt: Servant".

- (b) That all the three impugned transfer and posting orders have just been issued under the pretext of Corrigendum of the order dated **20-02-2019** whereas in fact there was no clerical error or for that matter any bonafide mistake occurred in the order dated **20-02-2019**.
- (c) That all the impugned orders issued within the span of just 15 days, have been issued, only to accommodate the Respondent No. 4 at the

sweet will of the local politicians, while issuing the said orders, the Respondent No. 2, failed to realize that, these orders will not only cause and enhance the mental worries and agonies of the appellant besides causing a disgrace to her, has been made a puppet and a rolling stone, while not realizing the fact that the appellant had served the Department for 21 long years, with the zeal and zest, upto entire satisfaction of her superiors, always rendered and performed her assigned duties faithfully and with due diligence.

- (d) That the impugned orders are void abinitio, issued in colourful exercise of powers, incomplete negation and derogation of the transfer and posting policy, framed by the Provincial Govt: thus are liable to be struck down.
- (e) That it is an inalienable right of the appellant to be treated in accordance with law, and to be protected against the misdeeds under the pretext of so called issuance of Corrigendum.
- (f) That although the appellant is regularly and continuously performing her duties in the GGMS Simlan Negear, Tehsil & District Haripur as SST (G) BPS-16 as Headmistress but illegally and malafidely the Respondent No.

2 through a verbal order had stopped the monthly pay of the appellant since April 2019, which is a worst type of victimization as the poor appellant has the only source of livelihood, from which she has been deprived, in colourful exercise of powers, which is also a denial even of the fundamental right of the appellant.

- (g) That the instant Service Appeal is within time, even otherwise the appellant has a recurring cause of action as her monthly pay has been stopped during the pendency of the Departmental Appeal, this Honourable Tribunal has got every jurisdiction to entertain and adjudicate upon the instant appeal and to award the relief.

It is therefore, respectfully prayed that on acceptance of instant Service Appeal the impugned transfer Orders/Corrigendum(s) dated 22-02-2019, 23-02-2019 & 08-03-2019 may graciously be struck down, with the restoration of the Notification No. 5219-49/SST Promotion File dated 20-02-2019 to the extent of the appellant.

It is further prayed that the appellant be allowed to continue her duties at GGMS Simlan Negear, Tehsil & District Haripur till the completion

of her tenure, with the direction to the Respondents for immediate release of her pay against the duty performed.

Any other relief which this Honourable Service Tribunal deems fit and proper may also be granted to the appellant.
