SERVICE APPEAL UNDER SECTION (4) OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 FOR THE ASSUMPTION OF CHARGE OF THE POST OF CERTIFIED TEACHER (CT BPS-15) FOR DIRECTING THE RESPONDENTS TO HAND OVER THE CHARGE TO THE APPELLANT ON THE POST MENTIONED ABOVE W.E.FROM 19-9-2017 IN ACCORDANCE OF THE TERMS AND CONDITIONS OF THE ORDER NO.20-26/AE-II /CT DATED 01-01-2018 WITH ALL BACK BENEFITS SERVICE SENIORITY, PRIVILEGE AS DEEMED APPROPRIATE BY THIS HONOURABLE TRIBUNAL IN THE CIRCUMSTANCES.

RESPECTFULLY SHEWTH:

- 1- That the appellant amongst other was appointed of the primary school teacher (PST- BPS-12) on of (18-04-2009) after full filing all the codal formalities in the department of Elementary & Secondary Education Bannu. (Copies of appointment order are annexure as "A").
- 2- That thereafter appellant was promoted from primary school teacher to Senior Primary School Teacher (SPST BPS-14)on dated 23-09-2016 by the departmental promotion committee of the said department. (Copies of promotion order from (PST-BPS-12) to (SPST BPS-14) are annexure- B).
- 3- That the respondents department once again prepare seniority lists as well as working papers for promotion and filling the vacancies posts of Certified Teachers (CT BPS-15) which were lying vacant in different schools i.e Middle . High , Higher Secondary throughout the District Bannu. It is pertinent to mentioned here that the appellant is / was standing at S. No.172 and seniority No. 1146 of the said merit lists. It is also worth mentioning that some 12 teachers of cadre are junior than the appellant, in accordance of qualification, seniority and service record. Although the appellant is /was eligible for promotion to CT (BPS-15) post at that time , but he was kept deprived from the right of promotion all because of malafide intentions and non giving fifty thousand rupees for the said promotion. (Copies of seniority merit lists / working papers , service record of the appellant are annexure – C).
- 4- That the respondent No.4 issued promotion order of 178 teacher on 19-09-2017 and 3 of vacancies left unfilled for corrupt practices (Copies of appointment order are annexure as D).

- 5- That the appellant submitted departmental appeals to respondent no.4 before and after the issuing the promotion order, but each and every appeal of the appellant condemned unheard. (Copies of departmental appeals are annexure as E).
- 6- That the appellant also filed complaints applications against the respondent No.4 to respondent 2 and 3 and other departments, and in long run respondent No.4 issued promotion order No.20-26/AE-II/CT of the appellant on dated (01-01-2018), but astonishingly the promotion order copy was kept concealed in the office files and as such the appellant remained unaware of his said promotion order till to this day. (Copies of complaint applications are annexure as F).
- 7- That after lapsing of considerable time when the appellant came to know that respondent No.4 has promoted him on the post of (CT BPS-15) and requested him to handed over order copy, the respondent No.4 including the office officials, did not console him and as such the appellant went back from his office with empty hand.
- 8- That thereafter the appellant filed civil suit in order to receive the order copy of his promotion as well as for the assumption of charge which was partially allowed by the civil Judge No.13 Bannu and respondent No.4 through order sheet No.5, dated 14-05-2019 handed over the promotion order copy to the appellant and the court of civil judge No.13 Bannu, at the same time directed the appellant to appear before the competent forum/ tribunal for the assumption of charge on the post of Certified Teacher(CT BPS-15). (copies of the judgment of civil judge No 13 Bannu and promotion copy of the said post are annexure as-G)

Mr. Bannu

GROUNDS

- A That appellant is not treated according to Law.
- B That appellant was deprived form the right of his promotion to (CT BPS-15) post all because of malafide intentions and non giving fifty thousand rupees for his promotion to respondent No 4 and other office officials.
- C That appellant was/is eligible for promotion to (CT BPS-15) post.
- D That non giving of the promotion order copy and not handed over the charge to the appellant on the said post is against the article 25 of the constitution.
- E That after receipt of promotion order copy on dated (14-05-2019) of the said post respondents are under legal obligation to handover the charge to the appellant.

It is therefore most humbly prayed, that keeping in view the above stated facts and position this Honourable tribunal may very kindly be pleased to direct strictly the respondents especially respondent no.4 and 5 to compliance the said order and hand over the charge to the appellant on the said post (CT BPS-15) with all back benefits, service seniority w.e.from 19-09-2017 according to the said order terms and conditions, and other relief which this honorable Tribunal deem appropriate in the circumstance may also be granted.

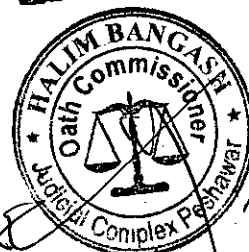



TERMS & CONDITIONS

- 1- Their services will be considered regular but without pension and gratuity in term of Section-19 of NWFP, Civil Servant Act, 1973 as amended vide NWFP, Civil Servant (Amendment) Act, 2005. They will however be entitled to Contributory Provident Fund in such a manner and at such rates as may be prescribed by the Government.
- 2- Their services will be liable to termination on one month's notice from either side, in case of resignation without notice their two month's pay/allowance will be forfeited to Govt.
- 3- The appointee should submit their charge Report to all concerned.
- 4- Their services can be terminated at any time, in case their performance is found unsatisfactory during probationary period. In case of misconduct they will be proceeded against under the NWFP removal from service Special Power Ordinance 2000 and the rules framed from time to time.
- 5- The candidate should join their post within 15 days of the issuance of this order. The Head of the Institution concerned should furnished a certificate to the effect that the appointee have joined the post or otherwise, after 15 days of the issuance of this order, failing which, their order will be treated as cancelled.
- 6- Charge should not be handed over if age of the candidate is below 18 year or above 35 years.
- 7- The appointees are directed to perform their duties in their respective schools noted against their names for a minimum period of Three years and they will not apply for transfer from school where appointed.
- 8- Each appointee will produce undertaking on stamp Paper to the effect that the District Domicile already produced on or before 3-7-2006. If found that his previous PR Domicile is not cancelled, then he will be removed from service with out issuing any notice.
- 9- In case of Fake Certificate and Degree detected later on the undersigned reserve the right of termination from service and disciplinary action will initiated against the teacher concerned.
- 10- They are required to produce Health & Fitness Certificate from the Medical Superintendent concerned before taking over charge.
- 11- Their original certificate/Degree should be verified from the Concerned Board/University/Institution on his own expenses before the release of their pay.
- 12- No TA/DA etc is allowed

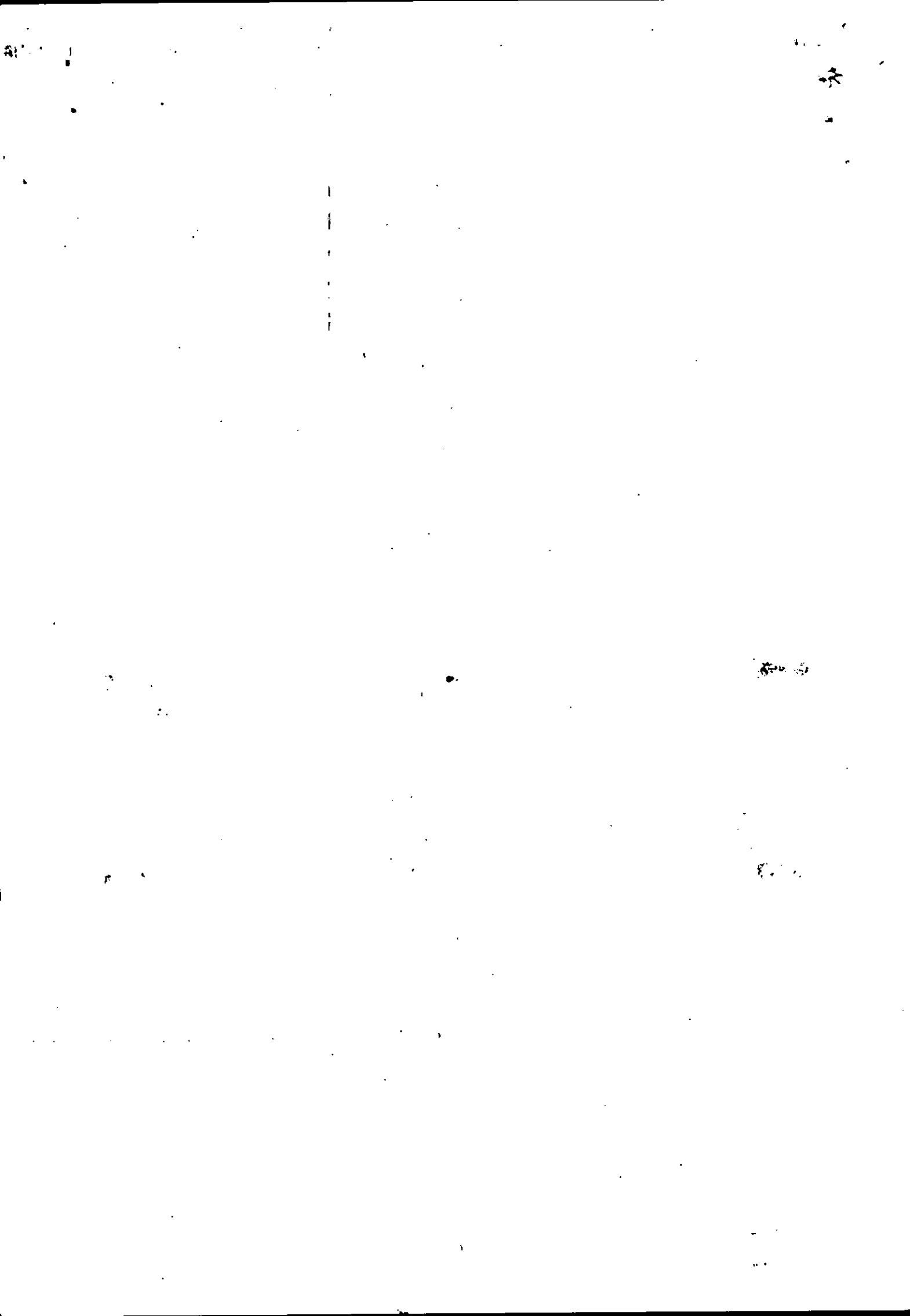




