JUDGMENT

HAMID FAROOO DURRANI, CHAIRMAN:-

1. The facts as noted in the memorandum of appeal suggest that the appellant was appointed as Naib Qasid in the office of Additional Advocate General at Bannu on 01.10.2011. On 15.12.2016, he was implicated in a criminal case registered through FIR No. 790 dated 15.12.2014 recorded u/s 302/324/148/149 PPC P.S Saddar, District Bannu. Subsequently, the appellant was arrested and was acquitted from the court of competent jurisdiction on 28.03.2018. After acquittal he visited his office for resumption of duty where he came to know that he was already removed from service through order dated 01.06.2017. A departmental appeal was submitted by the appellant which remained undecided.



2. Learned counsel for the appellant heard and available record gone through.

It is available on record that the appellant was proceeded against

departmentally on account of absence from duty. The absence attributable to the appellant in the charge sheet was 07 days in October, 2016, 08 days in November, 2016, 14 days in December, 2016 and whole months of January and February 2017. Evidently, the absence of appellant was for periods before the lodging of FIR on 15.12.2016 while, admittedly, he remained absconder for one year three months and thirteen days. The appellant was arrested on 24.02.2018 and was acquitted on 28.03.2018. On the other hand, the charge sheet and statement of allegations were dispatched to the appellant through his home

address on 03.03.2017 which returned undelivered due to his abscondance.

Subsequently, notices were published in two newspapers requiring the

resumption of duty by appellant, but to no avail. The impugned order of removal

from service was issued against the appellant on 01.06.2017 i.e. much before his

It is also a matter of record that the departmental representation for reinstatement into service was preferred by the appellant on 26.04.2018 which was not responded to. In the circumstances, the appellant was obligated to have preferred the service appeal within time prescribed by law but he opted to submit the appeal in hand on 20.06.2016, much beyond a period of one year from the date of submission of departmental representation/appeal. The appeal in hand is, therefore, barred by time and on this score alone does not warrant admission for regular hearing. It is resultantly dismissed in limine.



weapons. Hence, the instant case FIR was registered against the accused.

Perusal of the records reveals that on 05-03-2018 the sole major legal heirs of the deceased Muhammad Rali Khan i.e. Adnan (son). Mst. Mamtaza, Mst. Romana and Mst. Inshada (daughters) appeared and submitted affidavit Ex PA-1 and Proforma Ex PB-1 stating therein that they have effected a genuine compromise with the accused facing trial outside the court and have pardoned the accused facing trial in the namely of Almighty Allah by waiving off right of Qisas and Diyat and would have got no objection if the accused persons are acquitted from the charges leveled against them. To this effect their joint statement recorded wherein affidavit Ex PA-1, Proforma Ex PB-1, Fitwa Ex PF-1, copies of CNIC of elders/identifiers Umer Nawaz Khan and Barkat Ali are Ex PD and Ex PC, whereas copies of CNICs of Adnan Khan EX PE and Mst. Mamtaza Ex PF were exhibited.





The SHO concerned as per direction of this court also submitted report in respect of verification of factum of compromise among the parties and list of legal heirs of the deceased.



AND WHEREAS, the appellate authority in pursuance of Section 17 read with sub rule (1) & (2) of the E&D Rules-2011 called for the record of the case and comments from the concerned DEO vide letter No. 6066 dated 28.05.2018 for consideration of the appeal.

AND WHEREAS; the DEO concerned provided the requisite record/comments accordingly vide his letter . No. 5278 dated 11.6.2018.

AND WHEREAS, from the perusal of the record it was disclosed that the appellant was charged under section PPC-302/ vide FIR No. 790 dated 15/12/2016 Police Station Sadr Bannu and he was required to be kept under suspension through a specific order during the period when he was not actually detained as required under FR-53(b). Which was not done by DEO (M) Bannu.

AND WHEREAS, consequent upon his acquittal from the charges by the Honorable Additional Sessions Judge-II, Bannu vide Judgment dated 28.3.2018, Pervez Khan Ex-Lab Attendant, GHS No. 1 District Bannu has become liable for reinstatement under the provision of relevant rules.

Now therefore, the Director E&SE Khyber Pakhtunkhwa Peshawar, the Appellant Authority, under section-17 read with rules 2(b) of E&D.Rules-2011 has decided to set uside the major penalty imposed by the DEO (M) Bannu vide Notification No. 3142-48 dated 6.4.2017 and reinstate Mr. Pervez Khan Ex-Workshop Attendant, GHS No. 1 District Bannu in service w.e.f 19.05.2016. The absconding period from 15.12.2016 to 23.2.2018 is treated as EOL without pay in favour of appellant Mr. Pervez Lab Attendant GHS No.1 Bannu.
