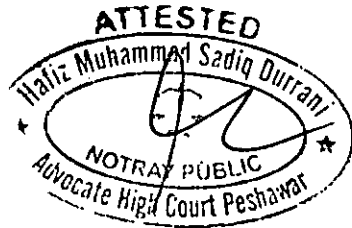

Para-wise comments /reply on behalf of Respondent No. 3

Respectfully Sheweth:

Preliminary Objections:

1. That the appellant has no cause of action/ locus standi to file the present appeal.
2. That the appellant has concealed the material facts from the honorable court.
3. That the appellant has not come to this honorable Service Tribunal with clean hands.
4. That the appellant has filed the instant appeal on malafide grounds.
5. That the appeal is against the prevailing law /rules.
6. That the appellant is estopped by his own conduct to file the instant appeal.
7. That the instant appeal is not maintainable in its present circumstances of the issue.
8. That the instant appeal bearing no cause of action may be dismissed without any further proceedings.

ON FACTS

1 Correct to the extent that the appellant has been serving in the respondents department as computer operator but he has never performed his duties with devotion, commitment and dedication rather he has always been found non-serious, non-professional, non-committed and involved in anti-institutional activities and not fit for female offices. He has never performed even touched his official responsibilities and has come to the office just for marking his attendance in the daily attendance register and then disappeared.

He being too much problematic in nature is also involved in fraudulent activities as he has produced fake and bogus copy of departmental appeal in another appeal bearing No. 1860/2023 which is pending adjudication before this honorable court which was got verified from Directorate of Elementary & Secondary Education vide this office letter No. 3369 Dated 19.10.2023 and the Director has declared it fake and bogus vide his office letter No. 889 Dated 30.11.2023. Copies attached as annexure "AB&C" respectively.

This is also on record that the appellant and his other colleagues have been in severe tussle with the Ex- DEO (F) Battagram and as a result she also relieved him from office and consequently FIRs was lodged in the local police station Battagram against them and later on some of them entered in to a written agreement with express provision of the term "shameful" and commitment that in future we will not repeat such act with female officers with the exception of appellant who is still same and want to satisfy his willful and problematic nature. Copy attached as annexure "D,E & F".

He has been transferred from DEO (F) office to DEO (M) office Battagram due to his willful and problematic nature which is his home district, same department and same designation and situated at 5 to 10 minutes walking distance from his home but he is reluctant to join DEO (M) office and interested in female offices.

2. Correct.
3. Incorrect as this was not versus transfer but merely adjustment due to non-availability of vacant post of computer operator in the office of the DEO (F) Battagram and also due to his problematic and wilful nature.
4. Incorrect as the appellant has neither been regular and punctual nor performed his duties and in-spite of all these the undersigned adjusted him against the post of Assistant Programmer BPS-17 in own pay scale as there was/is no vacant post of computer operator (BPS-16) in the office of the DEO (F) Battagram and source II in this regard duly signed by the District Education Officer (F) Battagram was handed over to him for getting his

salary released by the District Accounts Officer Battagram but he was reluctant to get his salary activated against the post of AP and filed an appeal to the provincial Ombudsman who has also very kindly ordered him to join DEO (Male) office Battagram which is his parents department, home district and original post situated at a 10 minutes walking distance from his residence but he is still reluctant to join male office and interested in female offices due to his ulterior motives being not fit for female offices and filed the instant appeal before this honourable service tribunal. Copy of adjustment order and source II are attached herewith as annexure "G&H" respectively.


5. Incorrect as there was no vacant post of computer Operator in the office of the DEO (F) Battagram and he was got adjusted at DEO (M) office Battagram vide DEO (F) Battagram letter No. 2616 Dated 29.08.2023. Copy attached as annexure "I"
6. The appellant was adjusted at DEO (M) office Battagram due to non-availability of vacant post in DEO (F) office Battagram and consequently relieved from this office on 13.09.2023 but he did not join DEO (M) office till date and has neither been at the strength of DEO (F) nor DEO (M) Battagram. He is wasting the precious time of this honourable court as well as all concerned offices and this is an evident proof of his non-obedience and willfulness that being transferred from DEO (F) office to DEO (M) Office Battagram and consequently relieved from DEO (F) office Battagram has reportedly not yet assumed his duties at DEO (M) office Battagram without any legal justification.

GROUND.

- a. That this was not a versus transfer but merely adjustment due to non-availability of vacant post of computer operator in the office of the DEO Battagram and his problematic and willful nature.

- b. That the order has been made in the larger interest of the office as stated vide para "a" above.
- c. That no extraneous consideration is involved and the appellant has badly failed to provide documentary proof in support of his contention.
- d. That the appellant is wasting precious time of this honourable court as well as all concerned offices and this is an evident proof of his non-obedience and willfulness that being transferred from DEO (F) office to DEO (M) Office Battagram and consequently relieved from DEO (F) office Battagram he has not yet assumed his duties at DEO (M) office Battagram without any legal justification and comes to DEO (F) office Battagram for drawing pictures in or outside the office building with one officer/official or the other.
- e. No comments.

It is therefore humbly prayed that on acceptance of above para wise comments, the appeal of the appellant may graciously be dismissed as he is neither entitled for the grant of salary on the basis of "No work no Pay" nor fit for female offices with direction to join DEO (M) office Battagram situated at a 10 minutes walking distance from his residence against his original vacant post as there is no vacant post of computer operator in the office of the DEO (F) Battagram.



Whereas he has also actively participating in in whatsapp group "Malgari DEO Female" created for communication to motivate the mob/officials for protest and other unofficial activities.


