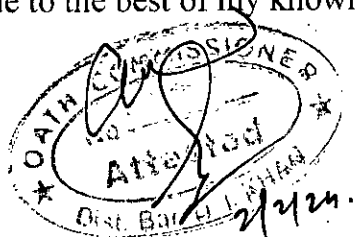



NOTIFICATION

NO SOH-III /8-60/05 (paramedics). In pursuance of the decision taken by the provincial cabinet in its meeting held on 27th December 2005, the Competent Authority is pleased to approve eight stage paramedics services structure of NWFP with effect from 27-12-2005. The salient features whereof shall be as under:-

1. The exiting 57 different categories of paramedics as mentioned in annexure A to this notification are restructured into 14 cadres as per annexure B.
2. In all the aforesaid cadres/specialties, the posts in various pay scales shall be integrated/categorized and re-nomenclatured as under:-

S.No.	Existing Posts	Re-structured posts
i)	Posts in BPS-5 to BPS-9 in all specialties.	Junior Technicians (BPS-9)
ii)	Posts in BPS-10 to BPS-12 in all specialties.	Technicians (BPS-12)
iii)	Posts in BPS-13 to BPS-14 in all specialties.	Senior Technicians (BPS-14)
iv)	Posts in BPS-15 to BPS-16 in all specialties	Chief Technicians (BPS-16)
v)	Posts in BPS-17 in all specialties.	Technologist (BPS-17)
vi)	Posts in BPS-18 in all specialties.	Senior Technologist (BPS-18)
vii)	Posts in BPS-19 in all specialties.	Chief Technologist (BPS-19)
viii)	Posts in BPS-20 in all specialties	Principal Technologists (BPS-20)

The words "clinical" shall be mentioned with the categories of posts meant for paramedics working in the hospitals and "Primary Health Care" with the paramedics working in the field along with mention of specific specialty (e.g. Junior Clinical Technician (Radiology) and Junior Primary Health Care Technician (Multi purpose).

3. The number of Posts in BPS-20, BPS-19, BPS-18, BPS-17, BPS-16, BPS-14, BPS-12 and BPS-9 shall be according to the proportionate ratio based on the total 8965 posts as mentioned in the provincial budget book for financial year 2005-2006. The proportionate ratio of 8 stage formula shall be as under:-



However additional posts shall be created for any of the left over personals of paramedics cadre (if any). Moreover, subsequent creation of posts in any of the 14 paramedics cadres in any scale shall also be included in the aforesaid proportionate ratio of posts in the 8 tiers formula. The proportionate ratios of posts in BPS-12 and above shall be modified accordingly as and when new creation of posts are made in BPS-9 in each of the 14 cadres subsequently.

4. Seniority of the incumbents of the posts in the 14 cadres so merged shall be caused on the basis of scale wise seniority as well as date of regular appointment in the pay scale. (e.g. in joint seniority list of BPS-12, the official already in BPS-12 will be placed on the top of the list and the officials in the lower pay scale shall be accordingly placed step by step in the list, invariably keeping intact the inter-Sr-seniority of the incumbents in the same pay scales).
5. In the first instance, the higher posts in the re-structured 14 paramedics cadres as per annexure "C" shall be filled in by way of promotion, as one time exercise, where-after the service rules duly prescribed as at annexure D shall be followed in subsequent promotion/ initial recruitment.
6. Promotions in the post in BPS-18, 19 and BPS 20 shall be made on the basis of joint seniority list. The Joint seniority list of all the 14 cadres shall be caused at BPS-17 level keeping in view the principles laid down in section 8 of the NWFP civil servants (ACT), 1973 read with Rule-17 of the NWFP civil servants (appointment, promotion and transfer) rules, 1989.
7. The afore-said paramedics service structure into 14 cadres shall also be applicable mutatis-mutandis to the paramedics working in IATA and employees working in Districts, all autonomous, semi autonomous and corporate bodies.
8. There shall be a council of paramedics to be notified separately.
9. The approved implementation committee and anomaly committee shall also be notified separately.
10. This eight stage paramedics service structure will replace all existing categories, cadres, structures and nomenclatures and will cancel all such cadres /categories rules and regulations etc which are in contravention to the approved paramedics service structure. New posts in all type of Health Delivery System will be created in

- i) Initially the one time up-gradation/Promotion is to be implemented upto BPS-17.
- ii) A joint seniority is to be developed in BPS-17. Based on the final joint seniority list of BPS-17 further promotion to BPS-18, BPS-19 and BPS-20 will be carried out on the basis of seniority-cum-fitness from BPS-17 to BPS-18, from BPS-18 to BPS-19 and BPS-19 to BPS-20 on step by step basis.

NO. SO(FR)FD/7-3/2015/Paramedics. The competent authority has been pleased to upgrade all the Paramedics Staff appointed under Khyber Pakhtunkhwa Civil Servants Act 1973, with immediate effect:

- I. All the incumbents Paramedics in BS-09 are upgraded to BS-12. In future the initial recruitment will be made in BS-12 instead of BS-09 and the Administrative Department shall immediately amend the service rules through SSRC accordingly.
- II. The incumbents presently serving in BS-12 & BS-14 are allowed 02 steps upgradation respectively with relaxation of condition of 10 years service in the same grade stipulated in the existing upgradation policy.
- III. The Paramedics presently serving in BS-16 and BS-17, having 05 years service in the respective pay scales, are allowed an allowance at the rate of fixation of pay in next grade.

- VI. This department notification bearing No. SO(FR)/FD/10-22/2015 dated 30-06-2015 will have no affect on the above employees.





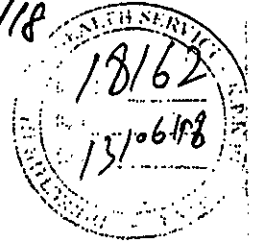

INTRODUCTION AND BACKGROUND:

I, Dr. Rizwanullah Khan Deputy Director (HRM) DGHS Office Peshawar was appointed inquiry officers vide Office Order No. 17547-50/AE-IV dated: 08.11.2017, in the matter of appointment of Mr. Khalid Mehmood S/O Ghulam Sarwar JCT Pharmacy (BPS-12) attached to District Health Office D.I.Khan in the year 2003 as CT Pharmacy (BPS-9) (Page-5).


PROCEEDINGS AND FINDINGS:

I visited DHO Office D.I.Khan on 23.11.2017, I recorded statements of Mr. Khalid Mehmood S/O Ghulam Sarwar JCT (BPS-12) attached to District Health Office D.I.Khan and examined Pharmacy the relevant enclosures with his statement. I also asked some questions for which he replied (Page-6).

Mr. Khalid Mehmood S/O Ghulam Sarwar JCT Pharmacy (BPS-12) attached to District Health Office D.I.Khan initially was appointed as Dispenser in (BPS-6) on 03.02.1990. The post of Pharmacy Technician (BPS-9) was advertised by EDO (H) D.I.Khan in August 2003 including other Paramedics posts. The said official having Diploma of Pharmacy Technology from the Khyber Pakhtunkhwa Medical Faculty Peshawar for the session 2000-2002, applied for Pharmacy Technician (BPS-9). He was selected and appointed by the then EDO (H) D.I.Khan on 20.08.2003 but his name was not shown according to his fresh appointment in the concerned seniority list. His name remained in the seniority list as Dispenser (BPS-6) at Serial No. 1077. Government of Khyber Pakhtunkhwa later on upgraded all Dispenser (BPS-6) to (BPS-9) in the year 2006 with new nomenclature JCT Pharmacy (Page-7 to 25).

It is pertinent to note here that Mr. Khalid Mehmood had already been appointed in (BPS-9) on 20.08.2003. Which means he was senior to his newly upgraded colleagues. He claims that Pharmacy Technicians juniors to him have been promoted to (BPS-14), (BPS-16) and (BPS-17).

In a similar nature case Mr. Wahidullah JCT (Radiology) who v initially appointed with Mr. Mr. Khalid Mehmood on 20.08.2003 and adjust against Ex-Cadre selective post of Dispenser (BPS-9), was upgraded in (BPS- on 25.11.2013. Which is proved by Final Seniority List of Chief. Clinia Technician Radiology (BPS-16). This is a blatant discrimination (Page-26 to 4:


Mr. Mohiuddin S/O Saeed was also initially appointed Radiographer (BPS-6) on 09.10.1988 later on Radiographer Technician (BPS- on 20.08.2003 along with Mr. Khalid Mehmood upgraded in (BPS-16) as Chi Clinical Technician (Radiographer) on 24.07.2013 just after 10-year (Page-43 to 46).

Mr. Ahmad Shah is another example of blatant discrimination wh was initially appointed as Dispenser on 03.02.1990 and later on he wa appointed as physiotherapy Technician (BPS-9) on 01.09.2003 and adjuste against ex-cadre post of Dispenser (BPS-9) for drawl of pay. He later on again illegally adjusted against the post of (BPS-17) on 01.10.2007 just afte 07-years till the arrival of Khyber Pakhtunkhwa Public Service Commissio selectee. He is enjoying the said post since last 11 years (Page-47 to 58).

Mr. Abdul Hameed S/O Abdur Rahman was also appointed Dispenser (BPS-6) on 26.07.1987 and Ophthalmic Technician (BPS-9) on 20.08.2003 along with Mr. Khalid Mehmood and upgraded in (BPS-16) as Chief Clinical Technician (Ophthalmology) on 02.08.2012 just after 09-year (Page-59 to 62).

These all above were appointed in the year 2003 after observing of all codal formalities and their seniority was reckoned w.e.f their appointment in 2003 except Mr. Khalid Mehmood S/O Ghulam Sarwar JCT Pharmacy (BPS-12) attached to District Health Office D.I.Khan, while he is continuously drawing salary in (BPS-9) since 22.08.2003 the same has been endorsed in his service book on 21.08.2003. It is pertinent to mention here that Mr. Khalid Mehmood Pharmacy Technician was adjusted after the appointment against (BPS-9) Dispenser post while other Mr. Ahmad Shah Physiotherapist Technician and Mr. Waheedullah Radiology Technician were appointed in (BPS-9) on 22.08.2003 and adjusted against Ex-cadre post Dispenser

(BPS-9) but they were granted seniority w.e.f 22.08.2003 while Mr. Khalid Mehmood who was appointed along with them in his own cadre against the post of (BPS-9) Dispenser on 22.08.2003 was not granted seniority w.e.f 22.08.2003. It is also a blatant discrimination. According to existing service rule at that time Dispenser (BPS-9) was not non-selective post for promotion (Page-63 to 75).

Mr. Muhammad Irfan s/o M. Zaman, Mr. Ishaq Shah s/o Shah Hussain, Mr. Yousaf Haroon s/o M. Bakhsh and Shoukat Ali s/o M. Abdullah all were appointed on 22.08.2003 as Operation Theater Assistant (BPS-6) against the Sterilization Technician post which was also ex-cadre post but they are enjoying their seniority w.e.f 22.08.2003 (Page-76 to 77).

Moreover, according to Government of Khyber Pakhtunkhwa Health Department Notification dated: 17.01.2009, Mr. Khalid Mehmood S/O Ghulam Sarwar JCT Pharmacy (BPS-12) attached to District Health Office D.I.Khan who was upgraded to (BPS-9) in 2006 on the basis of his initial appointment as Dispenser (BPS-6) was also entitled for seniority w.e.f 01.01.2002 (Page-78).

Mr. Khalid and others who were serving in (BPS-5, 6 & 11) as Lab attendant, Dispenser and Modular respectively when they were upgraded in (BPS-9) in 2006 in their respective categories, later on they were merged in single category of Pharmacy Technician but their inter-se-seniority was reckoned with their previous grade i.e (BPS-11) was senior to (BPS-6). The one Mr. Muhammad Jamshad s/o Ghulam Qasim attached to DHQ Hospital D.I.Khan. He was appointed as Modular (BPS-11) in 1999 now enjoying (BPS-17) since 2012 just in 13 year as Clinical Technologist Pharmacy without having Diploma in Pharmacy. It is due to merger of Modular category (BPS-11) in Pharmacy/ Dispenser category (BPS-6) at the time of the restructuring of their service structure in 2006. This was another blatant discrimination. Merger in one category and up-gradation in their respective categories were two different matters. It was mandatory after up-gradation in their respective categories that their inter-se-seniority would have been reckoned from their initial date of appointment.

I also wrote letters on dated: 28.11.2017 and 01.01.2018 to Mr. Sheraz Khan Assistant Director (Paramedics) and Mr. Syed Faiz Ali Shah Superintendent (Promotion Cell) of DGHS Office Peshawar. They submitted their statements on 03.01.2018 and 02.01.2018 respectively which are unsatisfactory. The concerned Promotion Cell was also reluctant to co-operate in this enquiry (Page-79 to 87).

CONCLUSION:

1. Mr. Khalid Mehmood S/O Ghulam Sarwar JCT Pharmacy (BPS-12) attached to District Health Office D.I.Khan qualified 02-years Diploma in Medical Technology (Pharmacy Technology) Correctly from Khyber Pakhtunkhwa Medical Faculty Peshawar in the session 2000-2002.
2. He was given (BPS-9) by EHO (D) D.I.Khan which was legal as Pharmacy Technician (BPS-9) on 22.08.2003 and rightly adjusted against his own cadre (selective) post Dispenser (BPS-9) while his other colleagues Mr. Ahmad Shah, Mr. Waheedullah, Mr. Muhammad Irfan, Mr. Ishaq, Mr. Yousaf & Mr. Shoukat illegally adjusted against ex-cadre posts of Dispenser (BPS-9 & 6) but they are still enjoying their seniority w.e.f 22.08.2003 while Mr. Khalid Mehmood on the basis of discrimination illegally deprived off from his due right of seniority w.e.f 22.08.2003 and consequently from promotion.
3. Mr. Khalid Mehmood has rightly knocked the door of Justice which is his legal right. He may be granted his due right of seniority w.e.f 22.08.2003 and consequently he may be promoted retrospectively when his colleagues were promoted with all back benefits.
4. However it is added that there is lot of discrepancies in the seniority lists of different categories of Paramedic. Therefore a high level committee may be constituted to enquire into the case to stream line the seniority / promotions of Paramedics.




