PRELIMINARY OBJECTIONS

- 1 That the Appellant has got no cause of action/locus standi to file instant appeal against the Respondent Department.
- 2 That the appellant is not an aggrieved person within the meaning of Section-4 Khyber Pakhtunkhwa Service Tribunal Act 1974 read with Article-212 of the constitution of Islamic Republic of Pakistan 1973.
- 3 That the appellant has concealed material facts from the ambit of this Honorable Tribunal in the titled appeal.
- 4 That the appellant has not come to this Honorable Tribunal with clean hands.
- 5 That the appeal in hand is based on mala fide intentions for gaining illegal service benefits from the Department in violation of the Rules & Policy.
- 6 That the appeal in hand is barred by law and limitation Act, 1908.
- 7 That the appeal in hand is bad for mis-joinder and non-joinder of the necessary parties.
- 8 That the appeal is not maintainable and even incompetent in the eyes of Law, Rules & Policy in vogue.
- 9 That the Notification dated 31-05-2019 is legally competent & liable to be maintained in favor of the Department.
- 10 That the appellant is not entitled for promotion against the BPS-17, 18 & 19 posts with retrospective effect under the Rules, Criteria & Policy in vogue
- 11 That as per seniority list dated 30-11-2018 SPETs in BPS-16, the appellant has been placed at seniority list No. 149, whereas, the Department has promoted SPETs in BPS-16 to the post of DPEs in 17 up to the Seniority list No. 108 under the Rules & Policy.

ON FACTS

- 1) That Para-1 pertains to the service record of the appellant against the PET in BPS-9 post inducted vide Notification dated 08-08-1995 with her subsequent up gradation in BPS-14 in the year 1999 by the Department under the Rules.
- 2) That Para-2 pertains to the academic record of the appellant during her service in the Department which is also subject to the production of NOC/Departmental permission of the competent authority.
- 3) That Para-3 is incorrect, hence, denied as against the factual position that the correct date of appointment as PET is 08-08-1995 with her date of regularization as PET is 24-04-2000 & her subsequent promotion to the post of SPET is 26-02-2013 as per available record mentioned in the final seniority list at S.No. 149 dated 30-11-2018 of the SPET (F) in BPS-16 maintained by the Department with further submission that the Department has allowed promotion to the DPEs in BPS-17 till the seniority list No. 108 namely Asifa Shahdab under the Rules attached as Annex-A for ready reference.
- 4) That Para-4 is correct that vide Notification dated 24-07-2014 formal Service Rules were notified by the Department with reference to Serial No. I/A, whereby, the way out of promotion from SPETs BPS-16 to DPEs BS-17 was made by the Department. (attached as Annex-B).
- 5) That Para-5 is correct to the extent of Notification dated 23-02-2017 Annex-C., whereby, the appellant was adjusted as DPE BS-17 in her own pay & scale which does not accrued any legal & vested rights of promotion to the appellant for her regular promotion as DPE against existing Rules, Criteria & Policy in vogue.
- 6) That Para-6 is incorrect & denied on the grounds that submission of ACRs etc by the appellant in response to the Department letters dated 14-10-2017 & 31-10-2017 do not confer any legal right of promotion to the appellant as replied by the Department vide letter dated 20-10-2023 attached as Annex-D.
- 7) That Para-7 is incorrect on the grounds that the stand of the appellant is illegal, the following table will negate the plea of the appellant which is as under:

The appellant has concealed facts regarding her regular appointment in the Department as PET & is junior most to the female SPETs promoted on the basis of their regular appointments as mentioned in the table, whereas, the regular appointment of the appellant is 25-04-2000, hence, claim of the appellant is illegal & liable to be rejected.

- 8) That Para-8 is also incorrect as the plea of the appellant is mis-leading in view of the fore made facts submitted by the Department in the instant reply before this Honorable Tribunal,
- 9) That Para-9 is correct to the extent of filing of Departmental Appeal to the Department which was disposed of vide letter dated 20-10-2023 under the Rules & Policy.
- 10) That Para-10 is incorrect as the appellant is not an aggrieved person within the meaning of Section-4 of Khyber Pakhtunkhwa Service Tribunal Act, 1974, hence, the appeal in hand is liable 5to be dismissed on the following grounds inter alia:

ON GROUNDS

- A. <u>Incorrect & not admitted</u>. the Notification dated 31-05-2019 is within legal parameter wherein, the appellant could not made out her case for promotion in upper scales under the Rules & Policy. Attached as Annex-E.
- B. <u>Incorrect & not admitted</u>. the act of the Department with regard to the service record of the appellant & Notification dated 31-05-2019 is legal & in accordance with the provision of Articles 04 & 25 of the constitution of 1973.
- C. <u>Incorrect & not admitted.</u> the plea of the appellant is illegal & even against the rules & Policy.
- D. <u>Incorrect & not admitted</u>. the appellant is junior most against the Private Respondents in the afore cited seniority, hence, did not promoted in the Notification dated 31-05-2019.
- E. <u>Incorrect & not admitted</u>, the act of the Department with regard to the Notification dated 31-05-2019 is in accordance with the provision of Article 38(c) of the constitution ibid.

- F. <u>Incorrect & not admitted</u>. the stance of the appellant is illegal as the Department has acted legally in the titled matter.
- G. <u>Incorrect & not admitted</u>. the appellant is not an aggrieved person in the titled matter in view of the fore made submission by the Department, hence, also seek leave of this Honorable Tribunal to submit additional grounds, case law & record at the time of arguments.

PRAYER.

In view of the above made submissions, it is requested that this Tribunal may very graciously be pleased to dismiss the instant service appeal with cost in favor of the Respondent Department.


