- 1. Learned counsel for the appellant present. Mr. Fazal Shah Mohmand learned Additional Advocate General for the awar respondents present.
- 2. Learned counsel for the appellant argued that criminal case on the basis of involvement of which appellant was dismissed from service is still pending adjudication and it has wrongly been mentioned in para 3 of the appeal that appellant is acquitted from the charges. He further argued that BBA confirmed on the basis of compromise by Additional Sessions Judge-Mardan which is evident from order No. 5 dated 10.01.2023 annexed with the main appeal. Learned District Attorney raised no objection upon *sine-die* adjournment. For fair and best administration of justice it will be more appropriate that instant appeal be adjourned *sine-die* till decision of criminal case by the competent court of law. Therefore, application is allowed and appeal is adjourned *sine-die*.

APP for the State present. Accused Bacha Khitab and Murad Ali Shah on bail present. Original record received.

Accused facing trial has been booked in the instant case FIR No.273 dated 30.04.2013 under sections 302/324/34 PPC, police station Saddar, Mardan.

Brief facts of the case are that complainant Younas sorg of Pasham Gul has charged the accused facing trial for committing the murder of his son Tayyub and causing injury to him by way of firing; hence, the FIR was registered.

The case was fixed for attendance of accused but perusal of record reveals that complainant party have patched up the matter with accused facing trial at bail stage.

The complainant/father and mother namely Mst.Nihar Begum have recorded their statements wherein they have stated that they pardoned the accused facing trial in the

name of Almighty Allah by waving off their rights of Qisas and Diyat and expressed their no objection on acquittal of accused facing trial. Upon said compromise BBA petition of both the accused facing trial was confirmed by this court vide order dated 10.01.2023. As per record deceased Tayyib was unmarried and his parents are only legal heirs and they have expressed their no objection on acquittal of accused facing trial at bail stage.

As it is a verdict of superior courts that once a compromise is always a compromise, therefore, keeping in view the above discussion there is no probability of the accused being convicted in the present case; hence by invoking the provision of section 265-K CrPC accused facing trial Bacha Khitab and Murad Ali Shah are acquitted from the charge leveled against them. Accused facing trial are on bail, therefore, their sureties are discharged from hability of their bail bonds.

Case property be disposed of in accordance with law expiry of period of appeal/revision.

File be consigned to record room after its completion and compilation accordingly.
