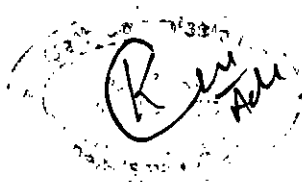





**TERMS & CONDITIONS**

1. The regularization will not be in favour of those, who have not taken over charge or has remained absent from duty or resign from service and also not for those who are under disciplinary proceedings.
2. Their services shall be governed by the Khyber Pakhtunkhwa Civil Servant Act, 1973, The Khyber Pakhtunkhwa (Appointment, Deputation, Posting and Transfer of Teachers, Lecturer, Instructors and Doctors) Regularity Act, 2011 and such rules and Regulations as may be issued from time to time by the Government.
3. They shall be subject to the verification of academic and professional documents/ testimonials from the concerned boards/universities by the District Officer concerned.
4. Their services will be considered regular and they shall be eligible for pension/deduction of G.P Fund in terms of the Khyber Pakhtunkhwa Civil Servant Act, 1983 as amended in 2013.
5. Their services are liable to termination on one month notice from either side. In case of resignation without notice, their one month pay/allowances shall be forfeited to the Government.
6. They shall possess the same qualification and experience required for the subject post on regular basis.
7. Their regularization shall not affect the promotion quota of the existing holders of posts in respective service cadre. They shall rank junior to all civil servants belonging to the same service or cadre, as the case may be, who are in service on regular basis on the commencement of the Khyber Pakhtunkhwa Employees of the Elementary & Secondary Education (Appointment and Regularization of Services) Act, 2018 (Khyber Pakhtunkhwa Act No.1 of 2018) and shall also rank junior to such other persons, if any, who, in pursuance of the recommendation of commencement of this Act, are to be appointed to the respective service or cadre, irrespective of their actual date of appointment.
8. The seniority shall be determined on the basis of their continuous services in cadre, provided that if the date of continuous service in case of two or more employee is the same; the employee elder in age shall rank senior to the younger one.

**NOTIFICATION:**

1. Whereas different posts of teaching cadre were advertised in daily newspapers in 2014, which were filled through NTS school based and for one year contract in all over the province of Khyber Pakhtunkhwa.
2. Whereas candidates appeared through NTS as per Government of Khyber Pakhtunkhwa policy.
3. Whereas some place meal orders were issued without prescribe manner and in prima facie contradiction to the existing rules at Government of Khyber Pakhtunkhwa.

Whereas some irregularities were observed as under.

- a. Whereas some of the below mentioned candidates did not appear in the interview, while others did not apply for the post against which their appointment were made, without the recommendation of SCRUTINY COMMITTEE and furthermore, they were not on merit.
- b. Whereas some candidates were appointed from other UCs, which is totally against the Government of Khyber Pakhtunkhwa policy of hundred parent recruitment of PST teacher on Union Council wise.
- c. Whereas some candidates had not appointed for the schools where their appointment were made.
4. Whereas the SCRUTINY COMMITTEE meeting was held on 2015, chaired by the then DEO (F), DIKhan in compensation with the grade of extension in respect of NTS appointments in various cadres in the department of Education DIKhan.
5. Whereas numerous deprived meritorious candidates lodged appeals the respective appointment held in the department.
6. Whereas the competent authority scrutinized the record of NTS appointees of 2014, and post explicitly respective comments against the following candidates which were resultantly not recommended for the extensions.
7. Whereas the competent authority had not extended their contract period after it was power that the appointment of the following candidates are illegal.
8. Whereas department inquiry was constituted by the department against these irregular appointment orders and as per decision of the inquiry, penalty was imposed against the then DEO (F), DIKhan.
9. Whereas the malafide appointees lodged appeal before the Honourable Peshawar High Court, Bench Dera Ismail Khan.
10. Whereas the above factual position had been concealed and the Honourable Court was not assisted properly, resultantly the Honourable Court accepted appeals and ordered according to the writ petitions.
11. Whereas the order of the Honourable Court were hnoured and extensions were granted on one year.
12. Whereas committee was constituted by this Office, regarding further extension for 2017-18 in respect of the NTS appointees.


