# FACTS:-

- 1. Yes it's true that Mr. Rahmat Gul S/O Said Gul (herein after called appellant) was appointed as DRR Cleaner in BPS-02 under Employees Son's Quota by the Superintending Engineer C&W Circle Swat (Appointing Authority) vide his Office Order No.438/4-E, Dated 26/09/2012 (Copy of Appointment Order Attached as Annexure-A).
- 2. Salaries were not paid as after arrival, the whereabouts of the appellant was not known and due to continuous absentee from Govt: Duty, the appellant has been directed several times to resume his duty vide Executive Engineer C&W Division Malakand Office letter No 804/5-E, Dated 20/11/2012 and No.895/4-E, Dated 11/12/2012 as the appellant has proceeded abroad. It is true that Senior Civil Judge dismissed the Case on 16/04/2018 due to non jurisdiction (Copy of Notices Served to appellant and computerized Air Port Arrival attached as (Annexure-B).
- 3. It is true that the appellant ceases to be a Govt: Employee vide Superintending Engineer C&W Circle Swat Vide letter No.1396/4-E, Dated 26/12/2013 due to continuous absentee from Govt: Duty and proceeding abroad without prior permission within probation period (Copy of termination order attached as Annexure-C).

#### **GROUNDS**

- a) It is incorrect, the order of dismissal of the appellant was as per E&D Rules as the appellant proceeded abroad and absent from Govt: Duty for 11-Months within a probation period and power of dismissal is vested in Superintending Engineer (Appointing Authority) (Annexure C).
- b) Proceeding abroad during a probation period without prior permission /availing Ex-Pakistan Leave Rules is not the theme of Govt: Employee and within a probation period, the appellant was dismissed in the Court of Senior Civil Judge due to non jurisdiction.
- c) As per above.
- d) As per point "(b)".
- e) Point "e' is correct to the extent of minor discipline fault on part of Govt: employee but in the subject case appellant was proceeded abroad within a probation period for 11-Months without prior permission / NOC Ex-Pakistan Leave Rules.
- f) The Appellant should have availed Ex-Pakistan Leave Rules or Medical Leaves.
- g) As per point "f" above.
- h) Notices were served an appellant to Explain / resume his duty as per (Annexure-B) and Office Employee was sent to the House of appellant time and again to resume his duty but he was not found in his house. He remained abroad for 11 months. (Ticket Attached as Annexure-B).
- i) This Statement is contrary to statement "F" of the appellant in which appellant claimed himself that he was unable to perform his duties while in this statement he claim that he was performing his duties with great zeal zest and devotion.
- j) The transfer order which was issued erroneously by the than Sub Divisional Officer concerned was immediately with drawn vide this office order No.349/3-E Dated 09/12/2014 as the official has been terminated vide Superintending Engineer C&W Circle Swat (Copy attached as Annexure-D).
- k) As per Statement "(I)".

- I) The statement is subject to proof that how the Office Order issued by Superintending Engineer vide his office No.1396, has bogus / illegal (Annexure-C).
- m) The respondents would like to seek permission of this Hon'able Court to adhere more grounds during the time of arguments.


