

Respectfully Sheweth!

1. That, the appellant is resident of village Chakiya, Tehsil and District Mansehra.
2. That the educational qualification of the appellant is F.A, B.A, B.Ed. M.A, M.Ed, Junior Diploma in Physical Education.

*(Copies of educational record is annexed as annexure "A").*

3. That, in the year 2011, District Education Officer, Mansehra/respondent No.4 advertised some vacancies in the education department. The appellant applied for the post of Physical Education Teacher (P.E.T).

*(Copy of the advertisement is annexed as annexure "B").*

4. That, in pursuance of the said advertisement, the appellant submitted her form for making her appearance in E.A.T.A Test. The respondent No.4 issued Roll No.1700889 and under the said roll number, the appellant appeared in the E.A.T.A Test and qualified the same by securing 156 marks and secured the average of 52%. The respondents No.3 and 4 placed the

appellant at serial No.10 of the merit list.

*(Copy of the E.A.T.A result of 2011 and merit list are annexed as annexure "C & D respectively).*

5. That, the name of the appellant was dropped from appointment rather the other candidates whose names were figure at serial Nos. 11 and 12 were appointed. When appellant came to know about this, she filed an appeal before the then Executive District Education Officer which was accepted and the appellant was appointed as P.E.T in Government Girls Middle School Baradar, Tehsil Oghi District Mansehra vide office original officer order No.5360-5384/Estab (F) Apptt PET (F)/2012 and in continuance of the same, other office order bearing No.6879-85 Estab: Apptt: PET/2011-12 dated 31.05.2012.

*(Copy of the appointment order is annexed as annexure "E").*

6. That, after appointment, the appellant reported in the relevant school and taken the charge on 01.06.2012 forenoon.

*(Copy of charge report is annexed as annexure "F").*

7. That, the appellant remained posted in the above-mentioned school till dismissal of the appellant from service through impugned order dated 03.03.2015. In the meanwhile the officials of the Education Department off and on visited the school and inspected the record and verified the same.

*(Copy of the attendance register and certificates of duty issued by the concerned Headmistresses are annexed as annexure "G&H").*

8. That, during the service, the official of the education department issued the service book to the appellant after due verification and there is also a confidential report of the then District Education Officer, Mansehra, service book is still in the possession of the respondents No.3 and 4 which may be requisitioned from the quarter concerned. When the respondents did not paid salary to the appellant, the appellant submitted applications for release of the salary time and again.

*(Copy of the confidential report is annexed as annexure "I").*

9. That, during the course of service, the appellant was appointed as Assistant Presiding Officer in General Election, 2013 and similarly the appellant was also appointed as Centre Invigilator at Government Girls High School No.1, Mansehra for examination of the year 2014 vide order dated 22.02.2014 and appellant also received the charges of examination duty. Duty certificate was also issued by the quarter concerned. Similarly at the day of dismissal of the appellant from service i.e. 03.03.2015, the appellant was again appointed as Centre Invigilator in the annual examination of 2015.

*(Copies of the election duty, examination duty, duty Certificate and bank receipt are annexed as annexure "J")*

10. That, when no action was taken on the applications of the appellant, the appellant was constrained to file a Writ Petition bearing No.733-A of 2014 which was disposed off with the directions to the respondent No.4 to release the salary of the appellant.

*(Copy of the order of the Honourable High Court is annexed as annexure "K").*

11. That, in the meanwhile the respondent No.4 issued show cause notice to the appellant which was duly replied.

*(Copies of show cause notice and reply are annexed as annexure "L").*

12. That, ultimately the respondent No.4 dismissed the appellant from service vide impugned order dated 03.03.2015.

*(Copy of the impugned order dated 03.03.2015 is annexed as annexure "M").*

13. That, when the appellant came to know about the dismissal order passed by the respondent No.4, appellant filed her representation on ~~29.03~~ 2015 before the proper forum but it is still unattended to.

*(Copy of the representation is annexed as annexure "N").*

14. That, the appellant being aggrieved from the impugned order, seeks the gracious indulgence of this Honourable Court/tribunal, inter alia, on the following amongst the other grounds: -

**GROUNDS**

- i. That, the impugned dated 03.03.2014 is wrong, illegal, against the law and facts, arbitrary, fanciful, perverse, without lawful authority, based on malafide, unconstitutional and against the relevant rules and regulations hence not maintainable and liable to be set aside.
- ii. That, the respondents No.3 and 4 absolutely having no authority to dismiss the appellant from service without adopting the proper procedure as contained in KPK Efficiency and Disciplinary Rules, 2011. The respondents No.3 and 4 were duty bound to issue notice to the appellant and then give a chance to the appellant for personal hearing before passing the dismissal/impugned order. Similarly the respondent No.4 was also duty bound to make inquiry in accordance with law wherein inquiry officer may collect the evidence regarding the allegations levelled against the appellant and then to give its findings and provide the copy of the inquiry report to the appellant as per law and rules and then proceed

against the appellant. But in the instant case, the law and the relevant rules were not followed by the respondents and the services of the appellant were terminated in a very hurried manner which is absolutely not permissible under the law.

- iii. That, once a civil servant is inducted in the Government Service then all the appointing authorities/officers are duty bound to abide by the relevant law, rules and regulations while passing any order which effect the service of the civil servant. Respondents No.3 and 4 have overlooked all the relevant laws, rules and regulations while passing the impugned order.
- iv. That, the respondent No.4 passed the impugned order without conducting proper inquiry into the matter which is not permissible under the law as when the major penalty is to be imposed on the civil servant then conducting of the proper inquiry is too much essential and after inquiry, copy of the inquiry report is to be delivered to the civil servant but in the present case, the respondents No.3 and 4 have not conducted the inquiry and also have not delivered any

copy to the appellant which is violation of the relevant law and rules. Even the appellant has no knowledge regarding the constitution of the so-called inquiry committee and conducting of the inquiry as the appellant was not given any chance of hearing, in this way, the appellant was condemned unheard which is against the natural justice that no one should be condemned unheard.

- v. That, the respondents No.3 and 4 changed their stance time and again and taken different pleas at different times.
- vi. That, the appellant has full educational qualification required for the post. The respondents have no authority to dismiss the appellant from service on these flimsy grounds without due process of law.
- vii. That, due to the passing of impugned order, the fundamental rights of the appellant were also violated which were jealously guaranteed by the Constitution.
- viii. That, the appellant performed the General election duty of 2013 and examination duties and appellant also received the duty charges which was



well within the knowledge of the respondents and the appellant conducted the duty in election and examination with the consent and permission of the respondents. Respondents cannot resile from their stance that the appellant is not the civil servant.

- ix. That, many officials of the Education Department time and again visited the Government Girls Middle School Baradar Darband where the appellant was posted and it is well in their knowledge regarding the appointment and performance of the duty by the petitioner. Similarly, when the appellant herself sent the applications to respondents No.3 and 4 through registered A/D, they never replied and communicated to the appellant that she has been appointed as P.E.T in violation of the rules.
- x. That, the reasons assigned by respondents No.3 and 4 while passing the impugned order are too much alien to the law, rules and regulations of the education department.
- xi. That, the impugned order passed by respondents No.3 and 4 is totally unjust,

unfair and based on cruel and malafide conduct of the said respondents.

It is, therefore, most humbly prayed that on acceptance of instant appeal, the impugned order dated 03.03.2015 passed by the respondents No.3 and 4 may please be set aside and the appellant may graciously be re-instated in service with all back benefits.

- 13) Para No. 13 is correct to the extent of appeal which was rejected by the authority.
- 14) Para No. 14 needs no comments.







WHEREAS, Mst Sadaf Riaz, PET at Government Girls Middle School Bradar District Mansehra was dismissed from service by the DEO (Female) Mansehra vide Order No. 1452-61 dated 03/03/2015 after serving Show Cause Notice and giving her an opportunity of personal hearing on charge of irregular/fake/bogus appointment.

WHEREAS, consequently the above aggrieved teacher lodged/preferred an appeal to the Director E&SE Khyber Pakhtunkhwa, Peshawar (appellant authority) against her dismissal from service with the pray to set aside her dismissal order issued by the DEO concerned followed by her reinstatement.

AND WHEREAS, the Director E&SE Khyber Pakhtunkhwa, Peshawar constituted a committee vide Notification No. 5500-09 dated 23-04-2015 for the scrutiny of appeals of above dismissed teacher.

AND WHEREAS, the committee having scrutinized appeal of above affected teacher on the basis of available record and merit of the case submitted its report to the Director E&SE Khyber Pakhtunkhwa, Peshawar with the findings and recommendations reproduced briefly below:-

1. Sadaf Riaz's name was in the Merit list at S.No. 10 under ETEA R. No. 1700889, but her ETEA application form was not found. Her name was neither included in the working paper nor in the DSC minutes. Only 09 candidates were recommended against 09 available vacancies. She was appointed through a single/individual order.
2. Appeal may be rejected with the remarks that there were 09 vacancies reserved for initial recruitment for fresh candidates and in accordance with the merit list her name was stood at Sr.No.10. Hence she was not entitled to appointment.

NOW, THEREFORE, in exercise of powers conferred upon the Director E&SE Khyber Pakhtunkhwa, Peshawar (appellant authority) under E&D Rules 2011 read with rules 17 (2) (a) and keeping the findings/recommendations of the committee into consideration, rejects the appeal of aforesaid sacked teacher for reinstatement, however her dismissal order issued by the DEO (F) Mansehra vide order No. 1452-61 dated 03/03/2015 is hereby converted into removal from service.

**PRELIMINARY OBJECTIONS.**

1. Para No.1 is incorrect, Honourable Court has got jurisdiction to entertain the appeal in hand.
2. Para No.2 is incorrect.
3. Para No.3 is incorrect.
4. Para No.4 is incorrect.
5. Para No.5 is incorrect.
6. Para No.6 is incorrect.
7. Para No.7 is incorrect.
8. Para No.8 is incorrect. The authority has acted with malice and

dismissal/removal order of appellant is totally wrong, illegal, against the law and facts.

9. Para No.9 is incorrect. The appointment of the appellant was made by the then Executive District Officer, Mansehra Mr. Umer Khan Kundi and the appellant after her appointment regularly put her appearance in Government Girls Middle School Brader Darband, Tehsil Oghi District Mansehra and her appearance was also noted in the register of the School which was duly checked by the Circle A.D.O and the then D.O. As the respondents have acted illegally and with malice, to save their skin, they are making lame excuse by blaming the then E.D.O Umer Khan Kundi. As per contention of the respondents Umer Khan Kundi was removed from service. Now the said Umer Khan Kundi was restored in service by the competent authority and the respondents have not challenged that very order. The other female teachers who were terminated by the respondents and were 42 in numbers, all these female teachers

were restored by the competent authority and all these appointments were made by the then Executive District Officer namely Umer Khan Kundi.

**FACTUAL OBJECTIONS.**

1. Para No.1 needs no reply.
2. Para No.2 needs no reply.
3. Para No.3 needs no reply to the extent of advertisement in Daily Aaj while the reply of the rest of the para is that the appellant duly applied for the advertised post i.e. Physical Education Teacher.
4. The reply of para No.4 is that the appellant appeared in the EATA test and secured 56 marks with the average of 52%. The respondents wrongly placed the appellant at serial No.10 of the merit list; rest of the reply of para No.4 is incorrect.
5. Para No.5 is incorrect.
  - i. Sub para (i) needs no reply to the extent of placing the name of the appellant at serial No.10 of the merit list while the rest of the para is incorrect. The respondents

deliberately placed the name of the appellant at serial No.10 while the appellant has secured marks in the EATA test with fine average and the name of the appellant must be shown before serial No.10 of the merit list. The respondents deliberately misplaced the relevant documents of the appellant just to deprive the appellant from her legal right, actually the advertised posts were twelve in number and the respondents deliberately suppressed the actual number of the posts with malafide intention and for sinister purpose. As the appellant was entitled for the post in all respects, the appellant is not in knowledge about the malafide intention of the appointing authority as why he has appointed the appellant with single order, if the appellant is appointed with single order then no illegality was committed by the then appointing authority. So far, the respondents have failed to mention any illegality about the said single order of appointment of the appellant and this is no ground to terminate the services of the appellant

after more than two and a half year of unblemished service.

- ii. Sub para (ii) is incorrect. The advertisement of the respondents is already on the court file which is worth perusal. The respondents have never mentioned the number of posts in their advertisement. The respondents have appointed the other candidates who were lower in merit than the appellant. In this way, the appellant was discriminately treated by the respondents.
6. Para No.6 is incorrect. As the appellant has made his arrival in the concerned school on 01.06.2012 soon after the appointment order and record in this respect is already available on the file. The respondents are trying to suppress the material facts from this Honourable Court just to deprive the appellant from her legal right.
7. Para No.7 is incorrect.
8. Para No.8 is incorrect. The record available on the file reflects that the appellant has performed her duties regularly. Writ Petition No.737-A of

2014 was allowed by the Peshawar High Court, Bench Abbottabad and the respondents were directed to release the salary and other allowances of the appellant but so far the respondents are reluctant to redress the grievance of the appellant in respect of the salary and allowances on one pretext or other.

9. Para No.9 is incorrect. The performance of election duty was on the direction and order of the respondents. If the appellant was not duly appointed by the respondents then common/lay man is not allowed to perform the election duty. Similarly, the appellant has also performed the duties of invigilator twice during the service on the direction of the respondents.
  - i. Sub para (i) is incorrect. The respondents are consistently making false statements before the Honourable Court. Previously, the respondents stated that the name of the appellant was at serial No.10 of the merit list, now they are stating that the name of the appellant was at S.No.11 of the merit list. It is again

stated that the respondents have never mentioned the number of posts in the advertisement and the respondents have made the appointments of the persons who were placed lower than the appellant in the merit list.

- ii. Sub para (ii) is incorrect. The reply of the same has already been given.
- 10. Para No.10 needs no reply to the extent of filing of Writ Petition. Rest of the para is incorrect.
- 11. Para No.11 needs no reply.
- 12. Para No.12 needs no reply.
- 13. Para No.13 needs no reply. The authority has wrongly rejected the appeal of the appellant.
- 14. Para No.14 needs no comments.

**GROUND**
