APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST NOT ALLOWING THE APPELLANT TO PERFORM HER DUTIES AND FOR THE RELEASE OF HER SALARY SINCE HER APPOINTMENT I.E 10.08.2010, AGAINST WHICH HER DEPARTMENTAL APPEAL DATED 20.07.2013, HAS NOT BEEN RESPONDED DESPITE THE LAPSE OF STATUTORY PERIOD.

JUDGMENT

MUHAMMAD AMIN KHAN KUNDI, MEMBER: - Appellant

alongwith counsel and Mr. Kabirullah Khattak, Additional Advocate General for the respondents present. Arguments heard and record perused.

2. Brief facts of the case as per present service appeal are that the appellant was appointed as Primary School Teacher (BPS-7) vide order dated 10.08.2010.

After medical fitness certificate, she assumed the charge but since her

appointment, the respondent-department has not paid salary to the appellant therefore, the appellant filed departmental appeal on 20.07.2013 which was not responded, hence, the present service appeal on 19.11.2013.

3. Respondents were summoned who contested the appeal by filing written reply/comments.

4. Learned counsel for the appellant contended that the appellant was appointed as Primary School Teacher (BPS-7) vide order dated 10.08.2010. It was further contended that the appellant was continuously performing her duty till April 2012 however, her salary was not released. It was further contended that due to threat from local Taliban, the appellant was forced to remain at her home, therefore, she could not join her duty. It was further contended that when the situation was normalized, the appellant went to join her duty however, she was not allowed to join her duty therefore, the appellant filed departmental appeal on 20.07.2013 but the same was not decided within the statutory period hence, the present service appeal. It was further contended that the respondent-department may be directed to allow the appellant to perform her duty and also release her salary from the date of her appointed i.e 10.08.2010 and prayed for acceptance of appeal.

5. On the other hand, learned Additional Advocate General for the respondents opposed the contention of learned counsel for the appellant and contended that the appellant has not performed any duty after her appointment. It was further contended that the appellant also prepared fake/bogus attendance register for the purpose of gaining illegally service benefits from the respondent-department. It was further contended that since the appellant has not performed any duty since her appointment i.e 10.08.2010 therefore, the appellant is not entitled for any salary. It was further contended under section-4


of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 a service appeal be filed against any final order whether original or appellate made by the departmental authority in respect of any term and condition of the service but in the present service appeal there is no final order, whether original or appellate made by the departmental authority in respect of any term and condition of her service therefore, it was vehemently contended that the present service appeal is also not maintainable on this ground and prayed for dismissal of appeal.

6. Perusal of the record reveals that the appellant has claimed that she was appointed as Primary School Teacher (BPS-7) vide order dated 10.08.2010. The record further reveals that the appellant has also claimed that she was performing her duty regularly since her appointment but the respondent-department has not paid salary to her, since her appointment therefore, the appellant filed departmental appeal on 20.07.2013 but the same was not responded within the statutory period hence, the present service appeal. The record further reveals that on one hand, the appellant has claimed that she has performed her duty regularly while on the other hand respondent-department has denied her claim of performing duty in the school. The record further reveals that the appellant has also submitted application/departmental appeal to EDO (E&SE) District Dir Lower for release of her salary and requested for her transfer to another school but the same has not been decided therefore, we deem it appropriate to direct the concerned EDO (E&SE) District Dir Lower to decide the said application of the appellant within a period of 60 days from the date of receipt of copy of this judgment after examining the relevant record and providing opportunity of personal hearing to the appellant and also communicate the order to the appellant and thereafter if the appellant is aggrieved from the order of the EDO (E&SE) District Dir Lower than she will be

Counsel for the appellant contended that the appellant has not been treated in accordance with law/rules. She filed departmental appeal on 20.07.2013 against the non receipt of salary which the Section-17 of the Khyber Pakhtunkhwa Civil Servant, Act 1973 provides that the Civil Servant appointed to a post shall be entitled, in accordance with the Rules to the pay sanctioned for such post. Hence non receipt of pay at the end of every month is a recurring loss to the appellant which could be treated as original order. The departmental appeal dated 20.07.2013 is not responded within the statutory period of 90 days, hence the present appeal on 19.11.2013. He further contended that after appointment on 10.08.2010, the appellant took over charge on 11.08.2010 since then he regularly performed her duty.


The learned Government Pleader while assisting the court was of the view that there is not final order. The departmental appeal has been filed against violation of Section-17 of the Khyber Pakhtunkhwa Civil Servant, Act 1973 and there is no original order.

Points raised at the Bar need consideration. The appeal is admitted to regular hearing subject to all legal objections. 





Appeal under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 against not allowing the appellant to perform her duties and for the release of her salary since her appointment i.e 10.08.2010, against which her Departmental Appeal dated 20.07.2013, has not been responded despite the lapse of statutory period.

Prayed in Appeal:

On acceptance of this Appeal the Respondent may be directed to allow the appellant to perform her duties and her salary may also be released since her appointment i.e 10.08.2010 she may also be allowed consequential benefits.

RESPECTFULLY SUBMITTED:

1. That the appellant was initially appointed as Primary School Teacher (PST) BPS-7 vide appointment Order No 11956-12094, dated 10.08.2010, the appellant duly took over the charge of her post on 11.10.2010 and started performing her duties, she also produce her medical fitness certificate from the concerned Hospital. (Copies of the *appointment Order dated*

10.08.2010, charge report and Medical Certificate are attached as Annexure A, B & C).

2. That ever since her appointment, the appellant performed her duties as assigned to her with zeal and devotion and never gave any chance of complaint to her Superiors regarding her performance. (Copy of the *Attendance Register* is attached as Annexure D).
3. That despite her regular performance of duty, the salary / pay of the appellant was not released, she continuously approached the Respondents for the release of her salary, however they remained reluctant. It is pertinent to mention that the appellant was directed to produce duty certificate from her School which she duly produced, moreover she was also asked to open account in bank so that her salary may be released, she did so, however her salary was not released. (Copies of the *Duty Certificate and Bank Slip* are attached as Annexure E & F).
4. That the appellant continuously performed her duties till April, 2012, however her salary was not released, thereafter due to threats from the Local Taliban / Militants the appellant was forced to remain at her home, therefore she could not join her duty.
5. That again when the situation normalized the appellant went to join her duty, however she was not allowed to join and also continuously visited the Respondents for the release of her salary since her appointment but her requests were made but her requests were paid no heed, hence as a last resort she submitted her departmental appeal dated 20.07.2013, which was not responded despite the lapse of 90 days period. (Copy of the *Departmental Appeal* is attached as Annexure G).
6. That the appellant prays for acceptance of her appeal inter alia on the following grounds:-

GROUND OF APPEAL:

- A. That the Appellant has not been treated in accordance with law, she has been denied her right to life/livelihood, which is violation of article 4 read with article 9 of the constitution of Islamic Republic of Pakistan, 1973.

- B. That the order of appointment is issued by the competent authority, the appellant has took over the charge of her post and started performing duties, thus valuable rights have been created in her favour the same cannot be snatched or withheld. Hence the respondents are under obligation to release the salary to the appellant.
- C. That the appellant has not been terminated from service, nor there was any departmental proceedings conducted against her, thus she has every right to be allowed to join her duty and also entitled for her salary.
- D. That the appellant has continuously performed her duties, since her appointment hence not allowing her salary of her post is illegal unlawful, against law and facts and ineffective upon the rights of the appellant.
- E. That the appellant has regularly been performed her duties, thus not allowing her salary of her post is illegal and unlawful.
- F. That the appellant has never committed any act or omission which could be termed as misconduct, albeit she has been illegally kept away of her duty and deprived of her salary.
- G. That withholding / not releasing of salary amount to punishment, albeit without holding any enquiry or proceeding against the appellant the salary of the appellant is withheld thus the acts and omission of the Respondents are illegal and unlawful.
- H. That since not releasing salary of the appellant is a continuous cause of action, therefore no period of limitation is applicable in the instant case.
- I. That the appellant seeks the permission of this Honourable Tribunal to rely on additional grounds at the hearing of this appeal.

It is, therefore, prayed that on acceptance of this Appeal the Respondent may be directed to allow the appellant to perform her duties and her salary may also be released since her appointment i.e 10.08.2010 she may also be allowed consequential benefits.

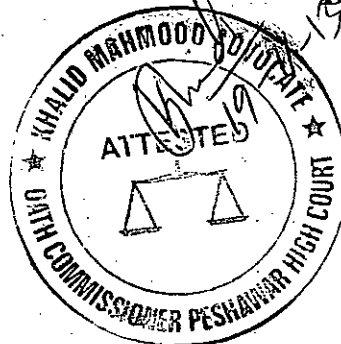

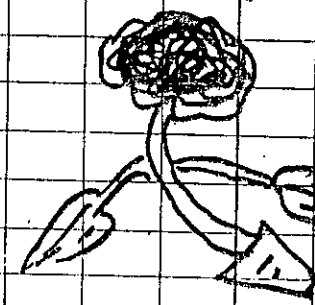

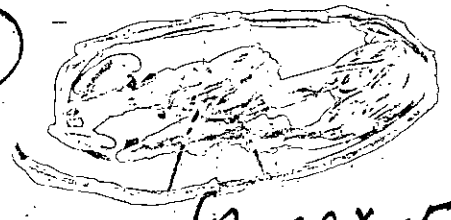

PARA WISE COMMENTS/REPLY FOR AND ON BEHALF OF THE RESPONDENTS NO 1, 2 & 3.

Respectfully Sheweth:-

Preliminary Objections:-

1. The appellant has got no locus standi or cause of action to file the instant appeal.
2. The instant appeal is badly time barred.
3. The instant service appeal is based on malafied intention for gaining illegal and unauthorized service benefits from the respondents.
4. The appellant has concealed the material fact from this Hon! Able Tribunal, hence liable to be dismissed.
5. The appellant has not approached this Honorable Tribunal with clean hands.
6. The present appeal is liable to be dismissed for mis-joinder of unnecessary and non-joinder of necessary parties.
7. The appellant has filed the instant appeal on malafide motives.
8. The instant appeal is against the prevailing laws & rules.
9. The appellant has rightly been treated by respondent No.3
10. The appellant is estopped by his own conduct to file in present appeals.

ON FACTS.

1. Correct up to the extent of appointment as PST vide order No.11956-12094 dated 10/08/2010 and taking over charge on 11/08/2010 in the said School after school hour/official time. But the rest of the para is incorrect because the appellant has not performed her official duty even for an hour or single day against the said post. Furthermore, in the absence of the then headmistress Shumaila Gul, the appellant stole the original teacher's attendance register and was disappeared. Then the appellant prepared fake and bogus attendance register for the purpose of gaining illegal service benefits from the respondents departments through the instant service appeal.

It is also pertinent to note that the then headmistress deny of her signature on the charge report written in English. However she admit her signature on the charge report written in Urdu.

In a nutshell, the teachers attendance register and charge report produced is fake and bogus. (Photo copy of the written statement of the then headmistress is attached as Annexure- A)

2. Incorrect. As replied above in para 1 of the facts.
3. Incorrect. As replied in para 1 of the facts above. As for as the claim of salary is concerned, the under signed is bound to release the pay of a teacher when she perform duty regularly and her service book has properly been prepared by the competent authority. The school was closed in the said period and mistress Hadia

Begum was transferred from GGPS Siah Gawni to open the said closed school. When the school was closed then how the appellant can claim of duty and salary.

According to the written statements of the new Headmistress and Chowkidar, the appellant has not performed her duty in the said school due to which the school remained closed. (Copy attached as Annex- B & C)

4. As replied in para, 3 above. However she remained willful absent from duty and it is pertinent to point out that there was militancy in the area in the year 2009. But in 2012, there was no threat from Taliban/Militants and all the surrounding schools were open and functional. Mst: Hadia Begum PST was performing her duty regularly during that period.
5. Incorrect. The appellant was not allowed by the Head Mistress to join her duty because the appellant was not on the teacher's strength of the school. So there is no question of salary. It is worth mentioned to note that if appellant was regular PST, then why the appellant applied for CT post through NTS without any departmental permission and now the appellant has been appointed as CT on contract basis at GGHS Inzaro vide this office order No.1075-78 dated 03-05-2014 (copy attached as Annex-D)
6. The instant appeal may kindly be dismissed on the following grounds.

ON GROUNDS:-

- (A) Incorrect. The appellant has been treated in accordance to law and no violation of rules has been made.
- (B) As replied in para 1 & 3 above of the facts.
- (C) Since after taking over charge, the appellant has not performed her duty in the said school for even an hour and her service book had also not been prepared by the concerned SDEO (F) Timergara as well as the appellant was not a regular govt servant. Therefore there was no need of departmental proceeding and thus the appellant was not terminated. Hence the question of termination does not arise.
- (D) As replied in para 1 and 3 above of the facts.
- (E) As replied in para 1 and 3 above of the facts.
- (F) As per para's above.
- (G) As replied in para C above of the grounds.
- (H) Incorrect.
- (I) The respondent seek permission of this honorable Tribunal to advance further grounds at the time of arguments.

In view of the above made submission, it is humbly requested that this Honorable Tribunal may very graciously be pleased to dismiss the instant appeal with cost in favor of the respondents Department.


