Facts forming the back ground of the instant Service Appeal is as under:-

1. That, the appellant is serving as Senior theology teacher in GGHS, Berkund, Mansehra.



- 2. That, the appellant is serving in BPS-16 with complete devotion and dedication to the entire satisfaction of her superior authorities.
- 3. That, the appellant as per seniority list of STT was placed at Serial No 2 for promotion to the post of SST (Senior Science Teacher General) BPS-16.
- 4. That, the appellant is BA, Bed and is eligible for promotion to the post of SST (BPS-16). Copies of degrees are attached as annexure "A".
- 5. That, respondent No 2 issued direction to respondent No 3 for submission of working papers of those STT who are eligible for promotion for SST (General) vide letter dated 23.12.2013. Copy of letter of respondent no2 dated 23.12.2013 is attached as Annexure "B".
- 6. That, the appellant as per order submitted her requisite documents viz bio-date, ACR and non-involvement certificates etc to respondent No 3 for her promotion as SST. Copies of the requisite documents for promotion as SST are attached as Annexure "C".
- 7. That respondents' department illegally promoted respondent No 4 whose documents were not placed before the department promotion committee instead of the appellant vide impugned promotion order endst. No 8988-90291/AF-II dated 5.11.2013. Copy of promotion order of respondent No 4 is placed at S. No 37 of the order dated 5.11.2013 which is attached as Annexure "D".
- 8. That, the respondents' Department kept the said promotion order secret which was obtained/received by the appellant from the office of respondent No 3 on 14.11.2014.
- 9. That, the appellant feeling aggrieved filed departmental appeal against the impugned order to respondent No 2 on 14/1/2015 but respondents' Department did not reply to the appellant so far. Copy of Departmental appeal is attached as Annexure "E".

Hence, the appellant feeling aggrieved filed the instant appeal inter-alia on the following grounds:-



GROUNDS

- SST (BPS-16) being qualified as well as the principle of seniority cum fitness. The appellant was placed at S.

 No 2 of the seniority list which shall be placed on record on receipt of the same from the office of respondents' department. Hence, the appellant is entitled for promotion as SST (General).
- b. That, respondent No 4 did not submit her documents before the DPC and her case was not placed by respondent NO 3 before DPC for promotion but even then she has been promoted instead of the appellant. Promotion of respondent No 4 is illegal and liable to be set aside.
 - That, when law prescribe something which is to be done in a particular manner that must be done in that manner and not otherwise. As per law the appellant is eligible for promotion in BPS-16 as SST. The conduct of respondents towards the appellant is mala fide, discriminatory and not maintainable at law.
- d. That, this fact may not be left to fade in oblivion that respondent No 4 whose case was not placed before



the DPC even then she has been promoted which is against the law.

- been promoted as SST by the respondents' due to political pressure and motivation. Hence, her promotion order is liable to be set aside.
- f. That, respondents' Department has led the appellant to the place which is utterly unknown to the principle of jurisprudence and natural justice.
- g. That, the Honourable Service Tribunal have jurisdiction to entertain the grievance of the appellant and the appeal of the appellant is within the prescribe period of limitation

It is, therefore, prayed that on acceptance of the instant Service Appeal, promotion order of respondent No 4 may graciously be set aside and respondents may be directed to promote the appellant as SST (General) w.e.f. the date of promotion of her other counter part employees with all service back benefits.







 - (a) As objective as possible and
 - (b) Clear and direct, not ambiguous or evasive in their remarks.
 - The forms are to be field in duplicate. Part-I will be filled by the officer being reported upon and should be type written. Parts-II to VI will be filled by the reporting Officer and Part-VII by the Countersigning Officer. Both the Reporting Officer and Countersigning Officers should give their assessment of the Officer report upon in respective boxes in Part-V. The Ministry/division/Department concerned will fill Part-VIII, if any adverse remark are recorded in the report.
 - 3. Assessment in the ACR should be confined to the work done by the officer reported upon during the period covered by the report.
 - A. Reporting Officer is expected to counsel the officer being reporting upon about his weak points and advise him how to improve. Adverse remarks should normally be recorded when the officer fails to improve despite counseling.
