Copies of Judgment and Notification are attached as Annexure-B and C.

That as the appellant was also allowed only fixation of untrained period with effect from 31.08.1980 to 01.08.1988 but no arrears have been give. Therefore, the appellant filed departmental appeal for his claim and waited for statutory period but no reply has been received so far. 
