



ALL FINANCIAL BACK BENEFITS BY CONSIDERING HIS
APPOINTMENT ON 15.05.2020 AS SUBJECT
SPECIALIST(S.S) IN ISLAMIAT (BS-17), PURSUANT TO
ADVERTISEMENT NO.03/2018 DATED 09.02.2018.

Prayer:

On acceptance of this Service Appeal, the *Respondents* may please kindly be directed to grant the appellant all financial back benefits by considering his appointment on 15.05.2020 as subject specialist (S.S) in Islamiat (BS-17)

Respectfully Sheweth:

The appellant submits as under:

1. That the appellant is law Abiding person and citizen of Pakistan, living in village Kander, District Battgram. Presently serving in the school of respondent No.4. **(Copy of CNIC is Annexed as Annexure A).**
2. That the respondent No.3 on requisition placed by respondent No. 2 advertised 36 posts, amongst many more, of Subject Specialist (SS) in Islamiat through advertisement No. 03/2018 and serial No. 23 on 09.02.2018. The appellant duly responded to this opportunity by submitting an application for the advertised post. **(Copy of the advertisement is annexed as annexure "B").**
3. That after completion of the selection process, all 36 advertised posts were filled on 15.04.2020. Regrettably, due to erroneous scrutiny of examination papers by respondent No.3, both the appellant and another candidate namely Liaqat Ali, were unjustly excluded from appointment to any of the advertised

positions. **(Copy of the appointment order of the rest of the appointees is annexure "C")**

4. That in response to the flawed checking process and irregularities, the appellant, aggrieved by the injustice suffered, filed Writ Petition No. 1489-P/2020. The Honorable Peshawar High court, Peshawar while accepting the writ petition issued direction for corrective measures. Subsequently, following the court's order dated 27.07.2023 in COC No. 154-P/2023, the appellant rightfully secured appointment to one of the advertised posts on 31.07.2023. **(Copy of appointment order is annexure "D")**
5. That after appointment in accordance with Honorable High court's intervention, and despite placing the name of the appellant at the correct position of seniority list i.e. at serial No. 2300 of the seniority list, the appellant was unjustly deprived of all financial back benefits. **(Copy of the relevant pages of seniority list are annexure "E")**
6. That in view of the aforementioned unequal and unjust treatment leading to the deprivation of his rights, the appellant, aggrieved by the circumstances, preferred a departmental appeal to respondent No. 2 on 23.09.2023. **(Copy of the said appeal is annexure "F")**. Regrettably, up until now, no action has been taken on the said appeal, despite expiry of 90 days, hence, this service appeal, inter alia, on the following grounds;

GROUNDS

- A. That the non-appointment of the appellant was an unequivocal and glaring mistake on the part of the respondent No.3. The appellant, through no fault of his own, continues to endure the adverse consequences of this error, had he been appointed with the other recommendees of his batch, he would have received the salaries and all other back benefits similarly, like them. However, the appointment of the appellant was delayed due to error of respondent No.3, which they did not rectify on their own until the same was got adjudicated before the Peshawar High Court, Peshawar and they were compelled by the court orders in COC-Application, thus the wrongful act of an authority duly proved as such in an adjudicatory process can not adversely affect the entitlements of the appellant for financial back benefits inter see the payment of arrears of salaries and other admissible evidence.
- B. That treatment he has endured is a direct violation of his fundamental right to equal treatment, as safeguarded by the Constitution. The respondent department's actions stand in stark contradiction to the foundational principles of equality before the law, thereby infringing upon the appellant's constitutional rights.

C. That other grounds not specifically raised here would be raised with the permission of this Hon'ble Tribunal at the time of arguments.

It is, therefore, most humbly prayed that on acceptance of this Service Appeal, the respondents may please kindly be directed to grant the appellant all financial back benefits by considering his appointment on 15.05.2020 as subject specialist (S.S) in Islamiat (BS-17)

Any other remedy/relief which is just appropriate, may also be awarded in favour of the appellant, please.
