<u>JÚDGMENT</u>

HAMID FAROOQ DURRANI, CHAIRMAN:-

- 01. The appellant is aggrieved of order dated 02.11.2016 passed by respondent No.2/Regional Police Officer, Mardan Region whereby the penalty of dismissal from service awarded to him was converted into minor punishment of stoppage of three increments with accumulative effect. Through the impugned order the intervening period was treated as leave without pay while the appellant was transferred, upon reinstatement, to Charsadda.
- 02. Learned counsel for the appellant heard and available record gone through.

Learned counsel mainly contended that the allegations against the appellant were based on malafide and his case was not decided on merits by the departmental authority. It was also contended that the appellant was awarded three tier penalty which was not sustainable. Attempting to cover the delay in submission of petition under Rule-11-A of the Khyber Pakhtunkhwa Police Rules, 1975, learned counsel relied on judgments reported as 2002 PLC (C.S) 1388, 2002 PLC (C.S) 268, 2006 PLC (C.S) 489 and PLD 2002 Supreme Court 84.

03. The available record reveals that the appellant was proceeded against on account of mis-behavior with the complainant of FIR no. 313 dated 01.09.2016 recorded under Section-377 PPC at Police Station Tordher. Further, the appellant was dubbed as being corrupt, dishonest and inefficient. On 04.10.2016 the respondent No.3/District Police Officer, Swabi passed an order, upon conclusion of departmental proceedings, whereby major punishment of dismissal from service was awarded to the appellant. He preferred a departmental appeal which was decided through the impugned order on 02.11.2016. As per the learned counsel for the appellant, the petition under Rule-11-A of Rules ibid was preferred before the respondent No.1 on 04.09.2018. The same was rejected on the ground of being barred by time through order dated 13.09.2018.



04. It is not denied by learned counsel that the revision petition was barred by more than a year, however, it was his contention that the case of appellant was to be examined on merits and the delay to be ignored.

At the outset, it noted that the judgments relied upon by learned counsel

are distinguishable which may not lend any support to the appellant in

the facts and circumstances of his case. Sub-Rule-4 of Rule-11-A of the

Khyber Pakhtunkhwa Police Rules 1975, makes mandatory for an official

to invoke the jurisdiction of revisional authority within thirty days of the

order passed on his appeal. The appellant squarely failed to prefer the

petition within the given time, besides, also not preferred to submit any

application for condonation of the formidable delay. The revision petition

submitted by the appellant on 04.09.2018, also appears to be more of a

mercy petition wherein sole prayer for restoration of increments has

been made.

In view of the above and also the judgments reported as 2006

SCMR 453 and 2012 SCMR 195, the appeal in hand does not merit

admission for regular hearing, hence is dismissed in limine.

PRAYER:

That on acceptance of this appeal the impugned order dated 02-11-2016 may very kindly be modified/rectified to the extent that the three increments be restored with all back benefits, the intervening period w-e-f 04-10-2016 to 02-11-2016 may kindly be regularized or treated the said intervening period as leave of the kind due and the appellant may also be transfer back to his previous place of posting i.e. District Swabi. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

R/SHEWETH: ON FACTS:

Brief facts giving rise to the present appeal are as under:

- 1. That the appellant was appointed as constable in the respondents Department in the year 1994, promoted to the post of Assistant Sub-Inspector in 2012 and finally to the post of Sub-Inspector in the year 2017.

- 6. That the Revision Petition/Appeal was filed/Regretted by the Worthy Inspector General of Police vide order dated 13-09-2018 on technicality that the Revision Petition/Appeal is time bared for about one year and ten months. Copy of the Revision Order dated 13-09-2018 is attached as annexure.
- 7. That having no other remedies the appellant preferred present service appeal on the following grounds amongst others.

GROUNDS:

- A- That the impugned orders dated 02-11-2016 and 13-09-2018 are against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be modified/rectified.
- B- That appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the constitution of Islamic Republic of Pakistan 1973.
- C- That no charge sheet and statement of allegation has been provided to the appellant before initiating the inquiry, hence the whole procedure adopted by the respondents is doubtful and void, therefore, is to be vitiated.
- D- That the respondents acted in arbitrary and malafide manner while issuing the dismissal order followed by the impugned appellate and revision orders.
- E- That during inquiry statements of some of the officials had been recorded, wherein, all of them had categorically stated that neither the appellant had illegally confined the complainant in the FIR-313 nor any unethical words had been used during investigation. Copies of the statements of the officials are attached as annexure......
- F- That no complaint whatsoever had been lodged against the appellant during service as is manifest from the Annual Confidential Reposts of the year 2015 and 2016. Furthermore, high ups in the remarks column marked the appellant as Good and Hardworking Police officer. Copies of the ACR is attached as annexure.
- G- That it is pertinent to mentioned here that the accuse in the case FIR-313 was found innocent during the inquiry after the medical reposts came negative and was discharged from the charges leveled against him. Copy of the medical report and discharge is attached as annexure.
- H- That the impugned order dated 02-11-2016 is against the spirit of F.R-26, therefore, is liable to be modified/rectified.
- I- That no chance of personal hearing and personal defense has been provided to the appellant.
- J- That the appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed far.




