

Prayer:-

On acceptance of the Service Appeal the impugned orders based on wrong fixation of seniority may be set aside and appellant being senior to private Respondent No.5 may be promoted to the rank of ASI driver.

Facts forming the background of appeal are as follows:-

That appellant was recruited as constable in Police department in the year 1987. Appellant was experienced driver therefore, in the year 2001, appellant submitted written application before Respondent No. 3 for transfer to M.T staff which was accepted and appellant was transferred to M.T staff vide order bearing OB No. 106 dated 29.12.2001.

Copies of the application and order are enclosed as Annexure-C & D respectively.

2. That appellant was promoted to the rank of head constable in the year 2009 and seniority of driver head constables were controversial therefore, Respondent No. 2 constituted a committee comprising DSP/Legal Kohat and PSO to DIG Kohat. The committee submitted written report dated 09.12.2015 wherein appellant was declared senior to Yaqoob Nawaz private Respondent No. 5. Copy of the decision of committee is enclosed as Annexure-E.

That later on a committee comprising of Respondents No. 3 & 4 held a meeting dated 31.12.2015 and appellant was made junior to private Respondent No.5 on wrong assumption of date of entry into M.T staff and appointment as constable. Copy enclosed as Annexure-F.

4. That the committee did not consider the break in service of private Respondent No. 5 who was convicted in murder case and was dismissed from service vide order dated 31.12.1992. He remained out of service with effect from 31.12.1992 till 13.04.1999. He was reinstated in service on his acquittal from murder charges on the basis of compromise.

That appellant is in possession of heavy driving license and has also qualified SSC examination, while private Respondent No. 5 is in possession of LTV and he is under metric and committee did not take into account the seniority accrued to appellant against the private Respondent No. 5 on the basis of higher qualifications That Respondent No. 2 while relying on the decision

That Respondent No. 2 while relying on the decision of committee comprising Respondent No. 3 & 4 issued promotion order of private Respondent No.5 to the rank of ASI Driver vide impugned order dated 07.01.2016.

That appellant submitted representation before Respondent No.1 through proper channel against the

above decision but the representation was withheld by Respondent No.2 vides impugned order dated 03.02.2016 and did not forward it to Respondent No.1. Hence the appellant submits the service appeal on the following grounds for restoration of seniority and promotion to the rank of ASI driver.

#### **GROUNDS:-**

C.

A. That the impugned orders have wrongly been based on decision of committee comprising Respondent No. 3 & 4 as the said committee did not bother to examine the record. Appellant was enlisted in M.T staff in the year 2001 while private Respondent No. 2 was enlisted in M.T staff in the year 2002. The entire service of appellant was regular and continuous while private Respondent No. 5 remained out of service for long period and the committee did not take into account the break in service of private Respondent No. 5. In the same vein the committee also ignored the higher qualifications of appellant as compare to private Respondent No.5. Therefore, the impugned order based on wrong decision of the committee is worth set aside.

That appellant is senior to private Respondent No. 5 as evident from the decision of the committee dated 09.12.2015 which was constituted for fixation of the controversial seniority of driver head constables. Furthermore, appellant was promoted to rank of head constable in the year 2009 while private Respondent No. 5 was promoted to the rank of head constable in the year 2010. Therefore, appellant rank senior to private Respondent No. 5 in all respects.

That Respondent No. 2, 3 & 4 without taking into consideration the proved seniority of appellant, wrongly showed private respondent No. 5 senior to appellant and promoted him to the rank of ASI driver vide impugned order. Therefore, the impugned orders are worth set aside.

- D. That in view of the option of appellant for transfer to M.T staff prior to private Respondent No. 5, appellant rank senior to him.
- E. That appellant was promoted to the rank of head constable earlier than private Respondent No. 5, therefore, appellant rank senior to him.
- F. That the decision of committee comprising DSP/Legal Kohat and PSO to DIG Kohat was denied without any reasons and grounds. Therefore, the impugned orders were wrongly passed.

It is therefore prayed that the impugned orders may be set aside and seniority of appellant may be restored and appellant may be promoted to the rank of ASI driver vice private Respondent No. 5.







#### Respectively Sheweth:-

Parawise comments are submitted as under:-

#### Preliminary objections:-

- 1. That the appeal is not maintainable in the present form.
- 2. That the appellant has got no cause of action and locus standai to file the appeal.
- 3. That the appellant has not come to this Hon: Tribunal with clean hands.
- 4. That the appeal is badly time barred.
- 5. That the appeal is bad for misjoinder of unnecessary parties and non-joinder of necessary parties.

#### Reply on Facts:-

- 1. Pertains to record.
- 2. Incorrect. Infact appellant was promoted to the rank of HC in MT Staff on adhoc basis w.e.from 08.10.2009 and was adjusted as driver HC on 15.01.2015. Furthermore, due to controversy in the seniority list of MT staff observed by the Departmental Promotion Committee held on 04.10.2015 the DPC constituted committee comprising of DSP Legal Kohat and PSO to DIG Kohat to examine the seniority of MT staff. According to criteria for preparation of seniority list of MT staff, the seniority of MT staff will be determine from the date of entry to MT staff of regular constable and date of enlistment of driver constables. The perusal of relevant record revealed that appellant was enlisted as regular constable and joined MT staff on 05.08.2003 whereas private respondent No. 5 being entrusted as regular constable and joined MT staff on 27.06.2002. Therefore according to the criteria the appellant was junior to respondent No. 5.
- 3. Correct to the extent that committee meeting was held on 31.12.2015 the remaining portion of the para is incorrect because senior most official was considered for promotion whereas appellant was joiner according to criteria mentioned in the previous para.
- 4. Incorrect. Infact the seniority of the appellant and respondent No. 5 was determined from the date of their joining to MT staff. The appellant is junior to respondent No. 5. Furthermore, the break in service of private respondent as mentioned by the appellant in this para was prior to their joining to MT staff of the district.



- 5. Incorrect. The qualifications or driving license is not the criteria of determining the seniority of the officials of the MT staff.
- 6. Pertains to record.
- 7. Pertains to record. However, reply on the grounds are as under:-

#### **Grounds:-**

- A. Incorrect. The orders were passed by the Authority in accordance with law & rules. Furthermore, the appellant initially transferred as driver in MT staff on 29.12.2001 but he was transferred back to Police Lines on 07.01.2003. After that he was posted to MT staff on 05.08.2003. According to record has regular period in MT staff was considered from 15.08.2003, whereas respondent No. 5 junior to MT staff on 27.06.2002, therefore, the appellant is junior to respondent No. 5.
- B. Incorrect. The appellant is junior to Respondent No.5 according to seniority list prepared in accordance with law & rules and purely on merits. Furthermore, both appellant and respondent No. 5 were adjusted as driver HC w.e.from 13.01.2015. Copy of order vide OB No. 30 dated 15.01.2015 enclosed as annexure "A".
- C. Incorrect. The order of promotion of respondent No. 5 was passed by Authority according to seniority. The appellant was junior to respondent No. 2 therefore, orders are sustainable.
- D. Incorrect. According to criteria of determining the seniority of MT staff, the appellant is junior to Respondent No. 5.
- E. Incorrect. Infact appellant & respondent No. 5 were promoted as HCs purely on adhoc basis respective w.e.from 08.10.2009 and 03.12.2010 but both of them were adjusted as driver HC to MT staff w.e.from 13.01.2015 vide OB No. 30 dated 15.01.2015. copy of the order has already been enclosed as annexure "A".
- F. Incorrect. Infact the committee submitted its report regarding criteria of determining the seniority of MT staff. According to criteria and relevant record appellant was junior to respondent No.5. therefore, the order of the Authority or sustainable.



Per terms and condition of the appointment letter appellant is a civil servant for all purpose and intent civil servant and governed by rules of civil servant Act, 1973, the Khyber Pakhtunkhwa Service Act, 1973 has provided remedy in case of any adverse action. Appellant seniority has been miscalculated and placed junior

therefore appellant has very prima facie, cause of action and locus standi the present appeal has been field after observing all the codal formalities. All the necessary parties has been properly arrayed as respondents. Appellant has placed all the material facts before this Hon'ble Tribunal and nothing has been concealed in this respect. No principle of estoppels his against the appellant.

## ON FACTS:

- 1. That as per reply given in the comment to Para No.1 pertain to record hence needs no rejoinder.
- 2. That reply given by the answering respondents to Para No.2 of the appeal is wrong, baseless, misleading an incorrect, it is further submitted that the appellant was transferred to MT staff vide order bearing No.OB No.106 dated 29.12.2001 and was promoted to the rank of Hon'ble Court in the year 2009 and that due some controversy in the seniority list and through an application submitted to the consumed official a fresh committee was constitute comprsing SDP (legal Kohat) and PSO to DIG Kohat That as per this committee findings appellant was declared senior to Yaqoob Nawaz (reference to page-10 and 11 Annexure "E" of the appeal dated 10.11.2015)

Private respondent got driving license in year 2009 while the appellant got his valid driving license on 2001 means private respondent in much junior to the appellant.

- 3. That the reply given by the answering respondent to Para No.3 of the appeal is wrong and misleading as prior to DPC meeting held on 31.12.2015, on 10.11.2015 a controversy in the seniority committees held and gave its findings which is attached as annexure "A" with rejoinder and Page 10 and 11 Annexure-E of the appeal. According to this committee appellant is senior to private respondent No.5 the appellant has wrongly been placed junior to respondent No.5.
- 4. The reply given Para No.4 of the appeal, the reply is not correct and misleading; Appellant has joined MT staff much earlier/prior form the date of joining of the private respondent No.5 to MT Staff. The whole reply is denied.
- 5. That the reply to Para No.5 of appeal is also wrong and not correct. Without driving license how a pension can be posted as MT staff driver.
- 6-7 The reply has not been given. Hence needs no rejoinder

# 4

## GROUNDS:

- A. That reply given the respondent No.1 to 4 to ground A of the appeal is not based on proper appreciation and consultation of the record. The competent authority has not passed the seniority and promotion order in accordance with law and rules. It is further added that there is no break of service of appellant in staff and appellant is not joiner to the private respondent No.5.
- B. - C-D That replies given by the respondent to ground C & D are incorrect, wrong and misleading, the promotion order of the private respondent No.5 by the further is not according to seniority and not according to creation therefore the impugned order is not sustain.

- E. That reply to Ground E of the respondents is not correct, misleading and wrong hence denied while ground E of the appeal is correct.

In view of the above rejoinder, it is prayed that appeal of the appellant may please be accepted and allowed and the impugned promotion order may please be set aside.

It is pertinent to mentioned here, that previously with reference to the office of Regional Police Officer, Kohat Endst: No. 8019-23/EC dated 10.11.2015 regarding of minutes of meeting of Departmental Promotion Committee dated 04.10.2015, DSP Legal Kohat and PSO to DIG Kohat submitted report dated 09.12.2015 regarding seniority of driver HCs of Hangu District. In the light of report of MTO Hangu that no entry of Yaqoob Nawaz HC/ASI driver was made in MT staff, whose seniority was considered from the date of adjustment as HC Driver i.e 15.01.2015 and applicant Driver HC Mujahid Kareem was suggested senior to him. But Competent Authority did not agree and examined the relevant record of office of SRC/OHC Hangu District prior to DPC and found entry of Yaqoob Nawaz driver HC in MT staff on 27.06.2002. Accordingly, Yaqoob Nawaz driver HC was declared senior and subsequently promoted to the rank of ASI driver vide RPO Kohat order Endst: No. 261-62/EC dated 07.01.2016.
