

4. That his date of birth was mistakenly / inadvertently mentioned by respondents in the service book as 01.07.1964 instead of 01.02.1967 which was later on corrected by the department and this was the reason that department admitted their fault by correcting his date of birth
5. That now department is again denying his correct date of birth as 01.02.1967 instead of 01.07.1964 which act of respondents is illegal, against the facts and record and also without lawful authority.
6. That his grievance is genuine one and being a poor person on one hand while the whole family is depending upon him on the other hand and as evident from documentary evidence in the form of old and new CNIC coupled with school leaving certificate as well as metric certificate plus correction already made, there is no legal bar on acceptance of petitioner grievance.
7. That the appellant preferred departmental appeal to the respondent on 17-05-2019 which was entered vide dairy No 211/E dated 17.05.2019 wherein he requests the respondents to accept the correct date of birth in their record but the respondents refused and even do not bother to reply till date, hence the appellant has no other adequate remedy but to knock the door of this honourable tribunal because the appellant valuable rights are involved hence, prefers the instant appeal on the following grounds amongst others:-


GROUND

1. That respondent are not acting in accordance with law and are taking illegal acts with ulterior motive and malafide intention by not accepting the appellant date of birth as 01.02.1967 though already corrected by the respondents in his service documents, hence the refusal on the part of the respondents without any cogent reason.

2. That on the principle of locus potentia the appellant is also entitled for the relief claimed.
3. That the appellant applied to the respondents department having valid educational testimonial and CNIC showing appellant's correct date of birth but the respondents malafidely refuse to accept the same and directed verbally the appellant to file service appeal before the Service Tribunal on the pretext that the cutting made in his service book by the department for the purpose of correction is not acceptable to AG Office.
4. That valuable rights of the appellant are involved but the respondents are bent upon to deprive the appellant of them which shows malafidy and ulterior motives on the part of respondents.
5. That others grounds will be raised at the time of arguments

It is therefore requested that on acceptance of instant appeal, the respondents be directed to accept / correct date of birth of the appellant as 01.07.1964 instead of 01.02.1967 in service record and service book etc as already corrected by the respondents and their refusal in this regard is illegal and against the record and any other relief as may be deemed proper and just in circumstances of the case may also be granted in favour of the appellant.
