**Subject: MINUTES OF THE MEETING OF STANDING SERVICE RULES
COMMITTEE HELD ON 30.08.2023**

I am directed to refer to your office letter No.SO(Estt)/FE&WD/V-465/2023/S.R/PFI/15655, dated 14-11-2023, on the subject noted above and to state that the agenda regarding amendment in service rules of Pakistan Forest Institute (PFI), Peshawar against the post of Extension Specialist (BPS-18) was discussed in Standing Service Rules Committee (SSRC) held on 30.08.2023, however the decision on the said agenda not reflected in minutes of the meeting issued by Establishment Department vide Section Officer (Policy) letter No. SO(POLICY)/E&AD/2-69/2022, dated 30-10-2023, received to this office under your said letter.

Furthermore, it is pertinent to mention that Mr. Zahid Mehmood, Executive Officer, PFI, Peshawar filed Service Appeal No.8824/2020 in Hon'ble Khyber Pakhtunkhwa Service Tribunal, Peshawar. The said court disposed off the said appeal on 10-01-2024 (**copy attached**). The operative part of the judgment is reproduce as under:

"The representative further submitted that last meeting was held on 30-08-2023 in this respect but the decision on the request of the department was not reflected in the minutes. He further submitted that the department was again making a request that if any decision was taken regarding the proposed amendment, the same might be communicated to the department. In case no decision was made, the department would again agitate the matter, so that rules could be amended in the SSRC meeting. Upon, this, the learned counsel for appellant does not press this appeal. It is, however, expected that department will expeditiously pursue the matter, so that the grievances of the appellant could be redressed at the earliest possible".

In view of the above, it is requested that to please approach Establishment Department, Government of Khyber Pakhtunkhwa with the request to provide the decision of the SSRC on the said agenda for further necessary action accordingly.
