DISCRIMINATORY AGAINST THE RULES, TERMS &
CONDITIONS AND UNCONSTITUTIONAL TO THE
EXTENT OF SERIAL NO.2, 3 & 4 AND THE
APPELLANT BE DECLARE TO BE PROMOTED.

Respectfully Sheweth:-

FACTS

Facts of the instants appeal are as under.

1. That, appellant retired from Police Department of Khyber Pakhtunkhwa on 04.09.2022.
2. That, the appellant was confirmed as sub inspector after approval of the departmental promotion committee held on 09.10.2017 as the appellant had completed his two year officiating/probation period and fulfilled the laid down criteria under police rules and was allotted region number H/199 vide

order No.23242-63/E dated 10.10.2017
Abbottabad.

3. That, the appellant after confirmation & perform his official duties with greet zeal and zest as Sub Inspector from promotion order and appellant was brought on list "F" at Serial No.1 and 2 after recommendation of the departmental promotion committee dated 28.11.2018 and notification No.127 E-III, Admission to list "F" dated 11.01.2019 was issued in this respect by Respondent N. 2, 3 & 4.

4. That, on 22.02.2022 a list of 400 candidates to be promoted as sub-inspector who already in list "F" to the rank of offg: Inspector submitted. On the said list the appellant was placed at serial No.92.

5. That, the Appellant name was placed on serial No.182 as per seniority and respondents No.6, 7 are on serial No.208 and 219 respectively and Respondent No.8 was not included place in notification NO.127 dated 11-01-2019.

6. That, Appellant also appear in person before respondent No.4 but not heard

7. That, respondent No.1 vide notification No.641 E- III Admission to List "F" dated 30.03.2022 promoted respondents No.6 to 8 and the appellant was ignored in above notification.

8. That, the appellant being eligible and entitled from all respect to be promoted to the rank of inspector filed an application before respondent No.5 for promotion on 14-07-2022 through SP Investigation Abbottabad.

9. That, the appellant feeling aggrieved from the above notification of promotion fill revision/departmental appeal Diary No.4383/CPB dated 12.09.2022 before respondent No. 4 but neither called for hearing nor any written response was made by appellant.

10. That, appellant when approached the office respondent No.4 of the AIGP Establishment. In the office one Mst. Azra Bibi & Clerk Saadat Khan told the Appellant that his application is consigned in office.

11. That, appellant also filed application for providing attested, copies according to law & rules but the official of respondent No.4 of AIGP refuse to do so.

12. That, the appellant being aggrieved from the order/notification ran from pillar to pillar

but in vain, hence appellant challenged the notification through instant appeal on the following amongst other grounds.

GROUND

- A.** That, the promotion notification No.641 E-III admission to List "F" dated 30.03.2022 is wrong, illegal, perverse discriminatory, against the rules to the extent of respondents No.7 to 9 hence not maintainable by law and liable to be struck down.
- B.** That, the appellant has not been provided equal treatment when there is no expense inhibition against him under the law and has also not been given equal protection of law, which is against the principles enshrined in Articles 4 & 25 of the Constitution of Islamic Republic of Pakistan, 1973.
- C.** That, the appellant has been subjected to injustice and the case of appellant has not been dealt with under the principles of fair play.

D. That, the impugned notification of respondents No.3 & 4 and also the procedure adopted is wrong in exercised of excess of jurisdiction and misapplication of clear rules.

E. That, the impugned notification of respondents No.3 & 4 depict that respondents 3 & 4 mad pick & choose from the seniority list order No.127 F-III admission to list "F" dated 11.01.2019 and others which is against the settled laws and rules of seniority in service and no legal footing hence in-effective upon the rights of appellat as in seniority list appellat name is an serial NO.182 and respondents No.7 & 8 are on serial No.208 & on 219 respectively and the name of respondent No.9 is nowhere placed in seniority list.

F. That, the impugned notification is in violation of rules, statutory provisions as well as the dicta of superior courts hence the same need to be corrected.

G. That, this Honourable Tribunal is competent and has powers to adjudge the matter under appeal.

H. The, other grounds/points will be raised
at the time of arguments with permission
of this Honourable Tribunal.

-:PRAYER:-

It is therefore most humbly prayed that, On acceptance
of the Instant appeal the promotion notification No.641
E-III Admission to List "F" dated 30.03.2022 is declare
Wrong, void, Perverse, Illegal, discriminatory against
the rules, terms & Conditions and unconstitutional to the
extent of serial No.2, 3 & 4 and the appellant be declare
to be promoted.

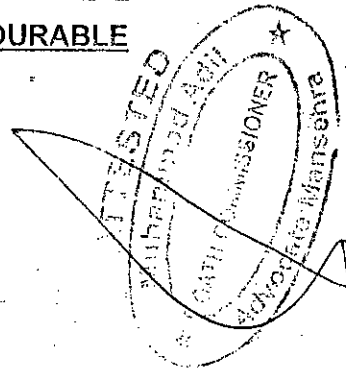




