



**APPEAL U/S 4 OF THE KHYBER
PAKHTUNKHWA SERVICE TRIBUNAL
ACT, 1974.**

Respectfully submitted;

1. That the petitioner being bonafide resident of the then Agency and now Merged District of North Waziristan and fully qualified was duly appointed as PTC (BPS-07) at GGPS Mir Rehman Kot, vide appointment order issued by respondent No.4 as Agency Education Officer (post-merger) dated 12.04.2006. (Copy of the CNIC, Domicile certificate and the appointment order are annexure A, B and C respectively)
2. That petitioner thereafter fulfilled all the requisite formalities including medical/ character certification and surety bonds etc,

assumed the charge and started performing her duties with utmost zeal and to the entire satisfaction of his superiors and public as well and was promoted from time to time and is now posted as CT (BPS-15) at the same posting area. (Copy of appointment order in the present pay scale is annexure D) *copy of Service book is D-1*


3. That during the course of her service the appellant got married in 2008 and her spouse Mr. Kashif Khan is a permanent employee in PESCO Peshawar and permanent resident at Peshawar. (Copy of the spouse service certificate is annexure E)
4. That since her initial posting and even after her marriage, the appellant has been serving at the same place of posting and initiated her inter district transfer desire on the basis of spouse posting policy in 2018, from her present place of posting to Peshawar District on any available post. (Copy of the application for transfer under the spouse policy dated 26.12.2018 is annexure F)
5. That however, no response was given by the concerned office/ respondents to the above referred request of the appellant compelling her to apply again for the same purpose in the year 2021 which was duly recommended by the relieving officer and endorsed by the receiving office with certificate of availability of appropriate post at Mohmand District adjoining the Peshawar District. However, the respondents issued yet another NOC for inter district transfer wherein appellant was approved for a post at Peshawar District under the spouse policy. (Copy of the application for transfer under the spouse policy dated 01.07.2021 and fresh NOC issued on 14.04.2023 as per demand of Director Office E&SE is annexure G/G/1).
6. That the sought relief not forthcoming from the respondents, the appellante despairingly approached other relevant authorities for grant of her right of transfer under the spouse policy but despite their strong and legitimate recommendations the respondents did not accede to her rightful demand without disclosing any reason at all. (Copies of the recommendations and forwarding letters are annexure H-1 to H-2) ✕
7. That finding no other alternative the appellant submitted a departmental appeal to respondent no. 3 on 23.10.2023 but despite passage of the statutory period no response was given, hence this appeal. (Copy of the departmental appeal is annexure I)

8. Feeling aggrieved by the above, the appellant now approach this honourable tribunal for allowing transfer & posting on spouse policy as prayed for, on the following inter alia grounds;

GROUNDS


- a. Because the appellant is lawfully entitled to be transferred and posted at Peshawar District under the spouse posting policy of the government and its refusal by the respondents is illegal and unwarranted, hence not tenable.
- b. Because there exists no bar or impediment in granting the desired posting under the government policy, hence the refusal is violative of the standard government policy and fundamental rights guaranteed by the constitution to the appellant.
- c. Because the impugned refusal to treat the appellant in accordance with law/ policy is arbitrary, whimsical, perverse and violative of the natural justice and good governance.
- d. Because even otherwise the appellant has served for about 18 years on the same place of posting and is entitled to transfer as a matter of rule.
- e. Because if the prayed relief is not granted it would frustrate the very object of the policy of the government regarding spouse posting and transfer and will definitely stand against public interest.
- f. Appellant seeks permission to agitate further grounds at the bar.

It is, therefore, most humbly prayed that on acceptance of this appeal, the appellant may be transferred and posted at Peshawar District under the spouse policy of the government and in public interest, along with any other relief deemed appropriate please.

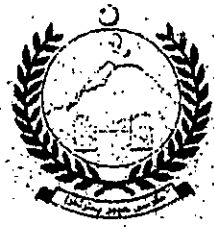

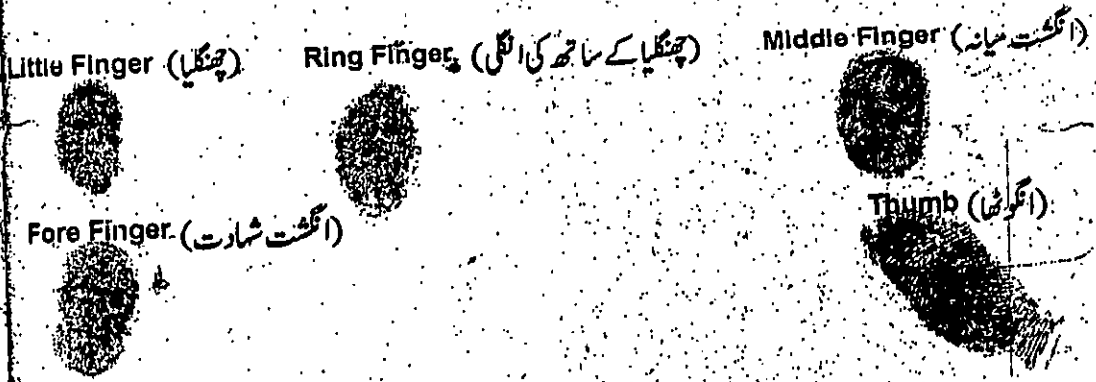
