Preliminary objections

- 1. That the appellant has no locus standi/cause of action to file instant appeal.
- 2. That the appellant is stopped to agitate the instant matter before this Honorable Tribunal.
- 3. That the appellant has not approached this Honorable Tribunal with clean hands.
- 4. That the appellant has filed instant appeal with malafide intention for wrongful gain and suppressing the original facts, from this Honorable Tribunal, hence the appeal is liable to be dismissed.
- 5. That the appeal is hopelessly time-barred.
- 6. That the appellant is treated as per rules and law and policy. Therefore appellant is not entitled for any relief and hence appeal is liable to be dismissed without further proceeding.
- 7. That the appellant file the service appeal to pressurize the respondents just to do unlawful act.
- 8. That the instant appeal is not maintainable in its present form.

- 9. That the instant appeal is against the law/service rules hence not raaintainable in the eye of law and liable to be dismissed.
- 10. That the appellant had already been willful/habitual absent during her service in various schools/posting stations vide the absent report sent by the PSHT GGPS Choona Kari dated 5-3-2020 along with staff attendance register of February, 2019 and logbook dated 5-3-2020. Similar, absent report sent by the concerned ASDEO (F) Abbottabad to SDEO (F) Abbottabad dated 5-3-2020. An explanation regarding the absent reports of appellant served to appellant by SDEO (F) Abbottabad vide No. 656 dated 26-3-2019. SDEO (F) Abbottabad also sent complaint/absent report of appellant to DEO (F) Abbottabad vide No. 248 dated 5-3-2020. Another, absent report sent by PSHT (GGPS Choona Kari) to DEO (F) Abbottabad vide dated 27-4-2020 and along with logbook dated 18-12-2020 and 16-2-2021. Another absent report sent by SDEO (F) Abbottabad to DEO (F) vide No. 1222 dated 19-2-2021 along with staff attendance register of February 2021. Show cause notice issued to appellant vide No. 2628-32 dated 9-3-2021 by DEO (F) Abbottabad. And in the light of show cause and personal hearing as outcomes of inquiries (Inquiry dated 4-5-2020 by the Principal Mst Saima Asghar, GGHS Kuthyala ATD) of appellant was rightly imposed major penalty that is compulsory retirement from the service (Efficiency and Discipline rule 2011) due to lack of interest and non-serious attitude that counted towards wastage of students precious time and public resources as well vide notification No. 4658-65 dated 20-5-2021 (Compulsory retirement) passed by the respondent No. 3. The appellant filed a departmental appeal to the respondent No. 2 against the impugned compulsory retirement order dated 27-5-2021. In the light of appeal forwarded by appellant, the respondent No. 2 decided for further probe into

the matter by the Ex DEO (M) Kolai Pallas vide No. 9419-20 dated 9-6-2021 and inquiry conducted by the ex DEO (M) K.P. Kohistan vide inquiry report No. 3 dated 7-7-2021. In pursuance of inquiry No. 03 dated 7-7-2021 and notification issued to respondent No. 3 to implement the recommendations of inquiry report vide No. 161/F.No.364/F/Appeal Abbottabad dated 16-8-2021. Respondent No. 2 issued the final notification to reduce "the major penalty of compulsory retirement into minor penalty of degrading to appellant from SPST BPS-14 to PST BPS-12 for the period of three years with immediate effect, vide No. 9925 dated 2-11-2021. Copy of relevant record is annexed as annexure "A" "B" "C" "P" "F" "G" "H" "I" "J" & "K"

11. That in pursuance of final notification (No. 9925 dated 2-11-2021) the departmental appeal filed by the appellant on 27-6-2022 which is hopelessly time-barred may kindly be dismissed as mentioned above.


Factual Objections

- 1. Para No 1 of service appeal as composed is incorrect, hence denied.

 Appellant was always habitually absent during her service, the absent reports sent by the PSHT GGPS Choona Kari dated 5-3-2020 and 27-4-2020 along with logbooks dated 5-3-2020, 18-12-2020 and 16-2-2021. And staff attendance register 2019, explanation sent to appellant by SDEO (F) Abbottabad vide No. 656 dated 26-3-2019. In the light of absent and inquiry (dated 4-5-2020 and 7-7-2021) reports is the result as minor penalty.
- 2. Para No 2 of service appeal is incorrect, hence denied. Detailed reply have already been given in Para 10 of the preliminary objection in the comments.

- 3. Para No 3 of Service Appeal is as composed is incorrect hence denied. Final order was issued and received by the appellant after three days for the purpose of charge in the said school. Therefore departmental appeal and service appeal in hand is time-barred and hit under the limitation Act, may kindly be dismissed.
- 4. Para No 4 of the service appeal is composed as incorrect and denied. That the departmental appeal filed by the appellant dated 27-6-2022 whereas final order was passed on 22-11-2021 which is hopelessly time-barred and may kindly be struck down.

GROUNDS:



- A. That Para A of the ground is incorrect and denied in the light of absent reports, staff attendance register, logbook, personal hearing and inquiry reports. The order passed by the DEO (F) Abbottabad dated 02-11-2021 in accordance with law and rules on the subject.
- B. That Para B of the ground as composed is incorrect hence denied.

 Detailed reply have already been given in Para A of the ground in the comments.
- C. Para C of the ground as composed is incorrect hence denied. Previous history/record regarding service of appellant being habitual absent, willful disobedience, lack of interest, mismanagement in school timing and belongs to a political family is the result of impugned order which is passed by the competent authority in accordance with the interest of children and their learning aspects as well as under the rules and policy on the subject.
- D. Para D of the ground as composed is incorrect hence denied. In the instant case departmental appeal as well as service appeal of the appellant is the time barred and may kindly be struck down.

Phat the other points shall be agitated during her of arguments to the permission of Honorable Court.

It is therefore humbly prayed that the instant Service Appeal in the light of comments may graciously be dismissed throughout with cost.

In compliance of your office notification No. 9419-20/F.NO.364/F.Apeal/Atd. Dated Peshawar the 09.06.2021 on the subject cited above. The undersigned visited the DEO (F) Abbottabad office on 16th and 17th June, 2021 after proper intimation to the above mentioned female teachers and the DEO (F) Abbottabad Vide letter no.01 and 02 dated · 15.6.2021(Annex:01) to probe into the matter.

Brief History.


District Education Officer (F) Abbottabad, the competent authority vide Notification No. 4658-65 dated 20.5.2021, imposed major penalty of Compulsory Retirement as per rule 4(b) of E&D rules 2011, vide notification no.4658-65 dated 20.5.2021,upon Ms. Alia Jadoon ,SPST GGPS Chonakari Abbottabad due to her long and habitual absence from her duty as reported by SDEO Abbottabad and circle ASDEO Abbottabad in the light of a fact finding inquiry.

The teacher concern used her right of appeal before the Director E&SED Peshawar, the appellate Authority as per rule and before deciding the case the respected Director E&SED decided to further probe into the matter and directed the undersigned to probe into the matter.

Procedure

1. The respected teacher Ms. Alia Jadoon was requested through letter to submit her written defense and appear before inquiry officer in the presence of representative of the DEO (F) Abbottabad in the office of DEO (F) Abbottabad.

2. The DEO (F) Abbottabad was requested by letter to nominate a representative to provide the relevant record in this regard.



3. The teacher Ms. Alia Jadoon was given a conducive environment of personal hearing to cross examine the record and allegations in the presence of representative of DEO(F) Abbottabad.(Anex .2)

4. The written statements of SDEO atd. and the circle ASDEO atd against Ms. Alia jadoon were examined and discussed during the personal hearing of the respected teacher Ms. Alia jadoon.

5. The circle ASDEO atd. Briefed the undersigned regarding late coming of the teacher Ms. Alia Jadoon during her visit to her school.

6. All the relevant record, Photocopies of relevant documents, EMA reports e.t.c and supportive environment provided by representative of DEO were carefully observed.

7. Interviews and briefings.

Findings

1. A fact finding inquiry regarding habitual absenteeism of Ms. Alia Jadoon SPST was conducted one and a half year ago before the latest proceedings i.e on 10.03.2020 and inquiry report submitted on 04.5.2020 by the inquiry officer in which the inquiry officer recommended for proceeding against the mentioned teacher but no proceeding was initiated in the light of recommendations of inquiry till 9.3.2021 when a show cause notice was served to the concern teacher for her absence from duty for one day on the report of SDEO atd.

2. A personal hearing of the concern teacher was conducted on 11.5.2020 without any show cause notice and this personal hearing even was not decided by the competent authority till a fresh show cause notice for absence from duty of a single day i.e 16.02.2021 as reported by SDEO atd. A personal hearing by a committee rather the DEO herself, was conducted on 29.03.2021 and a final decision of major penalty of compulsory retirement of the concern teacher was imposed by the competent authority.

3. No formal inquiry with clear charge sheet and statement of allegations, observing all steps / formalities of the regular/formal inquiry was conducted by the competent authority in the light of fact finding inquiry before imposing major penalty which can easily be challenged in any court of law and may be a source of ill reputation for Education Department.

4. As per written and verbal statement of the concern teacher, Ms. Alia Jadoon she has never been habitual absent from her duty and as her mother is seriously ill and she has to take care of her medicine that is why she often come late to school.(Annex.3)

5. The undersigned found a difference between written and verbal statement of the circle ASDEO about habitual absenteeism of the teacher concern as according to the

verbal statement of circle*ASDEO Ms. Alia Jadoon was late comer only due to the serious illness of her mother, rather than habitual absent. (Annex.4)

6. As per report of the SDEO atd the teacher concern was habitual absent.

7. Though the teacher concern was reported to be irregular, least interested in her professional duties and latecomer to school as per report of EMA, SDEO atd, Circle ASDEO, inquiry officers as well as her head teacher but it seems that she was not proceeded as per E&D rules 2011 especially for imposing major penalty, also there exists a difference between written and verbal statements as observe during

Recommendations

1. The teacher concerned be reinstated in service and the competent authority i.e the DEO (F) Abbottabad be directed to conduct a formal De novo inquiry with clear charge sheet and statements of allegation and observing all the formalities/steps of regular/formal inquiry in the light of the fact finding inquiry before final decision of imposing any major penalty as per rule 4(B) of E&D rules 2011 or new E&D rules 2020 in the light of recommendations of the regular/formal inquiry report if so OR

- The major penalty of compulsory retirement be reduced to Miner penalty of degrading the teacher concern from SPST_BS-14_to PST_BS-12 for a period of three years if agree please.
- 3. All the respected DEOs male and female be directed to conduct a regular inquiry before imposing any major penalty except for long absenteeism for which fule 9 of E&D rules 2011 can be applied without formal inquiry please.
- 4. A format of, Notice of being proceeded, charge sheet and statements of allegation with constitution of inquiry committee and final show cause notice be circulated in official WhatsApp groups for capacity boosting of respected DEOs please.
