Joint Para Wise Comments on behalf of respondents are submitted as under:-<u>PRELIMINARY OBJECTIONS</u>:-

- 1. That the appellant has no cause of action to file the instant appeal.
- 2. That the appellant has no locus standi to file the present appeal.
- 3. That the appellant did not come to this Honorable Tribunal with clean hands.
- 4. That the present appeal has been filed to pressurize the respondents.
- 5. That instant appeal is hopelessly time barred hence, liable to be dismissed.
- 6. That the instant appeal is not maintainable in its present form hence, liable to be dismissed.
- 7. That the appellant has suppressed the material facts from this Honorable Tribunal hence, not entitled for any relief and appeal is liable to be dismissed without any further proceedings.
- 8. That impugned order dated 05-08-2019 was issued after observing all the codal formalities hence, same is liable to be maintained.
- That as per Government of Khyber Pakhtunkhwa Finance Department (Regulation Wing) dated 05-10-2015, 05 years service length is pre-requisite for granting study leave to Govt Employees.

10.That the appellant left the school and proceeded to Dalian institute of Chemical Physics in China for her PhD on 27-08-18 without NOC and sanction/ permission of leave for the higher studies. Hence, impugned Notification dated 05-08-2019 was issued by competent authority after observing due process of law.

11.That appellant did not prefer departmental appeal to appellate as required in the light of notification No. SO(PE)/5-19/reinstatement/speaking order/2022 dated Peshawar the August, 15th 2022, to appellate authority under Section 04 of the Khyber Pakhtunkhwa Service Tribunal Act 1974 hence, instant service appeal is not maintainable in its present form.

Factual Objections:-

- 1. That Para No. 01, of the instant appeal pertains to record hence, need no comment.
- 2. That Para No. 02, of the instant appeal as composed is incorrect hence, denied. Appellant applied for study leave w.e.f 28-08-2018 to 30-08-2021 (3 years) to the respondent No. 03 through respondent No. 04 vide letter No. 419 dated 10-08-2018 and in pursuance to the Notification of Finance Department (Regulation Wing) dated 05-10-2015, respondent No. 03 returned the study leave case of appellant to respondent No. 4 vide letter No. 5921 dated 15-08-2018 with the remarks that appellant having less than 05 years of service cannot avail the study leave. (Copy of letter dated 10-08-2018, letter dated 05-10-2015 and letter dated 15-08-2018 are herby annexed as Annexure "A", "B" and "C" respectively).
- In reply to Para No. 03, of the appeal it is submitted that appellant left the school and proceeded to Dalian Institute of Chemical Physics in China for her P.hD on 27-08-2018 without NOC and Sanction/Permission of leave for the higher studies.
- 4. That the Para No. 04, of the appeal is correct to the extent of submission of application dated 18-08-2018 for grant of study leave without pay while rest of the Para as composed is incorrect hence, denied and not admitted. Respondent No. 4 intimated the absent report of appellant vide letter No. 423 dated 31-08-2018. (Copy of absent report dated 31-08-2018 is annexed as Annexure "D").

- 5. That Para No. 05, of the appeal as composed is incorrect hence, denied and not admitted as appellant broken the official hierarchy and Submitted an application to Respondent No.2 on 18-08-2018. (Copy of application dated 18-08-2018 is annexed as Annexure "E").
- 6. That the Para No. 06 as composed is incorrect hence, denied as replied above.
- 7. That the Para No. 07, of the appeal is incorrect to the extent of impugned order dated 05-08-2019 while rest of the Para as composed is incorrect hence, denied and not admitted. In response to letter No. 2183 dated 18-03-2019 of Respondent No.3, a show-cause Notice was issued by the Respondent No.2 being competent authority vide No. 5587 dated 20-03-2019 and appellant submitted her reply on 03-04-2019. (Copy of letter No 2183 dated 18-03-2019, show-cause Notice vide No.5587 dated 20-03-2019 are annexed as Annexure "F" & "G" respectively.
- 8. That the Para No. 08, of the appeal as composed is incorrect hence, denied and not admitted. Appellant did not prefer departmental appeal to the next higher appellate authority as Annexure "F" is silent regarding the name of the appellant authority and appellant did not annex the copy of postal receipt as a proof.

<u>GROUNDS:-</u>

- a. That ground a, of instant appeal is incorrect hence, denied. As per Govt of Finance Department (Regulation wing) dated 05-10-2015 05 years length of service is Pre-requisite for granting study leave to the government employees.
- b. That ground b, of instant appeal is incorrect hence, denied as replied above.
- c. That ground c, as composed is incorrect hence, denied and not admitted as opportunity of personal hearing was provided to appellant vide letter No.5271 dated 20-05-2019 but appellant intimated a letter dated 30-05-2019 wherein, she stated that she cannot appear for personal hearing and requested to condone her presence. (Copy of letter dated 30-05-2019 is annexed as Annexure "H").
- d. That the ground d, as composed is incorrect hence, denied and not admitted as above.
- e. That the ground e, as instant appeal is not maintainable as there is no Departmental appeal in the service appeal.

- f. That the ground f, as composed is incorrect hence, denied. Detail has been give
- g. This Honourable Tribunal has got no jurisdiction to entertain the instant *Porras* petition.
- h. No comments.

That answering respondents seek leave of this Hounourable Tribunal to raise additional points/grounds during the course of arguments.

Under the circumstance, it is very humbly prayed that in the light of above mentioned facts, appeal in hand may kindly be dismissed in favour of respondents with cost.


