# SERVICE APPEAL UNDER SECTION 4 OF SERVICE TRIBUNAL ACT, 1974.

## Respectfully Sheweth,

- 1)- That the appellant is serving as a Research Officer (BPS-17) in the office of the Directorate of Archives and Libraries, Government of Khyber Pakhtunkhwa, Peshawar since November 2007.
- 2)- That the appellant has submitted an application to the concerned office of the Secretary Higher Education Archives & Libraries Department on 07-09-20 23 regarding the issues related to the appellant's job whose meaningful intimation is still awaited. (Copy of the application is attached as annexture-1).
  - 3)- That in the application filed by the appellant, the appellant has raised very sensitive issues before high-ups related to the appellant's Job i.e the role of the Higher Education Archives & Libraries Department in mis-handling the affairs of the Directorate of Archives & Libraries, the issue of interference in the appellant's duties, worst condition of the record-rooms of the Administrative Departments, mishandling of the appellant's Seniority by the Higher Education Archives & Libraries Department and in this connection not forwarding the appellant's appeal to the Chief-Secretary Khyber Pakhtunkhwa, in violation of Standing rules the transfer of the appellant from the existing post that is non-transferable to other posts/places, wrongfully deduction from the salary of the appellant, the issue of mis-handling the PERs' case of the appellant as well as Reporting of the Eris of the appellant's subordinates by irrelevant bodies other than the appellant, the issue of Training related to the appellant's job, disappearance of the appellant's documents in the Office of the Higher Education Archives & Libraries

Department, the issue of the designated office of the post of Research Officer, stoppage of the official correspondence by the appellant's high-ups in connection to the issues related to the Job of the appellant, disturbance of the job structure of the post of Research Officer, the establish strange practice of joint seniority of different cadres in the Directorate, wrongful appointments, creation of posts and promotions as well as highlighted other irregularities with the following para-wise details.

In the para-1 of the appellant's application it is stated that on 14-07-2008, the appellant had made a written complaint to the Director Archives & Libraries regarding an incident that took place in the Weeding and publication Section of the Directorate of Archives & Libraries, but when confirmed that the Director Archives & Libraries was not going to take any action against the concerned quarter within the Directorate of Archives & Libraries, then due to emergency situation the appellant directly approached to the next higher Authority i.e. the Office of the then Secretary Higher Education, Archives & Libraries (HED). Next day, the then Secretary Higher Education Archives & Libraries Department, personally, visited the Weeding & Publication Section of the Directorate of Archives & Libraries and after few days, the appellant came to know about the transfer of the then Secretary Higher Education Archives & Libraries with no further legal action seemed to be taken against the concerned quarters. After this, one can easily imagine the situation that the appellant was facing at that time within the Directorate. Similarly, on dated 30-05-2009, the appellant had made a written request to the then Secretary Higher Education Archives & Libraries Department regarding the problems of Archives (enclosure "A"). In response, an enquiry was initiated against the appellant without the approval of the appellant's competent authority i.e. Chief Secretary, and the proper Official Visit-Report of the then Section Officer (C-IV Section) of Higher Education Archives & Libraries Department who on the instruction of the then Secretary Higher Education Archives & Libraries Department visited the Directorate of Archives & Libraries, met with the then Director Archives & Libraries and then wrote to the then Secretary Higher Education Archives & Libraries Department that according to the Director Archives & Libraries, everything is ok. After which the Secretary Higher Education Archives & Libraries issued instructions for taking action against the appellant. It is pointed out that the appellant during the official visit of the then Section Officer of C-IV Section Higher Education Archives & Libraries Department, practically, showed and proved before him each and every thing that had been stated by the appellant in the enclosure "A" in which the appellant had raised very basic points like running of sections without any charge responsibilities (handover/takeover activity), running of Periodical Section and Newspaper Section of Archives Wing without any written order and by a Peon respectively, non-availability of Officers of Archives Wing, lack of through proper channel administration etc. If the then Section Officer (C\_IV Section) had presented his complete Official Visit-Report before the then Secretary Higher Education Archives & Libraries Department, then the direction of the enquiry would be surely against others instead of the appellant. It is necessary to highlight that in the enclosure "A", the appellant had also pointed out the performance of the Preservation Section of the Directorate of Archives & Libraries, especially, the lamination of Record which after few months became crystal-clear when the in-charge of the Preservation Section of the Directorate of Archives & Libraries working as Preservation Officer (BPS-16) was caught red-handed by the National Accountability Bureau and then through plea bargaining was exonerated by the National Accountability Bureau. Without the information and approval of the Ex-Director and Ex-Deputy-Director Archives & Libraries etc how a Preservation Officer (BPS-16) could make corruption is a Question mark. Moreover, this Preservation Officer was so close to the high-ups that the Designated Office of the Research Officer of Archives Wing was occupied by him even when he was just a Preservation-Assistant (BPS-11). Many things will be crystal clear if the case is reopened. It is also pertinent to mention that the above mentioned Section-in-charge of Preservation Section was appointed in the Directorate of Archives & Libraries as Preservation-Assistant (BPS-11), but within few years and with the help of the then Director Archives & Libraries and without the consultations of the other officers of the Archives Wing, a new post of the Preservation Officer (BPS -16) was created for him and he got promotion. The above discussed fake and baseless inquiry was a heavy blow to the appellant's career, reputation and moral. Legal Action against those who deliberately mishandled the enclosure "A" may kindly be taken for fixing the responsibilities on the concerned bodies.

b) - In the Para-2 of the appellant's application it is stated that Interference in one's official duty is tantamount to rape and in this regard, the appellant had made a complaint to the appellant's high-ups (enclosure "B1") after which a letter dated December 2nd, 2015 from C-IV Section Higher Education Archives & Libraries Department (enclosure "B2") was served to the Directorate of Archives And Libraries, but still the appellant has no information about the status of the enclosure "B1". Details of the complaint are attached as (annexure "B3"). After the above mentioned complaint, the appellant was directed by the appellant's high-ups to arrange the record of the Litigation Section of the Higher Education Archive & Libraries Department that was in scattered form and due to the non-availability of the record on time for pursuing the case of the Higher Education Archives & Libraries Department in the Law Courts, the salaries of the then two Secretaries of Higher Education Archives & Libraries Department were stopped by the Court at that time. It is pointed out that, at that time, the Officer discussed in the enclosure "B1" was working as Litigation Officer in the Higher Education Archives & Libraries Department, not much sure about his proper official order in this regard. In order to avoid any disciplinary action against the appellant, the appellant did that task on time though it was not related to the appellant's Job Description. From this, one can easily get to know about an indirect message that was conveyed to the appellant from the appellant's high-ups and the situation that the appellant faced at that time through this task. Similarly, the Scanner of the Weeding and Publication Section of the Directorate of Archives & Libraries, whose administration belongs to the appellant, became disappeared in 2018. The Police not only recovered the Scanner, but also through CCTV camera of the Section caught redhanded the one Officer, who has already been discussed in the enclosure "B1, B2 & B3", and one Official. Both were, later on, released from the Police Station on the assurance of the then Director Archives & Libraries. The Officer was then exonerated by the then Secretary Higher Education Archives & Libraries Department (enclosure "B4") from any disciplinary action with just a warning. In case, he was not caught red-handed, the whole responsibility of the missing of the Scanner would fall upon the appellant's shoulders being the administrator of the Section. Here, it is pointed out that, at that very day when the incident took place, the Officer was appointed by the Office of the Higher Education Archives & Libraries Department against the then vacant post of the Deputy-Director Archives & Libraries on acting-charge-base and had yet neither received the Job Descriptions of the post of the Deputy-Director, nor had taken-over the charge responsibilities being an acting-Deputy-Director in the Directorate of Archives & Libraries. Actions speak louder than words, so one can easily evaluate who was on the target, through and by whom. In this connection, the contents of the application of the Ex-Deputy-Director Archives & Libraries (enclosure "B5") may need your kind attention, if the application is genuine. Moreover, it is the same Officer who, when unpunished time and again, became so bold that after his promotion to the post of the Deputy-Director Archives & Libraries, whose seniority has already been challenged by the appellant with details mentioned in the enclosure "E" and in the Para (d) / Para 4 of the application, prepared a letter (enclosure "B6") with the signatures of the two Research Officers of the Archives Wing against the appellant and the appellant's Job Description. Clause (i) in Para 1 of enclosure "B6" is the clear-cut violations of the Manual of the Secretariat Instructions while in Para 3 of the enclosure "B6", there is baseless statement against the appellant whose clarification on behalf of the appellant is available on the back of enclosure "B6". Even, calling the direct explanations (without the approval of the Director Archives & Libraries from the appellant with irritating words and baseless allegations against the appellant by the same Officer became a routine. Upon proper inquiry by the Government, the appellant will provide the details of other Officers too, who also from time to time have interfered and are still interfering in the official business of the Weeding & Publication Section of the Directorate of Archives & Libraries and the appellant's Job Description.

c) - In the para-3 of the appellant's application it is stated that from time to time, the

appellant's Job, like the appellant's Report about the Record, especially, of the Higher Education Archives & Libraries Department to the then Secretary Higher Education Archives & Libraries Department (enclosure "C") whose written intimation is still awaited. This report is enough in highlighting the worse condition of the Record and Record Rooms of the various Government Departments/bodies in the Province, especially, of the Higher Education Department, Finance etc. In this connection, some details are already mentioned in the (enclosure "D") that served as a copy to the PS to the then Secretary Higher Education Department in which the appellant had raised very sensitive points regarding the Directorate of Archives & Libraries; dully marked to the then Section Officer of C-IV Section Higher Education Archives & Libraries Department by the then Additional Secretary Higher Education Archives & Libraries Department, but , unfortunately, not put up by the then Section Officer(C-IV) before the high-ups, due to which one sided decision took place and the appellant got Warning and Counseling in the office of the then Additional Secretary(Dev) Higher Education Archives & Libraries Department on behalf of the then Secretary Higher Education Archives & Libraries Department. Without entertaining enclosure "D", in which the appellant had stated the details in the appellant's defense, legal Status of the above mentioned Warning and Counseling as well as not putting up the enclosure "D" before the high-ups by the then Section Officer (C-IV Section) Higher Education Archives & Libraries Department may need your kind attention. Here, It is necessary to point out that the enclosure "D" after submitting in the Office of the then Secretary Higher Education Archives & Libraries Department, disappeared in the Office of the then Deputy-Secretary Colleges Higher Education Archives & Libraries Department, after which the appellant submitted another copy of the enclosure "D" before the then Additional Secretary (Dev) Higher Education Archives & Libraries Department for onward process.

d) - In the para-4 of the appellant's application it is stated that every year, the Appellant record reservations on the Seniority List i.e. "my reservations are intact and still did not get any intimation of my appeal to the Chief Secretary Khyber Pakhtunkhwa (enclosure "E")". In the enclosure "E", the details about the deliberate disturbance of the appellant's Job Structure are mentioned. In the beginning one post of Research Officer (BPS-17) to be appointed by initial recruitment through Public Service Commission was sanctioned for the Directorate of Archives, then another Specific Post of Research Officer (BPS-17) with Specific Duties that to be appointed by initial recruitment through Public Service Commission was sanctioned for the Directorate of Archives. MA History was made mandatory as a qualification for both the Posts of Research Officers of the Directorate of Archives. After the initial appointments of two Research Officers through Public Service Commission against the above mentioned two Posts, in the Service Rules of the Directorate, 50% quota for the appointment of Research Officers was introduced and later on, MA History qualification criteria was also

removed for the Post of Research Officer that to be filled by promotion. As per the then Service Rules of the Directorate, the senior most among the incumbents of the two Research Officers was made qualified to be promoted to the Post of the Deputy-Director Archives & Libraries. In the recent past, another post of Research Officer (BPS-17) was sanction. It is to be pointed out that one Post among the three Posts of Research Officers is Specific with Specific duties and qualification criteria for appointment while the other two Posts of Research Officers are General Posts. Introduction of 50% quota and placing both Specific and General Posts of Research Officers in the Joint Seniority made very hard the chances of Promotion of the appellant. For example, the present incumbent of the Post of the Deputy-Director Archives & Libraries appointed as an Assistant Research Officer (BPS-16) in the Directorate that got promotion to the post of Research Officer, then promoted to the post of the Deputy-Director Archives & Libraries and now in the near coming months going to be promoted to the post of the Director Archives & Libraries while on the other hand the appellant appointed in the Directorate of Archives & Libraries against the Specific Post of Research Officer (BPS-17) with Specific Duties and qualification criteria for appointment as per existing Service Rules on 07-11-2007 and after serving more than sixteen years got not a single scale promotion. Keeping in mind, the qualification criteria of MA-History for the post of Research Officer that to be filled by promotion was abolished by the Ex-Director Archives & Libraries without consulting the Officers of the Archives wing of the Directorate of Archives & Libraries and without genuine reason that provided much chances of the misuse of authority in future like the Joint Seniority of the Posts of Research Officers and Assistant Directors, both being quite different cadres. The strange stance of the Ex-Director Archives & Libraries in a Court was that MA History qualification criteria for post of Research Officer that to be filled by promotion was abolished on the direction of the Public Service Commission. It is pointed out that upon the retirement of the ex-Deputy-Director Archives & Libraries in April 2018 and due to some deficiencies like PERs etc of the present incumbent of the Post of the Deputy Director Archives & Libraries, the Post of the Deputy-Director Archives & Libraries was occupied by the Officers of other cadres as well as outside the Directorate i.e. one from Library side and other from College side, for more than two years. Here, it is mentioned that according to the then Job Structure of the Directorate of Archives & Libraries , only the senior most Research Officer of the Archives Wing could be promoted and posted against the vacant post of the Deputy-Director Archives & Libraries. So in case of no disturbance in the appellant's Job Structure discussed above and not mishandling the PERs' case of the appellant by the appellant's high-ups, the appellant would be promoted to and posted against the then vacant post of the Deputy Director in April 2018 and then the appellant would be able in challenging under the Archival Act, 1993 and Archival Material (Preservation and Export Control) Act, 1975 as well as on the basis of the point of Reporting Officer of the Post of Research Officer of Archives Wing, the appointment of a Librarian cadre on the seat of the Director Archives & Libraries which became vacant in March, 2021. Moreover, in the recent past, the Posts of the Assistant Directors (BPS-17), a quite different cadre with quite different qualification and Job Descriptions, were created in the Directorate of Archives & Libraries and were placed at joint Seniority with the Research Officers of Archives Wing without consulting the Officers of the Archives Wing. Here, it is pointed out that both the posts of Research Officer and Assistant Director are two quite different cadres by every aspect from each other both qualification and Job Descriptions wise. Furthermore, Joint Seniority of Assistant-Directors and Research Officers is going to block the promotion chances of the Research Assistant (BPS-12), Assistant Research Officer (BPS-16) and delay much the promotion chances of the Research Officers of the Archives Wing. Similarly, Joint Seniority of the Post of the Deputy-Director (BPS-17) Archives & Libraries and the Chief-Librarian Archives & Libraries (BPS-18), that are two different cadres by all aspects from each other, also adversely affect the Archives. In the enclosure "E" the issue of upgradation of Librarians on the basis of qualification is also highlighted. On the basis of qualifications, the Staff of the Archives Wing like Librarians of the Library Wing was also required to be upgraded with back date benefits as both wings belong to the same Directorate. The appellant has also informed through various correspondences, from time to time, the Officers of the office of the Secretary Higher Education Archives & Libraries Department about not forwarding the appellant's appeal to the Chief-Secretary Khyber Pakhtunkhwa. The issue of forwarding enclosure "E" to the Chief Secretary may need your kind attention.

## e) - In the para-5 of the appellant's application it is stated that in response to a letter

from C-IV Section Higher Education Archives & Libraries Department (enclosure "F") regarding the notification of the Final/Updated Joint Seniority List of the Posts of the Research Officer of Archives Wing and the newly created Posts of the Assistant Directors, the Director Archives & Libraries issued a letter (enclosure "F2") on 29-06-2019, for submitting written observations on behalf of the appellant within 03days of the issuance of the enclosure "F2". The appellant submitted his reservations (enclosure "F3") in the Directorate of Archives & Libraries as well as in the CIV Section Higher Education Archives & Libraries Department on 01-08-2019. Moreover, in connection to the disputed seniority list, two meetings were also held i.e. one in the office of the then Additional Secretary (Dev) Higher Education Archives & Libraries Department (enclosure "G1") and other in the office of the then Deputy-Secretary (Litig) Higher Education Archives & Libraries Department (enclosure "G2"), but the appellant received neither any minutes of both the meetings, nor any-letter regarding the outcome of the above mentioned two meetings. Legal Status of the Notification of the Final/Updated Joint

Seniority List of the Posts of Research Officers and newly created Posts of Assistant Directors as well as outcome of the enclosures "G1" & "G2" may need to be in your kind attention.

- f) In the para-6 of the appellant's application it is stated that on 10th January, 2014, the appellant's services were placed at the disposal of the Director Higher Education Teacher Training Academy now (HEART) at Govt. Degree College for Boys, phase 6, Hayatabad (enclosure "H") by the Higher Education Archives & Libraries Department. In this connection, the appellant met with the then Secretary Higher Education Archives & Libraries Department who verbally directed the appellant to go there just for few weeks, but it took roundabout 10 months and then after a lot of correspondences, at last, the appellant repatriated to the Directorate of Archives & Libraries with a good performance certificate from the Director Higher Education Teacher Training Academy (HETTA) on the demand of the Higher Education Archives & Libraries Department. If that was a deputation etc, then the appellant never received any deputation allowance or TA/DA, but if that was a punishment, then the appellant has no information about the wrong made by the appellant at that time. The legal status of the enclosure "H" is still not known to the appellant.
- In the para-7 of the appellant's application it is stated that on -09-07-2014, in the Office of the Secretary Higher Education Archives & Libraries Department, the appellant submitted an application along with all details and the relevant documents (enclosure "11") regarding the wrongfully deduction from the appellant's salary. Just a letter to the Administration Department (enclosures "I2") by the Higher Education Archives & Libraries Department was served with no further follow-ups and action taken against those who wrongfully deducted full house-rent for a Bachelor accommodation in the absence of any rules from the appellant's pay. The appellant, personally, followed the case in the Administration Department and got the reply (enclosure "13") which needs further follow-ups, as the appellant was allotted a Bachelor accommodation i.e. BOQ  $\cdot$ (Bachelor Officer Quarter) No.4, which is a Suite, not a family Quarter of one or two rooms. It is pointed out that the Administration Department has not yet made any rules regarding deduction of rent for that building in which the appellant resides which can be proved from the letters of the Estate Officer\*(enclosure "I4") to the Provincial Building Maintenance Cell. Still full house rent is deducted without any rules from the appellant's pay for a Bachelor Accommodation that needs your kind attention.
- h) In the para-8 of the appellant's application it is stated that the appellant had made an appeal regarding the appellant's PERs (Performance Evaluation Reports) to the then Secretary Higher Education Department on 25-06-2020 (enclosure "J1") whose meaningful intimation is still awaited. The intimation which the appellant got, after approaching to the Right to Information Commissioner, from the CIV Section Higher

Education Archives & Libraries Department (enclosure "J2") dated April 10, 2023 in response to the appellant's application to then Secretary Higher Education Department (enclosure "J3") cannot be the meaningful intimation of the enclosures "J1" and "J3" by any means, as there is nothing in the enclosure "J2" about the rejection of enclosure "J1" as well as complete silence over the many issues raised in "J3". Moreover, enclosure "J2" discusses just the withdrawal order of the then Secretary Higher Education Archives & Libraries Department and change of the appellant's Reporting Channel, but does not disclose the fact that when and by whom the appellant's Reporting Channel has been changed as the appellant has not yet received the Orders of the appellant's Competent Authority i.e. Chief Secretary, regarding the change of the appellant's Reporting Channel. It is pointed out that after the appeal to the Secretary Higher Education Archives & Libraries Department on 25-06-2020 by the appellant in which the appellant requested to the Secretary Higher Education Department that the appellant's Reporting Officer is the Director Archives & Libraries who has not yet forwarded the PERs of the appellant to the Secretary Higher Education Archives & Libraries Department for counter signature. In response to the letter of the Office of the Secretary Higher Education Archives & Libraries Department regarding the above mentioned appeal, the first comments of the Director Archives & Libraries were that the appellant submitted his PERs not on time as well as the appellant had no progress during his entire service career that is why the Ex-Director Archives & Libraries reported and countersigned the PERs of the appellant within the Directorate of Archives & Libraries. One PER for the year 2018 of the appellant was badly reported by the present Director Archives & Libraries who was at that time serving as Chief Librarian Archives & Libraries while the remaining PERs of the appellant were badly reported by the Ex-Deputy-Director Archives & Libraries both being irrelevant as per the Job Descriptions of the appellant and can also be easily proved from the fact that the Job Descriptions of both the Chief-Librarian and the Deputy-Director are quite different from the Job Descriptions of the appellant. It is necessary to highlight that the Ex-Director Archives & Libraries remained the appellant's Reporting Officer since the appellant's appointment w.e.f 2007 up to 2020. During the last year of the tenure of the Ex-Director Archives & Libraries, after submitting an appeal regarding the PERs issue to the Secretary Higher Education Archives & Libraries Department by the appellant on 25-06-2020, the Ex-Director Archives & Libraries badly reported the appellant's PERs by irrelevant quarters within the Directorate and himself countersigned all PERs of the appellant, while on the other hand the appellant's subordinates got promotions without reported their PERs by the appellant. After a lot of correspondences on the PERs' issue of the appellant, at last, the Secretary Higher Education Archives & Libraries issued an Office Order in favour of the appellant but, later on, withdrew his own Office Order. Here, it needs to be scrutinized first the issuance of the Office Order in favour of the appellant and then the

withdrawal Order of his own Office Order by the Secretary Higher Education Archives & Libraries Department that will reveal the whole scenario of the appellant PERs issue. Now, the appellant's high-ups say that the appellant's Reporting Officer is Deputy-Director without the provision of any Order, properly justified, from the appellant's competent Authority i.e Chief Secretary, regarding change of the appellant's Reporting Channel. Deliberately mishandling and delaying of the PERs' case of the appellant seems providing a base for justifying the appointment of a librarian on the seat of the Director Archives & Libraries that will ultimately helpful in justifying the establishment of the Public Libraries, a secular concept, in the Province with their attachment with the Provincial State Archives or Archival library. The details in the enclosures, "E" & "O" are worth mentioning in this regard. In the light of the 1973 Constitution of Pakistan as well as Archival Act, 1993 and Archival Material (Preservation and Export Control) Act, 1975 such justification, appointment and attachment with legal action against all those who deliberately delayed and mishandled PERs' Case of the appellant as well as meaningful intimation/status of enclosure "J1" and "J3" may need your kind attention in the best public interest.

- In the para-9 of the appellant's application it is stated that from the day one, when the appellant was appointed in the Directorate of Archives & Libraries, the appellant time and again requested for proper training in the field of Archives and was intimated that the appellant's name will be proposed for the training when will be offered. To the appellant's surprise, when the Training for Officers from the National Archives, Islamabad was offered in roundabout 2011, two Assistants (BPS-11), one Peon (BPS-3) and one Mender (BPS-4) were nominated for the training. It is pointed out that this training was only for the Research Officers (BPS-17) of Archives Wing and due to which the issue of Training Completion Certificates to the above mentioned staff of the Directorate of Archives & Libraries arose among the Staff who were imparting the training in the National Archives, Islamabad. Later on, the issue was resolved by writing on a plain paper, by the Staff imparting training, the attendance of the above mentioned staff of the Directorate of Archives & Libraries for TA/DA purpose. The appellant still did not get any nomination for any proper training in the Archives field after serving more than sixteen years as a Research Officer (BPS-17) on the same scale and same post with no promotion since appointment through Public Service Commission due to the deliberately Disturbed Job Structure of the post of the Research Officer and deliberately mishandling of the PERs' case of the appellant for the reason already stated in Para 8.
  - j) In the para-10 of the appellant's application it is stated that due to the performance of the Higher Education Archives & Libraries Department discussed above, situation reached to that extent that missing of letters, not forwarding letters to high-ups, missing and return of unsigned documents from the high-ups etc became a

Secretary Higher Education Archives & Libraries Department on dated 18-07-2023 (enclosure "K1"), along with the copies to the Deputy Secretary (Admin) Higher Education Archives & Libraries Department as well as the Deputy Secretary (Litig.) Higher Education Archives & Libraries Department and, personally, initiated a note-part (enclosure "K2") dated 03-08-2023 which is self-explanatory. One of the two missing copies of the appellant's application, submitted in the Office of the Secretary Higher Education Archives & Libraries Department, recovered from the Directorate of Archives & Libraries while the other copy, submitted in the Office of the Deputy-Secretary (Litig.) Higher Education Archives & Libraries Department, dully marked to the Section Officer (General) Higher Education Archives & Libraries Department is still missing.

- k) In the para-11 of the appellant's application it is stated that the appellant was on leave in the month of March 2023 due to severe Pollen-Allergy problem and then arrived on 14-4-2023 in his Office, but the appellant's Conveyance and Special Allowances remained stopped for ten months. In this regard, the (enclosure "L") is self-explanatory.
  - Onstitution means treason against the State of Pakistan. The Provincial State Archives is still a Constitutional Institution and the Designated Office of a Research Officer of the Directorate of Archives & Libraries has its own legal status. Since the appellant's appointment, the appellant's Designated Office is occupied by other Staff members of appointment, the appellant's Designated Office is occupied by other Staff members of the Directorate of Archives & Libraries and the appellant had requested many times to the high-ups in different times including the Secretary Higher Education Department in the high-ups in different times including the Secretary Higher Education Department in this regarding. Instead of the provision of the appellant's Designated Office, now the appellant's high-ups are issuing orders, from time to time, regarding forceful vacation of appellant's existing office. The self-explanatory enclosure "M1", "M2" & "M3" give the details about the forcefully vacation of the appellant's office by the appellant's high-ups.
    - m) In the para-13 of the appellant's application it is stated that the stoppage of Correspondence in a department is like the stoppage of the movement of Blood in a Body. Enclosure "N" is self-explanatory about the refusal of the appellant's application, note-part etc by the Establishment Section of the Directorate of Archives & Libraries.
      - n) In the para-14 of the appellant's application it is stated that Archival Library and Public Library are two quite different subjects from every angle. The Archives and the Archival library is a sensitive and serious subject and are required to be entertained for research purpose by research scholars of serious nature as well as by the Government, while the Public Library, a secular concept, is commonly entertained by common public.

Archival Library always remained the part and parcel of the Directorate of Archives since its establishment, but after the attachment of the Subject of the Public Library with the Directorate of Archives, the very name of the Directorate changed from the Directorate of Archives into the Directorate of Archives & Libraries in roundabout 1992. Service rules were framed/changed accordingly and both the then newly created posts of the Deputy-Director (from Archives side) and the Chief Librarian (from Public library side) were placed in a Joint Seniority. Exactly, same like the joint Seniority of the posts of the Research Officers of Archives Wing and the newly created posts of the Assistant-Directors as both the posts of Research Officer and Assistant-Director belong to two quite different cadres. Joint Seniority of two different cadres, Creation of new posts without any proper proposal from the bottom and consultations of the concerned Staff members like in the case of newly created posts of the Assistant Directors or the creation of the new post of the Research Officer of Archives wing in the recent past, upgradation and framing of service rules without consulting those staff members who are affecting, in violation of standing rules promotion of rankers to initial posts and very much delay in the appointment on the initial posts etc are the established practices since long that need justification. The staff of the Archives cadre of the Directorate of Archives & Libraries have no upgradation while the staff of the Library and ministerial cadres of the Directorate got upgradation, though all cadres serve in the same Directorate, seems against Natural Justice and are extremely harmful from the Administrative point of view that adversely affects the functions of the Provincial Archives, the custodian of the Record of the Province. Here, the appellant would like to draw your kind attention towards another very serious issue of justification of posting of a librarian on the seat of the Director Archives & Libraries in the light of the Archival Act, 1993 and Archival Material (Preservation and Export Control) Act, 1975. In this connection, the appellant had submitted an application to the then Secretary Higher Education Archives & Libraries Department on 06-04-2021 (enclosure "O") with detail description whose written intimation is still awaited, as well as some details are already mentioned in the enclosure "E". Justification of Joint Seniority of different cadres, framing of rules, creation of new posts or upgradation of existing posts without consultation of those staff members who are affecting as well as Justification of Public Library, a secular concept, in a traditional country and in the light of 1973 Constitution of Pakistan the justification of attaching Public Libraries with the Archives or Archival Library and then establishing of Public Library in College like the establishment of the Public Library in the Government Degree College Lakki-Marwat as well as justification of other issues discussed above may need your kind attention on priority basis in the best public interest.

o) - In the para-15 of the appellant's application it is stated that in the light of the Archival Act, 1993 and Archival Material (Preservation and Export Control) Act, 1975

scanning of the Record of the Provincial State Archives by the staff of the **11 Corps**, **Peshawar** and **introduction of E-Government** in the province without the approval of the Provincial State Archives, being the custodian of the Record of the Province, may need your kind attention. In this connection, appellant's application to the Director Archives & Libraries is enclosed as **Annexure** ("P").

p) - In the para-16 of the appellant's application it is stated that keeping in view, the above mentioned facts along with the role and nature of the work of the Provincial State Archives in the Government Machinery i.e. inspection of Record-Rooms of the District Governments as well as of the other Departments, selection of Record having Archival Importance from the Record already declared as Obsolete Record by its parent Department from its Non-Current Record, Record preservation and its retrieval to the public as well as Government etc; it is the humble opinion of the appellant, if possible, that a request may be forwarded to the Government with recommendations for bringing the Provincial State Archives under the Direct Control of the Cabinet or Chief-Secretary or, at least, under the Establishment Department. The National State Archives, in Islamabad, also works directly under the Cabinet Division. | Unlike the Charity Organizations, Government Departments, especially, a sensitive Department like the Provincial State Archives that is handling the Record is required to deliver services of very serious nature and in order to achieve this end, if possible, on emergency basis necessary recommendations may kindly be forwarded to the Government, like recommendations for the Performance Audit by the office of the Accountant General for a sensitive Department like Provincial State Archives as only through this why one can easily get to know that where and for what purpose the resources of the Government are practically spent or spending. Similarly, recommendations for the abolition of 50% quota for promotion in the Jobs related to the Provincial State Archives as like in the Armed Forces or the Government Departments of the British era may need to be forwarded to the Government. 50% quota is secured on the pretext of giving chances to the employees already working in the Department which makes some sense, but, practically, this concept is not so innocent and is misused that leads to corruption and destruction of Talent. For example, in the beginning, the Directorate of Archives got two seats of the posts of Research Officers to be appointed, initially, by Public Services Commission, but later on, the concept of 50% Quota was introduced on the pretext of giving chances to the existing employees of the Directorate and hence the chapter of violations of standing rules started. PER (ACR), practically, became just a formality and most probably can be misused like discussed in the enclosures "D", "J1" & "J3". Appointment only through Public Service Commission or Departmental Exams may need to be recommended for getting suitable staff for a department that has a very sensitive role in Government Machinery being the Custodian of the Record as well as the rights of the people.

- q) In the para-17 of the appellant's application it is stated that last, but not least, Record means anything that can be produced before the Court of Law as evidence, so authenticity of Record must be ensured. Handling of Record needs much privacy, security and strict observance of standing rules, otherwise, the question of authenticity arises. Under the circumstance stated above, the authenticity of Record may need your kind attention. Keeping in view your precious time, the above-mentioned details are just few examples of the ground realities while there are much that need to be highlighted in the best public interest.
  - r) At last of the appellant's application, the appellant has very humbly requested for legal protection for what has been stated above in good faith and if possible, the release of the appellant's Conveyance and Special Allowances highlighted in the enclosure "L", issuing necessary orders regarding the stoppage of deduction of full house rent from the appellant's pay for a Bachelor Accommodation and reimbursement of the amount that is being deducted wrongfully from the appellant's pay since then with details mentioned in the enclosures "I1", "I2" & "I3", meaningful intimation/status of enclosures "B1", "B5", "C", "J1", "J3", "O" & " $\dot{p}$ ", forwarding enclosures "E". It is also requested for taking legal action against those who deliberately mishandled enclosures "A", "J1" & "J3" as well as after the appellant's appeal to the Secretary Higher Education Archives & Libraries Department on 25-06-2020 the justification of the reporting of the appellant's PER for the year 2018 by the present Director Archives & Libraries who at that time was serving as the Chief Librarian Archives & Libraries along with justification of reporting the appellant's PERs by the Ex-Deputy Director Archives & Libraries as both being irrelevant to the appellant's Job Descriptions, involved in the enclosures "B6", "L", "M1", "M2", "M3" & "N", not putting up enclosure "D" before high-ups. It is also requested for the re-examination of enclosure "B4", issuing orders to the concerned quarter in respect of provision of justification of the Legal status of the Notification of the Joint/Updated Seniority List of the Posts of the Research Officers of Archives Wing of the Directorate of Archives & Libraries and the newly created Posts of the Assistant-Directors of the Directorate of Archives & Libraries highlighted in the enclosures "F1","F2", & "F3" as well as justification of Joint seniority of the post of the Deputy Director Archives & Libraries and the Chief Librarian Archives & Libraries along with the justification of the legal status of enclosure "H" and outcome of enclosures "G1" & "G2". It is further requested for issuing orders to the concerned quarters regarding the justification of the establishment of Public Library, a secular concept that is quite a different thing from every aspects to Archives or Archival Library, its attachment with Archives or Archival Library along with the appointment of a librarian on the seat of the Directorate of Archives & Librages in the presence of 1973 Constitution of Pakistan, Archival Act, 1993 and Archival Material (Preservation and Export Control) Act, 1975,

respectively, with sympathetic consideration in respect of Para 14, 15, 16 & 17 in the best public interest, please.

## PRAYERS:-

The aforementioned challenges have significantly disrupted the appellant's professional journey and persist as ongoing concerns. It is currently of utmost importance to promptly address the PERs issue, given the appellant's imminent eligibility for the post of the Deputy-Director Archives & Libraries. The incumbent Deputy-Director's impending promotion to the post of the Director<sub>|</sub> of Archives and Libraries in July 2024 adds urgency to the matter. Consequently, it is, therefore, kindly requested for the acceptance of the appellant's appeal that the Secretary Higher Education Department, Khyber Pakhtunkhwa, Peshawar may kindly be approached for meaningful intimation of the annexure-1 for further perusal of those issues among all the above stated issues that come under the preview/jurisdiction of the Tribunal with a particular focus on appellant's PERs issue. Here, it is pointed out that when the post of the Deputy-Director Archives & Libraries became vacant after the retirement of its incumbent in 2018, due to the deficiency of the PERs etc of the present incumbent of the post of the Deputy-Director, the post remained occupied by officers of other cadres for more than two years. Therefore, It is also very humbly requested that in order to avoid the repetition of the above stated delay in promotion to the post of the Deputy-Director, the Higher Education Department may kindly be directed for expedite the preparation of paper work and other arrangements like PSB meeting etc., necessary for the candidate to be promoted to the post of the Deputy-Director Archives & Libraries, before July 2024.

It is, therefore, prayed that the appeal in hand may be accepted and proper order deems fit may be passed in favor of the appellant.

Respected Madam,

With due respect it is stated that on 14-07-2008, I had made a written complaint to the Director A & L regarding an incident that took place in the Weeding and publication Section, but when confirmed that the Director A & L was not going to take any action against the concerned quarter within the Directorate, then due to emergency situation directly approached to the next higher Authority i.e. the Office of the then Secretary Higher Education, Archives & Libraries (HED). Next day, the then Secretary HED, personally, visited the W & P Section of the Directorate and after few days, I came to know that the Secretary was transferred with no further legal action seemed to be taken against the concerned quarters. After this, one can easy imagine the situation I was facing at that time within the Directorate as well as about my surrounding environment. Similarly, on dated 30-05-2009, I made a request to the then Secretary HED regarding the problems of Archives (enclosure "A"). In response, an enquiry was initiated against me without the approval of my competent authority i.e. Chief Secretary, and the proper Official Visit-Report of the then Section Officer (CIV Section) who on the instruction of the then Secretary HED visited the Directorate, met with the then Director A & L and then wrote to the then Secretary HED that according to the Director A & L, everything is ok. It is pointed out that I, practically, showed and proved before him each and every thing that I had stated in the enclosure "A" in which I had raised very basic points like running of sections without any charge responsibilities (handover/takeover activity), running of Periodical Section and Newspaper Section without any written order and by a Peon respectively, non-availability of Officers of Archives Wing, lack of through proper channel administration etc. If the then Section Officer had presented his complete Official Visit-Report before the then Secretary HED, then the direction of the enquiry would be surely against others instead of me. It is necessary to highlight that in the enclosure "A", I had also pointed out the performance of the Preservation Section, especially, the lamination of Record which after few months became Crystal clear when the in-charge of the Preservation Section was caught red-handed by the National Accountability Bureau and then through plea bargaining was exonerated by NAB. Without the information and approval of the Ex-Director, Ex-Deputy-Director etc how a Research- Assistant (BPS 11) could make corruption is a Question mark. Moreover, this Research Assistant was so close to the high-ups that the Designated Office of a Research Officer of Archives Wing was occupied by him. Many things will be crystal clear if the case is reopened. It is pertinent to mention that the Section-in-charge was appointed in the Directorate as Preservation-Assistant (BPS-11), but, later on, with the help of the then Director A & L and without the consultations of the other officers of the Archives Wing, created a new post of the Preservation-Officer (BPS-16) on which he became promoted. This fake and baseless inquiry was a heavy blow to my career, reputation and moral. Legal Action against those who deliberately mishandled the enclosure "A" may kindly be taken for fixing the responsibilities on the concerned bodies.

2. Interference in one's official duty is tantamount to rape and in this regard I had made a complaint to my high-ups (enclosure "B1") after which a letter dated December 2<sup>nd</sup>, 2015 from CHV Section (enclosure "B2") was served to the Directorate, but still do not know about the status of my that complaint. Details of the complaint are attached as (annexure "B3"). After the complaint, on the orders of my high-ups, I was directed to arrange the record of the Litigation Section of the HED that was in scattered form and due to the non-availability of the record on time for pursuing the case of the HED before the Law Court, the salaries of the two Secretaries were stopped by the Court at that time. It is pointed out that, at that time, the Officer discussed in the enclosure "B'l" was working as Litigation Officer though, not much sure about his proper official order in this regard. In order to avoid the initiation of any disciplinary action against me, I did that task on time though it was not related to my Job Description. From this, one can easily get to know about an indirect message that was conveyed to me from my high-ups and the situation that I faced at that time through this task. Similarly, the Scanner of the Weeding and Publication Section, whose administration belongs to me, became disappeared in 2018. The Police not only recovered the Scanner, but also through CCTV camera of the Section caught red handed the one Officer, who has already been discussed in the enclosure "BI, B2 & B3", and one Official. Both were, later on, released from the Police Station on the assurance of the then Director A & L. The Officer was exonerated by the then Secretary HED (enclosure "B4"). In case, he was not caught red-handed, the whole responsibility of the missing of the Scanner would fall upon my shoulders being the administrator of the Section. Here, it is pointed out that, at that very day, when the incident took place, he was appointed by the HED against the vacant post of the Deputy-Director on Acting-Charge-Base and had yet neither received the Job Descriptions of the post of the Deputy-Director, nor had taken-over the charge responsibilities being an Acting Deputy-Director in the Directorate: Actions speak louder than words, so one can easily evaluate who was on the target, through and by whom. In this connection, the contents of the application of the Ex-Deputy-Director (enclosure "B5") may need your kind attention, if the application is genuine. Moreover, it is the same Officer who, when unpunished

time and again, became so bold that after his promotion to the post of the Deputy-Director, whose seniority I have already challenged with details mentioned in the enclosure ("E"), prepared a letter (enclosure "B6") with the signatures of the two Research Officers of the Archives Wing against me and my Job Description. Clause (i) in Para 1 of enclosure "B6" is the clear-cut violations of the Manual of the Secretariat Instructions while in Para 3 of the enclosure "B6", there is baseless statement against me whose clarification on behalf of me is available on the back of enclosure "B6". Even, calling the direct explanations with irritating words and baseless allegations against me by the same Officer became a routine. Upon proper inquiry by the Government, I will provide the details of other Officers too, who also from time to time have interfered and are still interfering in the official business of the Weeding & Publication Section and my Job Description. It is pointed out that after the retirement of the ex-Deputy-Director in 2018, from other cadres i.e. one from college side and other from Library side, were posted against the vacant post of the Deputy Director A & L. Here, it is mentioned that according to the Job Structure of the Directorate, only the senior most Research Officer of the Archives Wing can be promoted and posted against the vacant post of the Deputy-Director. In case of no disturbance in my Job Structure whose details is mentioned in the enclosure "E" and not mishandling of my PERs' case by my high-ups, I would be promoted to and appointed against the then vacant post of the Deputy Director in 2018 and then would be able in challenging under the Archival Act, 1993 and Archival Material (Preservation and Export Control) Act, 1975 the appointment of a Librarian cadre on the seat of the Director A & L which became vacant in March, 2021.

3. From time to time, I have always informed my high-ups about the issues related to my Job, like my Report about the Record, especially, of the HED to the then Secretary HED (enclosure "C") whose written intimation is still awaited. This report is enough in highlighting the worse condition of the Record and Record Rooms of the various Government Departments/bodies in the Province, especially, of the HED, Finance etc. Still did not get the written intimation of enclosure "C". In this connection, some details are already mentioned in the enclosure "D" served as a copy to the PS to the then Secretary HED in which I have raised very sensitive points regarding the Directorate, dully marked to the then Section Officer of C-IV Section by the then Additional Secretary HED, but, unfortunately, not put up by the then Section Officer before the high-ups, due to which one sided decision took place and I got Warning and Counseling in the office of the then Additional Secretary(Dev) HED on behalf of the then Secretary HED. Without entertaining enclosure "D", in which I had stated the details in my defense, legal Status of the above mentioned Warning and Counseling as well as not putting up the letter before the high-ups by the then Section Officer may need your kind attention. Here, It is necessary to point out that the enclosure "D" after submitting in the Office of the then Secretary HED, disappeared in



the Office of the then Deputy-Secretary Colleges, after which I submitted another copy of enclosure D' before the then Additional Secretary (Dev) HED for onward process.

Every year. I record my reservations on the Seniority List i.e. "my reservations are intact and did not get any intimation in response to my appeal to the Chief Secretary (enclosure "E") regarding the deliberately disturbance of my Job Structure, as still the enclosure "E" has not been forwarded. I through various correspondences, from time to time, have informed the Officers of the HED. Forwarding enclosure "E" to the Chief Secretary may need your kind attention.

- In response to a letter from C-IV Section (enclosure "F") regarding the notification of the Final/Updated Joint Seniority List of the Post of the Research Officer of Archives Wing and the newly created Post of the Assistant Director, the Director A & L issued a letter (enclosure "F2") on 29-06-2019, for submitting written observations on behalf of me within 03days of the issuance of the enclosure "F2". I submitted my reservations (enclosure "F3") in the Directorate as well as in the CIV Section on 01-08-2019. Moreover, in connection to the disputed seniority list, two meetings were also held i.e. one in the office of the then Additional Secretary (Dev) HED (enclosure "G1") and other in the office of the then Deputy-Secretary (Litig) HED (enclosure "G2"), but neither received the minutes of both the meetings, nor received any letter regarding the outcome of the above mentioned two meetings. Legal Status of the Notification of the Final/Updated Seniority List of the Post of Research Officer and newly created Post of Assistant Director as well as outcome of the enclosures "G1"& "G2"may need to be in your kind-attention.
- 6. On 10th January, 2014, my services were placed at the disposal of the Director (HETTA) now (HEART) at Govt. Degree College for Boys, phase 6, Hayatabad (enclosure "H") by the HED. In this connection, I met with the then Secretary HED and she verbally directed me to go there just for few weeks, but it took roundabout 10 months and then after a lot of correspondences, at last, repatriated to the Directorate of A & L with a good performance certificate from the Director HETTA on the demand of the HED. If it was a deputation etc, then never received any deputation allowance or TA/DA and if it was a punishment, then I have no information about the wrong I did at that time. Still do not know the legal status of the enclosure "H".
  - On -09-07-2014, in the Office of the Secretary HED, I submitted an application along with all details and the relevant documents (enclosure "I1") regarding the wrongfully deduction from my salary. Just a letter to the Administration Department (enclosures "I2") by the HED was served with no further follow-up and action taken against those who wrongfully deducted full-house-rent for a Bachelor accommodation, in the absence of any rules, from my pay. I, personally, followed my case in the Administration department and got the reply (enclosure "I3") which needs further follow-ups, as I was allotted a Bachelor accommodation i.e. BOQ No.4, which is

a Suite, not a family Quarter of one or two rooms. It is pointed out that the Administration Department has not yet made any rules regarding deduction of rent for that building in which I reside which can be proved from the letters of the Estate Office (enclosure "I4") to the PBMC. Still full house rent is deducted without any rules from my pay for a Bachelor Accommodation.

- I made an appeal regarding my PER (Performance Evaluation Report) to the then Secretary HED on 25-06-2020 (enclosure "J1") whose meaningful intimation (written) is still awaited. The intimation which I got, after approaching to RTI, from the CIV Section (enclosure "J2") dated April 10, 2023 in response to my application to the Secretary HED (enclosure "J3") cannot be the meaningful intimation of enclosures "J1" and "J3" by any means, as there is nothing in the enclosure "J2" about the rejection of enclosure "J1" as well as complete silence over the many issues raised in "J3". Moreover, enclosure "J2" discusses just the withdrawal order of the then Secretary HED and change of my Reporting Channel, but does not disclose the fact that when and by whom my Reporting Channel has been changed as I have not yet received the Orders of my Competent Authority i.e. Chief Secretary, and Appointing Authority regarding the change of my Reporting Channel. It is necessary to highlight that the Ex-Director Archives & Libraries remained my Reporting Officer since my appointment w.e.f 2007 up to 2021 and during the last year of his tenure, he badly reported my PERs through irrelevant quarters within the Directorate and himself countersigned all my PERs, while on the other hand my subordinates got promotions without reported their PERs by me. It is pointed out that the PER of one year was reported by the present Director A & L who was at that time serving as Chief Librarian, not relevant to my Job. Now, after my appeal, my high-ups say that my Reporting Officer is Deputy-Director without the provision of any Order, properly justified, from my competent Authority i.e Chief Secretary, regarding change of my Reporting Channel. Deliberately mishandling and delaying of my PERs' case seems providing a base for justifying the appointment of a librarian on the seat of the Director Archives & Libraries that will ultimately helpful in justifying the establishment of the Public Libraries in the Province with its attachment with the Provincial State Archives or Archival library as well as College Libraries. The details in the enclosures "E" & "O" are worth mentioning in this regard. In the light of the 1973 Constitution of Pakistan as well as Archival Act, 1993 and Archival Material (Preservation and Export Control) Act, 1975 such justification, appointment and attachment with legal action against all those who deliberately delayed and mishandled my PERs' Case as well as meaningful (written) intimation/status of enclosure "JI" and "J3" may need your kind attention in the best public interest.
- 9. From the day one, when I was appointed in this Department, I time and again requested for my proper training in the field of Archives and was intimated that my name will be proposed for the

training when will be offered. To my surprise, when the Training for Officers from the National Archives; Islamabad was offered in roundabout 2011, two Assistants (BPS-11); one Peon (BPS-3) and one Mender (BPS-4) were nominated for the training. It is pointed out that this training was only for the Research Officers (BPS-17) of Archives Wing and due to which the issue of Training Completion Certificates to the above mentioned arose among the Staff who were imparting the training in the National Archives, Islamabad which was, later on, resolved by writing on a plain paper by the Staff, imparting training, the attendance of the above mentioned for TA/DA purpose. Still did not get nomination for any proper training in the Archives field after serving roundabout sixteen years as a Research Officer on the same scale and same post with no promotion since appointment through Public Service Commission due to the deliberately Disturbed Job Structure of the post of the Research Officer and deliberately mishandling of my PERs' case for the reason already stated in Para 8.

- Die to the performance of the HED discussed above, situation reached to that extent that missing of letters, not forwarding letters to high-ups, missing and return of unsigned documents from the high-ups etc became a common practice. In this connection, I made just one request to the Secretary HED on dated 18-07-2023 (enclosure "K1"), along with the copies to the Deputy Secretary (Admin) as well-as the Deputy Secretary (Litg) and, personally, initiated a note-part (enclosure "K2") dated 03-08-2023 which is self-explanatory. One of the two missing copies of my application, submitted in the Office of the Secretary HED, recovered from the Directorate while the other copy, submitted in the Office of the Deputy-Secretary (Litg) HED, dully marked to the Section Officer (General) is still missing.
- 1. I was on leave in the month of March 2023 due to severe Pollen-Allergy problem and then arrived on 14-4-2023 in the Office, but my Conveyance Allowance and Special Allowance are still stopped since then. In this regard, the enclosure "L" is self-explanatory. After the wrongful deduction of my House Rent, now became the turn of the stoppage of my Special Allowance and Conveyance Allowance and if this practice was not discourage on time, seems to me the stoppage of my remaining salary in the near future like the stoppage of my promotion etc....
- Archives is still a Constitutional Institution and the Designated Office of an Officer has its own legal status. Since my appointment, my Designated Office is occupied by others and I had requested to my high-ups in different times including to the Secretary HED in this regarding. Instead of the provision of my own Designated Office, now my high-ups are issuing orders, from time to time, regarding forceful vacation of my existing office. The enclosures "M1", "M2" & "M3" in which the details about the forcefully vacation of my office by my high-ups are self-explanatory.

- 13. The stoppage of Correspondence in a department is like the stoppage of the movement of Blood in a Body. Enclosure "N" in which the details about the refusal of the Establishment Section of my application, note-part etc is self-explanatory.
- 14. Archival Library and Public Library are two quite different subjects from every angle. The Archives and the Archival library is a sensitive and serious subject and are required to be entertained for research purpose by research scholars of serious nature as well as by the Government, while the Public Library, a secular concept, is commonly entertained by common public. Archival Library always remained the part and parcel of the Directorate of Archives since its establishment, but after the attachment of the Subject of the Public Library with the Directorate of Archives, the very name of the Directorate changed from the Directorate of Archives into the Directorate of Archives & Libraries in roundabout 1992. Service rules were framed/changed accordingly and both the then newly created posts of the Deputy-Director (from Archives side) and the Chief Librarian were placed in a Joint Seniority. Exactly, same like the joint Seniority of the post of Research Officer of Archives Wing and the newly created post of the Assistant-Director as both the posts belong to two quite different cadres. Joint Seniority of two different cadres, Creation of new posts without any proper proposal from the bottom and consultations of the concerned Staff members like in the case of newly created posts of the Assistant Directors or the creation of the new post of the Research Officer of Archives wing in the recent past, Up gradation and Framing of service rules without consulting those staff members who are affecting, promotion of rankers to initial posts and in violation of standing rules very much delay in the appointment on the initial posts etc are the established practices since long that need justification as are extremely harmful from the Administrative point of view: Here, I would like to draw your kind attention towards another very serious issue like justification of posting of a librarian on the seat of the Director A & L in the light of the Archival Act, 1993 and Archival Material (Preservation and Export Control) Act, 1975. In this connection, I had submitted an application to the then Secretary HED on 06-04-2021 (enclosure "O") with detail description whose written intimation is still awaited, as well as some details are mentioned in the enclosure "E". Justification of Joint Seniority of different cadres, framing of rules, creation of new post or upgradation of existing post without consultation of those who are affecting as well as Justification of Public Library, a secular concept, in a traditional country with the presence of 1973 Constitution of Pakistan, justification of attaching Public Libraries with the Archives or Archival Library and then establishing of Public Library in College like the Public Library in the Government Degree College Lakki-Marwat as well as justification of other issues discussed above may need your kind attention on priority basis in the best public interest.

It is a second of the Provincial State Archives by the staff of the 11 Corps,

Peshawar and introduction of E-Government in the province without the approval of the Provincial State Archives may need your kind attention. In this connection, my application to the Director Archives & Libraries is enclosed as Annexure ("P").

Keeping in view, the above mentioned facts along with the role and nature of the work of the Provincial State Archives in the Government Machinery i.e. inspection of Record-Rooms of District Governments as well as of other Departments, selection of Record having Archival Importance from the Record already declared as Obsolete Record by its parent Department from its Non-Current Record, Record preservation and its retrieval to the public as well as Government etc, it is my humble opinion, if possible, that a request may be forwarded to the Government with recommendations for bringing the Provincial State Archives under the Direct Control of the Cabinet or Chief-Secretary or, at least, under the Establishment Department. The National State Archives, in Islamabad, also works directly under the Cabinet Division. Unlike the Charity Organizations, Government Departments, especially, a sensitive Department like the Provincial State Archives that is handling the Record is required to deliver just services of very sections nature and in order to achieve this end, if possible, on emergency basis necessary recommendations may kindly be forwarded to the Government, like recommendations for the Performance Audit by the office of the Accountant General for a sensitive Department like Provincial State Archives, as only through this why one can easily get to know that where and for what purpose the resources of the Government are practically spent or spending. Similarly, recommendations for the abolition of 50% quota for promotion in the Jobs related to the Provincial State Archives as like in Armed Forces or the Government Departments of the British era may need to be forwarded to the Government. 50% quota is secured on the pretext of giving chances to the employees already working in the Department which makes some sense, but, practically, this concept is not so innocent and is misused that leads to corruption and destruction of Talent. For example, in the beginning, the Directorate of Archives got two seats of the posts of Research Officers to be appointed, initially, by Public Services Commission, but later on, the concept of 50% Quota was introduced on the pretext of giving chances to the existing employees of the Directorate and hence the chapter of violations of standing rules started. PER (ACR), practically, became just a formality and most probably can be misused like discussed in the enclosures "D", "J1" & "J3". Appointment only through Public Service Commission or Departmental Exams may need to be recommended for getting suitable staff for a Department that has a very sensitive role in Government Machinery being the Custodian of the Record/ rights of the people.

17. Last, but not least, Record means anything that can be produced before the Court of Law as evidence, so authenticity of Record must be ensured. Handling of Record needs much privacy, security and strict observance of standing rules, otherwise, the question of authenticity arises. Under the circumstance stated above, the authenticity of Record may need your kind attention. Keeping in view your precious time, the above mentioned details are just few examples of the ground realities while there are much that need to be highlighted in the best public interest.

Anything stated above, though in good faith, may need legal protection.

You are, therefore, very humbly requested for, if possible, the release of my Conveyance Allowance and Special Allowance highlighted in the enclosure "L", issuing necessary orders regarding the stoppage of deduction of full house rent from my pay for a Bachelor Accommodation and reimbursement of the amount that is being deducted wrongfully from my pay since then with details mentioned in the enclosures "I1", "I2", & "I3", meaningful (written) intimation/status of enclosures "B1", "B5", "C", "J1", "J3", "O" & "P", forwarding enclosures "E". It is also requested for taking legal action against those who deliberately mishandled enclosures "A", "J1" & "J3" as well as justification of reporting my PER, after my appeal to the Secretary HED, of the year 2018 by the present Director A & L who at time was serving as Chief Librarian along with justification of reporting my PERs by ex-Deputy Director both being irrelevant to my Job Descriptions, involved in the enclosures "B6", "L", "M1", "M2", "M3" & "N", not put up enclosure "D" before high-ups. It is also requested for the reexamination of enclosure "B4", issuing orders to the concerned quarter in respect of provision of justification of the Legal status of the Notification of the Joint/Updated Seniority List of the Post of the Research Officer of Archives Wing and the newly created Post of the Assistant-Director highlighted in the enclosures "F1", "F2", & "F3" as well as justification of Joint seniority of the post of the Deputy Director and the Chief Librarian along with the justification of the legal status of enclosure "H" and outcome of enclosures "G1" & "G2". It is further requested for issuing orders to the concerned quarters regarding provision of justification of the establishment of Public Library, a secular concept that is quite a different thing from every angle In respect to Archives of Archival Library, and its attachment with Archives or Archival Library along with the provision of justification of the appointment of a librarian on the seat of the Directorate of A & L in the presence of 1973 Constitution of Pakistan and Archival Act, 1993 and Archival Material (Preservation and Export Control) Act, 1975, respectively, with sympathetic consideration in respect of Para 14, 15, 16 & 17 in the best public interest, please.

I time and again requested for my proper training in the field of Archives but such request was not entertained. Though the post of a Research Officer, who is the custodian of the precious Record is a very sensitive post and requires professional techniques.]

Sir, I have tried my best to solve the various problems of Archives with in the Directorate but it seems to me that without the interference of your honorable authority, it is not possible to solve the intricate and sensitive problems of Archives.

Sir, according to my enservation, Arch ves is going from bad to worse and it requires your immediate attention, otherwise our precious record which is in the shape of Newspapers, Magazines, Classified Files, Tresties, Pictures, Books, etc., will be permanently damaged or lost.

The main problems of Archives are the following.

With due respect it is stated that before receiving the present Joint Seniority List, enclosed as annexure "A "on dated 8th March 2018, I received the joint seniority list for the first time on dated 13th May 2014 and 1 submitted my reservations to the Director Archives and Libraries on time copy enclosed as annexure "B" and the reply of the Director Archives and Libraries is attached as annexure "C", then appealed to the Secretary Higher Education Archives and Libraries on 05-08-2016, copy enclosed as annexure "D". I raised three points in my application to the Director Archives and I braries at that time. Firstly, the delay in the recruitment process of the Post of Research Officer (initial). Secondly, the attachment of the newly created Posts of the Deserty Directors, belong to a different Cadre and are not the part of the Archives side, with the Research Officer in Joint Seniority. Thirdly, The Archives side and the Library side of the Directorate of Archiv's and Libraries should have equal rights regarding up gradation as both are two wings of the sene Directorate. In fact, the up-gradation policy was for the Librarians of the Directorate of Higger Education Le. College Librarians who had no further chances of promotion while the Lit trians in the Direc orate of Archives and Libraries had already window for further promotion to the post of Chica Librarian and then the Director-Archives and Libraries under the existing prvice structure. Sc, the Archives side may 2 50 be given up gradation like the Librarian side of the Directorate of trchives and Libraries as both are two wings of the same Directorate.

The delay in the advertisement / completion of recruitment process of the post of Research Officer (by Initial) disturbed the routine sequence of seniority of this post and resultantly is now depriving the incumbent of the post of Research Officer (by initial) from promotion to the post of Deputy Director under the present Departmental Seniority List. The matter needs serious and urgent attention because it is directly affecting my chance to promotion to the post of Deputy Director as my post is by initial recruitment. If the matter is not now addressed judiciously then I will have to wait for promotion to the post of Deputy Director for about eight years further after already serving for more than 10 years on the same scale and same post. The total span of service will become 18 years on the same scale and same post. As according to the existing service rules, the senior most one, between the post of the Deputy Director and the post of the Chief Librarian, will be promoted to the post of the Director Archives and Libraries. Since the Chief Librarian being retired (Retired in January 2018) earlier than the Deputy Director (will retire in the end of April 2018) then obviously the new Chief Librarian will be senior to the New Deput Director and thus the new Chief Librarian will be promoted to the post of the Director Archives and Libraries after the retirement of the present incumbent of the post of the Director in 202 and then the new Director will retire in 2025.







REQUEST FOR COMPREHENSIVE RELEVANT COMMENTS, HIGHLIGHTING THE REAL POSITION OF MY PROGRESS IN RESPONSE TO THE LETTER NO. 2493/3/49/DA DATED 08-12-2022 AND CORRECTING THE DIRECTION OF MY PERS' CASE.

Respected Sir,

With humble regards it is stated that a letter No. SO(C-IV) HE/1-6/Archives Misc/Munir Alam PER, issue/2021/5681 dated 20-10-2022 (Annexure-A) was issued from SO (C-IV) towards the Director of Archives and Libraries for comprehensive comments regarding my appeal (enclosed as Annexure B) to the Secretary HED, where in the Secretary HED was requested for help regarding hanging of my applications either within directorate or in the C-IV section. In the application enclosed as (Annexure-B) the reference of my previous three applications was given. The brief and processing status of my previous three applications is as under.

- a. The first through proper channel application addressed to the Secretary HED submitted in the Directorate on 05-07-2022 was not forwarded to the Secretary HED after the laps of more than two and half months (Annexure-C).
- b. The second application related to my seniority issue submitted on 10-04-2018 is still not forwarded to the Chief Secretary, Khyber Pakhtunkhwa for consideration (Annexure-D).
- c. The third application addressed to the Director Archives and Libraries (Annexure-E) in which I had raised some sensitive points regarding the Directorate of Archives and Libraries. The copy of the said application was also forwarded to Secretary HED and SO (C-IV), the then Additional Secretar HED marked the same application to SO (C-IV) for processing, which was not processed by SO(C-IV) till date.

In this connection I requested to the Secretary HED for a strong worded reminder to the quarter concerned through a copy of my application addressed to the Director Archives & Libraries (Annexure-F) but the reply of the application enclosed as annexure-B is still awaited on the part of the Directorate.

- 2. In connection to my PERs issue the Director of A chives & Libraries issued a letter no.2493/3/49/DA, dated 08-12-2022(Annecture G) which needs clarification in some areas for the sake of my career, image and getting to the ground realities.
  - Sir, My Reporting Officer was Director Archives & Libraries cleared from the written orders of the Ex-Director from time to time (copies et closed as Annexure H&!) but he in violation of rules badly Reported my PERs by the irrelevant quarters within the Directorate during the last year of his tenure. On the other hand the PERs of my subordinates were also reported by relevant quarters and they got promotions while I

and post live serving on the same scale and post facing the sensitive issue of my PERs. One can easily imagine such an Environment.

- I have made two appeals to the Secretary HED for help regarding the solution of my PERs'case (copies enclosed as Annexure J & K). After my second Appeal the ex-Director in violation of standing rules badly reported all my submitted PERs within the Directorate. He, in violation of rules, not only tried to use the Authorities of my Competent and Appointing Authorities by trying to change my Reporting and Countersignature Channels but also badly reported my PERs by irrelevant quarters, especially, at the time when the case of my PERs was in the Court of the Secretary HED due to my Appeal submitted on 25-6-2020 in the Office of the Secretary HED.
- iii- In response to his stance i.e provision of Statistical data, late and collective submission of PERs by Muneer Alam, I would like to say that at this stage when my appeal regarding my PERs'case is in the office of the Secretary HED seems to me has no legal grounds. So far as my Progress and Statistical data is concerned then it is stated that Statistical data is subject to various official orders of the Reporting Officer from time to time. In various correspondences I stated time and again that there is not a single order in my notice whose compliance is still awaited on my part. While the responsibility of late and collective submission of PERs rests on the shoulder of the ex-Director according to the PERs' rule of that time (Just two copies of my progress report and details related to the late submission of my PERs are attached as Annexure L & M.)
- iv- Unfortunately, after my appeal to the Secretary HED my PERs'case was moved in such a direction that it took more than two and a half years and is still not solved. I at that time submitted an application for correcting the direction of my PERs'case (copy enclosed as Annexure N).

In view of the above mentioned facts it is kindly requested that in order to save the time and energy, my PERs'case may kindly be moved in the light of my appeal to the Secretary HED and then the subsequent response of the ex-Director in this regard. It is also requested that a strong worded reminder, if possible, may be ssued to the quarter concerned for the relevant comprehensive comments in response to the le er enclosed as Annexure A.



At that time on pattern in vog 2e in the world, Library was just a section like other sections of the Directorate of Archives. In 1992, this office was re-designated as Directorate of Archives & Libraries after construction of the present building. The service rules were accordingly changed, whereby, the post of Director Archives & Libraries was reserved for promotion amongst holders of the posts of Deputy Director and Chief Libraries on the basis of joint seniority. Previously, the Director promoted from Archival wing served till March, 2021, therefore, no issue existed regarding ascertainment of the Reporting Officer for the posts of Research Officers of Archives wing.

- Now, according to the existing service rules, the Chief Librarian being the sen or most is going to be promoted to the post of Director, Archives & Libraries, Listuch a situation the Reporting Officer for the PERs of the posts of Research Officers will be acquestion mark because the Chief Librarian due for premotion to the post of the Director, having thravy background i.e. Librarian, is irrelevant officer for initiating PERs of the Research Officers of Archives wing as according to rules of PERS only senior relevant officer can be the Reporting Officer.
- As far promotion rights of the present Chief Librarian is concerned the 1 it pointed out that she was appointed in this Office as Librarian in BPS-16 then promote to BPS-17. She also availed the upgradation facility in BPS-18; which was due only for librarians of colleges, as they had no chance of promotion in colleges. Moreover, 15 per Court decision, she and other librarians of this Directorate got back benefit of approximately Rs. 02.00 million on account of retrospec we upgradation in BPS-17 with affect from the date of a quiring Master degree in library & Information Science. Besides, she was also promoted to the post of Chief Librarian vacated in 2018.

With due respect it is stated that there is difference between official meeting and official sitting and the details about the sitting of 26<sup>th</sup> July, 2021 are elaborated in the letter No. 1125/10/50/DA dated 23<sup>rd</sup> August, 2021, addressed to the Deputy Commissioner Peshawar. On the attendance sheet, someone first fluid/erased my remarks i.e. not attendant the full meeting, and then the tempered document was scanned. The above mentioned scanned tempered document of File no. 10/50 may need to be corrected.

- Description, I would like to say that some record of Weeding and Publication section have been scanned during the tenure of the previous Director Archives & Libraries without consulting /by-passing me, like in other matters related to my post and career and roundabout same situation is still going on Microfilm record is, comparatively, an authentic source and is beyond the approach of human expertise regarding tempering & authenticity while scanned material is not as such. Only, Primary (original) Source is consulted by both the Courts as well as the Research Scholars. Keeping in mind, it is the established practice throughout the World that Research Scholars, in order to save the original old Paper-Record from wearing & tearing by time and again touching the old paper-record, consult their relevant material in the Microfilmed Record, so need is to revive again the Microfilm-Section.
- As the custodian of the record, we must receive, preserve and retrieve the public record under the National Archival Act, of 1993, and the Archival Material (Preservation and export control) Act, of 1975. Facilitating a Government Agency/Department or Public means the provision of only the selected relevant material from the available Archival Record, with the proper approval of the Director of Archives & Libraries Only notes taken by Research Scholar through pencil on a paper is allowed while photocoping, scanning etc. of the record is a Section with the proper facilitation of the Staff of the Directorate in the Research and Record attention.
