

SERVICE APPEAL U/S 4 OF THE KHYBER PAKHTUNKHWA SERVICES
TRIBUNAL ACT, 1974

Respectfully Sheweth: -

The appellant very humbly submits as under: -

BRIEF FACTS:

1. That the Appellant was inducted into District Police, Dera Ismail Khan on 21/11/1978 as Constable, since then the Appellant performed his duties honestly with zeal and zest and to the satisfaction of his superiors. In this respect the service record of Appellant is very much evident.
2. That the Appellant performed his duties with full satisfaction of his superiors and was promoted as Head Constable/Hawaldar vide order book No. 992 on 13/09/1997 due to better performance in the department in accordance with service role.
3. That thereafter the Appellant due to his better performance and passing of departmental courses was promoted to the rank of Assistant Sub Inspector vide office order No. 1192-93/ES dated 24/04/2007 Diary No. 3835, Order Book No. 395 dated 27/04/2007 & then confirmed as ASI on 09/06/2011 vide order No. 2561-63/ES dated 30/06/2011 and Order Book No. 727 dated 04/07/2011. It is worth mentioning here that the Appellant was eligible to be promoted as ASI in 2009 but due to lethargic conduct of respondents the Appellant was much later promoted as ASI in 2011 vide letter No. 2561-63/ES dated 30/06/2011.
4. That on 15/06/2011 the Appellant was enlisted in confirmation list-E No. 2561-63/ES dated 30/06/2011 and order book No. 727 dated 04/07/2011 and then promoted as Sub-Inspector according to letter No. 4105-8/ES dated 26/12/2013 order book No. 1846 dtd 30.12.2013 and confirmed as S.I vide RPO D.I. Khan Endst No. 4246/54/ES dated 23/04/2017.
5. That on 11/01/2019 the Appellant was placed in Promotion List F vide No. 127E111 & for confirmation and promotion placed at serial No. 14 dated 09/07/2016 and order book No. 94 dated 21/01/2019. Copies of relevant records are placed at Annexures A to A/5.
6. That the Appellant time and again requested the Respondents to promote him to the rank of Inspector (BPS-16) but the requests of Appellant were shuffling from desk to desk. Copies of applications are annexed as Annexures B to B/ .

7. That according to letter No. 247-53/CCP dated 09/02/2016 the IGP Khyber Pakhtunkhwa directed the authority to take up and decide the case in the given schedule of the said letter and proposal. Schedule of list-F and E, are annexed as Annexures C to C/1.
8. That on applications of Appellant the respondents even did not bother to call the Appellant for personal hearing nor any departmental proceeding was initiated to redress the grievances of Appellant and even did not respond to the requests of Appellant in written or oral form. The Appellant requests this Hon'ble Tribunal to direct the Respondents to produce office file No. 5252/ES dated 05/07/2023 and 11/10/2023 from the office of Respondent No. 2 regarding detail report of the case of Appellant (which was not provided to Appellant despite several requests).
9. That in the attending circumstances as the departmental appeal of Appellant was not decided within stipulated period hence this instant petition of following grounds inter-alia, as under,

Grounds:

- A. That in view of the hard work and better performance in Department the Appellant ought be treated on equality being similarly placed to those earlier benefited on same terms.
- B. That the Appellant has been discriminated in the matter of promotion and as the said discrimination smacks of malafide, the impugned act of quarter concerned merits annulment.
- C. That as the Appellant is senior hence the Respondents/Authorities were required to promote Appellant as senior but he was ignored in violation of all the rules, hence the said act of Respondents is not tenable in the eyes of law.
- D. That the Appellant has unblemished service record in his favor and to his credit but the Respondents did not consider this important aspect of the case and promoted juniors than Appellant while ignoring the service right of Appellant without any lawful justifications.
- E. That the impugned acts of Respondents are based on pick and choose to oblige the blue eyed employees which speak of explicit discrimination and amounts to infringement of rights of the appellant.
- F. That this Hon'ble Tribunal has got vasa and ample powers to entertain and allow the instant appeal.
- G. That Counsel for Appellant may graciously be allowed to raise additional grounds at the time of arguments, if need be.

PRAYER:

In view of the fore mentioned submissions, it is very humbly prayed that on acceptance of instant appeal the Appellant may kindly be promoted in BPS-16 as an Inspector from 2015 according to F-List No. 127/E-III dated 11/01/2019 placed on serial No.14 and according to seniority list of OFFG/Inspector and confirmed Assistant Sub-Inspectors on List-E as it stood on 31/12/2012 Notification No. 555 serial No. 64. Grant of any other relief including costs, as may be deemed appropriate by the Hon'ble Tribunal is solicited, too.
