Learned counsel for the appellant present. Preliminary arguments heard.

The appellant has filed the present service appeal against the order dated 02.11.2011 whereby the appellate authority converted the major penalty of removal from service into penalty of stoppage of four increments. The appellant has also assailed the order dated 29.08.2019 through which case/appeal of the appellant was rejected.

Initially, the appellant was removed from service vide order dated 08.04.2011. Upon acceptance of departmental appeal of the appellant vide order, dated 28.07.2011, major penalty of removal from service was converted into major penalty of reduction to lower post of Theology Teacher. However office letter dated 22.09.2011 from the Khyber Pakhtunkhwa Elementary & Secondary Education Department was issued to the Director Elementary & Secondary Education Khyber Pakhtunkhwa Peshawar wherein it was mentioned that the appellant does not fulfill the prescribed qualification for the post of Theology Teacher to which he has been reverted and the appellate authority vide order dated 02.11.2011, reviewed its earlier order and converted the penalty of removal from service into minor penalty of stoppage of four increments.

The impugned order of appellate authority was issued on 02.11.2011, however, the appellant has approached there against before this Tribunal, by filing service appeal, on 26.09.2019 i.e. after a period of more than seven years. Consequently the present service appeal is found hopelessly time barred and as such is hereby dismissed in limine. Needless to mention that subsequent order dated 29.08.2019 mentioned above, from the Directorate of Elementary & Secondary Education Khyber Pakhtunkhwa Peshawar, cannot extend the period of limitation. No order as to costs. File be consigned to the record room.

ON ACCEPTANCE OF INSTANT APPEAL, THE IMPUGNED ORDER NO 221-26 DATED 02/11/2011 BE MODIFIED. TO THE EXTENT OF RESTORATION OF ENTIRE FOUR (4) INCREMENTS OF THE APPELLANT.

Respectfully Sheweth,

FACTS

- That, the appellant was appointed as Arabic Teacher (A.T) BPS-09 in the Elementary & Secondary Education Department District Abbottabad, on 05.04.1999 and has been serving the Department since then.
- 2) That, appellant was serving at GHS No.3 Abbottabad where on 15.08.2009, another teacher namely Mr. Abdur Rasheed Ex-A.T at GHS Jhangi in order to break his long tenure, did a mutual transfer with appellant and on 12.092009, after a month to the above said order, appellant was transferred from GHS Jhangi to GHS Jabrian and Mr. Amanullah A.T previously at GHS Jabrian was transferred to GHS Jhangi. After approximately 8 months to the above said transfer, on 20.05.2010 vide order No. 5778-82 by respondent No.3, three teachers returned on their previous posted schools. (Copies of above said all three transfer orders are attached as annexure "A").
- 3) That, on 31.05.2010 Mr. Abdur Rasheed Ex-A.T filed a departmental appeal against the order dated 20.05.2010 before DCO Abbottabad and on 16.06.2010 the aforesaid appeal was dismissed. (Copy of Departmental appeal and order dated 16.06.2010 are annexed as Annexure "B").
- 4) That, after dismissal of above said departmental appeal, Mr. Abdur Rasheed used political influence by approaching Mr. Inayat Ullah Khan Ex-MPA PK-44, who recommended the application of Mr. Abdur Rasheed and cancelled the order of respondent No.3 dated 20.05.2010 on 29.06.2010. (Copy of application and order dated 29.06.2010 are annexed as annexure "C").
- 5) That, the appellant filed a departmental appeal on 03.07.2010 before District Coordination Officer, Abbottabad against the cancellation order dated 29.06.2010 which is pending since long time. The appellant moved an application before respondent No.2 requesting him for disposal of the appellant's departmental appeal. In reply respondent No. 2 issued order to respondent No.3 on 15.07.2010 vide Endst No:6624 for cancellation of said

order dated 29.06.2010 but Respondent No.3 did not comply with the order of respondent No.2 and mentioned that the letter No. 6627 is bogus and forged. (Copies of departmental appeal and order No. 6624 dated 15.07.2010 are annexed as annexure "D").

- 6) That, on 17.07.2010, Mr. Abdur Rasheed Ex-A.T challenged the earlier cancelled order i.e. 20.05.2010 before the Hon'ble Service Tribunal, Peshawar vide infructuous appeal No. 1199/2010. The respondents /Department took the stance in their reply to the above said appeal, that the above said order dated 20.05.2010 was on merit and as per the posting / transfer policy. (Copy of written reply is annexed as annexure "E").
- 7) That, respondent No.3, vide letter No. 10547 dated 05.08.2010 wrote to the respondent No.2 regarding the verification of letter No. 6624 dated 15.07.2010, upon which the respondent No.2 replied in positive vide letter No. 3962 dated 07.09.2010 and directed respondent No.3 to take action upon the said letter. (Copies of letter No. 10547 dated 05.08.2010 and letter dated 07.09.2010 are annexed as annexure "F").
- 8) That, the respondents conducted inquiry for the genuineness of letter No. 6624 dated 15.10.2010 issued by respondent No.2, without issuing any charge sheet / statement of allegation to the appellant and inquiry officer handed over to the appellant (by hand) questionnaire for reply. During the inquiry no charge has been proved against the appellant. (Copy of questionnaire and written reply of questionnaire are annexed as annexure "G").
- 9) That, on 24.08.2010, Mr. Abdur Rasheed (Ex-A.T), presented a so-called letter before the Hon'ble Service Tribunal in absence of appellant, on behalf of appellant, and the Hon'ble Service Tribunal fixed date for the verification of the same on 04.10.2010, and at the same date, Mr. Abdur Rasheed submitted application for withdrawal of his said appeal which was accepted.

- 10) That, on 15.01.2011, respondent No.3 issued a Show Cause Notice to appellant and the reply was submitted properly on 08.02.2011 by the appellant. (Copy of show cause notice, reply of show cause notice is annexed as annexure "H").
- 11) That, on 08.04.2011, respondent No.3, issued order for removal from service of the appellant w.e.f 23.11.2010 under Repeal Act, Special Power Ordinance 2000. (Copy of order dated 08.04.2011 is annexed as annexure "I").
- 12) That, the appellant has filed Departmental Appeal before the respondent No.2 against the Removal from Service and the same was decided by the respondent No.2 on 28.07.11 whereby the major penalty of the appellant was converted into another major penalty "Reduction to Lower Post". The appellant feeling aggrieved by the decision of respondent No.2, filed an appeal before respondent No.1 where upon respondent No.1 sought comments from respondent No.2 vide letter dated 22.09.2011 and finally respondent No.2 issued order No.221-26 dated 02.11.2011 vide which the previous order dated 28.07.2011 held cancelled and the Minor Penalty of stoppage of four (4) increments for cumulative effects was imposed. (Copy of the order dated 28.07.2011 and Appeal and Letter dated 22.09.2011 & Order dated 02.11.2011 are attached as annexure "J").
- 13) That, still feeling aggrieved, appellant field a Departmental Appeal on 16.11.2011 against the said order dated 02.11.2011 before the respondent No.1 but unfortunately the appeal was rejected on 29/08/2019. (Copy of Appeal dated 16.11.2019 and order dated 29.08.2019 is annexed as annexure "K").
- 14) That, feeling aggrieved the appellant left no other option for his redressal except to knock the door of this honourable tribunal, against the impugned order dated 02.11.2011 on the following amongst other grounds:-

GROUNDS:

- a) That order dated 02.11.2011 to the extent of stoppage of four (4) increments of appellant is void, ab-initio, illegal, erroneous, unlawful.
- b) That, during the whole inquiry process, the appellant has not been provided any opportunity of cross examination. Hence, the said order is liable to be modified.

- c) That, the appellant has also not been given any opportunity of personal hearing which is the basic right of appellant hence, the said inquiry is totally based on malafide.
- d) That, whole inquiry process was conducted only at the questionnaire basis and no charge sheet / statement of allegation was served upon the appellant, which is not warranted in law.
- e) That, the directions dated 04.10.2010 by the Hon'ble Tribunal against the appellant were totally against the law because:
 - a) Service Appeal No. 1199/2010 has already been infractious on 29.06.2010.
 - b) The said Service Appeal has also been withdrawn by the then appellant (Mr. Abdur Rasheed).
 - c) The directions, against the appellant by the Hon'ble Service Tribunal was issued in the absence of appellant.
- f) That, the order of stoppage of four (4) increments was totally against the E&D Rule 2011.
- g) That, order No. 6624 was earlier proved genuine and true after the conclusion of verification. But this fact was ignored by the respondents.
- h) That, appellant filed a review petition against the order dated 04 10.2010 before the Hon'ble Tribunal but the same was not entertained and was returned with the remarks that the Hon'ble Service Tribunal has no jurisdiction to adjudicate the said matter. (Copy of Review Petition is annexed as annexure "L")
- i) That, after the reinstatement, the appellant filed Service Appeal before this Hon'ble Tribunal against the transfer order dated 29.06.2010 and placed all the real fact and grounds before the Hon'ble Tribunal and, the Hon'ble Tribunal accepted the Service Appeal No. 304/2012 of appellant on 02.05.2013. (Copy of judgment is annexed as annexure "M").

- j) That, the four (4) increments of appellant was stopped with cumulative effect by the respondent No. 2 everlastingly while, under the E&D Rules 2011, Increment of any employee can only be stopped maximum for three years.
- k) That, respondent No.3 Zafar Arbab Abbasi (Ex-DDO), was very much biased with the appellant and the local MPA (PK-44, Abbottabad) was also against the appellant which is crystal clear from this point that respondent No.2 issued two letter No. 6624 and 6625 dated 15/07/2010 to the respondent No.3 for compliance regarding the transfer but the respondent No.3 compliance the order No.6625 on 28/07/2010 but did not compliance the second letter No.6624 which was related to the appellant. (Copies of order No.6625 by respondent No.2 and order dated 28/07/2010 are annexed as annexure "N")
- 1) That, the instant Appeal is well within time. The other points shall be argued at the time of arguments with the prior permission of this Hon'ble Tribunal.

It is therefore, respectfully prayed that the instant appeal may graciously be accepted, and impugned Order No. 221-26 dated 02.11.2011 be modified to the extent of restoration of entire four (4) increments of appellant. Any other relief for which the appellant is entitled and same is not asked/prayed, specifically may kindly be granted in the favour of the Appellant too.

JUDGMENT

SYED MANZOOR ALI SHAH, MEMBER.- This appeal has been filed by Naveed Iqbal, the appellant under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act 1974, against the order dated 30.11.2011, whereby he was transferred to GMS Todo Maira, Abbottabad. It has been prayed that on acceptance of the appeal, the impugned order may be set aside and the order dated 20.5.2010 may be restored.

2. Brief facts of the case are that the appellant while serving as Arabic Teacher in GHS No. 3 Abbottabad, respondent No. 4 offered the appellant for mutual transfer only for three months. In this respect an agreement was written

and the appellant was transferred to GHS Jhangi Abbottabad and respondent No. 4 to GHS No. 3 Abbottabad. After expiry of three months period, respondent No. 4 turned from his version and refused to join his previous station i.e. GHS Jhangi Abnbottabad. After few days the appellant was further transferred from GHS Jhangi to GMS Jabrian, Abbottabad and respondent No. 3 was transferred to GHS Jhangi vide order dated 12.9,2009. Appellant was again transferred from GMS Jabrian to GHS No. 3 Abbottabad vide order dated 20.5,2010, but due to political influence of respondent No. 4 the said order was cancelled through the order dated 29.6,2010 and appellant was directed to perform his duties at GMS Jabrian. On 30.11.2011, again due to political pressure exercised by respondent No. 4 appellant was transferred from Jabrian to GMS Todo Maira. Feeling aggrieved, the appellant filed departmental appeal to respondent No. 2, which has not been decided within the statutory period, hence the present appeal.

3. The appeal was admitted to regular hearing on 27.3.2012 and notices were issued to the respondents. The respondents have filed their written replies and contested the appeal. The appellant also filed rejoinder in rebuttal.

Arguments heard and record perused.

pellant argued that he while serving at GMS Jabrian was transferred to GHS No. 3 Abbottabad in public interest on 20.5.2010. He served there for only 40 days that all of a sudden vide order dated 29.6.2010, he was again transferred to GMS Jabrian and private respondent No. 4 was transferred in his place through political interference and private respondent No. 3 transferred from GMS Jabrian to GHS Jhangi, Abbottabad. Vide order dated 30.11.2011, the appellant was further transferred to GMS Todo Maira and private respondent No. 3 transferred to GMS Jabrian through political interference. Appellant further argued that the he has been victimized through political pressure as is evident from application dated 25.5.2010 of private respondent No.4, which has been recommended by Mr. Inayatullah Khan Jadoon, MPA PK-44, and copy of order dated 29.6.2010 has also been endorsed to P.S to the Chief Minister Khyber Pakhtunkhwa. He further argued that he has not completed his normal tenure at GHS No. 3 Abbottabad, hence the impugned order is premature and against the policy of the provincial government. He stated that private respondent No. 4 served in GHS No. 3 for more than 3 years and no one can ask for his choice posting for ever.⁴ On the point of learned counsel for the private respondents that the appellant was removed from service on production of forged stay order, the appellant stated that he has been reinstated into service vide order dated 2.11.2011. In case anyone, aggrieved from his reinstatement order could

approach be the proper forum. He requested that the appeal may be accepted as prayed for.

6. The learned counsel for private respondent No. 4 stated that the appellant has been removed from service on production of bogus stay order. He further argued that it is correct that the appellant has been transferred repeatedly but on his own request. So far as the mutual transfer is concerned, it was made with the consent of the appellant without any external pressure. He stated that under Section 10 of the Khyber Pakhtunkhwa Civil Servants Act 1973, every civil servant is bound to serve anywhere in public interest and no one can ask for his choice posting. He further stated that the appellant through bogus signature of private respondent No. 3, succeeded to transfer himself to GHS No. 3 Abbottabad, vide order dated 20.5.2010. The learned Government Pleader also relied on the arguments advanced by the learned counsel for private respondents No. 3 and 4. They both requested that the appeal may be dismissed.

7. Counsel for the private respondents mainly argued on the point that the appellant was removed from service on production of bogus stay order. But since the appellant has been reinstated into service by the departmental appellate authority, the matter has been settled. In case there was any allegations against the appellant, he could be dealt with in accordance with the law but he could not be transferred as a punishment. In a short span of time, the appellant has been repeated transferred through political pressure as is evident from application dated 25.5.2010 which has been recommended by the Mr. Inayatullah Khan, Local MPA PK- 44. All these show that the impugned order as well as subsequent order dated 29.6.2011 issued on malafide intentions, through political pressure and premature. Such practice has been deprecated by the august Supreme Court of Pakistan in a judgment as reported in 2007 SCMR-599.

8. In view of the above, the appeal is accepted the impugned orders dated 29.6.2010 and 30.11.2011 are set aside and order dated 20.5.2010 is restored. Parties are left to bear their own costs. File be consigned to the record.
