



APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974, AGAINST THE ACT OF RESPONDENTS, NO.1 & 2, WHEREBY THEY HAVE BEEN ISSUED SENIORITY LIST OF EMPLOYEES VIDE DATED 25/04/2019, IN WHICH THE NAME OF APPELLANT HAS BEEN PLACED AT SERIAL NO.12, WHILE THE NMAES OF HIS JUNIORS. I.E. RESPONDENTS NO 3 TO 6 HAS BEEN PLACED AHEAD FROM THE APPELLANT IN THE ABOVE MENTIONED SENIORITY LIST, AGAINST WHICH THE DEPARTMENTAL APPEAL OF THE APPELLANT HAS NOT BEEN RESPONDED, DESPITE THE LAPS OF MORE THAN THE STATUTORY PERIOD OF NINTY DAYS.

Prayer in Appeal: -

On acceptance of this appeal the acts and conducts of the respondents in respect of being placed the name of appellant below from his juniors in the impugned seniority list issued vide dated 24/05/2019, may kindly be declared illegal, unlawful, without lawful authority, against the natural justice, violation of rules and law and liable to be declared so. Accordingly the respondents be directed not violate the original seniority of the appellant and to place the name of appellant on his original position from his appointment 14/03/1983 and accordingly promoted to BPS-17 on his own turn.

BRIEF FACTS:-

- 1) That Petitioner is a bonafide citizen of Pakistan and belongs to a respectable family and serving as Assistant BPS-16, presently posted at GTVC Hayatabad, Peshawar.

- 2) That the appellant had preferred an application to the Director Technical Education, KPK for his appointment in February 1983, which was strongly recommended and he was appointed as junior clerk vide dated 12/03/1983, thereafter the appellant submitted arrival report to the competent authority and accordingly assumed the charge of his respective post of junior Clerk. **(Copy of appointment order and arrival report are attached as annexure "A" & "B")**
- 3) That the appellant after his appointment was performing his duty to the entire satisfaction of his high ups and no Complaint whatsoever has ever been forwarded against him, moreover when the appellant was performing his duty with great zeal and zest on the above mentioned respective post, In the meanwhile the respondents no.1 & 2 has issued a seniority list vide dated 31/12/1989, whereby the Juniors most employees were placed as senior from the appellant and the name of appellant has been mentioned below from his Juniors, accordingly the appellant had submitted an application for rectification/correction of the already issued seniority list. **(copies of Seniority list issued dated 31/12/1989 and appeal of the appellant are attached as annexure "C" & "D")**

4) That the appellant had objected the seniority list and submitted the above mentioned application, the respondents had realized their mistake in respect of seniority list, with the commitment to appellant for reissuance of the said, however after sufficient time the respondents did not bother to reissue the correct seniority list, therefore, the appellant had again submitted an applications in the year 1996 and 97, while the respondents had never ever even considered the request of the appellant and maintained the above mentioned wrong seniority list. **(copies of applications are attached as annexure "E" &"F")**

5) That after submission of various applications and objections by the appellant, consequent upon the respondents had issued a tentative seniority list, whereby the name of appellant had been again placed below his juniors and did not consider his seniority from his first appointment, thereafter, the appellant along with other his colleagues have been raised objections on the seniority list and time and again submitted objections applications to the competent authority for issuance of accurate and as per correct seniority list, but the competent authority did not bother to issue seniority list as per actual appointment of amongst employees.

- 6) That it is pertinent to mention here that competent authority have been pleased to issue various seniority list, whereby the name of the appellant changed in different numbers, it could be seen in the tentative seniority list of 2015 and final merit list of 2015, similarly in tentative merit of 2016 and final merit list of the year 2016, from that it could easily be gathered that the respondents had been issued all the seniority lists blindly and the name of the appellant have been placed below his juniors. **(Copies of tentative and final merit lists are attached as annexure "G")**
- 7) That the appellant had strongly objected all the above mentioned seniority lists issued by the competent authority, therefore, time and again submitted his objections, while placed his name below his juniors, but no avail, now once again the respondent no.1 has issued a tentative and final seniority list, whereby the name of appellant has been placed in two different numbers, and the seniority of the appellant has been violated. **(Copies of seniority lists of 2019 are attached as annexure "H")**
- 8) That after issuance of tentative merit list of 2019 the appellant again submitted a departmental appeal before the competent authority for redressal, while the Respondent No 1 without any rhymes and reasons

delayed and not accepting the departmental appeal, neither issued correct seniority list in favour of appellant, nor rectified the same incorrect seniority list.

(Copy of departmental appeal is attached as annexure "I")

- 9) That it is impliedly declined on completion of statutory period, hence the appellant is constrained to files the instant **Service Appeal** against the violation of his right of seniority on the following grounds inter-alia!

GROUND:-

- A) That the act of Respondents is unlawful, illegal, void ab-initio and in disregard of law applicable to the matter.
- B) That appellant meeting being fulfilling the same criteria was deem to have been validly appointed on regular basis, but declined to favour blue eyed from whom the appellant being qualified, eligible and competent for the promotion has acquired the status of regular employees.
- C) That the appellant has been initially appointed as junior clerk on dated 14.03.1983, in all the seniority lists the initial appointment of the appellant has been mentioned, similarly the respondents no.3 to 6 are appointed after the appellant and the appellant is being senior most

from the respondents no.3 to 6, however the competent authority had been placed the names of the respondents no.3 to 6 prior to the appellant in the last impugned seniority list, therefore, violated the right of seniority of appellant, these acts of the respondents are highly discriminatory and based on pick and choose which is liable to be declared so.

D) That since the issuance of 1st seniority list the appellant had made strong objection and submitted a departmental appeals, but the respondents had never ever considered the objection of the appellant and time and again raised such objections and now when the respondents finally issued a tentative merit list of 2019, the appellant accordingly submitted a departmental appeal for consideration, but no avail.

E) That as per the law and guideline of the apex courts it has categorically been specified that seniority will be counted from the date of appointment and it has been again specified that if two persons have been appointed on the same day the seniority would be given to the candidate on their age, similarly the case of the appellant is

concerned it is crystal clear from the above mentioned record that he has been superseded through his juniors, which is illegal against the seniority policy and liable to be set aside.

- F) That the department is violating all the basic fundamental rights and protections given in the Constitution of Islamic Republic of Pakistan, 1973.
- G) That the conduct of Respondents is offending the principles of natural justice, equity and fair play.
- H) That in the peculiar facts and circumstances of the case, the interference of this Honourable service tribunal is warranted under the law.
- I) That other grounds will be raised at the time of arguments with the permission of this Honourable Court.

It is, therefore, respectfully prayed that

On acceptance of this appeal the acts and conducts of the respondents in respect of being placed the name of appellant below from his juniors in the impugned seniority list issued vide dated 24/05/2019, may kindly be declared illegal, unlawful, without lawful authority, against the natural justice, violation of rules and law and liable to be declared so. Accordingly the respondents be directed not violate the original seniority of the appellant and to place the name of appellant on his original position from his appointment 14/03/1983 and accordingly promoted to BPS-17 on his own turn.

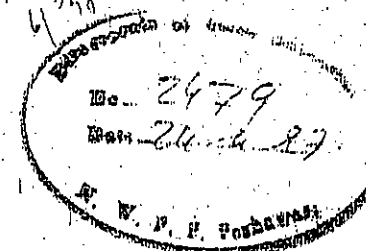

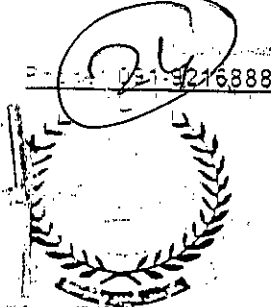

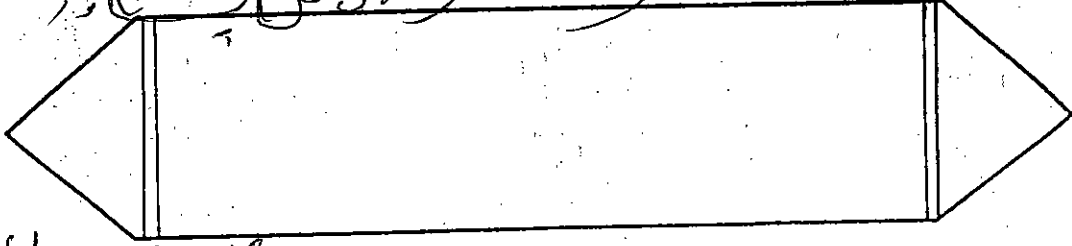
