APPEAL UNDER SACTION 4 OF THE K.P.K SERVICE TRIBUNAL ACT 1974 AGAINST THE ORDER # 112-19/SCJ (Admn) BANNU, dated 01.11.2023, whereby the appellant has been awarded for the major penalty of compulsory retirement from service imposed by Muhammad Asghar, Senior Civil Judge (Admn), Bannu, against which the departmental appeal was also dismissed vide Departmental appeal No. 02 of 2023 instituted on: 24.11.2023, decided on 13.01.2024 by Muzzamil Shah Khattak District & Session Judge, Bannu.

PRAYER IN APPEAL:

ON ACCEPTENCE OF THIS APPEAL THE ORDER NO. 112-19/SCJ (ADMN) BANNU DATED: 01.11.2023 VIDE WHICH MAJOR PENALTY OF COMPULSORY RETIREMENT FROM SERVICE WAS IMPOSED UPON THE APPELLANT AND DEPARTMENTAL APPEAL NO. 02 OF 2023 WHICH WAS DISMISSED BY MUZZAMIL SHAH KHATTAK DISTRICT & SESSION JUDGE, BANNU ON 13.01.2024 MAY PLEASE BE DECLARED AS ILLEGAL, VOID AB INITIO, UNLAWFUL, AGAINST LAW BE SET-ASIDE AND THE RESPONDENT MAY GRACIOUSLY ΒE DIRECTED TO REINSTATE THE APPELLANT ON HIS POST WITH ALL HIS BACK BENEFITS.

Respectfully Sheweth:

- A. That the applicant was initially appointed as process server, whereafter he was promoted to the post of junior clerk/Niab Nazir (BPS-11) in the establishment of Senior Civil Judge (Admn) Bannu, and was posted as a reader to court of learned Civil Judge X, Bannu.
- B. A written complaint No. 336/civil judge-X, Bannu dated: 09.09.2023 was received to the office by presiding officer of civil judge X, Bannu, which was subsequently enterested to Senior Civil Judge (Admn) Bannu through letter No. 4158/DSJ, Bannu dated: 11.09.2023 with direction to proceed the complaint in accordance with law and rules, (Copy of complaint No. 336 dated 09.09.2023 & Letter No. 4158/DSJ, Bannu dated: 11.09.2023 is annexed as annexure "A & B")

- C. The appellant is saddled with the accusation of his having received a bribe of Rs. 1000/- from plaintiff Abdul Raheem in civil suit titled "Nawab Zada Abdul Raheem vs Muzffar Khan & others" scheduled for hearing on 09.09.2023 before the court of civil judge X, Bannu.
- D. The matter was referred to senior civil judge (Admn) Bannu for further action in accordance with law, which led to initiation of disciplinary proceedings against appellant. On 12.09.2023 a show cause notice No. 930/SCJ(Admn) dated 12.09.2023 was served upon the appellant and on the same day, he was suspended until the completion of departmental inquiry, as per office order No. 933/SCJ(Admn) Bannu. The reply of the notice No.930 was also submitted by the appellant. (Copy of show cause notice No.930 dated: 12.09.2023 & letter of suspension no. 933/SCJ (Admn) dated: 12.09. 2023, and reply of the notice No. 930 is annexed as annexure "C, D & E")
- E. After submitting the reply, of the final show cause notice No. 955 dated: 21.09.2023 and the reply it was deemed unsatisfactory. And major penalty of compulsory retirement under rule 4 (b)(ii) of Khyber Pakhtunkhwa Governments servants (efficiency & disciplinary) rules 2011 was imposed on 31.10.2023 & the office order dated:01.11.2023 by Hon,ble Muhammad Asghar Senior Civil Judge (Adman) Bannu. (Copy of final show cause notice and the reply and final order dated: 31.10.2023 and the office order dt: 01.11.2023 are annexed as annexure "F, G,H & H-1")

G. That the appellant now approaches this Honourable tribunal against the above said order on the following grounds amongst others.

GROUNDS: -

- A. That the above said orders of compulsory retirement of the appellant is illegal, unlawful and against the law and facts on record: hence liable to be set aside.
- B. That the respondents as well as the enquiry officer failed to comply with the procedure of enquiry as provided in the efficiency & discipline rules 2011, thereby causing grave miscarriage of justice.
- C. That the appellant has been wrongly penalized for an act for which he is not responsible. The amount was not recovered from the direct possession of the appellant.
- D. The amount was picked by the hon, ble civil Judge X,

 Bannu from the table. And the video also made by the
 same Judge. The Appellate authority/officer falled to give
 due consideration to this vital aspect of the case.

- E. That this fact was also ignored by the enquiry officer and the appellate authority that on the date fixed layers are on strike and in routine the hon, ble Civil Judge X, Bannu fixed the next dates of the cases. And further it was unbelievable and also not acceptable to the prudent mind that in presence of Hon, ble Judge and other officials the appellant take the money from the plaintiff Abdul Raheem whose case was fixed before the court.
- F. In video if some one as per allegation drop some money on the table without the information of appellant and the appellant also not take the same amount and the same was also not recovered from the appellant then how and why the appellant is responsible in presence of other officials who also used the same table.
- G. The learned authority also ignores this fact and decide the matter on the basses of other enquires which were already decided in appellant favour. The decisions are against the orders of apex courts because it's held in various decisions that each and every case must be decided on their own facts and on their own merits.
- H. That there is no evidence of any relations with the person Abdul Raheem from whom the amount was stated to be taken even his statement against the appellant was also not available on the record.
- I. That this fact was also ignored by the appellate authority that when the Hon, ble Civil Judge-X, Bannu noticed and saw the that a person secretly drop the money on the table and the appellant not notice the same then why he

was not arrested on the spot and why his statement was not recorded and why he was not enquired regarding the matter to dig out the facts on the spot.

- J. That appellant has performed his duty with due care, loyalty and with great zeal.
- K. That appellant never been involved in any illegal act regarding his official duty and even on duty hours he never made any conversation with the person from whom the amount was stated to be taken.
- L. That appellant belongs to a very poor and humble family and he is the only source of income of his family and never think about such like offence.
- M. That its also unjust that in criminal case if someone was plead guilty then the other one cannot be punished on this score.
- N. That the appellant seeks leave of this Hon, ble Tribunal to raise additional grounds at the time of arguments.

It is therefore respectively requested that on acceptance of instant appeal the order no: 112-19/scj (admn) Bannu dated: 01.11.2023 vide which major penalty of compulsory retirement from service was imposed upon the appellant and departmental appeal no. 02 of 2023 which was dismissed by muzzamil shah khattak district & session judge, bannu on 13.01.2024 may please be declared as illegal, vold ab initio, unlawful, against law be set-aside

and the respondent may graciously be directed to reinstate the appellant on his post with all his back benefits.

Any other relief deemed appropriate but not specifically asked for may also be granted.

With due reverence, it is to bring into your kind notice that today at about 09.27 am, the undersigned was presiding over the court that in the meanwhile a person/plaintiff in civil case titled "Nawabzada Abdul Reaheem versus Muzaffar Khan etc." entered into court room and stood in the witness box, adjacent to the reader of the court for receiving next date. He bent on reader of the court, signaled him and placed some piece of paper beneath the register/files lying on left side of the reader. 2. Allegations leveled against the delinquent official are that Civil Suit titled "Nawab Zada Abdur Raheem ... VS ... Muzaffar Khan & others" was fixed for hearing before the Learned Civil Judge-X, Bannu on 09.09.2023 and on the same day an amount of Rs.1000/- was received by the delinquent official from plaintiff as bribe; that the incident was preserved in CCTV footage installed inside the Court and recovery was effected on spot from delinquent official by the Learned Presiding Officer of the Court. Video recording of recovery from the spot was also preserved in the personal

cell phone of the Learned Presiding Officer and hence the matter was referred to the undersigned being competent authority to proceed against him in accordance with law/rules.

Show Cause Notice Bearing No. 930/SCJ (Admn), 3. Bannu dated 12.09.2023 was served upon the delinquent official with the direction to submit his reply within 07 days positively. Since allegations of corruption were leveled against the delinquent official; therefore, he was also suspended till completion of departmental inquiry vide Office Order No.933/SCJ (Admn), Bannu dated 12.09.2023. Before submission of written reply to the Show Cause, delinquent official requested for provision of Video Recordings which were provided to him and thereafter he submitted reply to the Show Cause on 19.09.2023. Reply to the Show Cause Notice was found unsatisfactory. Keeping in view the sufficient evidence on record in shape of Video Recording and recovery of amount of Rs. 1000/- as bribe, inquiry in the instant case was dispensed with under Rule 5 (1)(a) of the Khyber Pakhtunkhwa Government Servants (Efficiency & Disciplinary) Rules, 2011 and Final Show Cause Notice Under Rule 7 (a) of the Khyber Pakhtunkhwa Government Servants (Efficiency & Disciplinary) Rules, 2011 was served upon him as to why major penalty Under Rule 3 (c) read with 4 (b) of the ibid rules shall not be imposed upon him. He was directed to submit reply to the final show cause within 07 days. Reply to the final show cause Notice bearing No. 955/SCJ (Admn), Bannu dated 21.09.2023 was submitted by the delinquent official on 27.09,2023 which was also found unsatisfactory. Notice of personal hearing was given to the delinquent

official as to why major penalty Under Rule 4 (b) (ii) of the Khyber Pakhtunkhwa Government Servants (Efficiency & Disciplinary) Rules, 2011 shall not be imposed upon him.

On 05.10.2023, delinquent official was heard in person. Incharge Data Management Cell Mr. Tariq Khan provided CCTV footage Video Recording of the Court of Learned Civil Judge-X, Bannu and video recording preserved by the presiding officer/Learned Civil Judge-X, Bannu and both the videos were displayed before the delinquent official in open court. Delinquent official was confronted with the video recordings and particularly the recovery of an amount of Rs. 1000/- available on file. In response he was unable to justify his guilt before the court as is evident from Order Sheet No.4 dated 05.10.2023.

for Final Order on 31.10.2023. Alongside the instant departmental proceedings, Criminal Complaint No.40 of 2023 was also filed against the delinquent official and co-accused/plaintiff Mr. Abdur Raheem Khan who offered bribe of Rs. 1000/- to the delinquent official and the same is still pending before the learned Judicial Magistrate-II, Bannu. Accused Abdur Raheem Khan has pleaded his guilt in the said complaint before the JM-II, Bannu on 10.10.2023 and he is convicted and sentenced to suffer imprisonment for a period of 06 months Under Section 162 PPC. This sentence is converted into probation. The criminal complaint against delinquent official Hanif Ullah Under Section 161 PPC is still pending before the learned JM-II, Bannu in which next date of hearing is fixed as 11.11.2023.

The material piece of evidence against the delinquent official is video recording and recovery of Rs. 1000/- as bribe offered by the litigant Abdur Raheem Khan/plaintiff. Accused Abdur Raheem Khan has pleaded his guilt before the learned JM-II, Bannu and this fact is clearly reflected in Order dated 10.10.2023 of the learned JM-II, Bannu. The attested copy of which is officially received from the learned Court concerned and is placed on file. Video recording in shape of USB has 02 videos. One is CCTV footage installed inside the court room which clearly shows that the delinquent official after having handshake with accused Abdur Raheem Khan/plaintiff in the civil suit referred above has placed an amount of Rs. 1000/- in register lying in the possession of the delinquent official. The 2nd video recording is made by the Learned Civil Judge-X, Bannu through his personal cell phone and recovery from the possession of the delinquent official is very much clear. Delinquent official remained calm till the time the accused Abdur Raheem/plaintiff left the court and delinquent official having conscious of the bribe being placed in his register lying in front of him, intentionally avoided to bring this fact in notice of the Learned Presiding Officer. When the accused Abdur Raheem/plaintiff left the court, the Learned Presiding Officer took the action and recovered an amount of Rs. 1000/- from the register lying in possession of the delinquent official. This whole story of the incident is crystal clear from both the video recordings and recovery of Rs. 1000/- cash the evidence of which is available on file.

7. No doubt the guilt of the delinquent official is proved against him without any doubt. He was appointed as Process Server

in the Establishment of Senior Civil Judge, Bannu in 1994 and has almost 29-year service at his credit. His service record also perused which shows that he was also dismissed from service and was later on reinstated. The very act of the delinquent official is liable to major penalty but he has 29-year service at his credit and has a family with minor members dependent on him; therefore, major penalty of Compulsory Retirement Under Rule 4 (b) (ii) of the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 is imposed upon him with immediate effect. Office Order in this regard be issued forthwith with intimation to the District Comptroller Office, Bannu for further legal process. Copy of this Order/Report be placed on the personal file of the delinquent official for further entries in the record. Copy of this order/report be forwarded to the Hon'ble District & Sessions Judge, Bannu for information

Consequent upon the inquiry proceedings initiated against Mr. Hanif Ullah Khan, Naib Nazir/ Junior Clerk under the Khyber Pakhtunkhwa Govt: Servants (Efficiency and Discipline) Rules 2011 for inefficiency/corruption with respect to non-observance of discipline and misconduct by taking Rs. 1000/- from plaintiff as bribe in Civil Suit titled "Nawab Zada Abdur Raheem ... VS ... Muzaffar Khan & others" fixed for hearing before the Learned Civil Judge-X, Bannu on 09.09.2023.

And whereas, Final Show Cause Notice was issued to Mr. Hanif Ullah Khan, Naib Nazir/ Junior Clerk (P.No.00179649) bearing No. 955/SCJ(Admn) dated 21.09.2023 with proposed Major penalty, but his reply was also found unsatisfactory. The opportunity of personal hearing was also given to him but he could not defend the suggested penalty. The charges/ allegations with respect to Monetary Corruption are proved on record and so he is held guilty of misconduct/ corrupt practices liable to punishment under the rules ibid.

It is, therefore, established that the delinquent official/Naib Nazir, Mr Hanifullah is guilty of misconduct within the contemplation of Rule 3(c) & Rule 4(1)b(ii) of Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules 2011.

Now, therefore, I, Muhammad Asghar, Senior Civil Judge(Admin), Bannu, as competent authority impose on the accused / delinquent official the major penalty of compulsory retirement with immediate effect as provided under the rule 4(1)(b)(ii) of Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011.



IUDGMENT

- In this appeal, appellant, Hanif Ullah, challenges Office Order No.1112-19/SCJ (Admn), Bannu dated 01.11.2023, passed by learned Senior Civil Judge (Admn), Bannu/Competent Authority. This Order imposed a major penalty of compulsory retirement, as contemplated under Rule 4(1)(b)(ii) of the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011.
 - Succinct facts, giving rise to filing this appeal, are that appellant Hanif Ullah served as a Junior Clerk/Naib 2. Nazir (BPS-11) in the establishment of Senior Civil Judge (Admn), Bannu, and was posted as a Reader to Court of learned Civil Judge-X, Bannu. A written Complaint No.336/Civil Judge-X, Bannu dated 09.09.2023 was received to this office by Presiding Officer of Civil Judge-X, Bannu, which was subsequently entrusted to Senior Civil Judge (Admn), Bannu through letter No.4158/DSJ, Bannu dated 11.09.2023 with directions to proceed with the complaint in accordance with law and rules.
 - The appellant is saddled with the accusation of his having received a bribe of Rs.1,000/- from plaintiff Abdur Raheem in Civil Suit titled "Nawab Zada Abdur Raheem VS Muzaffar Khan & others," scheduled for a hearing on



09.09.2023 before Court of Civil Judge-X, Bannu. The incident was captured in CCTV footage installed inside the Court, and the recovery of amount of Rs.1,000/- was made on the spot by Presiding Officer of the Court. Video recording of recovered amount was also saved in personal cellphone of Presiding Officer.

- 4. The matter was referred to Senior Civil Judge (Admn), Bannu/Competent Authority for further action in accordance with law, which led to initiation of disciplinary proceedings against appellant. On 12.09.2023, a show cause notice was served upon the appellant, and on the same day, he was suspended until the completion of departmental inquiry, as per Office Order No.933/SCJ (Admn), Bannu.
 - 5. Prior to submission of a written reply to show cause notice, appellant requested the provision of video recording, which was provided to him. Subsequently, he submitted a reply that was deemed unsatisfactory. Given the substantial evidence, including the video recording of alleged bribe money, a final show cause notice was served upon him. In response, he submitted a reply, which was also found unsatisfactory. Consequently, a notice for a personal hearing was issued to him, asking him why a major penalty under Rule 4(b)(ii) of the Rules should not be imposed upon him. Appellant was personally heard as well on 05.10.2023.
 - against appellant, Mr. Tariq Khan, Incharge Data Management Cell/Computer Operator, provided CCTV footage video recording of Civil Judge-X, Bannu, alongwith video recording preserved by Presiding Officer. Senior Civil Judge (Admn)/Competent Authority, presented both videos in open Court, where the appellant was confronted with the evidence, specifically recovery of an amount of Rs.1,000/- as documented in Order Sheet No.4 dated 05.10.2023.

- 7. Upon confrontation, appellant was unable to justify his innocence before the competent authority, as evident from the proceedings on mentioned date. Inquiry proceedings were scheduled for a final Order on 31.10.2023.
- 8. Meanwhile, another criminal Complaint No.40 of 2023 under section 200 Cr.PC was filed against appellant and accused/plaintiff Abdur Raheem Khan, by Civil Judge-X, Bannu before this office which was subsequently entrusted to Court of learned Judicial Magistrate-II, Bannu for initiating proceedings under sections 161 read with 109 of the Pakistan Penal Code. In this case, accused/plaintiff Abdur Raheem Khan pleaded guilty, and by Order dated 10.10.2023, he was convicted and sentenced to six months of imprisonment under section 162 PPC. However, the sentence was later converted into probation.
- 9. After carefully considering the facts and circumstances, Senior Civil Judge (Admn), Bannu/Competent Authority, found the appellant guilty of misconduct. Consequently, a major penalty of compulsory retirement under Rule 4(1)(b)(ii) of the Rules was imposed upon him through impugned Office Order dated 01.11.2023. This forms the basis of this appeal.
- performed his duties with great zeal and zest. He contends that he has never been involved in any illegal acts related to his official duties. Furthermore, he claims that no conversations between him and any other person were overheard by the Presiding Officer of the Court. He highlights his belonging to a very poor family with no other source of income. Appellant argues that the inquiry proceedings leading to impugned Office Order dated 01.11.2023 were conducted against the rules and law established on the subject. Considering the mentioned above, I, Muzzamil Shah Khattak, District & Bannu/Appellate Authority, am Sessions Judge, convinced that Senior Civil Judge (Admn)/Competent Authority has rightly and legally held the appellant guilty of gross misconduct. The major penalty of compulsory retirement under Rule 4(1)(b)(ii) of the Rules, imposed upon him, vide impugned Office Order dated 01.11.2023, is found appropriate in the circumstances, to which no exception can be taken. As the competent authority has already shown leniency in favour of appellant, no further leniency is warranted. This appeal lacks due substance to overturn the impugned findings. It is, therefore, dismissed. Record be transmitted back, and instant file be kept in English record.


