

**WRITTEN ARGUMENTS ALONGWITH RELEVANT
DOCUMENTS**

Respectfully Sheweth:

1. That respondents No.4, 6 & 12 got admission in Patwari Training School at "Karak" way back in 04/10/2002. However appellants Asad and Amir were initially not admitted, meaning thereby they were not the selectee from DOR(E) Office and later on, on recommendation, they were admitted in school. Copy of admission letter dated 04/10/2002 is attached as Annexure "A".
2. That after regular training of 09 months, Patwar Training Course in due course of law, the respondents No.4, 6 & 12 passed the exam alongwith 22 others. Here, this fact must not be left to fade into oblivion that securing of high


marks is not mandatory but only to pass the exam is imperative for candidate/incumbent. Copy of result of Patwar Training dated 31/10/2003 is attached as Annexure "B".

3. That after passing of exam, the enlistment (in accordance with law i.e Land Record Manual/appointment of Patwari) was made by then DOR(E) (Haripur) dated 24/11/2003. Copy of enlistment order dated 24/11/2003 is attached as Annexure "C".
4. After enlistment, the name of the respondents and appellants were incorporated inserted into Register Candidate for Patwariyan vide Letter No. 2052/DOR dated 24/11/2003. Copy of Register Candidate Patwariyan is attached as Annexure "D". (Relevant portion starts from page No.20 to 47 of above register).
5. In the meanwhile, Board of Revenue issued a Notification No.5470-87/ADMN:VII/B Rev. dated 21/02/2002 for recruitment of Patwaris to be adopted instead of following old register of Patwar candidates but through open and transparent written test. Copy of BOR notification No.5470-81 dated 21/02/2002 is attached as Annexure "E".



6. That in pursuance of the above amendment /notification dated 21/02/2002, Secretary BOR issued Guidelines/ instruction to be kept in view while filling the post of Patwaries and issued office order No.6178/6200/Admn:VII/B Rev. Copy of guideline/office order No.6178-6207 is attached as Annexure "F".
7. Thereafter, written test/exam were conducted by DOR(E)/DCO and in view of that written test, merit list (obviously of those candidates who secured high marks and then downwards was prepared) and then in accordance with merits, the appointment letter dated 18/03/2004 was issued purely in accordance with the merit conducted by Department Selection Committee (DPC) of the written test marks. Copy of appointment letter dated 18/03/2004, (after the written exam/test) is attached as Annexure "G".
8. Pertinent to mention here that till now, the same formula is being adopted by BOR for appointment of Patwaris. Copy of notification/amendment 25/11/2016 published in KP Gazette in year 2019 is attached as Annexure "H".
9. That, seniority list starting from year 2004 till 2021 can be perused that appellant never challenged the same. Copy of seniority list is attached as Annexure "I".

10. Important to mention here is that appellant has been promoted as OPS Girdawar (out of turn) requires to be reverted back as Patwari in view of Commissioner Hazara order dated 21/08/2023. Copies of OPS office order dated 19/03/2021 and 21/08/2023 office dated 21/08/2023 are attached as Annexure "J" & "K".

11. That rest of the points would be agitated at the time of arguments.


