17 permanent posts of Assistants (BPS-16), falling under the promotion tubia are vacant due to promotion of 15 Assistants (BPS-16) to Superintendent BPS-17 on acting charge basis in the Directorate of Prosecution, Khyber Pakhtunkhwa vide (Annex-4-1) and other posts vacant due to retirement of Assistant (BS-16) vide (Annex-A-II).

In terms of appendix attached to service rules vide Notification No. SO Prosi/HD/1-5/2005/Vol: II (Annex-B), reflected in Serial No.08, Column No.05 and subsequently, as per last emendment vide Notification NO.SO(Pros)/HD/1-5/Rules/2018 guted 21 03.2018 (Annex-C), the following method of recruitment has been prescribed for the post of Assistants: -

- (a) 25, % by initing recrustment
- "(b) % by promotion on the basis of seniority-cum-fitness from amongst the Senior Clerks (BPS-9) with at least 5- years service as Junior Clerk & Senior Clerk."

According to Rule 9 of Khyber Pakhtunkhwa Civil Servants (Appointment, ging & Transfer) Rules 1989, relevant portion is reproduced as unders-

> Section 9. Appointment on Acting Charge or current Charge Basis. So long as a civil servant holds the acting charge appointment, a civil servant junior to him shall not be considered for regular promotion but may be appointed on acting charge basis to a higher post. (Annex-D)
