PRELIMINARY OBJECTIONS

- 1 That the Appellant has got no cause of action/locus standi.
- 2 That the appellant is not an aggrieved person within the meaning of Section-4 Khyber Pakhtunkhwa Service Tribunal Act 1974 read with Article-212 of the constitution of Islamic Republic of Pakistan 1973.
- 3 That the appellant has not come to this Honorable Tribunal with clean hands.
- 4 That the appeal is barred by the relevant provision of law of limitation Act, 1908
- 5 That the appeal in hand is bad for mis-joinder and non-joinder of the necessary parties to the titled appeal.
- 6 That the titled case is based on mala fide intentions.
- 7 That as per letter No. 1456 dated 11-02-2022, the appellant has not reported for duty against the Junior Clerk post to the Respondent No. 5 till date.
- 8 That the Notification dated 06-10-2023 whereby, the appellant has shown himself as adjusted for the purpose of pay w.e.f 01-12-2018 to 02-02-2021 & 01-12-2021 to 28-02-2022 has been declared as fake & bogus in response to the letter dated 22-11-2023 vide letter dated 05-12-2023 by the Respondent No. 1.
- 9 That as per record, the period w.e.f 01-12-2018 to 20-01-2021 has already been treated as leave without pay/EOL vide letter dated 04-08-2021 as the appellant has not performed his official duty during the said period in the Respondent Department
- 10 That the appellant is a habitual duty absconder against the Junior Clerk post as evident from so many complaints filed by the complainants against him.
- 11 That formal show cause Notice has been served upon the appellant by the competent authority on 25-09-2016.

ON FACTS

£.

- 1) That Para-1 pertain to the service record of the appellant against the Junior Clerk post inducted under the deceased sons quota vide appointment order dated 16-07-2012 in BPS-07 attached as Annex-A.
- 2) That Para-2 is incorrect on the grounds that as per Notification dated 31-12-2018 of the District Education Officer (Female) Swabi that the appellant has been found guilty of mis-conduct & inefficiency with regard to the performance of his official duty on female side which was resulted in the withholding of one annual increment along with his transfer/posting to the office of the District Education Officer (Male) Swabi on the grounds of being not fit on female side in view of his conduct attached as Annex-B.
- 3) That Para-3 is also incorrect on the ground that as per report submitted by the Respondent No. 3 vide letter dated 11-02-2022 to the Director E&SE Khyber Pakhtunkhwa Peshawar with reference to para-3 which says "that once again his services were placed at the disposal of this office { District Education Officer (Male) Swabi } while the absent period w.e.f 01-12-2018 to 28-02-2021 was treated as EOL/leave without pay vide order dated 04-08-2021 (Attached as Annex-C & D).
- 4) That Para-4 is correct that vide order dated 09-02-2021 & engineered, whereby, the appellant has shown as posted/ at the disposal of the Principal GGHSS Kalu Khan District Swabi which was shown to have been withdrawn vide order dated 12-10-2021 engineered by the appellant on mala fide. (Annex-E).

However, it is further submitted that vide letter dated 18-10-2021, the District Education Officer (Male) Swabi has forwarded the said withdrawal order dated 12-10-2021 to the Director E&SE Department for verification attached as Annex-F which has been disowned vide letter dated 25-10-2021 by the Respondent No. 2 attached as Annex-G.

Similarly, the appellant has also shown himself to have been adjusted as Junior Clerk in BPS-11 at GHSS Himlate District Swabi for the adjustment for the purpose of pay w.e.f 01-12-2018 to 02-02-2021 & 01-12-2021 to 28-02-2022 attached as Annex H which was also forwarded by the Respondent No. 3 vide her office letter dated 22-11-2023 attached as Annex-I & in response to the said letter, the same order dated 06-10-2023 was also disowned by the Respondent No. 1 vide letter dated 05-12-2023 attached as Annex-J showing that the whole service record of the appellant is fake & bogus & even engineered by the appellant on mala fide.

- 5) That Para-5 is correct to the extent of the Notification 31-12-2018, whereby, one annual increment was withheld, furthermore, vide Notification dated 09-02-2021, the services of the appellant were placed at the disposal of respondent No. 2 who vide order dated 22-02-2022, the services of the appellant was placed at the Disposal of the respondent No. 3 who further posted the appellant at GHS Lahore Swabi against the Junior Clerk post under the Law & Rules attached as K.
- 6) That Para-6 is correct that vide order dated 11-08-2021, the absence from duty period w.e.f 01-02-2018 to 28-02-2021 was treated as EOL under the Rules as explained in the forgoing paras by the replying Respondents.
- 7) That Para-7 is incorrect as no appeal has been filed by the appellant to the appellate authority against the afore said orders till date.
- 8) That Para 8 is correct to the extent of filing of Departmental appeal dated 24-08-2023 which was disposed of in terms of the fore made submissions made by the Department, therefore, the appeal in hand is liable to be rejected on following grounds inter alia:-

ON GROUNDS

- A. <u>Incorrect & not admitted.</u> The stand of the appellant is illegal & liable to be rejected.
- B. <u>Incorrect & not admitted</u>. The appellant has been found duty absconder against the Junior Clerk post for the said period by the competent authority, hence, the said period mentioned in Para-06 was treated as period leave without pay/EOL under the relevant provision of revised leave Rules-1981 in favor of the appellant.
- C. <u>Incorrect & not admitted</u>. The appellant is not entitled for the grant of salaries for the period w.e.f 01-02-2018 to 28-02-2021 on the analogy of no duty & no pay by the Department
- D. <u>Incorrect & not admitted</u>. The act of Department with regard to the non-grant of salaries for the period as cited above is legal & liable to be maintained.
- E. <u>Incorrect & not admitted</u>. The plea of the appellant is illegal & liable to be rejected in the above cited terms.
- F. <u>Incorrect & not admitted</u> the appellant has been treated as per Law & Rules in the titled matter by the Department.






