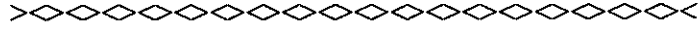

**APPEAL UNDER SECTION 4 OF KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST ERRONEOUS AND WRONG DETERMINATION OF SENIORITY INTER SE THE APPELLANT AND RESPONDENTS 04 TO 529, IN THE FINAL JOINT SENIORITY LIST OF REGULAR ASSISTANTS AND SENIOR SCALE STENOGRAPHERS (BPS-16) OFFICES OF DIVISIONAL COMMISSIONERS AND DEPUTY COMMISSIONERS IN THE PROVINCE AS IT STOOD ON 31.12.2022, ISSUED BY RESPONDENT NO. 3 VIDE NOTIFICATION NO. ESTT:/S.L./ASTT/SSS/22/1440-82 DATED 15-01-2024 AND CIRCULATED THROUGH IMMEDIATE CONTROLLING OFFICES OF THE LISTED OFFICIALS.**

### **PRAYER**

On acceptance of this appeal, decision of respondent No. 1 in determining *inter se* seniority of the appellant and respondents No. 04 to 522 may be declared as erroneous and wrong being against the facts and in violation of law and rules particularly in disregard to Section 8 of Khyber Pakhtunkhwa Civil Servants Act, 1973 and Rule-17 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989 ((APT rules for short)); and the Respondent No. 1 to 3 may kindly be required to determine appellant's seniority position from the date of his initial appointment i.e. 01.06.2005 instead of 01.07.2022 and to issue rectified Final Joint Seniority List of Assistants and Senior Scale Stenographers placing the appellant's name in the said seniority list at Sr. No. 1 up ahead of respondent No. 4. It may also be declared that if regular promotion of any of the private respondents to the post of Tehsildar takes place on the basis of disputed Final Seniority List, the same is liable to be reversed under the facts and law.

Any other relief as deemed fit in favor of appellant may also be granted for the sake of justice.

**Respectfully Sheweth,**

The Appellant seeks to prefer the instant appeal with relevant facts and grounds as follow:

1. That the appellant is in service under the Board of Revenue, Revenue & Estate Department, Khyber Pakhtunkhwa, as Computer Assistant/Operator (BPS-16) and presently posted in the office of Deputy Commissioner, Malakand.
2. That Member-III in the Board of Revenue (BOR) deals with service matters of the officers and officials under control of BOR; and the Competent Authority and reviewing authority in BOR is one and the same i.e. Senior Member Board of Revenue (SMBR) in relation to terms and conditions of service of the officers/officials.
3. That, vide Notification No. Estt:/S.L./Astt/SSS/22/27168-27210 dated 08-12-2023 issued by the Respondent No. 3 with approval of competent authority (Respondent No. 1), Tentative Joint Seniority List of Assistants and Senior Scale Stenographers (BPS-16) offices of Divisional Commissioners and Deputy Commissioners in the Province as it stood on 31.12.2022 (**Tentative Seniority List for short**) was circulated among the concerned officials including the appellant through their immediate controlling offices. The name of the appellant appeared at Sr. No. 531 of the said list. The names of private respondents respectively appeared at Sr. Nos. 1 to 522 in the tentative seniority list. In the remarks column # 9 of the Tentative Seniority List, a note against the name of appellant and some others was given as hereinafter follow: ***"In light of PHC Order dated 16.03.2022 & ST Order dated 05.11.2023 this department adjusted Computer Assistant/Operators w.e.f. 01.07.2022 in the joint seniority as per Notification No. Estt://W.P/3087-P/19/Azhar Iqbal Mughal/18628-35 dated 01.07.2022."*** Copies of PHC order, Service Tribunal order, Notification dated 01-07-2022 as mentioned in the said note, and of the notification dated 08-12-2022 regarding issuing of Tentative Seniority List and calling of objections, are **Annexure "A", "B", "C" & "D"** respectively.
4. That the appellant was not shown at the right place in the Tentative Seniority List and in order to get a right seniority position, he raised objections against the relegation of his seniority position from his due place. Therefore, he through objections before the Respondent No. 1 sought correction of the same with prayer for insertion of appellant's name in the final seniority list at appropriate place in light of his undisputed date of initial appointment i.e. 01.06.2005. The said appeal/objection petition may be read as part of this appeal. Copy of Objection Petition is **Annexure "E"**.
5. That appellant's objections/appeal was regretted by the Respondent No. 1 vide letter No. Estt:/S.L./Astt/SSS/22/1138 dated 15-01-2024 issued by Respondent



- No. 3. Consequently, Final Joint Seniority List of Assistants and Senior Scale Stenographers (BPS-16) offices of Divisional Commissioners and Deputy Commissioners of Province as it stood on 31-12-2022 (**Final Seniority List for short**) was issued on 15-01-2024 by Respondent No. 3 under approval of Respondent No. 1 vide Notification No. Estt://S.L./Astt/SSS/22/1440-82 of even date. Copies of the regret letter dated 15-01-2024 and Notification dated 15-01-2024 alongwith Final Seniority List are **Annexure "F" & "G"** respectively.
6. That some Misc. correspondence in between departments in relation to issue of determination of seniority in case of the appellant and others took place which is also worth reading. Copies of letters making part of said correspondence are collectively **Annexure "H"** for the ease of reference.
7. That letter dated 15-01-2024 about regretting of appellant's objections was communicated to him on next day and then he by his own efforts procured the copy of Final Seniority List with wrong and erroneous entry of his name at Sr. No. 531 therein with similar note against it in column # 9 as given in the Tentative Seniority List and copied herein above. Hence, this appeal against finalization of the Tentative Seniority List on wrong premises, regretting appeal/objections of the appellant. Grounds of appeal, *inter alia*, follow herein below:-

### **GROUND:-**

- (a) That according to date of joining Service as given in the Final Seniority List against the names of respondents 4 to 522, they joined the service or were promoted in the relevant cadre obviously on different dates but later than the date of initial appoint of the appellant.
- (b) That section 8 of the Khyber Pakhtunkhwa Civil Servant Act, 1973 read with Rule 17 of APT rules are the relevant provisions for determination of seniority. Official respondents were also advised by the Establishment Department of Government of Khyber Pakhtunkhwa to follow the said law. However, they glaringly disregarded the law on the subject, while issuing the Final Seniority List by rejection of Appellant's appeal/objections against the Tentative Seniority. Thus, the appellant is rightly aggrieved from ascending of Respondents No. 4 to 522 in seniority over him when there was no legal and factual justification to relegate the appellant in seniority from due position in light of the date of his regular initial appointment.

- (c) That the note given in remarks column of the Final Seniority List is meant to adjust the appellant in the Joint Seniority List w.e.f. 01-07-2022 is highly unfounded, illogical, mistaken, superfluous, random, perverse, perfunctory, and denude of any legal justification. Law on the subject of seniority of civil servants is very much clear and does not allow extraneous reasons to be supplied to it in style of said note in determination of seniority otherwise than the date of regular appointment either direct or by promotion. The respondents 4 to 522 have no right to claim and to get seniority against the appellant being junior to him in terms of date of regular appointment either direct or by promotion as the case may be. Therefore, the appellant is entitled to find place in the impugned list at Sr. No. 8 of the final seniority list after its rectification.
- (d) That the petitioners have been discriminated by the respondents for the reasons that Senior Scale Stenographers when given right of promotion to the post of Tehsildar like Assistants, their names in the joint seniority list with the Assistants were adjusted having regard to their date of regular appointment. The appellant having got the similar right established through judicial processes was similarly placed with the Senior Scale Stenographer in terms of his adjustment in the Joint Seniority List from the date of his regular appointment and not from 01-07-2022 by stretch of any reason like the note given in the impugned Final Seniority List. Thus, the rights of the appellant have been infringed otherwise than due course of law.
- (e) That the appellant has not been treated in accordance with law, rules and regulations by the official respondents. The impugned actions/omissions of the official respondents offend all norms of justice, fair play, equity and good conscious, who having acted in a manner otherwise than due course of law misused their lawful authority to the utter prejudice of the appellant.
- (f) That it is an inalienable right of the Appellant to enjoy the protection of law and to be treated in accordance with law, rules and regulations; and such a right having been infringed by the respondents otherwise than due course of law, makes out a case for judicial review of the actions/omissions of respondents.

(g) That the foregoing submissions are not exhaustive and kept precise. So, if need arises, the Appellant will seek permission to develop the grounds during arguments at the bar.

(h) That this appeal after rejection of objections/appeal is within time and this Honourable Tribunal has got jurisdiction to adjudicate upon it.

In light of foregoing facts and grounds, It is requested that this appeal may graciously be accepted as per prayer in the heading above.

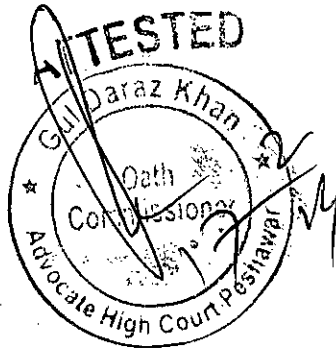

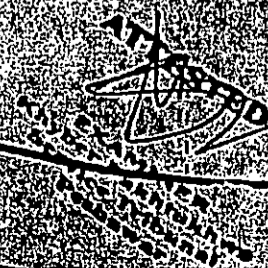

Respectfully Sheweth,

1. That the appellant is a law abiding and bona fide citizen of the Islamic Republic of Pakistan and hails from a respectable family.
2. That after going through the mandatorily required written examination and interview, and after being envisaged with the ordeals & inquisitions of selection process the appellant got selected, recommended, and appointed as Computer Assistants (BPS-11) on dated 20-02-2004. (Copy of Appointment order is annexed as annexure "A")
3. That before going to the main roots of the instant case, it would be equally importance to mention here that in 2010 the posts of the Computer Assistants were merged together with the posts of Key-Punch Operators (BPS-08), Data Entry Operators (BPS-09) and Computer Operators (BPS-10) vide Notification No. KC/FD/SO(FR)/7-3/2001 dated 12-07-2010 of

J. Learned counsel for the appellant present. Mr. Asif Masood Ali Shah, Deputy District Attorney alongwith Mr. Ghulam Shabir, Assistant Secretary for official respondents No. 1 and 2 and counsel for impleaded respondents No. 3 to 17 present.

2. At the very outset, learned counsel for the appellant referred to notification dated 01.07.2022, issued by the Board of Revenue, Revenue and Estate Department, Government of Khyber Pakhtunkhwa, wherein the competent authority had statedly adjusted the names of the appellants and others in the joint seniority list of Assistants and Senior Scale Stenographers at the offices of the Commissioners and Deputy Commissioners at the provincial level w.e.f the date of issuance of the notification but there was no such seniority list prepared, circulated or handed over to the persons listed in the list. Nor any such <sup>list</sup> is produced before this Tribunal. Learned counsel for the appellant says that appellant would be satisfied if a direction is given to the respondents to issue seniority list in compliance of notification dated 01.07.2022, within fifteen days. It is however further requested by the learned counsel for the appellant that unless issuance of the seniority list further promotion may not be made. In this respect it is observed that the department shall make promotion from the seniority list which is prepared in the light of

ASSISTANTS AND SENIOR SCALE STENOGRAPHERS (BPS-16) OFFICES OF  
THE COMMISSIONERS AND DEPUTY COMMISSIONERS IN THE PROVINCE  
AS IT STOOD ON 31.12.2022.**

Respected Sir,

The undersigned objector seeks to submit that the subject list has been published for circulation by the Board of Revenue, Revenue & Estate Department Khyber Pakhtunkhwa (hereinafter referred as Department) vide notification dated 08.12.2023 bearing No. Estt:I/S.L/Ast/SSS/27168-27210 inviting objection within 15 days; and the same has been circulated with endorsement of even number and date. The name of the objector appears at Sr. No. 531 without mentioning date of birth i.e 12.04.1982 and **Qualification of the objector i.e MSc**, in the said list, which is not correctly allocated, if regard is had to the law contained in Section-8 of the Khyber Pakhtunkhwa Civil Servants Act, 1973 read with Rule 17(4) of the Khyber Pakhtunkhwa Civil Servants (APT) Rules, 1989, and precedents of the department itself in previous similar cases. Therefore, insertion of objector's name in the subject list at wrong place is challenged with the submissions as follow:-

1. That undeniably, issuing of Joint Seniority List by inclusion of names of the objector and others was pending after Notification of the Department bearing No. Estt:II/WP/3087-P/19/Azhar Iqbal Mughal/18628-35 dated 01.07.2022, and in the meanwhile, advice of the Establishment Department was sought vide letter No. Estt: I/Azhar Iqbal/3928 dated 09.02.2023 (**Annexure-A**) about relevant place of their names in the list to be issued. In response to the said letter, the Establishment Department (Regulation Wing), Govt. of Khyber Pakhtunkhwa confirmed the advice given previously by it vide letter No. SOR.IV(ED)11-1/2023 dated 21.03.2023 (**Annexure-B**) with reaffirmation to settle the issue at department own level under Section-8(3) of Khyber Pakhtunkhwa Civil Servant Act-1973 read with Rule-17 of Khyber Pakhtunkhwa Civil Servants (APT) Rules, 1989; which is clear on the subject issue and leave no ambiguity.
2. That the Board of Revenue was required to issue the Joint Seniority List in accordance with advice of the Establishment Department but it was inordinately delayed. So, the objector resorted to filing of Service Appeal No. 1877/2022 dated 23.12.2022 before the Khyber Pakhtunkhwa, Service Tribunal, Peshawar. Said Service Appeal was disposed off in the terms as copied below.


**“In this respect it is observed that the department shall make promotion from the seniority list which is prepared in the light of Notification dated 01.07.2022 and ultimately finalized. Copy of the same be handed over to all the persons so listed in the list”**

3. That the Seniority list was not issued even after disposal of the Service Appeal No. 1877/2022 dated 23.12.2022 in light of the given terms, and the objector was compellingly filed Implementation Petition before the Hon'ble Service Tribunal. The Department was directed by orders passed in Implementation Petition to submit the compliance report and presumably, the subject disputed list has been issued to comply with the directions of Hon'ble Tribunal but in glaring violation of the advice of the Establishment Department issued vide No. SOR.IV(ED)11-1/2023 dated 21.03.2023.
4. That it is very much obvious from the advice of Establishment Department that the objector and others Computer Assistants were to be enlisted having regard to the provisions of Section-8(3) of Khyber Pakhtunkhwa Civil Servants Act-1973 and with Rules-17 of APT-1989. Needless to say that Section 8(3) of the Civil Service Act-1973 provides that Seniority shall be determine as may be prescribed. On the other hand, Rule-17 of APT Rules-1989 prescribed the factors for determination of Seniority.
5. That in Notification bearing No. Estt:I/S.L/Astt/SSS/27168-27210 dated 08.12.2023 where-under the disputed Seniority list has been issued, there is reference of Section-8 of the Civil Servant Act-1973 for eyewash but the procedural provision i.e. Rule-17 of APT Rules-1989 was completely ignored. Therefore, the disputed list has not been issued having regard to the advice of Establishment Department letter No. SOR.IV(ED) 11-1/2023 dated 21.03.2023, which is liable to be corrected in light of the procedure provided by aforementioned Rule-17 under advice of the Establishment Department issued vide No. SOR.IV(ED)11-1/2023 dated 21.03.2023.
6. That Sub Rule-4 of Rule-17 of APT Rule-1989 is very much clear regarding determination of *inter se* seniority of the Civil Servants of different cadres carrying the same pay scale. Accordingly, the date of regular appointment / promotion of the Civil Servants in the lower post is determinative factor. However, the said factor has not been taken into consideration while issuing the disputed Tentative Joint Seniority List.
7. That Senior Scale Stenographers were previously included in the joint seniority list alongwith Assistants, maintained for promotion quota in the posts of Tehsildar; and in their case, regular initial date of appointment / promotion was considered as determinative factor but the same precedent has not been given effect in case of the objector. Therefore, enlistment of the objector in the disputed seniority list w.e.f. the date of Notification at 01.07.2022 in not correct and does not fulfill the requirements of Rule 17 of APT Rules, 1989.
8. That the objector reasonably believes that he has not been treated in accordance with law in the matter of his enlistment in the disputed seniority list. As far as his enlistment in the disputed list is concerned, the same in view of the foregoing submissions is wrong, erroneous, arbitrary, perverse and liable to be corrected in accordance with law and advice of the Establishment Department.
