#### PRELIMINARY OBJECTIONS:

- 1. That appellant has got no cause of action to file instant appeal.
- 2. That appellant has not come to this Honorable Tribunal with clean hands.
- 3. That appellant has estopped by his own conduct.
- 4. That the appeal is barred by law and limitation.

#### **FACTS:**

- 1. Para 1 needs no comments.
- 2. Para 2 relates to the academic record of appellant.
- 3. Para 3 is correct.
- 4. Para 4 is also correct.
- 5. In reply to Para 5, it is submitted that the appellant was provided/given 05 marks for higher qualification by the Scrutiny Committee. He was provided marks for one stage higher qualification. Copy of Working Paper has already been annexed with appeal as annexure D.
- 6. Para 6 in incorrect. The appellant has not submitted any objection over the Tentative Seniority List and after finalization of all objections by the other staff members. The Final Seniority List was issued on 08.09.2021. The appellant has submitted objection on 28.09.2021 i-e after the approval of the Final Seniority List, therefore, the same being time barred, was rejected. The Tentative Seniority List, Final Seniority List and Objection Petition have been annexed with the appeal.
- 7. Para 7 is correct to the extent of promotion of appellant along with his other colleagues. Moreover, it is worth mentioning here that appellant has now been promoted to the post of Assistant on Acting Charge basis vide Promotion Order No: 1220-31/DSJ NW at Bannu, dated 18/10/2023; the Tentative Seniority List of Senior Clerks was not objected to, rather the appellant has

endorsed No Objection on the Tentative Seniority List of Senior Clerks wherein appellant is at Serial No.07, junior to respondents No. 03, 06, 07, 08, 09 & 10. Thereafter, the Final Seniority List was issued being not objected to by anyone including the appellant. Copies of the Seniority List, Final Seniority List and Promotion Order are annexed as annexure A, annexure B and annexure C.

- **8.** Para 8 is correct to the extent of filing of Departmental Appeal.
- 9. The appellant has no cause of action to file subject appeal, hence, the same may be dismissed.

#### **GROUNDS:**

- A. Para A needs no comment.
- **B.** In reply to Para B, it is submitted that appellant was given 05 marks for his higher qualification by Scrutiny Committee while considering testimonials of appellant.
- C. In reply to Para C, it is submitted that appellant was placed at Serial No. 07 in the appointing order according to his aggregate score in test and interview.
- **D.** Para D. The Appellant has been treated as per the law.
- E. Para E is incorrect. Appellant was never deprived of due rights. In reply to Para E, it is submitted that appellant was given 05 marks for higher qualification by the Scrutiny Committee while considering all the relevant testimonial annexed with application for appointment.
- **F.** Para F is incorrect. Appellant was never deprived and affected in the merit position.
- **G.** Para G is also incorrect. Appellant was granted due marks on the basis of aggregate marks and appellant was placed due position on the Promotion Order.
- **H.** In reply to Para H, it is submitted that the same pertains to the jurisdiction of Honorable Tribunal, therefore, needs no comment to that extent.
- I. Para I is incorrect. Appellant was never treated with different yard stick.
- J. Para J is also incorrect. No right of the appellant has been violated.
- **K.** Answering respondent also craves permission to raise additional grounds in rebuttal.

It is therefore, requested that the appeal in hand being without merits and barred by law and limitation, is liable to be dismissed with cost.
