  - (v) Remained under suspension vide Superintendent Headquarter Prison Haripur Letter No.466-67, Dated: 03-09-2012.
  - (vi) Reinstated in to services and censured vide Superintendent HQ Prison Haripur letter no 816-18, dated: 05-10-2012

Withholding up to two Annual Increments for two years vide IG Prisons order No.46671, Dated: 23-12-2023. (Copy Enclosed as Annex-A). Moreover, the appellant concerned was proceeding departmentally in a case regarding willful absence with effect from 14-04-2023 to 21-04-2023 till the date of his compulsory retirement from services i.e. 06-09-2023 from duty and the competent authority was pleased and imposed the major penalty of compulsory retirement from services with immediate effect vide.IG Prisons office order no 32464, dated: 06-09-2023(Copy enclosed). The appellant preferred the department appeal to Worthy Additional Chief Secretary against the compulsory retirement from services in which the appellant was called for Personal Hearing on 27-10-2023 before the office of Additional Chief Secretary being the appellant authority accordingly the appellant appeared for personal hearing and the appellant authority considered that the penalty imposed by the Competent Authority did not commensurate with the charges proved against him, resultantly the ordered regarding compulsory **retirement** from service was set aside and the appellant was reinstated into services with immediate effect. The intervene period i.e from the date of compulsory retirement from services to the date of reinstatement into services is hereby treated as leave without pay and a minor penalty of withholding of three increments for 03 years was imposed upon him.

- A. Incorrect and not admitted, such adverse remarks was the outcome of his incompetency/inefficiency which reflected in his PER for the year 2022.
- B. Incorrect and not admitted. The adverse remarks was the result of his poor performance recorded in his PER for the year 2022.Moreover, he was found non-cooperative and ill-disciplined having poor performance while discharging his official duties during the cited period.
- C. Incorrect and not admitted. The criteria for promotion are based on fitness while the appellant was superseded from promotion by the Departmental Promotion Committee on the basis of his adverse remarks which was reflected in his ACR for the cited period. Hence, rest of the Para needs no comments(copy of order dated 05/01/2024 is enclosed).
- D. Incorrect and not admitted. Detail of this Para is elaborated in **Para-B** above.
- E. Incorrect and not admitted. The respondent department has rightly awarded adverse remarks in his PER on the basis of his poor performance which resulted to suffer his promotion.
- F. Incorrect and not admitted. Detail of this Para is elaborated in **Para-E** above.
- G. The instant appeal is hit by limitation, hence not maintainable and liable to be dismissed.

# APPEAL AGAINST IMPUGNED COMPULSORY RETIREMENT ORDER DATED 06-09-2023.

I am directed to refer to Home Department SO(Prison-I)/HD/8-3/KC/2022 dated 22-09-2023 on the subject and to state that Mr. Amir Ali Shah Junior Clerk (BPS-11) posted at Sub ail Dassu, absented himself from duty with effect from 14-04-2023 unto 25-04-2023, without prior permission of the competent authority as reported by Superintendent Sub Jail Dassu Kohistan yide or his letter No. 417 dated 17-04-2023 (F/A) by spurning the orders of his immediate officer for stay at the station. He furnished his written reply (F/B), wherein he confessed the above mentioned allegation leveled against him, and took plea of illness by producing bed rest of five (05) days from 17-04-2023 to 21-04-2023, thus he committed grave misconduct on his part as well as violated rule-1082 and 1083 of Khyber Pakhtunkhwa Prisons Rules-2018. Accordingly, formal departmental proceeding was initiated against the accused official and inquiry officer was appointed under rule D1: 10(01)(a) of E&D rule 2011(F/C). The Inquiry Officer concerned submitted his inquiry report (F/D) alongwith all necessary documents and concluded that the charge leveled against the aforesaid accused was partially proved. Consequently, as required under the rules, show cause (F/E) was served on him. In response, he furnished his written reply (F/F). As provided under the rules ibid, P-, the opportunity of personal hearing was afforded on 04-09-2023. During the course of personal hearing, the accused official failed to prove his innocence fully by telling lies before the inquiry officer as well as the competent authority. He stated that he left the station without permission of his immediate officer on the plea that his wife was not feeling well whereas he got medical bed rests certificate for himself from a medical officer of Central Prison Haripur to cover his willful absence from duty. His past record is also adverse and the competent authority was convinced that the accused cannot continue government job. 



WHEREAS, Mr. Amir Ali Shah, Junior Clerk (BPS-12), attached to District Jail Mansehra was awarded the major penalty of "Compulsory Retirement from Service" by Inspector General of Prison Khyber Pakhtunkhwa Peshawar vide order No. 7/2-J-20-32464 dated 06-09-2023 due to his willful absence w.e.f. 14-04-2023 to 21-04-2023 till the date of his Compulsory Retirement from service.

AND WHEREAS, the said Junior Clerk preferred his departmental appeal for setting aside the penalty awarded to him and also requested for reinstatement into the service.

AND WHEREAS, he was afforded an opportunity of personal hearing on 27-10-2023 and of his appeal was examined in light of relevant rules, material on record and oral evidences.

AND WHEREAS, under Para-3(i) of Federal Government Instruction vide OM No. 4/42/83-D-2 dated 29.07.1985 reflected at page-227 of KP ESTA Code, he was not issued 2<sup>nd</sup> Show Cause notice, as required to be issued under ibid instructions when penalty is enhanced by competent authority as compared to the penalty proposed by the authorized officer.

AND WHEREAS the appellate authority also considered that the penalty imposed by the Competent Authority did not commensurate with the charge proved against him.

NOW THEREFORE, having considered the charges, evidences, facts on record, explanation of the accused official, the provision of rules in vogue and in exercise of powers conferred under Rule-17 of Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 read with Rule-05 of Khyber Pakhtunkhwa Civil Servant (Appeal) Rules 1986, the order regarding his compulsory retirement from service is hereby set aside and the appellant is reinstated into service with immediate effect. The intervening period i.e. from the date of from service to the date of reinstatement into the service is hereby being treated as leave without pay and a minor penalty of withholding of 03 increments for three years is being imposed.

On his reinstatement into the service, the services of the above named Junior Clerk is hereby placed at the disposal of Inspector General of Prisons Khyber Pakhtunkhwa Peshawar for further posting:






