APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE NOTIFICATION DATED 19.04.2023, WHEREBY THE APPELLANT WAS PROMOTED TO THE RANK OF INSPECTOR (BPS-16) WITH IMMEDIATE EFFECT INSTEAD OF 09.08.2012 I.E THE DATE WHEN HER BATCHMATES WERE PROMOTED TO THE RANK OF INSPECTOR (BPS-16) AND AGAINST NOT TAKING ACTION ON THE REVIEW PETITION OF THE APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS.

PRAYER:

THAT ON THE ACCEPTANCE OF THIS APPEAL, THE APPELLANT MAY KINDLY BE CONSIDERED FOR ANTEDATION OF HER PROMOTION TO THE RANK OF INSPECTOR (BPS-16) WITH EFFECT FROM 09.08.2012 I.E THE DATE WHEN HER BATCHMATES WERE PROMOTED TO THE RANK OF INSPECTOR (BPS-16) BY MODIFYING THE NOTIFICATION DATED 19.04.2023 TO THAT EXTENT TO THE EXTENT OF THE APPELLANT WITH ALL BACK AND CONSEQUENTIAL BENEFITS. ANY OTHER REMEDY WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND APPROPRIATE THAT MAY ALSO BE AWARDED IN FAVOUR OF APPELLANT.

RESPECTFULLY SHEWETH:

FACTS:

1. That the appellant was appointed as ASI in the year 1996 along with other officials/officers and since her appointment the appellant is performing her duty with devotion and honesty whatsoever assigned to her and no complaint has been filed regarding her performance by her high ups. (Copy of appointment order is attached as Annexure-A)
2. That the appellant was confirmed in the rank of ASI and her name was brought in list "E" along with batchmates vide notification dated 18.04.2002 with immediate effect. (Copy of notification dated 18.04.2002 is attached as Annexure-B)
3. That the appellant was promoted to the rank of Officiating SI along with her batchmates vide notification dated 13.05.2005, however, that notification was withdrawn to vide order dated 24.05.2005 to the extent of the appellant due to the reason that the appellant has not qualified the probation course. It is pertinent to mention here that the appellant was sent to PTC Sahala for probation course, but due to medical reason, the appellant was not allowed to take part in probation course and was sent back without doing her probation course, which is evident from the letter dated 22.06.2008 of Police College Sahala. (Copies of notification dated 13.05.2005, order dated 24.05.2005 and letter dated 22.06.2008 are attached as Annexure-C,D&E)
4. That the batch mates and juniors to the appellant were confirmed in the rank of SI vide notification dated 24.11.2008 with effect from 23.10.2008 and their name were included in list "F" vide notifications dated 05.03.2009 with immediate effect and were then promoted to the rank of Inspector (BPS-16) vide notification dated 09.08.2012, but the appellant was kept deprived from confirmation in the rank of SI on the reason that she did not qualify the probation course. (Copies of notification dated 24.11.2008, notification dated 05.03.2009 and notification dated 09.08.2012 are attached as Annexure-F,G&H)
5. That due to not sending/nominating the appellant for probation course in time by the respondent department, the appellant qualified probation course with new recruited Female PASIs in the year 2011-2012 in PTC Centre Hangu and then she was confirmed in the rank of ASI and also promoted to the rank of officiating SI vide notification dated 12.11.2013 with immediate effect. (Copy of notification dated 12.11.2013 is attached as Annexure-I)
6. That appellant was then confirmed in the rank of SI vide notification dated 11.03.2020 with immediate effect instead of due date i.e

23.10.2008, the date on which batchmates and juniors were of the appellant were confirmed in the rank of SI and the name of the appellant was also included in list "F" through another notification dated 03.12.2020 with immediate effect. (Copies of notification dated 11.03.2020 and notification dated 03.12.2020 are attached as Annexure-J&K)

7. That the appellant filed an application for confirmation as in the rank of ASI from the date of appointment i.e 24.03.1996 instead of 12.11.2013 as already granted to other official in the pursuance of the Honorable Peshawar High Court judgment dated 24.04.2019 rendered in writ petition No.3720-P/2018 and the date of confirmation of the appellant in the rank of ASI was also revised from the date of appointment i.e 24.03.1996 instead of immediate effect i.e 12.11.2013 vide notification dated 18.02.2021, however the name of the appellant was not include in list "E" as per notification dated 18.02.2021. (Copy of notification dated 18.02.2021 is attached as Annexure-L)
8. That as the name of the appellant was not included in list "E" as per notification dated 18.02.2021 and not confirmed in the rank of SI w.e.from 23.10.2008 and placed her name in list "F" along with batchmates and juniors, therefore, she filed departmental appeal for placing her name in list "E" as per notification dated 18.02.2021 and for antedation of her confirmation in the rank of SI w.e.from 23.10.2008, the date on which batchmates and juniors to the appellant were confirmed in the rank of SI and for placing her name in list "F" along with her batchmates and juniors, which was rejected on 07.07.2021. (Copies of departmental appeal and rejection order dated 07.07.2021 are attached as Annexure-M&N)
9. That the appellant then filed service appeal No.7260/2021 in this Honorable Service Tribunal with the prayer that the rejection order dated 07.07.2021 may kindly be set aside and the respondents may further be directed to place the name of the appellant in list "E" according to notification dated 18.02.2021 and also antedate her confirmation as SI w.e.from 23.10.2008 and place her name in list "F" along with her batchmates and juniors by revising her seniority with all back and consequential benefits. The Honorable Service Tribunal heard and decided the appeal of the appellant on 19.01.2022. The Honorable Service Tribunal accepted the appeal of the appellant, set aside the impugned rejection order dated 07.07.2021 with direction to the respondents to place the name of the appellant in list "E" in accordance with notification dated 18.02.2021 and also antedate her confirmation as SI with effect from 23.10.2008 and place her name in list "F" along with batch mates and juniors by revising her sonority list with all back and consequential benefits. (Copy of judgment dated 19.01.2022 is attached as Annexure-O)

10. That in compliance of judgment 19.01.2022, the name of the appellant was brought on promotion list "E" w.e.from 18.04.2002 instead of 12.11.2013 and her confirmation in the rank of Sub Inspector was also revised w.e.from 23.10.2008 instead of 03.03.2020 with her colleagues vide notification dated 22.03.2022, which was further revised from 23.10.2008 to 13.05.2007 along with her colleagues vide order dated 05.04.2022 and placed her in list "F" along with batchmates in order dated 05.04.2022. (Copies of notification 22.03.2022 and order dated 05.04.2022 are attached as Annexure-P&Q)
11. That the appellant was then promoted to the rank of Inspector (BPS-16) along with other officers vide notification dated 19.04.2023 with immediate effect instead of 09.08.2012, the date on which her batchmates were promoted to the rank of Inspector (BPS-16) as the appellant was confirmed in the rank of ASI w.e.f 18.04.2002 and SI w.e.f 13.05.2007 along with her batchmates and her seniority was also revised in list "E" and "F" and placed her name in list "E" and list "F" respectively along with batchmates. (Copy of notification dated 19.04.2023 is attached as Annexure-R)
12. That the appellant then filed review petition on 19.10.2023 for antedation of her promotion to the rank of Inspector (BPS-16) with effect from 09.08.2012 i.e the date on which her batchmates were promoted to the rank of Inspector (BPS-16) by modifying her promotion notification dated 19.04.2023 to that extent to the extent of the appellant, which was not respondent within the statutory period of ninety days. (Copy of review petition is attached as Annexure-S)
13. That the appellant has no other remedy except to file the instant appeal in this Honorable Tribunal for redressal of her grievance on the following grounds amongst others.

GROUND:

- A) That not taking action on the review petition of the appellant and not promoting the appellant in the rank of Inspector (BPS-16) with effect from 09.08.2012, "the date on which his colleagues and juniors were promoted to the rank of Inspector (BPS-16)" in the notification dated 19.04.2023 are against the law, facts, norms of justice, material on record and violation of Superior Courts judgments, therefore, not tenable and the notification dated 19.04.2023 is liable to modified to the extent to antedate the promotion of the appellant in the rank of Inspector (BPS-16) with effect from 09.08.2012, the date on which her batchmates and juniors were promoted to the rank of Inspector (BPS-16).

- B) That in compliance of judgment 19.01.2022, the name of the appellant was brought on promotion list "E" with effect from 18.04.2002 instead of 12.11.2013 and her confirmation in the rank of Sub Inspector was also revised with effect from 23.10.2008 instead of 03.03.2020 with her batchmates vide notification dated 22.03.2022, which was further revised from 23.10.2008 to 13.05.2007 along with her colleagues vide order dated 05.04.2022 and placed her in list "F" along with batchmates in order dated 05.04.2022, therefore, the appellant is also entitle to be promoted to the rank of Inspector (BPS-16) with effect from 09.08.2012 i.e the date on which her batchmates were promoted to the rank of Inspector by modifying the notification dated 19.04.2023 to that extent to the extent of the appellant.
- C) That the appellant was not confirmed in the rank of ASI and SI and her name was not brought in list "E" and list "F" along with her batchmates, which was challenged by the appellant in this Honorable Service Tribunal in service appeal 7260/2021, which was accepted in the favour of the appellant and on the basis of that judgment the appellant was confirmed in the rank of ASI and SI along with her batchmates and her seniority was also revised in list "E" and "F" and placed her name in list "E" and list "F" on 18.04.2002 and on 13.05.2007 respectively along with batchmates and as such the appellant is also entitle to be promoted the rank of Inspector (BPS-16) with effect from 09.08.2012 i.e the date on which his batchmates were promoted to the rank of Inspector (BPS-16).
- D) That not promoting the appellant to the rank of Inspector with effect from 09.08.2012 will affect her further promotion which will cause irreparable loss to the appellant in the shape of pension and other monetary benefits for no fault on his part.
- E) That the appellant has not been treated in accordance with law and rules and has been deprived from her legal right of promotion to the rank of Inspector with effect from 09.08.2012, the date when her batchmates were promoted to the rank of Inspector and the appellant was kept deprived from promotion.
- F) That the appellant seeks permission of this Honorable Tribunal to advance other grounds and proofs at the time of hearing.

It is, therefore most humbly prayed that on the acceptance of this appeal, the appellant may kindly be considered for antedation of her promotion to the rank of Inspector (BPS-16) with effect from 09.08.2012 i.e the date when her batchmates were promoted to the rank of Inspector (BPS-16) by modifying the notification dated 19.04.2023 to that extent to the extent of the appellant with all back and consequential benefits. Any other remedy which this Honorable Tribunal deems fit and appropriate that may also be awarded in favour of appellant.

JUDGMENT

ATIQ-UR-REHMAN WAZIR MEMBER (E):-

Brief facts of the

case are that the appellant joined police department as Assistant Sub Inspector (ASI) in the year 1996. The appellant was confirmed as ASI and her name was brought on list E alongwith her batch-mates vide order dated 18-04-2002 with immediate effect. The appellant was promoted to the rank of officiating Sub-Inspector (SI) alongwith her batch-mates vide order dated 13-05-2005, but such order was withdrawn vide order dated 24-05-2005, as she had not qualified the probation course. Other batch-mates and juniors of the appellant were confirmed as SI vide order dated 24-11-2008 with effect from 23-10-2008 and their names were included in list F vide order dated 05-03-2009 with immediate effect, but the appellant was kept deprived of confirmation as SI. The appellant qualified the probation course in the year 2011-12, thereafter the appellant was confirmed in

the rank of ASI and was also promoted to the rank of officiating SI vide order dated 12-11-2013 with immediate effect. The appellant was confirmed as SI vide order dated 11-03-2020 with immediate effect and name of the appellant was included in list F vide order dated 03-12-2020 with immediate effect. The appellant filed an application for confirmation as ASI from the date of her appointment i.e. 24-03-1996 instead of 12-11-2013, which was accepted and the appellant was confirmed as ASI with effect from 24-03-1996 vide order dated 18-02-2021, but name of the appellant was not included in list E. Since name of the appellant was not placed in list E as per order dated 18-02-2021 and was not confirmed as SI with effect from 23-10-2008, nor her name was placed on list F alongwith her batch-mates, therefore she filed departmental appeal on 18-04-2021 for placing her name on list E as per notification dated 18-02-2021 and for ante-dating of her confirmation as SI with effect from 23-10-2008, the date when her batch-mates and juniors were confirmed as SI and for placing her name in list F alongwith her batch-mates and juniors, but her departmental appeal was rejected vide order dated 07-07-2021, hence the instant service appeal with prayers that the order dated 07-07-2021 may be set aside and the respondents may be directed to place name of the appellant in list E according to notification dated 18-02-2021 and also ante-date her confirmation as SI with effect from 23-10-2008 and place her name in list F alongwith her batch-mates and juniors by revising her seniority with all back and consequential benefits.

02. Learned counsel for the appellant has contended that the order dated 07-07-2021 and not placing the name of appellant in list E as per notification dated 18-12-2021 and not ante-dating her confirmation as SI with effect from 23-10-2008 and not placing her name in list F alongwith her batch-mates and juniors are against law, facts and norms of natural justice, therefore not tenable and is liable to be set aside; that the appellant was selected/nominated for probation course and also went for course to police college Sehala in the year 2005, but she was sent back due to medical reason (pregnancy); that thereafter she filed many

application for her nomination for such course, but no attention was paid to her applications, due to which she did not complete her course well in time; that the appellant was nominated for such course at a belated stage, who completed such course in 2011-12; that the appellant was discriminated, as other official namely Salra Shah who was appointed alongwith the appellant in the same year i.e. 1996 was exempted from probation course but such benefit was not extended to the appellant, which is clear violation of Article-25 of the Constitution; that due to the fault of respondents, the appellant was not sent to such course well in time, the appellant suffered badly, as her batch-mates and juniors were promoted to the ranks of Inspectors vide order dated 09-08-2012 and then to DSP vide order dated 02-04-2015, while the appellant is still working on the post of SI, which is clear violation of Article-2A, 4, 25 and 38(e) of the Constitution; that confirmation of the appellant in the rank of ASI was revised from the date of appointment through an order dated 18-02-2021, however her name was not placed in list E in accordance with order dated 18-02-2021, which also shows mala fide on part of the respondents; that the appellant has not been treated in accordance with law, hence her rights secured and guaranteed under the Constitution were badly violated; that the appellant has been deprived of her legal rights of ante-dation of her confirmation as SI with effect from 23-10-2008 and placing her name in list F alongwith her batch-mates; that similar nature appeals have been allowed by this honorable tribunal by ante-dating their confirmation and placing their names alongwith their batch-mates and juniors and the appellant being similarly placed person is also entitled for the same relief under the rule of consistency.

03. Learned Deputy District Attorney for the respondents has contended that the appellant after qualifying the probationer course was confirmed as ASI and brought her name in list E and was also promoted to the officiating rank of SI; that colleagues of the appellant were confirmed in the rank of SI after completion of their mandatory period, confirmation in the rank of SI requires completion of laid down criteria and those SIs who fulfill the said qualification are confirmed first

and name of the appellant was not included in that list, as she had not qualified such course well in time, hence her claim for promotion with her colleagues is not justified under the existing rules; that the appellant was finally confirmed as SI after completion of the required course.

04. We have heard learned counsel for the parties and have perused the record.

05. Record reveals that the appellant was directly recruited as ASI vide order dated 24-03-1996. The appellant alongwith her batch-mates were confirmed as ASI's vide order dated 18-04-2002 with immediate effect. The appellant alongwith her other batch-mates was promoted to the rank of officiating SI vide order dated 13-05-2005 with immediate effect, but such order in respect of the appellant was withdrawn vide order dated 24-05-2005 due to the reason that the appellant had not completed the probation course. Record would reveal that the appellant joined such course in Police Training School Sehala, but she was returned on 22-06-2005, as her pregnancy was in the final stage and was not considered appropriate to undertake such training at that point of time. In the meanwhile, her other batch-mates, who were promoted as officiating SI vide order dated 13-05-2005, were confirmed in the rank of SI with effect from 23-10-2008 vide order dated 24-11-2008 and their names were included in list F vide order dated 05-03-2009 with immediate effect. On the other hand the appellant after completion of her probation course in 2011-12, was confirmed in the rank of ASI by bringing her name in list E and was also promoted to the rank of officiating SI vide order dated 12-11-2013 with immediate effect. Record would reveal that one Mst. Saira Shah, who was also batch-mate of the appellant was granted exemption from the probation course vide order dated 07-03-2009 and was confirmed as SI without conducting such course, but such benefit was not allowed to the appellant, which was discriminatory. The appellant was confirmed in the rank of SI vide order dated 11-03-2020 with immediate effect as well as her name was included in list

F vide order dated 03-12-2020 with immediate effect. The appellant filed an appeal before the competent authority, upon which comments of the DSP Legal were sought, such comments are reproduced as under:

"Available record reveals that the appellant was deferred from confirmation in the rank of ASI as well as promotion as SI due to non qualification of the basic training course and probationer period, which later on she fulfilled in proper manner, hence on qualifying the said course, she was confirmed in the rank of ASI and promoted as officiating SI on 12-11-2013. Foregoing in view, after qualification of basic training course, applicant is required to be confirmed from the date of appointment i.e. 24-03-1996 instead of 12-11-2013. Similarly as batches 2006, 2009, 2010 and 2011 have availed the benefit of the High Court Judgment in writ petition No 3720-P/2018, therefore applicant is entitled for the same."

06. While agreeing with the comments of DSP Legal, the competent authority revised her confirmation in the rank of ASI from the date of her appointment i.e. 24-03-1996 instead of 12-11-2013 vide order dated 18-02-2021, but rest of her prayers were ignored, respondents however, were required to bring her name on list E alongwith her confirmation as SI and her placement on list F alongwith her batch-mates, as the appellant case was only deferred and she deserved to be brought at par with her batch-mates, which however was not done by the respondents, for which the appellant filed departmental appeal dated 08-04-2021, but departmental appeal of the appellant was not considered on merit and was rejected vide order dated 07-07-2021. On the other hand, her other colleagues and juniors were promoted to the rank of Inspector vide order dated 09-08-2012 and further promoted as DSP vide order dated 02-04-2015.

07. We have observed that case of the appellant for further promotion was deferred due to the reason that she did not complete the probation course. As is evident from record that the appellant attended such course, but was sent back due to her health issue, but since it was not within the authority of the appellant to nominate herself for such training, rather it was prerogative of the respondents

to nominate her for such training, for which the appellant shall not suffer. The appellant was nominated for such training at a belated stage, which completed such training in 2011-12. We did not find anything adverse, except deferment to substantiate her confirmation/promotion on later dates. Moreover, deferment shall not debar the appellant from confirmation/promotion from the date of her deferment, after making good the deficiency. It is also well established from the prevailing rules that civil servant selected for promotion to a higher post in one batch shall, on their promotion to the higher post, retain their inter-se-seniority as was in the lower post. We have also observed that half of the issue was resolved by the respondents in the same analogy as explained above, but half of it was ignored, which however was not warranted and the appellant was compelled to knock at the door of the court. Moreover, the supreme court of Pakistan as well as this tribunal in a number of cases has granted similar relief in similar cases to other such employees.

08. In light of the facts and circumstances of the case, the instant appeal is accepted. The impugned order dated 07-07-2021 is set aside with direction to the respondents to place the name of the appellant in list E in accordance with notification dated 18-02-2021 and also ante-date her confirmation as SI with effect from 23-10-2008 and place her name in list F along with her batch mates and juniors by revising her seniority with all back and consequential benefits.

Parties are left to bear their own costs. File be assigned to record room.



Respectfully Submitted: -

1. That the appellant was appointed as ASI in the year 1996 along with other officials/officers and since her appointment, she is performing her duty with devotion and honesty whatsoever assigned to her and no complaint has been filed against her regarding her performance by her high ups.
2. That the appellant was confirmed in the rank of ASI and her name was brought in list "E" along with batchmates vide notification dated 18.04.2002 with immediate effect.
3. That the appellant was promoted to the rank of Officiating SI along with her batchmates vide notification dated 13.05.2005, however, that notification was withdrawn with respect to the appellant due to the reason that the appellant has not qualified the probation course. It is pertinent to mention here that the appellant was sent to PTC Sahala for probation course, but due to medical reason, the appellant was not allowed to take part in probation course and was sent back without doing her probation course.
4. That the batch mates and juniors to the appellant were confirmed in the rank of SI vide notification dated 24.11.2008 with effect from 23.10.2008 and their name were included in list "F" vide notifications dated 05.03.2009 with immediate effect, but the appellant was kept deprived from confirmation in the rank of SI on the reason that she did not qualify the probation course.
5. That due to not sending/nominating the appellant for probation course in time by the respondent department, the appellant qualified probation course with new recruited Female PASIs in the year 2011-2012 in PTC Centre Hangu and then she was confirmed in the rank of ASI and also promoted to the rank of officiating SI vide notification dated 12.11.2013 with immediate effect.

6. That appellant was then confirmed in the rank of SI vide notification dated 11.03.2020 with immediate effect instead of due dated i.e 23.10.2008, the date on which batchmates and juniors were of the appellant were confirmed in the rank of SI and the name of the appellant was also included in list "F" through another notification dated 03.12.2020 with immediate effect.
7. That the appellant filed an application for confirmation as in the rank of ASI from the date of appointment i.e 24.03.1996 instead of 12.11.2013 as already granted to other official in the pursuance of the Honorable Peshawar High Court judgment dated 24.04.2019 rendered in writ petition No.3720-P/2018 and on the confirmation of the appellant in the rank of ASI was revised from the date of appointment i.e 24.03.1996 instead of immediate effect i.e 12.11.2013 vide notification dated 18.02.2021, however the name of the appellant was not include in list "E" as per notification dated 18.02.2021.
8. That as the name of the appellant was not included in list "E" as per notification dated 18.02.2021 and not confirmed in the rank of SI w.e.from 23.10.2008 and placed her name in list "F" along with batchmates and juniors, therefore she filed departmental appeal for placing her name in list "E" as per notification dated 18.02.2021 and for antedation of his her confirmation in the rank of SI w.e.from 23.10.2008, the date on which batched mates and juniors to the appellant were confirmed in the rank of SI and for placing her name in list "F" along with her batchmates and juniors which was rejected on 07.07.2021.
9. That the appellant then filed service appeal No.7260/2021 in the Honorable Khyber Pakhtunkhwa Service Tribunal with the prayer that on acceptance of the service appeal of the appellant the rejection order dated 07.07.2021 may kindly be set aside and the respondents may further be directed to place the name of the appellant in list "E" according to notification dated 18.02.2021 and also antedate her confirmation as SI w.e.from 23.10.2008, and place her name in list "F" along with her batchmates and juniors by revising her seniority with all back and consequential benefits.
10. That the Honorable Service Tribunal accepted the appeal of the appellant on 19.01.2022 and set aside rejection order dated 07.07.2021 with direction to the respondents to place the name of the appellant in list "E" in accordance with notification dated 18.02.2021 and also antedate her confirmation as SI with effect from 23.10.2008 and place her name in list "F" along with batch mates and juniors by revising her sonority list with all back and consequential benefits.

11. That in compliance of judgment 19.01.2022, the name of the appellant was brought on promotion list "E" w.e.from 18.04.2002 instead of 12.11.2013 and also confirmation in the rank of Sub Inspector was revised w.e.from 23.10.2008 instead of 03.03.2020 with her colleagues vide notification dated 22.03.2022, which was further revised from 23.10.2008 to 13.05.2007 along with her colleagues vide order dated 05.04.2022 and placed her in list "F" along with batchmates in order dated 05.04.2022.
 12. That the appellant was promoted to the rank of Inspector (BPS-16) along with other officers vide notification dated 19.04.2023 with immediate effect instead 09.08.2012 the date on which her batchmates were promoted to the rank of Inspector (BPS-16) as the appellant was confirmed in the rank of ASI w.e.f 17.04.2002 and SI w.e.f 13.05.2007 along with her batchmates and her seniority was also revised in list "E" and "F" and placed her name in list "E" and list "F" respectively along with batchmates.
 13. That the appellant wants to file review for antedation of her promotion to the rank of Inspector (BPS-16) w.e.from 09.08.2012 i.e the date on which her batchmates were promoted to the rank of Inspector (BPS-16) by modifying her promotion notification dated 19.04.2023 to that extent to the extent of the appellant on the following grounds.

GROUND:

- A) That not promoting the appellant in the rank of Inspector (BPS-16) from 19.04.2023 to 09.08.2012, the date on which his colleagues and juniors were promoted to the rank of Inspector (BPS-16) is against the law, facts, norms of justice, material on record and violation of Superior Courts judgments, therefore, not tenable and the notification dated 19.04.2023 is liable to be modified to the extent to antedate the promotion of the appellant w.e.from 09.08.2012, the date on which her batchmates and juniors were promoted to the rank of Inspector (BPS-16). *Promotion order copy is attached.*
- B) That in compliance of judgment 19.01.2022, the name of the appellant was brought on promotion list "E" w.e.from 18.04.2002 instead of 12.11.2013 and also confirmation in the rank of Sub Inspector was revised w.e.from 23.10.2008 instead of 03.03.2020 with her batchmates vide notification dated 22.03.2022, which was further revised from 23.10.2008 to 13.05.2007 along with her colleagues vide order dated 05.04.2022 and placed her in list "F" along with batchmates in order dated 05.04.2022, therefore, the appellant is also entitled to be promoted to the rank of Inspector (BPS-16) w.e.from

09.08.2012 the date on which her batchmates were promoted to the rank of Inspector by modifying the notification dated 19.04.2023 to that extent to the extent of the appellant.



- C) That the appellant was not confirmed in the rank of ASI and SI and her name was not brought in list "E" and list "F" along with her batchmates, which was challenged by the appellant in KP Service Tribunal in service appeal 7260/2021, which was accepted in the favour of the appellant and on the basis of that judgment the appellant was confirmed in the rank of ASI and SI along with her batchmates and her seniority was also revised in list "E" and "F" and placed her name in list "E" and list "F" on 18.04.2002 and on 13.05.2007 respectively along with batchmates and as such also entitle to be promoted the rank of Inspector (BPS-16) w.e.from 09.08.2012 i.e the date on which his batchmates were promoted to the rank of Inspector.
- D) That not promoting the appellant to the rank of Inspector w.e.from 09.08.2012 will effect his further promotion which will cause irreparable loss to the appellant in the shape of pension and other monetary benefits for no fault on his part.
- E) That the appellant has not been treated in accordance with law and rules and has been deprived from his legal right of promotion to the rank of Inspector w.e.from 09.08.2012. the date when her batchmates were promoted and the appellant was kept deprived from promotion.

It is therefore, most humbly requested that on the acceptance of this review, the appellant may kindly be promoted to rank of Inspector (BPS-16) w.e.from 09.08.2012, i.e the date when her batchmates were promoted to the rank of Inspector (BPS-16) by modifying the notification dated 19.04.2023 to that extent to the extent of the appellant with all back and consequential benefits on the basis of above submission.
