### <u>PRAYER</u>

on accepting this service appeal, the impugned order No. 3662-66 D.R&P (P/F) Dated Peshawar the 11/09/2023 by respondent No. 2 signed by respondent deputy director (Admn) and order No. SO(PRISON-II)/HD/1-17/2023, Dated 23/01/2024 passed by respondent No. 1 signed by section officer-II may graciously be set aside by declaring it illegal, unlawful, without authority, based on mala fide, void abinitio and thus not sustainable in the eyes of law.



### Respectfully Sheweth;

- 1. That the appellant is serving as Junior clerk in respondent department, and performing his duty with great zeal and honesty, whatsoever, assigned to him and no complaint has been filed against him to the high ups regarding his performance.
- 2. That Senior Probation Officer (SPO) district Khyber had made baseless and unjustified report to the worthy Director, on the basis of which the worthy deputy director issued a charge sheet and statement of allegation and had initiated the disciplinary proceedings by issuing a show case Notice against the appellant. (Copy of Report, charge sheet along statement of allegation, and show case Notice are attached as Annexure A, B & C respectively)
- 3. That respondent No. 2 passed an order Dated 11/09/2023 vide which the minor penalty of withholding of two Annual Increments without cumulative effect has been passed against appellant, it is pertinent to mention here that the same impugned order is passed by the office of Worthy Respondent No.2 while surprisingly the same is signed the worthy deputy director, which clearly shows the departmental irregularity while passing the impugned order. (Copy of impugned order dated 11/09/2023 is attached as Annexure-D)
- 4. That feeling aggrieved the appellant had filed a departmental appeal before worthy respondent No. 1 (The facts and ground agitated therein may please be treated as part and parcel of this appeal) against the impugned order, who, vide order dated 23/01/2023 rejected the same without complying codal-formalities, and upheld the order of respondent No.2, it is further pertinent to mention here that, that impugned order too was signed by the section officer (prison-II) while the appellant had made the departmental representation to the worthy respondent No.1 which also speaks about the departmental irregularity made by the respondents. (Copy of appeal and impugned order dated 23/01/2023 are attached as Annexure-E and F).
- 5. That now appellant feeling aggrieved from the above orders, filling this appeal on the following amongst other grounds inter alia;

#### GROUNDS:

- a. That both the impugned orders of the respondents No.1 and 2, are illegal, unlawful, without authority, based on mala fide intention, against the natural justice, violative of the Constitution and Service Laws and equally without jurisdiction, hence the same are liable to be set aside in the best interest of justice.
- b. That both the impugned orders passed by respondents are very much harsh, without any evidence based on surmises & conjectures and is equally against the principle of natural justice.
- c. That while initiating the departmental proceedings against the appellant the authorities had not bothered to inquire about that, whether the reporting officer has the jurisdiction / power to made a report against the appellant, which clearly shows mala-fide on the part of the respondent. This fact is very much clear from the office order dated 09/03/2023, whereby the reporting officer / Senior Probation Officer (SPO) District Khyber was given the charge of District Kohat while the appellant was performing duty in District Karak, hence the orders are liable to be set side. (Office Order Dated 09/03/2023 is attached as Annexure-G)
- d. That, both the impugned orders are passed in violation of the service laws as while passing the impugned orders the respondents had clearly ignored the fact that the allegations leveled against the appellant are not in conformity within the domain of the appellant Job description, in fact the Authorities has clearly prohibited the taking probation cases from the courts, therefore both the orders are void in the eyes of law. (Letter Dated 20/12/2016 is attached as Annexure-H)
- e. That both the respondents No.1 and 2 have not properly evaluated the facts and evidences on record before passing the impugned orders, there is nothing on record which connects the appellant with the allegation, nor any cell data record available on record which proved any allegation against the appellant. Hence, the impugned orders

9

passed by the respondents against the appellant are liable to be set aside.

- That appellant is young energetic efficient person and having un blemished service record which could be verified from the service record of the appellant. In the present case all the proceedings carried in clear violation of service rules, law and constitution.
- g. That the inquiry officer had not collected any evidence in support of the charges. No one was examined as witness in presence of appellant nor was appellant confronted with any documentary or other kind of evidence on the basis of which the impugned orders were passed.
- h. That the biasness of the respondents are very much proved from the factum that while awarding the impugned punishment the enquiry report has not been given to the appellant which is very much necessary as per the dicta of superior judiciary.
- i. That while awarding the impugned orders the respondents not bothered to take that the appellant is honest and dedicated official of and left no stone unturned to discharge his duties
- That the impugned orders have been passed in violation of law and rules of disciplinary proceedings and principles of natural justice. The authority wrongly and Malafidely based the impugned orders without giving any reason with proof whatsoever, therefore the impugned orders are bad in law.
- k. That respondent No. 1 has not decided the departmental appeal / representation in accordance to the rules and regulation which clearly shows mala fide intention thus, has no sanctity in the eyes of law and the act of respondents are totally based on male fide intention which clearly shows discrimination and undue victimization.
- 1. That all the orders are very much silent regarding the compliance of operational and professional guideline issued by the respondents.



It is therefore most humbly prayed that on accepting this service appeal, the impugned order No. 3662-66 D.R&P (P/F) Dated Peshawar the 11/09/2023 by respondent No. 2 signed by respondent deputy director (Admn) and order No. SO(PRISON-II)/HD/1-17/2023, Dated 23/01/2024 passed by respondent No. I signed by section officer-II may graciously be set aside by declaring it illegal, unlawful, without authority, based on mala fide, void abinitio and thus not sustainable in the eyes of law.

Any other relief not specifically prayed for but deems appropriate circumstances of the case may also be granted.

### REPORT

## IRRESPONSIBLE ATTITUDE OF GOHAR FAROOQ JUNIOR CLERK KARAK

### Background

The Honorable Director Reclamation and Probation KPK directed the Senior Probation Officer Khyber to receive the pending probation cases from the court of Adj Banda Daud Shah tehsil Karak and also to look after the vacant post of the Probation Officer Karak until the arrival of the newly appointed officer. During this course, the SPO Khyber assigned different official tasks to Junior Clerk Mr. Gohar Farooq for the smooth running of the office, but he failed to comply.

The details of the discrepancies on the part of the J/C Karak are: -

- On 18-03-2023 the SPO Khyber was contacted on his mobile phone and informed by the Reader of Adj B.D.Shah to visit this court on 20-03-2023 for probation cases. The SPO Khyber on the same date informed the J/C Karak to ensure his presence and bring Form-A register for disposal of cases.
- 2. On 19-03-2023 again SPO Khyber contacted J/C Karak at 07:11 pm and reminds him.
- 3. On 20-03-2023 after the arrival of SPO Khyber to the court of Adj B.D.Shah the J/C karak was contacted, upon which he stated that he doesn't know where B.D.Shah tehsil is located. The SPO Khyber informed the P/A to the director R&P about the situation. Consequently, the J/C Karak arrived to the court of adj B.D.Shah within 30 minutes along with Form-A register after receiving a sudden call from the directorate of R&P. Later on, the J/C Karak was allowed on his request for paper/exam in the evening. The SPO Khyber disposed of 20 probation cases and shared its list with the direction to J/C Karak to receive the judgment copies and other forms of said cases from the court concerned, as the SPO Khyber directed Naib Court of Adj B.D.Shah to send all the documents to the office of Probation Officer Kurak after completion, but the J/C Karak didn't bother to ask about these cases.
- 4. On 03-04-2023 the J/C Karak was contacted and asked to share the monthly progress reports along with the other official letters for further correspondence. The J/C Karak ensured to share all of these by tomorrow, but he didn't.

- 5. On 04-03-2023 SPO Khyber, himself contacted again to the reader of Adj B.D.Shah regarding the documentation of the received 20 probation cases as it was noticed that those cases were still pending due to negligence of the J/C Karak. The SPO Khyber also contacted the J/C Karak to pursue this matter seriously, but he didn't comply.
- 6. On 05-04-2023 SPO Khyber noticed that the J/C harak is non-serious towards his duty as he still didn't pursue receiving the 20 new probation cases from the court of Adj B.D.Shah and he didn't share the monthly progres; reports of Karak to communicate with the directorate of R&P. Moreover, it is very astenishing that the mobile number of J/C Karak is usually switched off or doesn't receive the call of SPO Khyber during the official time, once again SPO Khyber contacted him at 07:18 pm and strictly directed him to share the monthly progress reports. The J/C karak ensured that till 11:30 am, he will communicate all the progress reports by tomorrow, but he disobeyed the direction.
- 7. On 06-04-2023 the Deputy Director R&P Muhammad Niaz and SPO Khyber both repeatedly tried to contact J/C Karak to share monthly progress till 12:00 pm, but his contact number was off. As if he was not on his duty because he didn't bother to contact his high-ups for an unknown reason.

After all, his irresponsible attitude shows that he doesn't take interest in official business on one hand while on the other he pays no attention / weightage to the calls / directions of high-ups.



(F/H)


