satisfied with the decision of the department, he might then avail the remedies available to him under the law. It was then the appellant, vide Application No.438 dated 03.02.2020, filed a representation to the Secretary to Government of Khyber Pakhtunkhwa Elementary & Secondary Education Department, Peshawar. The appellant says that the same was decided on 07.10.2020 vide No.7913 but when we peruse the letter of 07.10.2020, issued by the Directorate of Elementary & Secondary Education Khyber Pakhtunkhwa, Peshawar, that instead refers to a letter dated 09.09.2020 of the appellant and not to No.438 of 03.02.2020, the date of representation of the appellant. The said letter also shows that after sending representation on 03.02.2020 might have sent a letter No.480 of 09.09.2020. When confronted with the situation, he seeks some time to produce the same letter i.e. letter No.480 of 09.09.2020. Appellant and departmental representative namely Mr. Mubashir Ahmad, present in the court, both are directed to produce copy of the said letter i.e. No.480 dated 09.09.2020, within 15 days. To come up for arguments on 27.05.2024 before D.B at Camp Court, Abbottabad. P.P given to the parties.

2. For the same relief, the appellant had filed Service Appeal No.19 of 2011 which was dismissed by this Tribunal on 15.12.2017. The appellant then filed a Writ Petition No.170-A of 2018 before the Peshawar High Court, Abbottabad Bench, which was also dismissed, where-after, the appellant filed CP No.1927 of 2018 before the Supreme Court of Pakistan, which was decided on 24.01.2020 with the observation that as this Tribunal had decided the case of the petitioner on technical grounds, therefore, if the petitioner wished to file a representation before the department, he might do so and the department on filing of such representation, would decide the same within a period of two months.
