4. That the Honorable Tribunal vide order dated 24/10/2023, the order dated 18/10/2023 of the respondent was set-aside and directed the respondent to





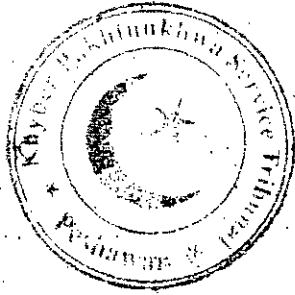
