JUDGMENT

MUHAMMAD AMIN KHAN KUNDI, MEMBER: - Counsel for

heard and record perused.

2. Brief facts of the case as per present service appeal are that the appellant is serving as Lecturer in Chemistry (BPS-17) in Higher Education Department. She was transferred from Government Girls Degree College Takht bhai to Government Girls Degree College Lund Khwar District Mardan while private respondent No. 5 Mst. Saira Bano Lecturer in Chemistry (BPS-17) was transferred from Government Girls Degree College Lund Khwar District Mardan to Government Girls Degree College Takht bhai at the place of appellant vide same order dated 26.09.2019. The appellant filed departmental appeal on 27.09.2019 which was rejected vide order dated 28.10.2019 hence, the present service appeal on 29.10.2019.

3. Respondents were summoned who contested the appeal by filing written reply/comments.

4. Learned counsel for the appellant contended that the appellant and private respondent No. 5 were serving as Lecturers in Higher Education Department. It was further contended that the private respondent was regularized as Lecturer vide order dated 07.03.2018. It was further contended that the appellant was appointed as Lecturer (BPS-17) in respondent-department on the proper recommendation of Khyber Pakhtunkhwa Public Service Commission. It was further contended that the appellant is serving in respondent-department quite efficiently and up to the entire satisfaction of her superior since her date of appointment. It was further contended that later on the appellant was transferred to Government Girls Degree College Takht bhai District Mardan vide notification dated 06.02.2017. It was further contended that in response, the appellant submitted her charge report against the vacant post of Lecturer in Chemistry and started her duty at the said station with all zeal and zest. It was further contended that the

private respondent No 5 while serving, as Lecturer in BPS-17 at Government Girls Degree College Jandol, Dir Lower managed her transfer to Government Girls Post Graduate College Mardan in the year 2017 and just after the lapse of eight months, the private respondent No. 5 was further transferred to Government Girls Degree College Lund Khwar District Mardan vide order dated 02.11.2018, it was further contended that vide notification dated 26.09.2019, the private respondent No. 5 without completion of her normal tenure at Government Girls Degree College Lund Khwar has been transferred to Government Girls Degree College Takht bhai District Mardan at the place of appellant. It was further contended that the husband of the appellant is also serving as Assistant Professor (BPS-18) at Government Post Graduate College Mardan, therefore, under the spouse policy, the appellant is entitled to serve $_{\mathcal{M}}$ at Government Girls Degree College Takht bhai but the respondent- $\sqrt{}$ department has illegally transferred the appellant from Government Girls Degree College Takht bhai District Mardan to Government Girls Degree College Lund Khwar District Mardan vide order dated 26.09.2019. It was further contended that the impugned notification dated 26.09.2019 to the extent of appellant and private respondent No. 5 is againt the law and natural justice and is not tenable. It was further contended that the appellant was not treated by the respondent-department in accordance with law. It was further contended that the impugned notification dated 26.09.2019 is against clause (i) (ii) of the Transfer Posting Policy of the Provincial Government of Khyber Pakhtunkhwa. It was further contended that the impugned notification dated 26.09.2019 is also violative of clause-9 of Transfer Posting Policy, therefore, not tenable and liable to be set-aside. It was further contended that the respondentdepartment acted in arbitrary and malafide manners by issuing impugned notification dated 26.09.2019 against the appellant, therefore, the appellant has been discriminated. It was further contended that the impugned notification dated 26.09.2019 regarding transfer posting of the appellant and private respondent No. 5 has been passed by the incompetent authority and the departmental authority has also not passed a speaking order, therefore, the impugned order is illegal and liable to be set-aside and prayed for acceptance of appeal.

On the other hand, learned Deputy District Attorney assisted 5. by learned counsel for private respondent No. 5 opposed the contention of learned counsel for the appellant and contended that the appellant was transferred from Government Girls Degree College Lund Khwar to Government Girls Degree College Takht bhai vide order dated 06.02.2017 and this facts has also been admitted by the appellant in para-2 of the service appeal, therefore, the respondentdepartment has righty transferred the appellant from Government Girls Degree College Takht bhai to Government Girls Degree College Lund Khwar after completion of her normal tenure for more than two years. It was further contended that the respondent-department has transferred the appellant and private respondent No. 5 alongwith 97 others employees through general transfer posting order vide notification dated 26.09.2019 in the best interest of public. It was further contended that no malafide has been shown by the appellant regarding the impugned general transfer posting notification. It was further contended that the Government Girls Degree College Lund Khwar is situated District Mardan and the husband of the appellant is also serving in District Mardan, therefore, the impugned transfer posting order of the appellant is not against spouse policy. It was

further contended that the impugned transfer posting notification has been issued by the Secretary to Government of Khyber Pakhtunkhwa Higher Education Department and it has been mentioned in the heading of the impugned notification that the competent authority is pleased to order the transfer posting in the best interest of public, therefore, the impugned transfer posting notification has been passed by the competent authority. It was further contended that under section-10 of the Civil Servants Act, the civil servant has no right to claim for choice posting and the competent authority is empowered to transfer any civil servant anywhere in the province. It was further contended that the appellant has completed her normal tenure of two years in Government Girls Degree College Takht bhai, therefore, the impugned transfer order of the appellant was passed as per transfer posting policy and prayed for dismissal of appeal.

6. Perusal of the record reveals that the appellant was serving in Higher Education Department as Lecturer (BPS-17). The record further reveals that the appellant was transferred from Government Girls Degree College Lund Khwar to Government Girls Degree College Takht bhai vide order dated 06.02.2017 and this fact has also been admitted by the appellant in para-2 of the service appeal that lastly the appellant was transferred to Government Girls Degree College Takht bhai vide notification dated 06.02.2017. The record further reveals that the appellant is performing her duty since that time in Government Girls Degree College Takht bhai meaning thereby that the appellant has performed her duty in the Government Girls Degree College Takht bhai for more than two years, therefore, the impugned transfer order of the appellant is not in violation of the transfer posting policy. Moreover, though the appellant has claimed that her husband is serving in District Mardan, therefore, the impugned order was passed against the spouse policy but the record reveals that the husband of the appellant is serving in District Mardan and the Government Girls Degree College Lund Khwar where the appellant has been transferred is also situated at District Mardan, therefore, it cannot be said that the impugned transfer order of the appellant has been passed against the spouse policy. Moreover, the appellant and private respondent No. 5 have been transferred alongwith 97 others in general transfer posting notification dated 26.09.2019. No malafide has been proved against the respondent-department by the appellant in the impugned transfer posting notification. Furthermore, under Section-10 of the Civil Servants Act, 1973 a civil servant is not entitled to claim for choice posting and the competent authority is empowered/competent to transfer any civil servant anywhere in the province, therefore, we see no illegality in the transfer order of the appellant and private respondent No. 5. Hence, the appeal has no force which is hereby dismissed. Parties are left to bear their own costs. File be consigned to the record room.



That lastly the appellant was transferred to GGDC Takht Bhai, District Mardan vide Notification dated 06.02.2017. That in response the appellant submitted her charge report against the vacant post of Lecturer in Chemistry (BPS-17) and started her duty at the said station with all zeal and zest. Copy of the Notification dated 06.02.2017 is attached as annexure **A**.

impugned from the appellant feeling aggrieved That Notification dated 26.9.2019 submitted Departmental appeal before the appellate authority but the appellate authority was not willing to dispose of Departmental appeal of the appellant. That appellant time and again visited the concerned quarter for disposal of her departmental appeal one way or other but of no avail, therefore the appellant filed writ petition No. 5256/2019 which was disposed of vide judgment dated 15.10.2019 with the directions to the appellate authority to decide the Departmental appeal of the appellant earliest. Copies of the Departmental appeal and judgment are attached as annexure G & H.

- A- That the impugned Notification dated 26.9.2019 and appellate order dated 28.10.2019 are against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be set aside.
- **B-** That the appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the constitution of Islamic Republic of Pakistan 1973.
- **C-** That the impugned Notification dated 26.9.2019 is against the clauses-I & II of the transfer/posting policy of the provincial Government of Khyber Pakhtunkhwa.
- **D-** That the impugned Notification dated 26.09.2019 is also violative of Clause- IX of the transfer/posting policy, therefore not tenable and liable to be set aside. Copy of the transfer/posting policy is attached as annexure.....J.
- **E-** That the respondents acted in arbitrary and malafide manner by issuing the impugned Notification dated 26.9.2019 against the appellant.
- **F-** That, the appellant has been discriminated by the respondents on the subject noted above and as such the respondents violated the Principle of Natural Justice.
- **G-** That neither the impugned Notification dated 26.9.2018 has been issued in the public interest nor the same has been issued in exigencies of public service.
- H- That the private respondent has not been completed of her normal tenure in place of duty which is the clear violation of Clause-IV of the transfer/posting Policy.

I- That the appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.





All the posting/transfers shall be strictly in public interest and shall not be abused/misused to victimize the Government servants

- ii) All Government servants are prohibited to exert political, Administrative or any other pressures upon the posting/transfer authorities for seeking posing/transfers of their choice and against the public interest.
  - All contract Government employees appointed against specific posts, can not be posted against any other post.

The normal tenure of posting shall be three years subject to the condition that for the officers/officials posted in unattractive areas the tenure shall be two years and for the hard areas the tenure shall be one year. The unattractive and hard areas will be notified by the Government.
