

Respectfully Sheweth;

- 1. That appellant was initially appointed as constable on 24.03.1987 and on dedicated performances, he was promoted to the rank of Head Constable in the year, 2003 and thereafter promoted to the rank of ASI on 01.01.2009.
- 2. That on 09.07.2015, Mad No. 28 was registered in PS Lakki Marwat by complainant, Irfan Rasheed S/o Muhammad Hassan to the effect that Barkat Ullah S/o Naimat Ullah and 03 others betted him for ill wishes. (Copy as annex "A")
 - That on 10.07.2015, complainant made report in PS Lakki Marwat under Section 506, 342/34PPC against the said accused, Barkat Ullah and Sakhwat Ullah for beating and forcibly putting him in car to abduct him and then fled away. Appellant scribed Muraslla which was converted into

FIR No. 444 by Imtiaz Khan ASHO of the PS. (Copy as annex "B")

- 4. That on the said date Asmat Ullah, Lecturer in General Science brother of accused Barkat Ullah made call to appellant through Mobile No. 0313-9108725 that he has made report against his brother for abduction of the complainant, so he will face consequences of the said report in this respect. (Copy as annex "C")
- 5. That at the instance and pressure of the brother of the accused, the impugned order dated 13.07.2015 was issued by R. No. 1, reverting him to the rank of Head Constable from the rank of ASI. (Copy as annex "D")
- 6. That it seemed that the authority was not satisfied with the aforesaid punishment, imposed upon appellant, served him with charge sheet, statement of allegation and show cause notice on 16.07.2015 simultaneously to the effect that:-
 - Malafidly, wrongfully registered FIR and willfully misstated the facts; and
 - 2. He did not notify the concerned SHO/DSP regarding the registration of FIR.

 But such allegations were totally false and incorrect. (Copies as annex "E" & "F")
- 7. That charge sheet and show cause notice were replied on 21.07.2015 by denying the allegations. (Copy as annex "G" & "H")
- 8. That the impugned order dated 13.07.2015, was not served upon appellant, so he submitted application on 22.07.2015 for supply of the same which was received from the office on 28.07.2015. (Copy as annex "I")
- 9. That on 24.08.2015, appellant submitted representation before R. No. 2 for restoration to the rank of ASI but in vain. (Copy as annex "J")

Hence this appeal, inter alia, on the following grounds:-

GROUNDS:

a. That it is astonished to note that the authority succumbed before the ill wishes of the brother of accused and appellant was awarded with major punishment for no fault.

b. That the accused Barkat Ullah took the law in to his hand to compel a poor fellow for ill wishes and due to his this subservient act, the family of the complainant left the home and shifted to Punjab.

c. That appellant was booked for misconduct by awarding him major punishment of reversion from the rank of ASI to the rank of Head Constable without re-coursing to law as he was neither served with any charge sheet, statement of allegation, enquiry and show cause notice nor served with final show cause notice, so the impugned order is of no legal effect.

- d. That appellant was due for promotion/confirmation as ASI but due to suspension and the case, he was deferred for such benefit.
- e. That from the available record, it is quite clear that appellant was made escaped got for others and not for the welfare of the department. Such act of the respondent is based of malafide.

It is, therefore, most humbly prayed that on acceptance of the appeal, the impugned order dated 13.07.2015 of respondent No. 1 be set aside and appellant be restored to his original position of ASI with all back benefits, with such relief as may be deemed proper and just in circumstances of the case.

On the way near Moh: Mina Khel Lakki a Motor Car red in colour came for behind and blocked his way. Accused Barkatullah, Sakhawat and 2 other unknown accused de-boarded from the car, accused were armed with KK-Rifles and Pistols they belabored him and forcibly put him in

the car, tightened his eyes with shawal () and drove towards unknown place. After some time they opened his eyes and threw him out of car. The complainant found himself near Gambila bridge. Complainant informed his brother Haroon Rashid & consequently the Police arrived on the spot and recorded his report. A Murasla was sent to the PS for further Police proceeding.

On 13.07.2015 worthy District Police Officer, Lakki Marwat vide his OB No. 255 dated 13.07.2015 reverted the appellant to his substantive rank of HC (copy of order is attached as Annex-A).

Grounds of Appeal:

That the order of learned DPO Lakki Marwat is against law, justice & facts on record.

That order of learned DPO Lakki Marwat has occasioned great miscarriage of justice.

3. That on receipt of information about the occurrence the appellant rushed to the sport, where report of complainant Irfan Rashid was recorded in shape of Murasla and sent to PS and also duly informed the senior Officer of PS Lakki Marwat.

4. That if there were any interventions/ directions regarding non registers their cases u/s 506 PPC, it was the duty of duty Officer not to register the FIR before notifying the senior officers regarding the

matter (registration of case u/s 506 PPC).

5. That as the complainant had earlier chronic enmity with the accused party, who forcibly wanted the friendship of complaint son Asif, therefore, non recording of his report, would have amounted to "Burking" which is always forbidden in the police department (copy attached as Annex-B).

6. That as per maxim of equality & justice a person cannot be fined/ punished twice for one & the same fault, where as in the present case, the appellant has been punished and reverted to substantive rank of HC, while on the other hand, the appellant has been charged sheeted for further departmental enquiry, which practice has always been held "BAD" by the honorable senior court.

PRAYERS:

That the appellant had joined the Police department as constable on 24.03.1987 and after qualifying all the pre-requisite courses of Police department gradually promoted to the rank of ASI on 01.01.2009. That as an ASI the appellant has rendered valuable and spotless service & there has never been any complaint for the senior officers or for the public.

In view of the above stated grounds, it is most humbly prayed that are acceptance of this appeal, the punishment of reversion to the substantive rank of HC by the worthy DPO Lakki Marwat may very graciously be set-aside and the appellant may be restored to the original position of ASI enabling him to discharge the duty with zeal, zest, dedication and relieved of mental agonize.

Respectfully Sheweth,

PRELIMINARY OBJECTIONS:

All the 6 preliminary objections are illegal and incorrect. No reason in support of the same is ever given as to why the appeal is time barred, order is legal, not maintainable, concealment of facts, miss and non-joinder of parties, unclean hands, no cause of action, locus standai and estoppel.

ON FACTS:

- 1-2: Needs no comments.
 - 3. Not correct. The para of the appeal is correct. The complainant has alleged beating, so to know the nature of injury / hurt, opinion of Medical Officer was must to inflict / impose relevant section of Law. For the said reason, it was incumbent upon the appellant to go through the prescribed process.
 - 4. Admitted correct by the respondents regarding giving threat to appellant by the brother of complainant namely Asmat Ullah lecturer through mobile No # 0313-9108725.
 - 5. Not correct. No illegality or misconduct was ever committed as stated in para No 3, above.

A part from the aforesaid facts, it is pertinent to bring in to the kind notice of the hon'ble court that appellant was promoted to the post of Off; ASI along with others vide order dated 07-10-2008. The Off; / probation period, being two (02) years, was successfully completed and as per Police Rules, 1934 (13.18)

Servant, who completed two years probation period, shall automatically become confirm / permanent, meaning thereby that appellant was confirmed ASI after 27-10-2010. (Copy as Annex "R")

The incumbents mentioned in order dated 27-10-2008 have by now confirmed as ASIs.

That inquiry into the matter was sub-judice before the authority and after completion of the same, R. No 1 passed order No 177, dated 16-06-2016 where in appellant was awarded written warning to be careful in future, meaning thereby that the punishment of reversion was converted into warning. (Copy as Annex "R/1")

That due to the case in hand, the department confirmed OASI as ASI, namely Shakirullah and M. Zahir Shah, being juniors vide order dated 11-08-2016 & 22-08-2016. (Copies as Annex "R/2")

- 6. Not correct. The authority illegally initiated proceedings against appellant for no obvious reasons and the proceedings were also not carried out as per the mandate of law.
- 7.9. Not commented upon by the respondents, so the paras of the appeal are admitted correct by the respondents.

GROUNDS:

All the grounds of the appeal are legal and correct while that of the reply are illegal and incorrect. The same are again adopted, as for Rule 13.18 of Police Rules, 1934 is concerned, appellant was not reverted for inefficiency but for misconduct, so the same punishment required thorough probe.

More so, there is no punishment of reversion in the law but of reduction.


